



GENERAL NOTES

- ALL STATIONING REFERS TO THE CENTERLINE OF NEW CONSTRUCTION
- THE EXISTING ROAD SHALL REMAIN CLOSED TO THROUGH TRAFFIC DURING CONSTRUCTION; SEE SPECIAL PROVISIONS.
- THE HIGHWAY STANDARD NUMBERS LISTED SHALL NOT BE SUPERCEDED BY LATER REVISIONS OF THE STANDARDS LISTED IN THE PLANS.
- THE LOCATIONS AND/OR DEPTHS OF UNDERGROUND UTILITIES SHOWN HAVE BEEN TAKEN FROM AVAILABLE RECORD INFORMATION FURNISHED BY THE UTILITY OWNERS AND MUST BE CONSIDERED APPROXIMATE.  FERTILIZER NUTRIENTS - 90 LBS / ACRE
 MULCH, METHOD 2 - 2 TONS / ACRE
- THE FINISHED EARTHWORK SHALL HAVE A VEGETATION SUSTAINING SOIL COVERING THE TOP 0.3 FT. IN ACRES TO BE SEEDED.


**COFFEEN RD (C.H. 5)




**SEVEN SISTERS AVE




BUTT JOINT DETAIL




**COFFEEN RD (C.H. 5)
