- 3, AN ESTIMATED QUANTITY OF 50 CU M OF "REMOVAL AND DISPOSAL OF UNSUITABLE MATERIAL" HAS BEEN INCLUDED IN THIS CONTRACT.
- 4 AN ESTIMATED QUANTITY OF 750 KG OF "TEMPORARY EROSION CONTROL SEEDING" HAS BEEN INCLUDED IN THIS CONTRACT.

THE CONTRACTOR SHALL DEWATER THE EXCAVATION, IF NECESSARY, AND FILL AND COMPACT THE HOLES WITH DIRT IN ACCORDANCE WITH THE STANDARD SPECIFICATIONS AND TO THE SATISFACTION OF THE ENGINEER. - 17. IF ANY UNSUITABLE MATERIAL IS ENCOUNTERED DURING CONSTRUCTION, IT WILL BE NECESSARY TO REMOVE THE UNSUITABLE MATERIAL AND REPLACE IT WITH A SUITABLE MATERIAL AS APPROVED BY THE ENGINEER.
