STRUCTURE REMOVAL

Structure removal shall consist of the complete removal of the weight scales at the Headquarters parking lot as shown in the plans. Work shall consist of removal of the weight scales, removal of any concrete higher than the parking lot and backfilling the pit with Porous Granular Backfill. Concrete removal shall be to 8" below the surface of the surrounding parking lot and to the satisfaction of the Engineer. No concrete removal shall be performed on the side of the pit adjacent to the office building. Saw cuts parallel to the building will be required to the depth of concrete removal.

Weight scale removal and concrete removal shall be paid for at the contract unit price each for REMOVAL OF EXISTING STRUCTURES. The porous granular backfill will be paid for at the contract unit price ton for POROUS GRANULAR BACKFILL.
