

GENERAL NOTES

1. THE RESIDENT ENGINEER SHALL LOCATE AND MARK THE EXACT LOCATIONS FOR ALL PROPOSED ITEMS PRIOR TO INSTALLATION BY THE CONTRACTOR.
2. FLUORESCENT ORANGE "ROAD CONSTRUCTION AHEAD" SIGNS SHALL BE PLACED AT THE BEGINNING AND END OF THE PROJECT PLUS THE INTERSECTING SIDE ROADS AS DIRECTED BY THE ENGINEER. THESE SIGNS SHALL NOT BE MEASURED FOR PAYMENT.
3. ILLINOIS STATE LAW REQUIRES A 48-HOUR NOTICE BE GIVEN TO ALL UTILITIES BEFORE DIGGING. FIELD MARKING OF FACILITIES MAY BE OBTAINED BY CONTACTING J.U.L.I.E. OR FOR NON-MEMBERS, THE UTILITY COMPANY DIRECTLY. AGENCIES KNOWN TO HAVE FACILITIES WITHIN THE PROJECT AREA ARE AS FOLLOWS:

4. EXCEPT WHERE DESIGNATED OTHERWISE, THE LOCATIONS AND/OR DEPTHS OF UNDERGROUND UTILITIES SHOWN HAVE BEEN TAKEN FROM OFFICE RECORD INFORMATION FURNISHED BY THE UTILITY OWNERS AND MUST BE CONSIDERED APPROXIMATE.
5. THE CONTRACTOR SHALL VERIFY ALL DIMENSIONS AND CONDITIONS IN THE FIELD PRIOR TO CONSTRUCTION AND ORDERING OF MATERIALS.
6. NO LANE CLOSURES WILL BE ALLOWED EXCEPT FOR SHORT TIME OPERATIONS AS SHOWN IN STANDARD 701301 AND SHALL BE PAID FOR AS PER SECTION 701.019(b) OF THE STANDARDS SPECIFICATION FOR ROAD AND BRIDGE CONSTRUCTION.
