## **WORKING DAYS (BDE)**

Effective: January 1, 2002

The Contractor shall complete the work within 15 working days.

### RAISED REFLECTIVE PAVEMENT MARKER REMOVAL

This work shall consist of removing existing raised reflective pavement markers and filling the hole after removal with rapid setting epoxy.

The removal shall be in accordance with applicable portions of Section 783 of the Standard Specifications and as directed by the Engineer.

Filling the hole shall be completed immediately following the removal of the raised reflective pavement marker using a rapid setting (hard in one hour) epoxy meeting the requirements of AASHTO M 237. It shall be poured into the hole to the level of all sides and gain strength fast enough to meet the satisfaction of the Engineer.

This work will be measured and paid for at the contract unit price each for RAISED REFLECTIVE PAVEMENT MARKER REMOVAL. No additional compensation will be allowed.

## RAISED REFLECTIVE PAVEMENT MARKER, REFLECTOR REMOVAL

This work shall consist of removing existing raised reflective pavement marker reflectors out of existing castings located in the pavement. The remaining castings will be able to remain in place at locations where they will not be in the middle of a proposed open lane of traffic.

The removal shall meet the satisfaction of the Engineer and be completed prior to opening the new lanes to traffic.

This work will be measured and paid for at the contract unit price each for RAISED REFLECTIVE PAVEMENT MARKER, REFLECTOR REMOVAL. No additional compensation will be allowed.
