To further clarify the design plans, the following notes are provided.

- On sheet 13, the material for the floral pattern shall be  $\frac{1}{4}$ " thick laser cut steel plate.
- On sheet 14, the thickness of the plates shall be  $\frac{1}{4}$ " laser cut steel.
- The polycarbonate thickness shall be per the manufacturer's recommendations.
- The raised letter dimensions are 1'-2  $\frac{3}{4}$ " high times new roman style.
- For section A-A, the length of the plate is shown on sheet 11, the length of plate for section A-A. The protective shield, special is 78' long.
- The graphic on sheet 22 is for informational purposes only. Not all ornamental metal panels will have a curved arch ceiling. Refer to sheet 17 for curved arch ornamental metal panel locations as dimensioned and noted with a double asterisk (\*\*). Ornamental metal panels will have 3 curved arches for the first 3 ornamental metal panels are the ends of the viaduct. Curved arch canopy construction consists of  $\frac{1}{4}$ " thick painted aluminum sheet secured to panel supports. Refer to sheet 20.
- Ornamental metal panels on sheet 17 are to be designed by the Contractor including the connection of the  $\frac{1}{4}$ " painted aluminum sheet to the 4" angle iron bent/rolled to shape. On sheet 20, the plans indicate the 4" angle iron final size to be determined by the Contractor.
