- BEFORE STARTING ANY EXCAVATIONS, THE CONTRACTOR SHALL CALL "J.U.L.L.E" AT (800)892-0123 FOR FIELD LOCATIONS OF BURIED ELECTRIC, TELEPHONE, AND GAS UTILITIES. (48 HOUR NOTIFICATION IS REQUIRED).
- CONTRACTOR SHALL COORDINATE CONSTRUCTION ACTIVITIES WITH UTILITY COMPANIES AND THE VILLAGE OF HILLSIDE.
- IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO VERIFY ALL DIMENSIONS AND CONDITIONS EXISTING IN THE FIELD PRIOR TO CONSTRUCTION AND ORDERING OF MATERIALS.
- THE CONTRACTOR SHALL NOTIFY MR. JOSEPH PISANO (708) 202-3434 AT THE VILLAGE OF HILLSIDE A MINIMUM OF 72 HOURS IN ADVANCE OF REGINNING WORK
- EXACT LOCATIONS AND LIMITS OF REMOVALS SHALL BE DETERMINED IN THE FIELD BY THE FIELD ENGINEER AT THE TIME OF CONSTRUCTION.
- CENTERLINES ARE APPROXIMATE AND SHALL BE USED FOR LOCAL REFERENCE ONLY.
- NO STOCKPILING OF MATERIAL ON THE JOB SITE IS PERMITTED.
- DO NOT SCALE PLANS FOR CONSTRUCTION DIMENSIONS.
- THE CONTRACTOR SHALL BE REQUIRED TO PROVIDE ACCESS TO ABUTTING PROPERTY AT ALL TIMES DURING THE CONSTRUCTION OF THE PROJECT.

- THE CONTRACTOR SHALL BE RESPONSIBLE FOR ANY REPAIRS OR RESTORATION TO ITEMS DAMAGED BY CONSTRUCTION OR CONSTRUCTION EQUIPMENT AT NO ADDITIONAL COST TO THE CONTRACT. THE DAMAGED AREAS SHALL BE RESTORED TO THE SATISFACTION OF THE VILLAGE OF HILLSIDE AND THE FIELD ENGINEER. ALL RESTORATION WORK SHALL BE INCLUDED IN THE COST OF THE CONTRACT.
- ALL WORK PERFORMED RELATIVE TO THIS IMPROVEMENT SHALL COMPLY WITH ALL APPLICABLE RULES AND REGULATIONS OF O.S.H.A.
- THE CONTRACTOR SHALL REMOVE ALL CONSTRUCTION DEBRIS AND LOOSE MATERIALS FROM THE ROADWAY AND ADJACENT AREAS AT THE CLOSE OF EACH WORKING DAY TO SATISFACTION OF THE FIELD ENGINEER. THIS WORK SHALL BE INCLUDED IN THE COST OF THE CONTRACT AND NO ADDITIONAL PAYMENT SHALL BE MADE.
