ALL TEMPORARY PAVEMENT MARKING SHALL BE, PAVEMENT MARKING TAPE, TYPE IV 4" AND THE MATERIALS SHALL BE ACCORDING TO ARTICLE 1095.06 OF THE STANDARD AND SPECIFICATIONS. THE CONTRACTOR SHALL INSTALL, MAINTAIN AND REMOVE ALL TEMPORARY PAVEMENT MARKING TAPE. THIS WORK SHALL NOT BE PAID SEPERATELY AND SHALL BE INCLUDED IN THE COST OF THE "TRAFFIC CONTROL AND PROTECTION STANDARD 701321 (SPECIAL)".

ALL CONFLICTING PAVEMENT MARKINGS AND RAISED REFLECTIVE PAVEMENT MARKERS SHALL BE PROTECTED PRIOR TO COVERING WITH PAVEMENT MARKING BLACKOUT TAPE, 4". PAVEMENT MARKING BLACKOUT TAPE, 4". SHALL EXTEND A MINIMUM OF 2 INCHES BEYOND THE EXISTING MARKINGS OR REFLECTORS IN ALL DIRECTIONS. THIS WORK SHALL INCLUDE PROTECTING EXISTING PAVEMENT MARKINGS AND RAISED REFLECTIVE PAVEMENT MARKERS, INSTALLING, MAINTAINING AND REMOVING BLACKOUT TAPE. THIS WORK SHALL NOT BE PAID SEPERATELY AND SHALL BE INCLUDED IN THE COST OF THE "TRAFFIC CONTROL AND PROTECTION STANDARD 701321 (SPECIAL)".

#### **GENERAL NOTES**

This Standard is used where, at any time, any vehicle, equipment, workers, or their activities will encroach on one lane of a bridge. Traffic signals and a positive barrier are required.

Traffic signals shall be operational only when all traffic controls are in place. When traffic signals are not in operation, flaggers shall be used and traffic control shall conform to Standard 701201 or 701206.

Temporary concrete barrier shall be according to Standard 704001.

Existing or temporary pavement markings shall be on both sides of open lane from stop bar to stop bar.
