NOTES:

1. FINAL BIKE RACK LOCATION TO BE VERIFIED IN THE FIELD AND APPROVED BY THE ENGINEER PRIOR TO INSTALLATION.
2. BICYCLE RACKS, TYPE 1 SHALL BE INVERTED "U" RACKS. RACKS SHALL BE 36 IN TALL AND 30 IN WIDE.
3. BICYCLE RACKS, TYPE 2 SHALL BE "WAVE" RACKS. RACKS SHALL BE 36 IN TALL AND 40 IN FROM CREST TO CREST OF THE WAVE. OVERALL WIDTH SHALL BE 100 IN. "WAVE" RACKS SHALL ACCOMMODATE 7 BIKES PER UNIT.

4. CONCRETE PADS, WHERE REQUIRED, SHALL BE AS FOLLOWS: FOR TYPE 1 RACKS, CONCRETE PADS SHALL BE 6'-6" BY 4'-0" (OR AS DIRECTED BY THE ENGINEER), FOR TYPE 2 RACKS, CONCRETE PADS SHALL BE 6'-0" BY 12'-4" (OR AS DIRECTED BY THE ENGINEER). THIS WORK SHALL BE INCLUDED IN THE COST OF THE BICYCLE RACKS, OF TYPE SPECIFIED.
