Limitations of Construction: The Contractor shall coordinate the items of work in order to keep hazards and traffic inconveniences to a minimum, as specified below.

1. During the construction of this section the following shall apply: At least one lane shall remain open to traffic at all times. No lane closures will be allowed without signal or flagger protection.
2. The Contractor shall provide, erect, and maintain all the necessary barricades, cones, drums, and lights for the warning and protection of traffic, as required by Sections 107 and 701 through 703 of the Standard Specifications, and as modified.
3. All post mounted signs shall use 100 x 100 mm (4 x 4 inches) wood posts according to Article 1093.01(b) of the Standard Specifications and shall be properly braced to the satisfaction of the Engineer. The use of metal posts will not be permitted.

STRUCTURE DESCRIPTIONS (086-0027) SCOTT COUNTY)

#1

Bridge 086-0027 (Scott County); Old 36, over I-72, 3.0 miles north of Winchester in Scott County.

This two span structure has an overall steel length of 210.92 feet, a total width of 68.0 feet. The cleaning and painting methods to be used are outlined on the plans.

The painting of this structure shall be according to the Special Provisions for Cleaning and Painting Existing Steel Structures contained herein. The paint shall be organic zinc, epoxy and polyurethane paint system. The color shall be as shown on the plans.

Traffic Control and Protection for Old 36 shall be in accordance to Standard 701006, 701201 and for FAI-72 Standards 701101, 701106, 701400, 701401 and 701406 as described in these Special Provisions.
