**STAGE 1 PHASE I CONSTRUCTION**

IL RTE 178: REMOVE EXISTING PAVEMENT AND CONSTRUCT NEW PAVEMENT FOR THE PROPOSED NB LANES TO THE LIMITS SHOWN ON THE MAINTENANCE OF TRAFFIC SHEETS. REMOVE NB LANES OF EXISTING STRUCTURE AND CONSTRUCT PROPOSED STRUCTURE FOR THE PROPOSED NB LANES. THIS WORK SHALL INCLUDE EARTHWORK AND GRADING, SUB-BASE GRANULAR MATERIAL, STABILIZED SUB-BASE, PORTLAND CEMENT CONCRETE JOINTED PAVEMENT, PORTLAND CEMENT CONCRETE SHOULDERS, COMBINATION CONCRETE CURB AND GUTTER AND ALL DRAINAGE ITEMS.

PROPOSED FRONTAGE ROAD: CONSTRUCT RELOCATED FRONTAGE ROAD PAVEMENT TO LIMITS SHOWN ON THE MAINTENANCE OF TRAFFIC SHEETS. THIS WORK SHALL INCLUDE EARTHWORK/GRADING, AGGREGATE BASE COURSE AND A BITUMINOUS SURFACE TREATMENT.

PROPOSED RAMP J: CONSTRUCT PROPOSED RAMP PAVEMENT TO LIMITS SHOWN ON THE MAINTENANCE OF TRAFFIC SHEETS. THIS WORK SHALL INCLUDE EARTHWORK AND GRADING, SUB-BASE GRANULAR MATERIAL, STABILIZED SUB-BASE, PORTLAND CEMENT CONCRETE JOINTED PAVEMENT, PORTLAND CEMENT CONCRETE SHOULDERS AND ALL DRAINAGE ITEMS.

PROPOSED RAMP L: CONSTRUCT PROPOSED RAMP PAVEMENT TO LIMITS SHOWN ON THE MAINTENANCE OF TRAFFIC SHEETS. THIS WORK SHALL INCLUDE EARTHWORK AND GRADING, SUB-BASE GRANULAR MATERIAL, STABILIZED SUB-BASE, PORTLAND CEMENT CONCRETE JOINTED PAVEMENT, PORTLAND CEMENT CONCRETE SHOULDERS AND ALL DRAINAGE ITEMS.

US RTE 6: REMOVE AND RECONSTRUCT DRIVEWAY ENTRANCES. ALSO CONSTRUCT STORM SEWER ON NORTH SIDE OF PAVEMENT.

**STAGE 1 PHASE I TRAFFIC**

F.A.I. 80: MAINTAIN TWO LANES OF TRAFFIC IN THE EB AND WB DIRECTION. TRAFFIC SHALL BE SHIFTED TO THE INSIDE SHOULDER FOR THE CONSTRUCTION OF PROPOSED RAMPS J & L CONNECTING TO F.A.I. 80. DURING BEAM REMOVAL AND CONSTRUCTION WB TRAFFIC SHALL BE DETOURED ONTO TEMPORARY RAMP J, ACROSS IL RTE 178 AND ONTO TEMPORARY RAMP I, THEN CONTINUING WB ON F.A.I. 80. EB TRAFFIC SHALL BE DETOURED ONTO TEMPORARY RAMP K, ACROSS IL RTE 178 AND ONTO TEMPORARY RAMP L, THEN CONTINUING EB ON F.A.I. 80.

IL RTE 178: PROVIDE ONE LANE OF TRAFFIC IN BOTH THE NB AND SB DIRECTION.

FRONTAGE ROAD: PROVIDE ONE LANE OF TRAFFIC IN BOTH DIRECTIONS. TRAFFIC WILL BE SHUT DOWN DURING OFF PEAK HOURS ONLY TO CONNECT INTO THE EXISTING FRONTAGE ROAD.

TEMPORARY RAMP I: PROVIDE ONE LANE OF TRAFFIC.

TEMPORARY RAMP J: PROVIDE ONE LANE OF TRAFFIC.

TEMPORARY RAMP K: PROVIDE ONE LANE OF TRAFFIC.

TEMPORARY RAMP L: PROVIDE ONE LANE OF TRAFFIC.

US RTE 6: EXISTING TRAFFIC PATTERN IS MAINTAINED.

**STAGE 1 PHASE II CONSTRUCTION**

IL RTE 178: REMOVE EXISTING PAVEMENT AND CONSTRUCT NEW PAVEMENT FOR THE PROPOSED NB LANES TO THE LIMITS SHOWN ON THE MAINTENANCE OF TRAFFIC SHEETS. THIS WORK SHALL INCLUDE EARTHWORK AND GRADING, SUB-BASE GRANULAR MATERIAL, STABILIZED SUB-BASE, PORTLAND CEMENT CONCRETE JOINTED PAVEMENT, PORTLAND CEMENT CONCRETE SHOULDERS, COMBINATION CONCRETE CURB AND GUTTER AND ALL DRAINAGE ITEMS.

TEMPORARY RAMP J: REMOVE TEMPORARY RAMP PAVEMENT TO LIMITS SHOWN ON THE MAINTENANCE OF TRAFFIC SHEETS. THIS WORK WILL INCLUDE EARTHWORK AND FINAL GRADING.

TEMPORARY RAMP L: REMOVE TEMPORARY RAMP PAVEMENT TO LIMITS SHOWN ON THE MAINTENANCE OF TRAFFIC SHEETS. THIS WORK WILL INCLUDE EARTHWORK AND FINAL GRADING.

PROPOSED RAMP J: CONSTRUCT GORE AREA ALONG W.B. F.A.I. 80 PAVEMENTS TO THE LIMITS SHOWN ON THE MAINTENANCE OF TRAFFIC SHEETS. THIS WORK SHALL INCLUDE EARTHWORK AND GRADING, SUB-BASE GRANULAR MATERIAL, STABILIZED SUB-BASE, PORTLAND CEMENT CONCRETE JOINTED PAVEMENT, PORTLAND CEMENT CONCRETE SHOULDERS AND ALL DRAINAGE ITEMS.

PROPOSED RAMP L: CONSTRUCT GORE AREA ALONG E.B. F.A.I. 80 PAVEMENTS TO THE LIMITS SHOWN ON THE MAINTENANCE OF TRAFFIC SHEETS. THIS WORK SHALL INCLUDE EARTHWORK AND GRADING, SUB-BASE GRANULAR MATERIAL, STABILIZED SUB-BASE, PORTLAND CEMENT CONCRETE JOINTED PAVEMENT, PORTLAND CEMENT CONCRETE SHOULDERS AND ALL DRAINAGE ITEMS.

**STAGE 1 PHASE II TRAFFIC**

F.A.I. 80: MAINTAIN TWO LANES OF TRAFFIC IN THE EB AND WB DIRECTION. TRAFFIC SHALL BE SHIFTED TO THE INSIDE SHOULDER FOR THE CONSTRUCTION OF PROPOSED RAMPS J & L CONNECTING TO F.A.I. 80.

IL RTE 178: PROVIDE ONE LANE OF TRAFFIC IN BOTH THE NB AND SB DIRECTION.

FRONTAGE ROAD: PROVIDE ONE LANE OF TRAFFIC IN EACH DIRECTION ON THE NEW REALIGNED PAVEMENT.

TEMPORARY RAMP I: PROVIDE ONE LANE OF TRAFFIC.

PROPOSED RAMP J: PROVIDE ONE LANE OF TRAFFIC.

TEMPORARY RAMP K: PROVIDE ONE LANE OF TRAFFIC.

PROPOSED RAMP L: PROVIDE ONE LANE OF TRAFFIC.
