# SPECIAL PROVISIONS

The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction, Adopted April 1, 2016, the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways", and the "Manual of Test Procedures for Materials" in effect on the date of invitation for bids, and the "Supplemental Specifications and Recurring Special Provisions" indicated on the Check Sheet included herein, which apply to and govern the construction of FAI Route 55 (I-55), Project NHPP-QDQF(941), Section (84-2) BDR, (84-2-2) BDR-1, Sangamon County, Contract No. 72L67 and in case of conflict with any part, or parts, of said Specifications, the said Special Provisions shall take precedence and shall govern.

## LOCATION OF PROJECT

This project is located at Sangamon River 2.7 miles north of IL 54/Sangamon Avenue, Over IL 54/Sangamon Avenue and IC Railroad 0.3 miles north of IL 54/Sangamon Avenue interchange in Springfield, IL. The improvements are in the following locations:

- 1. SN 084-0018 / SN 084-0019: Sangamon River
- 2. SN 084-0016 / SN 084-0017: IC Railroad
- 3. SN 084-0014 / SN 084-0015: IL 54/Sangamon Avenue

## DESCRIPTION OF PROJECT

The proposed work for this section of I-55 consist of bridge deck repairs, bridge deck overlays and bride repairs.

The existing guardrail terminal end sections located on I-55 on the overhead structures will be replaced as necessary to meet current standards. All guardrail work is to be done before the bridge work begins.

The work on this project consist of furnishing all labor, materials, and equipment required for the following:

- 1. SN 084-0018 / SN 084-0019: NB and SB over Sangamon River
- 2. SN 084-0016/ SN 084-0017: NB and SB over IC Railroad
- 3. SN 084-0014 / SN 084-0015: IL 54/ Sangamon Avenue
