#### GENERAL NOTES

- 1. ILLINOIS STATE LAW REQUIRES A 48-HOUR NOTICE TO BE GIVEN TO UTILITIES BEFORE DIGGING.
  FIELD MARKING OF FACILITIES MAY BE OBTAINED BY CONTACTING J.U.L.LE (1-800-892-0123 OR 81)
  OR FOR NON-MEMBERS. THE UTILITY COMPANY DIRECTLY.
- 2. UTILITY INTERFERENCES ARE NOT ANTICIPATED ON THIS CONTRACT. IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO COORDINATE HIS CONSTRUCTION ACTIVITIES WITH THE VARIOUS UTILITY OWNERS. ALL POTENTIAL CONFLICTS SHALL BE INVESTIGATED AND REMEDIAL ACTION TAKEN PRIOR TO INTERRUPTION OF THE CONTRACTOR'S PROGRESS. NO ADDITIONAL COST SHALL BE ADDED TO THE CONTRACT RESULTING FROM UTILITY CONFLICTS.
- 3. THE SSPC-OPI AND SSPC-OP2 CERTIFICATIONS WILL BE REQUIRED FOR THE BRIDGE.
- 4. ALL TURE AREA DISTURBED BY THE CONTRACTOR SHALL BE SEEDED WITH THE APPROPRIATE EROSION CONTROL AS DIRECTED BY THE RESIDENT ENGINEER/TECHNICIAN AT THE CONTRACTOR'S EXPENSE.
- 5. THE USE OF CONES SHALL NOT BE PERMITTED ON THIS PROJECT.
- 6. "ROAD CONSTRUCTION AHEAD" SIGNS SHALL BE PLACED AT EACH END OF THE PROJECT LOCATIONS AND ALL INTERSECTING SIDE ROADS AND WILL BE INCLUDED IN THE TRAFFIC CONTROL PAY ITEMS. ALL CONSTRUCTION SIGNS SHALL BE FLUORESCENT ORANGE. 48".
- CHANGEABLE MESSAGE SIGNS SHALL BE PLACED TWO (2) WEEKS PRIOR TO ANY LAME RESTRICTIONS
  AS DIRECTED BY THE RESIDENT ENGINEER/TECHNICIAN.

ALL EXISTING STEEL SHALL BE CLEANED PER NEAR WHITE BLAST CLEANING- SSPC-SPIO. ALL EXISTING STEEL SHALL BE PAINTED ACCORDING TO THE REDUIREMENTS OF PAINT SYSTEM 1-0Z/E/U. THE COLOR OF THE FINAL FINISH COAT FOR ALL STEEL SURFACES SHALL BE GRAY, MUNSELL NO 5B 7/1.

LOCATION SPECIFIC GENERAL NOTES

- A MINIMUM OF TWO AIR MONITORS WILL BE REQUIRED AT SN 060-0014 AND SN 060-0015 TO MONITOR ABRASIVE BLASTING OPERATION, SEE SPECIAL PROVISIONS FOR "CONTAINMENT AND DISPOSAL OF LEAD PAINT CLEANING RESIDUES."
- 3. EXISTING BEARINGS AND CATCH BEAMS THAT WERE PAINTED ON THE PREVIOUS CONTRACT ARE EXCLUDED FROM THIS CONTRACT. THE CONTRACTOR IS RESPONSIBLE FOR DAMAGE TO THE PAINT SYSTEM FOR THESE ITEMS THAT OCCURS DURING THE WORK BEING PERFORMED AS A PART OF THIS CONTRACT, AND THE CONTRACTOR IS RESPONSIBLE FOR CORRECTIVE MEASURES TO THE SATISFACTION OF THE RESIDENT ENGINEER/ TECHNICIAN.

- 1. CLEANING AND PAINTING OF THE EXISTING STEEL SHALL BE AS SPECIFIED IN THE SPEICAL PROVISION FOR "CLEANING AND PAINTING EXISTING STEEL STRUCTURES." ALL BEAMS, BEARINGS AND OTHER STEEL WITHIN 5 FT (MEASURED ALONG THE BEAM) OF EITHER SIDE OF DECK JOINTS SHALL BE CLEANED PER NEAR WHITE BLAST CLEANING SSPC-SPIO.
- 2. THE DESIGNATED AREAS CLEANED PER NEAR WHITE BLAST CLEANING AND PER COMMERCIAL GRADE POWER TOOL CLEANING SHALL BE PAINTED ACCORDING TO THE REQUIREMENTS OF PAINT SYSTEM 1-02/E/U, THE COLOR OF THE FINAL FINISH COAT FOR ALL CLEANED STEEL SHALL BE REDDISH BROWN, MUNSELL NO. 2.5YR 3/4.
- 3. A MINIMAN OF TWO AIR MONITORS WILL BE REQUIRED AT SN 082-0217 AND A MINIMAN OF TWO AIR MONITORS WILL BE REQUIED AT SN 082-0218 TO MONITOR ABRASIVE BLASTING OPERATION, SEE SPECIAL PROVISIONS FOR "CONTAINMENT AND DISPOSAL OF LEAD PAINT CLEANING RESIDUES."
