## GENERAL ACCESS NOTE:

ACCESS TO GRANT STREET AND KENNEDY COURT SHALL REMAIN OPEN AT ALL TIMES.

DRIVE APPROACHES SHALL BE CONSTRUCTED ONE—HALF AT A TIME UNLESS ALTERNATE ARRANGEMENTS ARE MADE BETWEEN THE PROPERTY OWNER AND THE CONTRACTOR. THE CITY OF WASHINGTON SHALL NE NOTIFIED OF SUCH ALTERNATE ARRANGEMENTS.

RESIDENTS AND/OR PROPERTY OWNERS SHALL BE NOTIFIED 24 HOURS IN ADVANCE PRIOR TO WORK BEING PERFORMED IN THE DRIVE APPROACH AREAS WHICH MAY HINDER ACCESS TO THEIR PROPERTY.

THIS WORK SHALL NOT BE PAID FOR SEPARATELY BUT SHALL BE CONSIDERED INCIDENTAL TO THE PAY ITEM "TRAFFIC CONTROL AND PROTECTION (SPECIAL)" AND SHALL INCLUDE ALL REMOVALS, MATERIAL, SIGNAGE, EQUIPMENT, LABOR, MAINTENANCE AND INCIDENTAL ITEMS NECESSARY TO PROVIDE FOR THE INGRESS/EGRESS TO SCHOOL STREET RESIDENCES, SCHOOLS AND BUSINESSES LOCATED WITHIN THE PROJECT LIMITS AND AFFECTED DURING CONSTRUCTION.

## NOTES:

- TRAFFIC CONTROL SHALL BE IN ACCORDANCE WITH STANDARD 701501-06 AND 701901-03.
- FLASHING LIGHTS SHALL BE USED ON EACH APPROACH IN ADVANCE OF THE WORK AREA DURING HOURS OF DARKNESS AND PLACED ON EACH PERMANENT SIGN.
- SCHOOL STREET TO REMAIN OPEN AT ALL TIMES. SOUTHBOUND LANE MAY BE CLOSED DURING WORKING HOURS ONLY WITH SIGNAGE AND FLAG PERSON AS PER STD. 701501-06
