- 1. TIME AND PLACE OF OPENING BIDS. Electronic bids are to be submitted to the electronic bidding system (iCX-Integrated Contractors Exchange). All bids must be submitted to the iCX system prior to 12:00 p.m. April 26, 2024 prevailing time at which time the bids will be publicly opened from the iCX SecureVault.
- **2. DESCRIPTION OF WORK**. The proposed improvement is identified and advertised for bids in the Invitation for Bids as:

Sidewalk construction on various routes within Neoga.

- 3. INSTRUCTIONS TO BIDDERS. (a) This Notice, the invitation for bids, proposal and letter of award shall, together with all other documents in accordance with Article 101.09 of the Standard Specifications for Road and Bridge Construction, become part of the contract. Bidders are cautioned to read and examine carefully all documents, to make all required inspections, and to inquire or seek explanation of the same prior to submission of a bid.
  - (b) State law, and, if the work is to be paid wholly or in part with Federal-aid funds, Federal law requires the bidder to make various certifications as a part of the proposal and contract. By execution and submission of the proposal, the bidder makes the certification contained therein. A false or fraudulent certification shall, in addition to all other remedies provided by law, be a breach of contract and may result in termination of the contract.
- 4. AWARD CRITERIA AND REJECTION OF BIDS. This contract will be awarded to the lowest responsive and responsible bidder considering conformity with the terms and conditions established by the Department in the rules, Invitation for Bids and contract documents. The issuance of plans and proposal forms for bidding based upon a prequalification rating shall not be the sole determinant of responsibility. The Department reserves the right to determine responsibility at the time of award, to reject any or all proposals, to readvertise the proposed improvement, and to waive technicalities.

# SPECIAL PROVISIONS

The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction" adopted January 1, 2022 (hereinafter referred to as "Standard Specifications"), the latest edition of the: "Manual on Uniform Traffic control Devices for Streets and Highways", and the "Manual of Test Procedures for Materials" in effect on the date of invitation for bids, and the "Supplemental and Recurring Special Provisions" indicated on the check sheet included herein which apply to and govern the construction of the proposed improvement designated as SRTS SIDEWALK 21-00008-01-SW in the City of Neoga, Cumberland County. In the case of conflict with any part, or parts of said Specifications, these Special Provisions shall take precedence and shall govern. All work within Railroad Right-Of-Way shall be specified in their specifications. The contractor shall include all training and necessary certifications to perform work within RR ROW in the bid price. The city will not be responsible for payment of training and certifications stated in Railroad specifications.

# DESCRIPTION OF WORK

The work in this contract consists of furnishing all equipment, labor, and materials necessary to construct a 5 foot wide concrete sidewalk with ADA compliances from the intersection of 6<sup>th</sup> Street & Park Avenue to Neoga Junior Senior High School in the City of Neoga, Cumberland County, Illinois. Included in the work is earth excavation, proposed sidewalk, detectable warning panel, seeding, driveway pavement, and all other incidental work required to complete the project.

# CONSTRUCTION STAKING AND MATERIAL TESTING

The construction staking and material testing will be the responsibility of the Owner. If the Contractor prefers additional staking and/or testing this shall be included in the project cost.

#### BURNING

No open burning will be allowed

#### **OVERHAUL**

No payment for Overhaul will be allowed for earth hauled from any source.

#### UTILITIES

The Contractor shall maintain in operating condition all utilities encountered in the work. The Contractor shall be entirely responsible for all damages to water pipes; electrical conduits; existing drains or sewers; gas pipes; and poles carrying electrical current, telephone or television lines during the prosecution of the work and shall be liable for damages to public or private property resulting therefrom, which amount may be deducted from any monies due the Contractor for work done. Any damage to existing utilities as a result of the Contractor's

construction operations shall be repaired to the satisfaction of the utility owner at the Contractor's expense, whether or not said utilities are shown on the plans. The Contractor shall cooperate with the utility companies within the project area in conformance to Article 105.07 of the Standard Specifications.

With the exception of those items specifically listed for payment, all utility adjustments will be done by others. In all probability, these adjustments will be carried out concurrently with the construction of the project.

However, the exact time, and the methods of adjustment are not known; should the Contractor desire more detailed information, he may contact the Owner of the Utility. It is the Contractor's responsibility to notify the Owners of the utilities two (2) weeks in advance of the date he intends to start construction operations.

It is hereby understood and agreed that the Contractor has taken this into consideration upon submitting his bid, and no additional compensation will be allowed for any delays occasioned by the failure of the Owners to move their utilities.

# LOCATION OF UTILITIES NOT SHOWN ON PLANS

The Contractor is advised that various underground and surface utilities and structures may or may not be shown on the plans. The locations and dimensions of such facilities where shown do not purport to be absolutely correct. Such facilities are shown on the plans for the information of the Contractor, but information so given is not to be construed as a representation that such facilities will be found or encountered exactly as shown. Other utilities and structures may also be encountered which are not shown on the plans. The Owner and its Engineer assume no responsibility whatever in respect to the sufficiency or accuracy of the information shown in the plans relative to the presence or location of such facilities.

# CONTRACTOR RESPONSIBLE FOR LOCATING UTILITIES

Before beginning work it shall be the Contractor's sole responsibility to coordinate with the utility owners and to determine the actual location of all such facilities. The Contractor shall also obtain from the respective utility owners detailed information relative to the location of their facilities and the working schedules of the utility owners for removing or adjusting them.

# COOPERATION AND CONTROL OF WORK

In addition to the requirements of Section 105, the Contractor shall make every effort to communicate their schedule and proposed construction activities to affected business owners and home owners on a daily basis. The Contractor shall identify a single person, on the work site at all times, to act as the liaison between property owners, residents, business owners, the City and the Contractor. This person shall have full authority from the Contractor to negotiate access matters with all parties and shall meet the approval of the City. The Contractor's liaison shall meet with business owners and residents affected by the work weekly to keep them updated on the actual construction progress.

The City shall have the authority to require the Contractor to replace this liaison should the City be dissatisfied with their performance for any reason. If required by the City, the Contractor shall designate a new liaison, meeting the approval of the City, within a 24-hour period of receiving written notice.

The Contractor shall coordinate with the owner of "Neoga Package Liquors" for access to the business. The proposed sidewalk shall be constructed while maintaining access to the drive through once front door access is closed. Once the front entrance door sidewalk area is completed and accessible to the public; the contractor may proceed with work in the drive through area.

# EARTH EXCAVATION SOIL MANAGMENT

The Contractor shall construct the proposed project to the line and grade shown on the plans. This work shall be in accordance with Article 202 and 205 of the Standard Specifications for Road and Bridge Construction and as detailed in the plans. At areas where the pavement is higher than the existing grade, the existing subgrade shall be compacted to a minimum 90% density prior to starting embankments for sidewalk construction. The table provided in the plans has estimated quantities for the Contractor's information only. The contractor shall be responsible for their own earthwork quantities based upon the supplied plan typical views provided in the plan sheets. No correction shall be made solely based upon load counts, or weights supplied in the field. All brush and hedge trimming shall be included in this pay item, there will be no compensation for clearing. Brush and trimmings shall be disposed of outside of City limits in a location approved by an on-site engineer. All aggregate shall be considered as equal to earth excavation and paid per this pay item. The contractor shall establish the price as a lump sum payment to construct the project as shown in the plans. The project shall use this pay item for all earth excavation work. There will be no additional compensation for earth excavation (aggregate base included) within the scope of the project indicated on the plans. The above work shall be paid for by the contract unit price per L SUM for EARTH EXCAVATION SOIL MANAGMENT.

# BORROW AREAS, USE AREAS, AND/OR WASTE AREAS

In addition to the provisions contained in Article 107.22 of the Standard Specifications, any required submittal(s) to the District 7 office shall require four (4) copies sent for processing. All copies of pictures submitted shall be in color.

# TRAFFIC CONTROL AND PROTECTION, (SPECIAL)

Traffic Control shall be in accordance with the applicable sections of the Standard Specifications for Road and Bridge Construction, the applicable guidelines contained in the Illinois Manual on Uniform Traffic Control Devices for Streets and Highways, these Special Provisions, and any special details and Highway Standards contained herein and in the plans.

Special attention is called to Articles 107.09 and 107.14 of the Standard Specifications for Road and Bridge Construction on the following Highway Standards & Traffic Control Standards: shown on Plan Sheet 2.

All streets will be allowed to remain open during the construction of the project. The contractor shall utilize highway standards as listed to minimize the impact to local residents and businesses. If a drive shall be closed the contractor shall coordinate the closure with the landowner a minimum of 24 hours before the proposed closure.

All existing traffic control devices and street signs that interfere with construction are to be either relocated or stored during construction and permanently erected once construction is complete.

All work associated with the acquiring/furnishing, erecting, maintaining, removal of Street Closures, Traffic Control complying with IDOT standards and traffic control plan along with the sequence of construction will be paid for at the contract Lump Sum price for TRAFFIC CONTROL AND PROTECTION (SPECIAL).

# TEMPORARY ACCESS

The Contractor shall utilize aggregate to allow temporary access to the entrances and locations between the construction stages. The contractor shall utilize aggregate from onsite. This work shall include the supplying, installing, and removal of the aggregate, if necessary. This work shall be included in the project with no additional compensation.

# DRAINAGE STRUCTURE SPECIAL

The sidewalk shall provide an ADA compliant drainage structure at the locations given in schedule of quantities and shown on plans to maintain water flow from the back side of the sidewalk to flowline. The grate and structure shall match the width of the design sidewalk on plan set. The structure shall be constructed according to Sheet 3 detail. The scope of work shall include tile drain connection, saw cutting sidewalk and curb, material to construct, labor, and equipment. The tile drain shall be adjusted for flow at no compensation.

Drainage structures shall be furnished and installed in accordance with section 602 of the Standard Specifications with exceptions as shown on the Plans and as specified herein. A general plan for the structure has been shown on the plan sheets for the contractor's information only. Actual calculations and redesign if necessary shall be signed and sealed by an Illinois Licensed Structural Engineer. This approval will not relieve the Contractor of responsibility for the safety of the excavation. The contractor's engineer shall address any buoyancy issues.

A 12-inch bedding of CA-7 aggregate or SI Concrete shall be placed on the bottom of the excavation and leveled to form a flat base to set the drainage structure.

All penetrations through the walls shall be sealed with a non-shrink grout.

This work includes all mobilization, excavation, temporary or permanent shoring/casing, labor, materials and equipment required to manufacture, furnish and install the drainage structures, CA-7 for base and backfill, concrete, removal and disposal of excess material and other incidental items as shown on the plans. This work shall be paid for by the contract unit price LSUM for DRAINAGE STRUCTURE SPECIAL.

# SEEDING, CLASS 1 (SPECIAL)

Earth surfaces disturbed by the Contractor shall be seeded in accordance with Section 250 and mulched in accordance with Section 251, Method 2 (Procedure 1) of the Standard Specifications at the locations shown in the schedule of quantities. All disturbed areas shall receive SEEDING, CLASS 1 (SPECIAL). Fertilizer nutrients, limestone, and mulch shall be applied as hereinafter specified except that the fertilizer nutrients, limestone, and mulch will not be paid for separately but shall be included in the unit bid price ACRE for SEEDING, CLASS 1 (SPECIAL).

\*Spring seeding shall be done between March 1 and June 1. Fall seeding shall be done between August 1 and November 15.

# PIPE HANDRAIL

This work shall include installing a hand railing at the locations as shown in the plans and specifications, and in accordance with Section 509 of the specifications. The pipe handrail shall be powder coated black. The railing shall be constructed in accordance with ADA compliance and the Illinois Accessibility Code. Base plates shall be placed in the concrete to allow for installation of handrail. Base plates will not be paid for separately but will be included in the price of pipe handrail. The contractor and/or handrail manufacturer will be responsible for taking all necessary measurements for length and elevation needed to compile the shop drawings for the proposed handrail.

This work will be paid for at the contractor unit price FOOT for PIPE HANDRAIL, which will shall include all equipment, materials, fabrication and labor.

# REMOVE RIGHT-OF-WAY MARKER

This work shall include the removal of the concrete right-of-way marker. The concrete marker shall not be damaged during the removal process. The material shall be salvaged to the City of Neoga. Once the marker is removed, the contractor shall have Milano & Grunloh replace the existing one with an iron pin. Call 217-347-7262 for reinstalment of boundary marker 48 hours prior to removal. This work shall be completed at no additional compensation and included into the EARTH EXCAVATION SOIL MANAGEMENT PAY ITEM.

# PORTLAND CEMENT CONCRETE SIDEWALK 4 INCH

This work shall be referenced in Section 424 in the IDOT Standard Specifications for Road and Bridge Construction manual. Additional pavement replacement from sawcut repairs shall be included in this pay item at no additional compensation. Additional pavement for connection to street pavement shall be included in this pay item at no additional compensation.

This work will be paid for at the contractor unit price SQ FT for PORTLAND CEMENT CONCRETE SIDEWALK 4 INCH, which shall include all equipment, materials, fabrication and labor

# **RETAINING WALL REMOVAL**

The Contractor shall remove the portion of the modular block retaining wall at the location shown in the plans. The Contractor shall take extra precaution to not damage the existing modular block retaining wall that is to remain. The modular blocks that are to be removed shall be returned to the Property Owner or disposed of by the Contractor with approval of property owner. The existing ground behind the modular block retaining wall to be removed shall be graded to drain as shown in the plans. This work shall include the removal and disposal of the modular block retaining wall and the necessary grading. This work shall be paid for at the contract unit price per FOOT for RETAINING WALL REMOVAL.

# **REMOVE GRATING**

The Contractor shall remove the portion of the existing grate at the location shown in the plans. The Contractor shall take extra precaution to not damage the existing grate during removal. Once the grate has been removed, the contractor shall salvage to the City of Neoga. Call the City for desired storage location. This work shall be paid for at the contract unit price per EACH for REMOVE GRATING.

# REMOVE AND REINSTALL PARKING BLOCKS

The Contractor shall relocate each parking block to the location shown in the plans. The Contractor shall take extra precaution to not damage the existing parking blocks. If a block happens to be damaged during relocation, the contractor shall provide a new parking block. The new block shall be paid in full by the contractor. Coordinate with the business owner prior for relocating. This work shall be paid for at the contract unit price per EACH for REMOVE AND REINSTALL PARKING BLOCKS.

# DOMESTIC METER VAULTS TO BE ADJUSTED

The Contractor shall adjust the existing water meter pits and meter lids to the elevations shown in the plans or match the ground elevations around the meter vault. The meter lid shall be in accordance with ADA specifications or replaced with an ADA lid which does not have more than a quarter inch elevation change in material. This work shall be in accordance to the applicable portions of Section 602 of the Standard Specifications for Road & Bridge Construction. The Contractor shall coordinate this work with the City of Neoga Water Department. The Contractor shall be paid at the contract unit price per EACH for DOMESTIC METER VAULTS TO BE ADJUSTED. Excavation, backfill, new risers, adjusting rings, all hardware, labor, and equipment necessary to complete the work shall be considered as included in the unit price bid.

# WATER VALVES TO BE ADJUSTED

This work shall consist of adjusting water valve lids to match the proposed grades as indicated on the plans and shall be in accordance with Section 565. The valve lid shall be in accordance

with ADA specifications or replaced with an ADA lid which does not have more than a quarter inch elevation change in material. Any existing valves damaged as part of the pavement removal, or adjustment work shall be replaced with new ones of the same kind as, or equal to, the damaged ones at no additional cost to the contract.

This work shall be paid for at the contract unit price EACH for WATER VALVES TO BE ADJUSTED. Excavation, backfill, new risers, adjusting rings, all hardware, labor and equipment necessary to complete the work shall be considered as included in the unit price bid.

# SIDEWALK REMOVAL

This work shall be in accordance with Section 440 of the Standard Specifications for Road & Bridge Construction. The contractor shall removal and dispose of all sidewalk materials (including brick sidewalks) indicated on plan sheets. This work shall be paid for at the contract unit price SQ FT for SIDEWALK REMOVAL. All transportation, labor, and equipment necessary to complete the work shall be considered as included in the unit price bid.

# DRIVEWAY PAVEMENT REMOVAL

This work shall be in accordance with Section 440 of the Standard Specifications for Road & Bridge Construction. The contractor shall removal and dispose of all driveway materials indicated on the plan sheets. This work shall be paid for at the contract unit price SQ YD for DRIVEWAY PAVEMENT REMOVAL. All transportation, labor, and equipment necessary to complete the work shall be considered as included in the unit price bid.

# RAILROAD PROTECTIVE LIABILITY INSURANCE

The Contractor shall furnish railroad protective insurance, and comply with BDE 3426I, they shall also secure all bonds, pay all costs, etc. required to comply with all requirements of the permit as a part of the project and no extra payment will be allowed. There are two railroad crossings. The west railroad crossing is owned by Illinois Central Railroad Company. The contractor shall comply with the "License for Multi-Use Pathway/Sidewalk" Agreement attached in the specifications. The east railroad crossing is owned by Decatur & Eastern Illinois Railroad, LLC. The contractor shall comply with the "Reimbursement Agreement" attached in the specifications. The above work shall be paid for by the contract Lump Sum price per RAILROAD PROTECTIVE LIABILITY INSURANCE.

The Contractor shall name the following entities as additional insured under the Contractor's general liability insurance policy in accordance with Article 107.27:

The entities listed above and their officers, employees, and agents shall be indemnified and held harmless in accordance with Article 107.26.

# State of Illinois DEPARTMENT OF TRANSPORTATION Bureau of Local Roads & Streets SPECIAL PROVISION FOR LOCAL QUALITY ASSURANCE/ QUALITY MANAGEMENT QC/QA Effective: January 1, 2022

Replace the first five paragraphs of Article 1030.06 of the Standard Specifications with the following:

"**1030.06 Quality Management Program.** The Quality Management Program (QMP) will be Quality Control / Quality Assurance (QC/QA) according to the following."

Delete Article 1030.06(d)(1) of the Standard Specifications.

Revise Article 1030.09(g)(3) of the Standard Specifications to read:

"(3) If core testing is the density verification method, the Contractor shall provide personnel and equipment to collect density verification cores for the Engineer. Core locations will be determined by the Engineer following the document "Hot-Mix Asphalt QC/QA Procedure for Determining Random Density Locations" at density verification intervals defined in Article 1030.09(b). After the Engineer identifies a density verification location and prior to opening to traffic, the Contractor shall cut a 4 in. (100 mm) diameter core. With the approval of the Engineer, the cores may be cut at a later time."

Revise Article 1030.09(h)(2) of the Standard Specifications to read:

"(2) After final rolling and prior to paving subsequent lifts, the Engineer will identify the random density verification test locations. Cores or nuclear density gauge testing will be used for density verification. The method used for density verification will be as selected below.

	Density Verification Method
	Cores
X	Nuclear Density Gauge (Correlated when paving ≥ 3,000 tons per mixture)

Density verification test locations will be determined according to the document "Hot-Mix Asphalt QC/QA Procedure for Determining Random Density Locations". The density testing interval for paving wider than or equal to 3 ft (1 m) will be 0.5 miles (800 m) for lift thicknesses of 3 in. (75 mm) or less and 0.2 miles (320 m) for lift thicknesses greater than 3 in. (75 mm). The density testing interval for paving less than 3 ft (1 m) wide will be 1 mile (1,600 m). If a day's paving will be less than the prescribed density testing interval, the length of the day's paving will be the interval for that day. The density testing interval for mixtures used for patching will be 50 patches with a minimum of one test per mixture per project.

If core testing is the density verification method, the Engineer will witness the Contractor coring, and secure and take possession of all density samples at the

density verification locations. The Engineer will test the cores collected by the Contractor for density according to Illinois Modified AASHTO T 166 or AASHTO T 275.

If nuclear density gauge testing is the density verification method, the Engineer will conduct nuclear density gauge tests. The Engineer will follow the density testing procedure detailed in the document "Illinois Modified ASTM D 2950, Standard Test Method for Density of Bituminous Concrete In-Place by Nuclear Method".

A density verification test will be the result of a single core or the average of the nuclear density tests at one location. The results of each density test must be within acceptable limits. The Engineer will promptly notify the Contractor of observed deficiencies."

Revise the seventh paragraph and all subsequent paragraphs in Section D. of the document "Hot-Mix Asphalt QC/QA Initial Daily Plant and Random Samples" to read:

"Mixtures shall be sampled from the truck at the plant by the Contractor following the same procedure used to collect QC mixture samples (Section A). This process will be witnessed by the Engineer who will take custody of the verification sample. Each sample bag with a verification mixture sample will be secured by the Engineer using a locking ID tag. Sample boxes containing the verification mixture sample will be sealed/taped by the Engineer using a security ID label."

# LICENSE FOR MULTI-USE PATHWAY/SIDEWALK

THIS LICENSE for Multi-Use Pathway(s)/Sidewalk(s) ("Agreement"), made and entered into as of the <u>state</u>, 20<u>3</u>, by and between the ILLINOIS CENTRAL RAILROAD COMPANY (hereinafter referred to as "Railroad Company") whose mailing address is 17641 S. Ashland Avenue, Homewood, Illinois, 60430-1345 and the CITY OF NEOGA, Illinois (hereinafter referred to as "Licensee") whose mailing address is City Hall, 533 Chestnut Avenue, Neoga, Illinois 62447;

# WITNESSETH:

IN CONSIDERATION of the sum of **TEN and NO/100 Dollars (\$10.00)** paid to Railroad Company by Licensee, for the preparation of this Agreement, and of the mutual covenants and agreements herein set forth, Railroad Company, insofar as it lawfully may, does hereby grant unto Licensee license and permission to construct, maintain, operate and use one (1) new ten foot (10F') multi-use pathway(s) and sidewalk(s) (hereinafter collectively referred to as "Pathway") upon, over and across the property or right-of-way of Railroad Company (including the track located thereon) at/near Railroad Company's industrial lead track at or near Milepost 184.25 on its Champaign Subdivision, as shown in **magenta** on the print marked Exhibit A, attached hereto and made a part hereof. The aforesaid sum is not refundable in the event Licensee elects not to enter upon Railroad Company's property or in the event Railroad Company elects to terminate this Agreement.

Licensee shall at all times conduct its work in accordance with any and all "Special Provisions" which may be appended hereto which, by reference hereto, are hereby made a part hereof.

UPON AND SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS:

- 1. **DEFINITIONS**.
  - (a) <u>Railroad Company's Property</u>. "Railroad Company's Property" shall mean the property shown on the attached print, to the extent owned by Railroad Company, whether owned in full ownership or as a servitude, easement, or right-of-way, including Railroad Company's track, the land on which the track is situated, and any adjacent land of Railroad Company on either side of the track.
  - (b) <u>Licensee's Property</u>. "Licensee's Property" shall mean the new ten foot (10') multi-use pathway(s) and sidewalk(s) right-of-way outside of the Railroad Company's Property.

- (c) <u>License</u>. "License" shall mean the right granted by Railroad Company to Licensee to construct, maintain and use the Pathway, under the terms and conditions set forth hereinafter.
- (d) <u>License Area</u>. "License Area" shall mean that portion of Railroad Company's Property over and across which the license is granted. The License Area extends from one edge of the Railroad Company's Property across the track to the opposite edge of the Railroad Company's Property with a width determined by the distance measured from a point approximately 20 feet outside of each outer edge of the pathway/sidewalk shown on Exhibit A in magenta.
- (e) <u>Roadway</u>. "Roadway" shall mean that portion of the License Area encompassing the approaches on either side of the Crossing Proper beyond the end-of-ties, and including that portion between tracks if/where multiple tracks exist.
- (f) <u>Crossing Proper</u>. "Crossing Proper" shall mean that portion of the License Area encompassing an area from end-of-tie to end-of-tie and from end-of-surface to end-of-surface in each track.
- (g) <u>Pathway</u>. "Pathway" shall mean the new ten foot (10') multi-use pathway(s) and sidewalk(s) as shown in **magenta** on the print attached hereto and made a part hereof that is contained within both the Roadway and Crossing Proper collectively encompassing the License Area on the Railroad Company's Property.
- (h) <u>Cost</u>. "Cost" shall mean the actual cost of labor, outside services, equipment and materials plus Railroad Company's then current customary additives for overhead and other indirect costs.
- 2. <u>USE</u>.
  - (a) The Licensee shall only affect and burden the License Area and no other portion of Railroad Company's Property, and the Pathway shall be constructed, located, and maintained entirely within the said License Area. Licensee shall have no right to use or cross any other portion of Railroad Company's Property with said Pathway or to use the Roadway and Crossing Proper individually for any purposes other than as expressly permitted herein. Unless otherwise provided in this Agreement, Licensee shall comply with all terms and conditions of the said grant of License to Licensee.
  - (b) Licensee shall not do or permit to be done any act which will in any manner interfere with, limit, restrict, obstruct, damage, interrupt, or endanger Railroad Company's operations or facilities. Licensee shall not use any other property of Railroad Company other than that which is occupied by the Pathway without first obtaining Railroad Company's prior written

consent (which may be denied for any reason) and complying with all of Railroad Company's requirements applicable thereto.

- (c) Licensee shall require and shall take all steps necessary to ensure that all persons using the Pathway come to a complete stop, look carefully for approaching trains before fouling or crossing Railroad Company's tracks, and yield to any approaching train.
- (d) The Pathway shall not be used by motorized vehicles of any size or type (including, but not limited to, ATV's, snowmobiles, motorcycles, etc.). The Pathway shall only be used by pedestrians and/or people riding bicycles.
- (e) It shall be Licensee's responsibility and duty to prevent all unauthorized persons from using the License Area and nothing herein shall be construed to relieve Licensee of this responsibility and duty.
- Licensee shall not permit any hazardous material to be deposited on the (f) lands of Railroad Company. Notwithstanding the foregoing, if hazardous material is so deposited by Licensee, Licensee shall indemnify, save harmless and defend Railroad Company from and against any claims made against Railroad Company arising therefrom. For the purposes of this Agreement, "Hazardous Material" shall mean any substance (i) defined as "hazardous substance" under Section 1.01(14) of CERCLA, 42 U.S.C. 9601 (14) or any successor regulation; (ii) containing petroleum, including any fraction thereof; or (iii) determined to be deleterious to human health or the environment by any federal, state or local environmental, occupational health, or public health agency or authority. Licensee expressly agrees to be responsible for any such contamination of the lands of Railroad Company or any adjacent premises, and if any contamination occurs on such premises. Licensee shall be responsible to clean-up, remediate and restore said premises to their original condition or to a condition that is in compliance with the applicable state and federal laws and regulations and all local ordinances. For the purposes of this Section the term Railroad Company shall include not only Railroad Company named herein but also any parent company(ies), subsidiary(ies) or affiliates(s) of Railroad Company, or its or their agents, servants, employees, directors, officers, contractors, subcontractors or suppliers.
- (g) Railroad Company does not undertake to provide a means of ingress and egress for the Pathway, except under lands of Railroad Company as herein specified, and in a manner approved by the Chief Engineer of Railroad Company, or his duly authorized representative.
- (h) Railroad Company reserves the right to grant licenses to others, but such licenses shall not interfere with Licensee's use and enjoyment of the rights granted through this Agreement.
- 3. <u>TERM</u>.

- (a) This Agreement shall become effective as of the date first written above and shall continue in effect thereafter until terminated in one of the manners set forth below:
  - Railroad Company shall have the right to terminate this Agreement immediately upon written notice to Licensee if Licensee at any time breaches or fails to perform any of the terms and conditions hereof;
  - (ii) This Agreement shall terminate through non-use or in any other manner provided by law; or
  - (iii) Either party may at any time give the other party written notice of termination specifying the date on which termination shall be effective, provided that such notice shall be delivered at least thirty (30) days in advance of the proposed date of termination.
- (b) Unless the parties mutually agree in writing to leave the Pathway in place after termination, the termination of this Agreement may not be effective, which determination shall be made in Railroad Company's sole discretion, until all removal and restoration is complete. Termination of this Agreement shall not release Licensee from any liability or responsibility and duty which accrued prior to such termination, removal and restoration.
- (c) If Licensee shall fail to make the required restoration, Railroad Company shall have the further option to elect and notify Licensee that all right, title and interest of Licensee in any of its property shall be forfeited and shall vest absolutely in Railroad Company as of the date of notice of such election.
- (d) Should Railroad Company exercise its right of termination, Licensee will support termination of this Agreement and cessation of the Pathway at any necessary hearings, proceedings or dockets before any regulatory body with jurisdiction over the Pathway.

# 4. <u>CONSTRUCTION</u>.

(a) The Pathway shall be constructed and maintained in accordance with Licensee's plans and specifications and as approved by Railroad Company. The Railroad Company shall, at the sole risk and expense of Licensee, install and maintain the Crossing Proper. Licensee shall pay Licensor ZERO DOLLARS (\$0.00) in advance as Crossing Proper currently exists. Licensee will construct and maintain all asphalt or concrete, pavement markings and warning signs, within and outside Railroad Company's property. All initial construction and work and all future construction and maintenance by either party will be at Licensee's sole cost and expense and in a manner that is to the satisfaction of Railroad Company's Chief Engineer.

- (b) Licensee shall be responsible for determining the location, elevation and extent of all utilities, underground structures and/or obstructions in the vicinity of the installation whether shown on the plans or not.
- (c) Licensee's use, as herein defined, shall be such that it shall cause a minimum of interference with the natural drainage of Railroad Company's lands. Any drainage facilities required by the installation or use of the Pathway shall be constructed, maintained, repaired and removed by Licensee, at Licensee's sole cost and expense, and all work associated herewith shall be subject to the approval of the Chief Engineer of Railroad Company, or his duly authorized representative.
- (d) Licensee shall be responsible for all additional costs incurred as determined by Railroad Company to accommodate railroad maintenance (i.e. mechanized surfacing operations, tie and rail replacements, etc.) of Railroad Company's track and facilities. Further, Licensee shall be responsible for any additions to track and facilities impacting the Pathway.
- (e) The Pathway and any appurtenances thereto shall be constructed such that vehicular traffic visibility will not be adversely affected.

# 5. <u>RELOCATION CHANGES AND ALTERATIONS.</u>

- (a) When and as often as Railroad Company shall require to have the location and/or elevation of the Pathway, or any portion thereof changed for the purposes of making improvements to the facilities of Railroad Company, including the installation of an additional track(s), minimizing any unreasonable hazards presented by the Pathway, or the contents thereof, Licensee shall, at its own cost and expense with due diligence but in any event not later than sixty (60) days after receipt of written notice from Railroad Company, change the location and/or elevation of the Pathway, or any portion thereof, to such a location and/or elevation as shall be designated by the Chief Engineer of Railroad Company, or his duly authorized representative.
- (b) In the event Licensee submits in writing a request to Railroad Company to extend the sixty (60) day relocation period, Railroad Company shall respond within thirty (30) days. Such extension request shall not be unreasonably withheld.
- (c) Licensee agrees that upon reasonable request from Railroad Company, it will, at its own cost and expense, make changes or alterations to the Pathway when Railroad Company's operations require modification to Railroad Company's facilities, or to minimize hazards presented by the Pathway or to the contents thereof.
- (d) In the event Licensee shall fail to change the location or elevation of, renew or repair, alter, or make any changes reasonably requested by

Railroad Company to the Pathway or any portion thereof, or to correct any defective conditions after receipt of written notice from Railroad Company as hereinbefore provided and within the time stipulated, then Railroad Company may, without further notice to Licensee, perform said work. The total cost of such work performed by Railroad Company hereunder shall be at the sole cost and expense of Licensee and Licensee shall reimburse Railroad Company for said costs and expenses upon receipt of same from Railroad Company.

# 6. NOTIFICATIONS.

(a) At least fifteen (15) days prior to Licensee's desire to enter upon Railroad Company's Property for the purpose of performing any construction or maintenance work hereunder, Licensee shall provide advance notification to Railroad Company's Engineering Manager in writing of the type of work to be performed and the date such work will commence and shall coordinate all work with Railroad Company's Engineering Manager. Licensee shall not be permitted to enter upon Railroad Company's premises, unless and until Railroad Company's Engineering Manager has reviewed Licensee's request and approved same. If Railroad Company approves Licensee's request to enter upon Railroad Company's Property upon the condition of certain safety precautions, including but not limited to, flaggers, Licensee shall not be permitted to enter upon Railroad Company's Property until all of said safety precautions are actively in place. The Licensee's request notice shall be sent to the following address:

(b) Any notice, other than the advance notification described herein above, required or permitted to be given under this Agreement shall be in writing and deemed to have been given when deposited in a United States Post Office, registered or certified mail, postage prepaid, return receipt requested and addressed as follows: If to Railroad Company:

# 7. <u>SIGHTING AT CROSSING</u>.

Licensee shall arrange to keep each quadrant of the intersection of the Roadway with Railroad Company's track free of bushes, trees, weeds, vegetation, and all other obstructions of any kind that could interfere with a motor vehicle operator sighting an approaching train. If Licensee requires access to Railroad Company's property outside the Pathway to satisfy this requirement, Licensee shall obtain written permission from Railroad Company's authorized representative.

#### 8. RAISING WIRE LINES.

If it should be necessary to raise any wires on Railroad Company's property not belonging to Railroad Company to provide safe clearance for Pathway users, Licensee shall make all arrangements therefor at its own sole risk and expense.

#### 9. MAINTENANCE.

Licensee shall, at its own risk and expense, maintain said Pathway in good and safe condition commensurate with its intended use. Railroad Company shall, at the sole risk and expense of Licensee, maintain the Crossing Proper, however, Railroad Company shall have the right, but not the duty, to perform at Licensee's sole risk and expense, any repair or maintenance on the Pathway that Railroad Company considers reasonably necessary and Licensee shall pay the cost thereof upon receipt of a bill whether made at Licensee's request or otherwise. Notwithstanding any other provisions of this Agreement, nothing contained herein shall relieve Licensee from its obligation to inspect and at all times maintain in good condition and repair the Pathway, and its facilities located under, upon or over the land of Railroad Company, or impose any obligation upon Railroad Company in respect to such inspection and maintenance.

# 10. FLAGGING.

Licensee shall, at its own risk and expense, provide whatever protective services Railroad Company shall indicate is necessary. Railroad Company shall have the right, but not the duty, to provide any such protection at Licensee's sole risk and expense and Licensee shall prepay the cost thereof. It is further understood and acknowledged by Licensee that Railroad Company has no obligation or duty to determine the need for any protective services.

# 11. CROSSING TO BE KEPT FREE OF DEBRIS.

Licensee shall at all times during the term of this Agreement, keep the Railroad Company's track free of dirt, rocks, snow, or other debris or obstructions of any kind, and will not permit any condition which might interfere with the safe and efficient operation of trains over the Crossing Proper, or which might damage equipment or facilities belonging to Railroad Company or others, or which might constitute a safety hazard of any kind. If at any time Licensee shall fail to do so, Railroad Company may, at its option, remove any dirt, rocks, snow, debris or obstructions, and Licensee will pay Railroad Company the cost thereof promptly upon receipt of bill therefor.

# 12. SIGNS, SIGNALS AND WARNING DEVICES.

Licensee acknowledges that Railroad Company has no obligation or duty to reduce the speed of its trains, nor alter its operations in any manner, owing to the presence or existence of the Pathway or other use or exercise of the License or permission granted herein. Licensee assumes, at its own risk and expense, sole responsibility for determining, in conjunction with any governing state regulatory agency, if any signs, signals or other warning devices are necessary or appropriate for the safety of persons using the Pathway in the vicinity of Railroad Company's track(s) and specifically acknowledges that Railroad Company has no obligation or duty whatever to make any such determination. If the installation of any signs, signals or warning devices on either side of the Crossing Proper is presently or hereafter required by law or by competent public authority, or is otherwise requested by Licensee and agreed to by Railroad Company, same shall conform to any then currently applicable practices of Railroad Company for such devices as to design, material and workmanship and all costs incurred by Railroad Company related to the installation, operation, maintenance, renewal, alteration and upgrading thereof shall be solely borne by Licensee.

#### 13. INDEMNITY.

AS A FURTHER CONSIDERATION FOR THE LICENSE HEREIN GRANTED, AND AS A CONDITION WITHOUT WHICH THE LICENSE WOULD NOT HAVE BEEN GRANTED, LICENSEE AGREES TO THE FULLEST EXTENT ALLOWED BY LAW, REGARDLESS OF ANY NEGLIGENCE OR OTHER LEGAL FAULT BY OR ON THE PART OF RAILROAD COMPANY OR ITS OFFICERS, EMPLOYEES OR AGENTS, FULLY TO DEFEND, INDEMNIFY AND SAVE HARMLESS RAILROAD COMPANY AND ITS OFFICERS, EMPLOYEES AND AGENTS, FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, ACTIONS AND CAUSES OF ACTION, AND TO ASSUME ALL RISK, RESPONSIBILITY AND LIABILITY (INCLUDING ALL LIABILITY FOR EXPENSES, ATTORNEY'S FEES AND COSTS INCURRED OR SUSTAINED BY RAILROAD COMPANY, WHETHER IN DEFENSE OF ANY SUCH CLAIMS, DEMANDS, ACTIONS AND CAUSES OF ACTION OR IN THE ENFORCEMENT OF THE INDEMNIFICATION RIGHTS HEREBY CONFERRED),

FOR DEATH OF OR INJURY TO ANY AND ALL PERSONS. **(A)** INCLUDING BUT NOT LIMITED TO THE OFFICERS. EMPLOYEES. AGENTS, PATRONS, INVITEES AND LICENSEES OF THE PARTIES HERETO, AND FOR ANY AND ALL LOSS, DAMAGE OR INJURY TO ANY PROPERTY WHATSOEVER, INCLUDING BUT NOT LIMITED TO THAT BELONGING TO OR IN THE CUSTODY AND CONTROL OF THE PARTIES HERETO, IN WHOLE OR IN PART ARISING FROM. GROWING OUT OF, OR IN ANY MANNER OR DEGREE DIRECTLY OR INDIRECTLY CAUSED BY. ATTRIBUTABLE TO OR RESULTING FROM THE GRANT OR EXERCISE OF THIS LICENSE. THE FAILURE OF LICENSEE TO CONFORM TO THE CONDITIONS OF THIS AGREEMENT, WORK PERFORMED BY RAILROAD COMPANY FOR LICENSEE UNDER THE TERMS OF THIS AGREEMENT, WORK PERFORMED BY LICENSEE UNDER THE TERMS OF THIS AGREEMENT, OR FROM THE CONSTRUCTION, INSTALLATION, MAINTENANCE, REPAIR, RENEWAL, ALTERATION, CHANGE, RELOCATION, EXISTENCE, PRESENCE, USE, OPERATION OR **REMOVAL OF ANY STRUCTURE INCIDENT THERETO, AND** 

(B) FOR DEATH OF OR INJURY TO THE OFFICERS, EMPLOYEES, AGENTS, PATRONS, INVITEES AND LICENSEES OF LICENSEE AND FOR ANY AND ALL LOSS, DAMAGE OR INJURY TO THEIR PROPERTY, AND TO ANY PROPERTY BELONGING TO OR IN THE CARE, CUSTODY OR CONTROL OF LICENSEE, IN WHOLE OR IN PART ARISING FROM, GROWING OUT OF, OR IN ANY MANNER OR DEGREE DIRECTLY OR INDIRECTLY CAUSED BY, ATTRIBUTABLE TO OR RESULTING FROM THE CONDUCT OF ANY RAILROAD OPERATIONS AT OR NEAR THE AREA IN WHICH THE HEREIN CONFERRED LICENSE IS GRANTED OR EXERCISED.

IT IS THE INTENTION OF THE PARTIES HERETO THAT LICENSEE SHALL BY SOLELY RESPONSIBLE FOR ALL SUCH DESTRUCTION OR DAMAGE TO PROPERTY OR FOR PERSONAL INJURY TO OR DEATH OF ANY PERSONS WHICH WOULD NOT HAVE OCCURRED IF SUCH PATHWAY HAD NEVER BEEN CONSTRUCTED OR USED. LICENSEE SHALL AT ITS SOLE EXPENSE JOIN IN OR ASSUME, AT THE ELECTION AND ON DEMAND OF RAILROAD COMPANY, THE DEFENSE OF ANY CLAIMS, DEMANDS, ACTIONS AND CAUSES OF ACTION HEREUNDER ARISING. THE WORD "RAILROAD COMPANY" AS USED IN THIS SECTION SHALL INCLUDE THE ASSIGNS OF RAILROAD COMPANY AND ANY OTHER RAILROAD COMPANY THAT MAY BE OPERATING UPON AND OVER THE TRACKS CROSSING THE LICENSE AREA.

# 14. INSURANCE.

Licensee shall procure and maintain during the life of this Agreement COMMERCIAL GENERAL LIABILITY INSURANCE (Occurrence Form) which will insure the indemnity undertaking hereinabove set forth. Such insurance shall have a minimum combined single limit of \$5,000,000 per occurrence with an aggregate limit of \$10,000,000 per annual policy period and said insurance shall be deemed primary as it relates to this Agreement. Licensee shall furnish the Railroad Company at the address shown below in this Section with a certificate evidencing that such insurance is in full force and effect and that the same will not be cancelled, terminated, or not renewed without at least thirty (30) days advance written notice by the insurance carrier to the Railroad Company. Such insurance shall include a complete waiver of subrogation by the insurer, a removal of any railroad exclusion through issuance of endorsement CG 24 17, and inclusion of the Railroad Company as an additional insured. In addition to other information, the certificate shall contain the following language:

Notwithstanding anything contained therein to the contrary, the Commercial Liability Insurance hereinabove referred to is extended to specifically insure the indemnity obligations assumed by the City of Neoga Illinois under Section 13 of an Agreement dated  $\Delta ot q$  (3, 2023 with Illinois Central Railroad Company covering use of Railroad Company's Property for a Multi-Use Pathway/Sidewalk private crossing. Insurer shall not cancel, terminate, or allow to lapse by reason of nonrenewal the policy without providing Illinois Central Railroad Company at least thirty (30) days' advance written notice, said notice to be sent via certified mail to:

# 15. REMOVAL OF PATHWAY AND CROSSING PROPER.

Prior to termination of this Agreement, Licensee shall remove the Pathway from Railroad Company's Property (except for the Crossing Proper located between the ends of ties) and restore the Railroad Company's Property, as near as may be to its former condition, insofar as such restoration may in the opinion of Railroad Company's duly authorized representative be practical, all at Licensee's sole risk and expense. If Licensee fails to so remove and restore, Railroad Company shall have the right, but not the obligation, to do so at Licensee's sole risk and expense. Upon termination, Railroad Company shall have the right, but not the duty, to remove both the Pathway and Crossing Proper and to restore the Railroad Company's Property, all at Licensee's sole risk and expense. Licensee shall promptly pay the cost of any work performed by Railroad Company upon presentation of a bill. Railroad Company shall have the right to require Licensee to deposit the estimated cost of any or all removal or restoration work involving the Roadway and/or Crossing Proper or to furnish an acceptable performance bond in such amount upon execution of this Agreement or at any time thereafter to assure complete performance under this Section.

# 16. ORDINANCES, REGULATIONS, ETC.

- (a) Licensee, at Licensee's sole cost and expense, shall comply with all applicable ordinances, rules, regulations, requirements and laws of any governmental authority, federal, state or local, having jurisdiction over Licensee's use and occupations, including but not limited to zoning, health, safety, building or environmental matters.
- (B) LICENSEE SHALL FURTHER DEFEND, INDEMNIFY AND HOLD RAILROAD COMPANY HARMLESS FROM ANY VIOLATIONS THEREOF, ANY PENALTY, LEVY, FINE OR ASSESSMENTS THEREFROM, AND ALL COST OF DEFENSE OF OR COMPLIANCE CITATION, ORDER OR VIOLATION NOTICE(S), WITH ANY SUCH INCLUDING ANY PENALTIES. LEVIES. FINES. ASSESSMENTS. COMPLIANCE OR REMEDIAL CHARGE(S) CAUSED BY OR ARISING FROM THIS AGREEMENT OR TERMINATION THEREOF, INCLUDING ANY VIOLATIONS, FINES OR PENALTIES **ARISING AFTER TERM OF THIS AGREEMENT. FOR THE PURPOSES** OF THIS SECTION 16., THE TERM RAILROAD COMPANY SHALL INCLUDE NOT ONLY RAILROAD COMPANY NAMED HEREIN BUT ALSO ANY PARENT COMPANY(IES), SUBSIDIARY(IES) OR AFFILIATE(S) OF RAILROAD COMPANY, OR ITS OR THEIR AGENTS, EMPLOYEES, SERVANTS. DIRECTORS. **OFFICERS**. CONTRACTORS, SUBCONTRACTORS OR SUPPLIERS.
- (c) Licensee shall determine whether a permit, license or other type of documentation is required by applicable law for the construction, maintenance, operation, use or removal of the Pathway.

# 17. CLAIM OF TITLE.

Licensee shall not at any time own or claim any right, title or interest in or to the lands of Railroad Company, nor shall the exercise of this License for any length of time give rise to any right, title or interest in or to the lands of Railroad Company, other than the License herein created. Railroad Company makes no warranty or guarantee of title to the premises, suitability of the premises for Licensee's purposes or any purposes, whether the premises may or might have been contaminated with Hazardous Materials as defined in paragraph 2(f). This License is extended subject to all of the limitations, reservations and restrictions upon the title of Railroad Company. Licensee accepts the premises "as is, where is" with all faults. Licensee shall be solely responsible, at its sole cost and expense, to secure any other or additional license, permit, permission or right necessary to construct, maintain, operate, use or remove the Pathway.

#### 18. <u>RECORDING</u>.

Licensee shall not record this Agreement without the written consent of Railroad Company, such consent not to be unreasonably withheld. However, upon the request of either party hereto the other party shall join in the execution of a memorandum or so-called "short form" of this Agreement for the purpose of recordation, provided Railroad Company has consented as required above. Said memorandum or short form of this Agreement shall describe the parties, the termination provision of this Agreement and shall incorporate this Agreement by reference. The party requesting the recording shall pay the recording costs.

# 19. ASSIGNMENT.

Licensee shall not have the right to assign this Agreement or any rights hereunder without first obtaining the consent in writing of the Railroad Company, which consent may be withheld for any reason or no reason.

#### 20. <u>HEADINGS</u>.

Headings used herein are placed for reading convenience and shall not have any other meaning, implication or purpose, legal or otherwise.

# 21. NON-WAIVER OF COVENANTS.

The failure of either party to enforce any of the provisions of this Agreement at any time shall in no way be construed to be a waiver of such provisions nor in any way affect the validity of this Agreement, or any part thereof, nor the right of any party thereafter to enforce each and every such provision.

#### 22. <u>TAXES</u>.

The Licensee shall pay all taxes, general and special, license fees or other charges which may become due or which may be assessed against the premises of the Railroad Company because of the construction, existence, operation or use of said Pathway, or the business conducted in connection with said facility, and shall reimburse the Railroad Company for any such taxes, license fees or other charges which may be paid by the Railroad Company upon the presentation of bills therefor.

# 23. <u>BILLS</u>.

All bills submitted by the Railroad Company to Licensee pursuant to the terms of this Agreement shall be paid by Licensee within fifteen (15) days of receipt thereof.

# 24. ENFORCEABILITY.

In the event that any parts, sections or other portions of this Agreement are found unenforceable under the applicable law of any courts having jurisdiction over this Agreement, the remaining parts, sections or other portions thereof and the enforcement of same shall not be affected and shall otherwise remain in full effect and enforceable.

# 25. <u>RELATIONSHIP OF THE PARTIES</u>.

The relationship of the parties is that of independent contractors and in no way establishes an agency relationship.

# 26. SURVIVAL CLAUSE.

Notwithstanding any other section of this Agreement, the rights and obligations of the parties expressed in this Agreement, including but not limited to, any provisions concerning Indemnity and Liability, shall remain in effect for any legal proceeding brought against Railroad Company, its officers or employees, which was commenced after the termination, for whatever reason, of this Agreement but was caused by, alleged to be caused by, or grew out of any accident or occurrence which but for this Agreement or the presence of Licensee's employees, agents, contractors, subcontractors, or suppliers pursuant to this Agreement, would not have been incurred, except when such proceeding is attributable to the sole fault, failure or negligence of Railroad Company, its officers or employees, contractors, subcontractors, or suppliers.

#### 27. ENTIRE AGREEMENT.

This Agreement and exhibits, if any, attached hereto and forming a part hereof, set forth all the covenants, promises, agreements, conditions and understandings between Railroad Company and Licensee concerning the premises and there are no covenants, promises, agreements, conditions or understandings, either oral or written, between them other than are herein set forth. Except as herein otherwise provided, no subsequent alteration, amendment, change or addition to this Agreement shall be binding upon Railroad Company or Licensee unless reduced to writing and signed by them.

# SPECIAL PROVISIONS

#### RELATIVE TO FLAGGING AND OTHER PROTECTION OF RAILROAD COMPANY TRAFFIC AND FACILITIES DURING CONSTRUCTION ADJACENT AND ABOVE, ON OR ACROSS, THE PROPERTY OF, OR ON, ABOVE AND BENEATH THE TRACKS OF THE ILLINOIS CENTRAL RAILROAD COMPANY

The Licensee shall, before entering upon the property of Railroad Company for performance of any work, secure a fully executed right of entry license from Railroad Company's Engineering Manager or their authorized representative for the occupancy and use of Railroad Company's property. Licensee shall confer with Railroad Company relative to requirements for railroad clearances, operation and general safety regulations.

Prior to any entry onto Railroad Company's property, employees and/or subcontractors of Licensee and/or any contractor doing work shall determine by the guidelines hereinafter provided and by the work to be performed the level of safety training to be required.

All employees and/or subcontractors of Licensee and/or any contractor not hired by Railroad Company that will work on CN property are required to have minimum <u>www.contractororientation.com</u>.

a. EXCEPTION: Railroad Company has exempted those it classifies as "Delivery Persons" from this training. This will include contractors such as UPS, FedEx, trucking companies, etc. who merely access the property to supply materials or equipment.

All employees and/or contractor(s) of Licensee hired by Railroad Company which will work on Railroad Company property are required to have minimum CN Safety and Security Awareness training, in addition to undergoing a background check. This training and background check must be obtained through the eRailSafe.com website. If not done before, the contractor must contact e-RailSafe at 855-383-7434 to be issued either a vendor number or issued instructions on obtaining a non Railroad contractor vendor number prior to accessing the noted website. Minimum information required of the Licensee and/or their contractor when contacting e-RailSafe is Name, Address, Telephone, Contact Person for State Projects, DOT Contract Number, and the AAR/DOT Number. This training is good for a period of two years.

- a. EXCEPTION: Railroad Company has exempted those employees of contractors providing paving services at a road crossing under construction or repair from this requirement.
- b. EXCEPTION: Railroad Company has exempted those it classifies as "Delivery Persons" from this training. This will include contractors such as UPS, FedEx, trucking companies, etc. who merely access the property to supply materials or equipment.

All employees and/or subcontractors of Licensee and/or any contractor hired by Railroad Company, whose duties include and who are engaged in the inspection, construction, maintenance, or repair of railroad track, bridges, roadway, signal and communication systems, roadway facilities, or roadway machinery that will work foul of or have the potential to foul a live track are considered Roadway Workers under FRA regulations and CN Policy. They must complete the On-Track Safety Training course approved by Railroad Company and provided by R.R. Safety – AMR, P.O. Box 75, Lomira, WI 53048, telephone (920) 517-1677, email rrsafetytraining@vahoo.com.

- a. EXCEPTION: Railroad Company has exempted those employees of contractors providing paving services at a road crossing under construction or repair from this requirement.
- b. EXCEPTION: Railroad Company has exempted those it classifies as "Delivery Persons" from this training. This will include contractors such as UPS, FedEx, trucking companies, etc. who merely access the property to supply materials or equipment.
- c. All the employees and/or subcontractors of Licensee and/or any contractor who will operate on-track machinery or those who will provide protection for other employees and/or subcontractors of Licensee and/or any contractor must also be trained on CN US Operating Rules pertaining to their duties. They must take and pass the required examination. This training is good for a period of two years.
- d. "Potential to foul a live track" is considered, at a minimum, to be working within twenty-five feet of the track; or as otherwise to be determined by CN Design & Construction Department.

The employees, subcontractors, and/or agents of the Licensee and/or any contractor shall qualify for, and make available for inspection to Railroad Company's employees or other authorized personnel at all times while on Railroad Company property, a photo identification issued by <u>www.e-railsafe.com</u>, along with at least one other government-issued form of identification. Licensee and/or any contractor shall bear all costs of compliance with the requirements of this Section. Railroad Company reserves the right to bar any of employees or agents of Licensee and/or any contractor from Railroad Company's property at any time for any reason.

Licensee and/or any contractor engaged on their behalf, shall at all times conduct work in a manner satisfactory to the Engineering Manager of Railroad Company, or their authorized representative, and shall exercise care so as to not damage the property of Railroad Company, or that belonging to any other grantees, licensees, permittees or tenants of Railroad Company, or to interfere with railroad operations.

Engineering Manager of Railroad Company, or their authorized representative, will at all times have jurisdiction over the safety of railroad operations., The decision of the Engineering Manager or their authorized representative as to procedures which may affect the safety of railroad operations shall be final, and Licensee and/or their contractor shall be governed by such decision.

All work shall be conducted in such a manner as will assure the safety of Railroad Company. Railroad Company's authorized representative shall have the right, but not the duty, to require certain procedures to be used or to supervise the work on Railroad Company's property.

Should any damage occur to Railroad Company property as a result of the authorized or unauthorized operations of Licensee and/or their contractor and Railroad Company deems it necessary to repair such damage or perform any work for the protection of its property or operations, the Licensee and/or their contractor, as the case may be, shall promptly reimburse Railroad Company for the actual cost of such repairs or work. For the purpose of these Special Provisions, actual cost shall be deemed to include the direct cost of any labor, materials, equipment, or contract expense plus Railroad Company's current standard additives in each instance.

If the work requires the construction of a temporary grade crossing across the track(s) of Railroad Company, Licensee and/or their contractor shall make the necessary arrangements and execute Railroad Company's temporary grade crossing agreement for the construction,

protection, maintenance, and later removal of such temporary grade crossing. The cost of such temporary grade crossing construction and later removal shall be prepaid to Railroad Company. Additional costs for repairs, maintenance or protection will be paid within thirty (30) days upon receipt of bill(s) therefor.

Licensee and/or their contractor shall at no time cross Railroad Company's property or tracks with vehicles or equipment of any kind or character, except at such temporary grade crossing as may be constructed as outlined herein, or at any existing and open public grade crossing. Operation over such crossing shall be at the direction and method of Railroad Company's Engineering Manager or their authorized representative.

Railroad Company may, at Licensee's and/or their contractor's sole cost, risk and expense, furnish whatever protective services it considers necessary, including, but not limited to, flagger(s), inspector(s), and stand-by personnel. Flagging protection, inspection services, or standby personnel required by Railroad Company for the safety of railroad operations because of work being conducted by Licensee and/or their contractor, or in connection therewith, will be provided by Railroad Company and the cost of Licensee and shall be prepaid to Railroad Company by Licensee and/or their contractor. Flagging protection, inspection services, or standby personnel, necessary or provided in excess of prepayment amounts will be billed at the proper rates and will be promptly paid by overnight delivery.

In the event Railroad Company is unable to furnish flagging protection, inspection services, or standby personnel at the desired time or on the desired date(s), or if Licensee's prepayment for such services is exhausted and not replenished by Licensee and/or their contractor, Licensee and/or their contractor shall not perform any work on Railroad Company's property until such time and date(s) that appropriate Railroad Company services can be made available and/or appropriate prepayment is received. It is understood that Railroad Company shall not be liable for any delay or increased costs incurred by Licensee and/or their contractor owing to Railroad Company's inability or failure to have appropriate flagging protection, inspection services, or standby personnel available at the time or on the date requested.

Licensee and/or their contractor shall request and secure flagging protection by written notice to Railroad Company using CN's "Request for Flagging Services" form. This form must be submitted at least ten (10) working days in advance of proposed performance of any work or access to Railroad Company's property.

Flagging protection will be required during any operation involving direct and potential interference with Railroad Company's tracks or traffic. This may include but is not limited to fouling of railroad operating clearances, reasonable proximity of accidental hazard to railroad traffic, work within twenty-five (25) feet horizontally of the nearest centerline of any railroad track, any work over any railroad track, or in any other condition that Railroad Company's property more than twenty-five (25) feet from the nearest centerline of any railroad track, such as any equipment extension (including but not limited to a crane boom) that will reach or has the potential to reach within twenty-five (25) feet of any track.

Licensee and/or their contractor shall request, prepay, and secure Railroad Company signal facility locates by written notice to Railroad Company along with submission of CN's "Request for Flagging Services" form at least ten (10) working days in advance of proposed performance of any work or access to Railroad Company property. Notice to Railroad Company does not fulfill or satisfy any other notification requirements for utility locates for non-railroad facilities.

Railroad Company may require that prior to digging, trenching, or boring activities on or near Railroad Company property, or beneath any railroad track, an on-site meeting be conducted

with Railroad Company's Signal Department representative. No digging, trenching or boring activities shall be conducted in the proximity of any known buried Railroad Company signal cables without Railroad Company's Signal Department representative being present.

The rate of pay for Railroad Company employees will be the prevailing hourly rate for not less than eight (8) hours for the class of labor at regular rates during regularly assigned work hours, and at overtime rates outside of regular hours and in accordance with Labor Agreements or Schedules plus Railroad Company's current standard additives in each instance.

Wage rates are subject to change, at any time, by law or agreement between Railroad Company and employees, and may be retroactive because of negotiations or a ruling by an authorized Governmental Agent. If the wage rates are changed, Licensee and/or their contractor shall pay on the basis of the new rates and/or additives.

No digging, trenching, or boring on Railroad Company property shall be conducted without Railroad Company's written approval of the plans that were furnished to Railroad Company's Engineering Manager at least thirty (30) in advance of the excavation.

The following temporary clearances are the minimum that must be maintained at all times during any operation on or adjacent to Railroad Company property:

- Vertical: 22'-0" (7.00 m) above top of highest rail within 12'-0" (3.81 m) of the centerline of any track
- Horizontal: 12'-0" (3.81 m) from centerline of the nearest track, measured at right angles thereto

If lesser clearances than the above are required for any part of the work, Licensee and/or their contractor shall secure written authorization from Railroad Company's Engineering Manager for such lesser clearances in advance of the start of that portion of the work.

No materials, supplies, or equipment will be stored within twenty-five (25) feet from the centerline of any railroad track, measured at right angles thereto.


Licensee and/or their contractor will be required upon the completion of the work to remove from within the limits of Railroad Company's property all machinery, equipment, surplus materials, false work, rubbish or temporary buildings, and to leave said property in a condition satisfactory to the Engineering Manager of Railroad Company or their authorized representative.

Nothing in these Special Provisions shall be construed to place any responsibility on Railroad Company for the quality or conduct of the work performed by Licensee and/or their contractor hereunder. Any approval given or supervision exercised by Railroad Company hereunder, or failure of Railroad Company to object to any work done, material used, or method of operation shall not be construed to relieve Licensee and/or their contractor of any obligations pursuant hereto or under the License these Special Provisions are appended to.

## **REIMBURSEMENT AGREEMENT**

This **Reimbursement Agreement** ("*Reimbursement*") is dated as of the 7\_th day of September 2023 ("*Effective Date*") by and between **Decatur & Eastern Illinois Railroad, L.L.C.**, a Delaware limited liability company ("**DREI**"), and **City of Neoga**, an Illinois municipal corporation ("Neoga") (each individually referred to herein as a "*Party*" and collectively as the "*Parties*").

WHEREAS, on August 29, 2023, Neoga contacted DREI requesting the improvements to an existing at-grade pedestrian crossing which requires installation of 30 ties near at or near Mile Post 338.52, DOT Crossing # 476229X, 6<sup>th</sup> Street, Neoga, IL and the DREI (the "*Work*" as described in more detail below).

**NOW THEREFORE**, for and in consideration of the mutual benefits and obligations set forth in this Reimbursement, with other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the Parties agree City of Neoga will reimburse DREI for the Work expenses as outlined by the following:

#### 1. SCOPE OF WORK

DREI is to perform the Work as follows:

• Replacement of 30 ties only at DOT Crossing # 476229X for sidewalk improvements. Sidewalk concrete and asphalt replacement will be performed by Neoga or their designated contractor.

#### Total Price of Work & Force Estimate:

• Neoga will pay to DREI, the sum of Two Thousand One Hundred Seventy-Five and No/100 Dollars (\$2,175.00) USD, Force Estimate marked **Exhibit A** and incorporated by reference herein.

#### 2. <u>REIMBURSEMENT</u>

• Neoga will reimburse DREI for the costs of such work within thirty (30) days of a Neoga's receipt of an invoice from DREI.

#### 3. MISCELLANEOUS

3.1. <u>Captions, Definitions, and Terminology</u>. The descriptive headings of the articles, sections, and subsections of this Reimbursement are for convenience of reference only and do not constitute a part of this Reimbursement. Terms not defined herein have the meaning ascribed in the referenced Agreements. Any reference in this Reimbursement to the singular includes the plural where appropriate, and any reference in this Reimbursement to the masculine gender includes the feminine and neuter genders where appropriate.

3.2. <u>Binding Effect on Successors</u>. This Reimbursement and the indemnifications, requirements, and obligations set forth herein, shall be binding upon and shall inure to the benefit of the successors, legal representatives, and the assigns of the Parties to this Reimbursement.

3.3. <u>Assignment</u>. Neither Party may assign this Reimbursement or any of its rights or obligations hereunder without the prior written consent of the other Party hereto, which consent shall not be unreasonably withheld, delayed or conditioned.

3.4. <u>Non-waiver</u>. The failure of either Party to insist upon or enforce, in any instance, strict performance by the other Party of any of the requirements, covenants, conditions, or restrictions of this Reimbursement or to exercise any rights herein conferred may not be construed as a waiver or relinquishment of the Party's right to assert or rely upon such terms or rights on any future occasion, except to the extent the Party specifically expresses, in writing, its intent to waive its rights.

3.5. <u>Governing Law</u>. The laws of the state of Illinois, without giving effect to any choice of law or conflict of law rules or provisions, govern all matters arising out of or relating to this Reimbursement, including, without limitation, its validity, interpretation, construction, performance, and enforcement.

3.6. <u>Severability</u>. To the maximum extent allowed by law, if any provision of this Reimbursement is held invalid, illegal or unenforceable, the validity, legality or enforceability of the remaining provisions of this Reimbursement are not affected or impaired in any way. Each covenant, agreement, obligation or other provision of this Reimbursement is separate and independent of any other provision of this Reimbursement unless expressly provided herein.

3.7. <u>Drafting</u>. The Parties have participated jointly in the negotiation and drafting of this Reimbursement. If an ambiguity or question of intent or interpretation arises, this Reimbursement will be construed as if drafted jointly by the Parties, and no presumption or burden of proof will arise favoring or disfavoring any Party by virtue of the authorship of any of the provisions of this Reimbursement.

3.8. <u>Authority</u>. By execution of this Reimbursement, the Parties represent to the other that they are entities validly existing, duly constituted and in good standing under the laws of the jurisdiction in which they were formed and in which they presently conduct business. The Parties further represent that all acts necessary to permit them to enter into and be bound by this Reimbursement have been taken and performed, and that the persons signing this Reimbursement on their behalf have due authorization to do so. The Parties further represent that they have carefully read this Reimbursement, and that they have consulted with legal counsel regarding the terms and provisions of this Reimbursement (or have had the opportunity to consult with legal counsel and have chosen not to do so), and that they have relied solely upon their own judgment without the influence of anyone in entering into this Reimbursement.

3.9. <u>Counterparts</u>. The Parties may execute this Reimbursement in multiple counterparts, each of which constitutes an original, and all of which, collectively, constitute only one agreement. The signatures of all of the Parties need not appear on the same counterpart, and delivery of an executed counterpart signature page by facsimile or by e-mail in portable document format "PDF", is as effective as executing and delivering this Reimbursement in the presence of the other Parties. This Reimbursement is effective upon delivery of one executed counterpart from each Party to the other Parties. In proving this Reimbursement, a Party must produce or account only for the executed counterpart of the Party to be charged.

3.10. <u>Entire Agreement</u>. This Reimbursement sets forth the entire agreement between the Parties, and replaces and supersedes any prior agreements, understandings, negotiations, or discussions between the Parties relative to the subject matter of this Reimbursement. Nothing contained in this Reimbursement, however, is intended to terminate any surviving obligation of a Party in any prior written agreement between the parties, including, but not limited to, the Parties' obligation to defend and hold the other harmless. This Reimbursement may only be modified by a written amendment signed by an authorized representative of both Parties and said written amendment must expressly refer to this Reimbursement.

IN WITNESS WHEREOF, both Parties have caused this Reimbursement to be duly executed by their duly authorized officers as of the date first above written.

#### COMPENSABLE DELAY COSTS (BDE)

Effective: June 2, 2017 Revised: April 1, 2019

Revise Article 107.40(b) of the Standard Specifications to read:

- "(b) Compensation. Compensation will not be allowed for delays, inconveniences, or damages sustained by the Contractor from conflicts with facilities not meeting the above definition; or if a conflict with a utility in an unanticipated location does not cause a shutdown of the work or a documentable reduction in the rate of progress exceeding the limits set herein. The provisions of Article 104.03 notwithstanding, compensation for delays caused by a utility in an unanticipated location will be paid according to the provisions of this Article governing minor and major delays or reduced rate of production which are defined as follows.
  - (1) Minor Delay. A minor delay occurs when the work in conflict with the utility in an unanticipated location is completely stopped for more than two hours, but not to exceed two weeks.
  - (2) Major Delay. A major delay occurs when the work in conflict with the utility in an unanticipated location is completely stopped for more than two weeks.
  - (3) Reduced Rate of Production Delay. A reduced rate of production delay occurs when the rate of production on the work in conflict with the utility in an unanticipated location decreases by more than 25 percent and lasts longer than seven calendar days."

Revise Article 107.40(c) of the Standard Specifications to read:

- "(c) Payment. Payment for Minor, Major, and Reduced Rate of Production Delays will be made as follows.
  - (1) Minor Delay. Labor idled which cannot be used on other work will be paid for according to Article 109.04(b)(1) and (2) for the time between start of the delay and the minimum remaining hours in the work shift required by the prevailing practice in the area.

Equipment idled which cannot be used on other work, and which is authorized to standby on the project site by the Engineer, will be paid for according to Article 109.04(b)(4).

(2) Major Delay. Labor will be the same as for a minor delay.

Equipment will be the same as for a minor delay, except Contractor-owned equipment will be limited to two weeks plus the cost of move-out to either the

Contractor's yard or another job and the cost to re-mobilize, whichever is less. Rental equipment may be paid for longer than two weeks provided the Contractor presents adequate support to the Department (including lease agreement) to show retaining equipment on the job is the most economical course to follow and in the public interest.

(3) Reduced Rate of Production Delay. The Contractor will be compensated for the reduced productivity for labor and equipment time in excess of the 25 percent threshold for that portion of the delay in excess of seven calendar days. Determination of compensation will be in accordance with Article 104.02, except labor and material additives will not be permitted.

Payment for escalated material costs, escalated labor costs, extended project overhead, and extended traffic control will be determined according to Article 109.13."

Revise Article 108.04(b) of the Standard Specifications to read:

- "(b) No working day will be charged under the following conditions.
  - (1) When adverse weather prevents work on the controlling item.
  - (2) When job conditions due to recent weather prevent work on the controlling item.
  - (3) When conduct or lack of conduct by the Department or its consultants, representatives, officers, agents, or employees; delay by the Department in making the site available; or delay in furnishing any items required to be furnished to the Contractor by the Department prevents work on the controlling item.
  - (4) When delays caused by utility or railroad adjustments prevent work on the controlling item.
  - (5) When strikes, lock-outs, extraordinary delays in transportation, or inability to procure critical materials prevent work on the controlling item, as long as these delays are not due to any fault of the Contractor.
  - (6) When any condition over which the Contractor has no control prevents work on the controlling item."

Revise Article 109.09(f) of the Standard Specifications to read:

"(f) Basis of Payment. After resolution of a claim in favor of the Contractor, any adjustment in time required for the work will be made according to Section 108. Any adjustment in the costs to be paid will be made for direct labor, direct materials, direct equipment, direct jobsite overhead, direct offsite overhead, and other direct costs allowed by the resolution. Adjustments in costs will not be made for interest charges, loss of anticipated profit, undocumented loss of efficiency, home office overhead and unabsorbed overhead other than as allowed by Article 109.13, lost opportunity, preparation of claim expenses and other consequential indirect costs regardless of method of calculation.

The above Basis of Payment is an essential element of the contract and the claim cost recovery of the Contractor shall be so limited."

Add the following to Section 109 of the Standard Specifications.

"**109.13 Payment for Contract Delay.** Compensation for escalated material costs, escalated labor costs, extended project overhead, and extended traffic control will be allowed when such costs result from a delay meeting the criteria in the following table.

Contract Type	Cause of Delay	Length of Delay
Working Days	Article 108.04(b)(3) or Article 108.04(b)(4)	No working days have been charged for two consecutive weeks.
Completion Date	Article 108.08(b)(1) or Article 108.08(b)(7)	The Contractor has been granted a minimum two week extension of contract time, according to Article 108.08.

Payment for each of the various costs will be according to the following.

- (a) Escalated Material and/or Labor Costs. When the delay causes work, which would have otherwise been completed, to be done after material and/or labor costs have increased, such increases will be paid. Payment for escalated material costs will be limited to the increased costs substantiated by documentation furnished by the Contractor. Payment for escalated labor costs will be limited to those items in Article 109.04(b)(1) and (2), except the 35 percent and 10 percent additives will not be permitted.
- (b) Extended Project Overhead. For the duration of the delay, payment for extended project overhead will be paid as follows.
  - (1) Direct Jobsite and Offsite Overhead. Payment for documented direct jobsite overhead and documented direct offsite overhead, including onsite supervisory and administrative personnel, will be allowed according to the following table.

- (2) Home Office and Unabsorbed Overhead. Payment for home office and unabsorbed overhead will be calculated as 8 percent of the total delay cost.
- (c) Extended Traffic Control. Traffic control required for an extended period of time due to the delay will be paid for according to Article 109.04.

When an extended traffic control adjustment is paid under this provision, an adjusted unit price as provided for in Article 701.20(a) for increase or decrease in the value of work by more than ten percent will not be paid.

Upon payment for a contract delay under this provision, the Contractor shall assign subrogation rights to the Department for the Department's efforts of recovery from any other party for monies paid by the Department as a result of any claim under this provision. The Contractor shall fully cooperate with the Department in its efforts to recover from another party any money paid to the Contractor for delay damages under this provision."

For the purposes of this Special Provision, a disadvantaged business enterprise (DBE) means a business certified by the Department in accordance with the requirements of 49 CFR Part 26 and listed in the Illinois Unified Certification Program (IL UCP) DBE Directory.

<u>STATE OBLIGATION</u>. This Special Provision will also be used by the Department to satisfy the requirements of the Business Enterprise for Minorities, Females, and Persons with Disabilities Act, 30 ILCS 575. When this Special Provision is used to satisfy state law requirements on 100 percent state-funded contracts, the federal government has no involvement in such contracts (not a federal-aid contract) and no responsibility to oversee the implementation of this Special Provision by the Department on those contracts. DBE participation on 100 percent state-funded contracts will not be credited toward fulfilling the Department's annual overall DBE goal required by the US Department of Transportation to comply with the federal DBE program requirements.

<u>CONTRACTOR ASSURANCE</u>. The Contractor makes the following assurance and agrees to include the assurance in each subcontract the Contractor signs with a subcontractor.

The Contractor, subrecipient, or subcontractor shall not discriminate on the basis of race, color, national origin, or sex in the performance of this contract. The Contractor shall carry out applicable requirements of 49 CFR Part 26 in the award and administration of contracts funded in whole or in part with federal or state funds. Failure by the Contractor to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy as the recipient deems appropriate, which may include, but is not limited to:

- (a) Withholding progress payments;
- (b) Assessing sanctions;
- (c) Liquidated damages; and/or
- (d) Disqualifying the Contractor from future bidding as non-responsible.

<u>OVERALL GOAL SET FOR THE DEPARTMENT</u>. As a requirement of compliance with 49 CFR Part 26, the Department has set an overall goal for DBE participation in its federally assisted contracts. That goal applies to all federal-aid funds the Department will expend in its federally assisted contracts for the subject reporting fiscal year. The Department is required to make a

good faith effort to achieve the overall goal. The dollar amount paid to all approved DBE companies performing work called for in this contract is eligible to be credited toward fulfillment of the Department's overall goal.

<u>CONTRACT GOAL TO BE ACHIEVED BY THE CONTRACTOR</u>. This contract includes a specific DBE utilization goal established by the Department. The goal has been included because the Department has determined the work of this contract has subcontracting opportunities that may be suitable for performance by DBE companies. The determination is based on an assessment of the type of work, the location of the work, and the availability of DBE companies to do a part of the work. The assessment indicates, in the absence of unlawful discrimination and in an arena of fair and open competition, DBE companies can be expected to perform <u>5.00</u>% of the work. This percentage is set as the DBE participation goal for this contract. Consequently, in addition to the other award criteria established for this contract, the Department will only award this contract to a bidder who makes a good faith effort to meet this goal of DBE participation in the performance of the work. A bidder makes a good faith effort for award consideration if either of the following is done in accordance with the procedures set for in this Special Provision:

- (a) The bidder documents enough DBE participation has been obtained to meet the goal or,
- (b) The bidder documents a good faith effort has been made to meet the goal, even though the effort did not succeed in obtaining enough DBE participation to meet the goal.

<u>DBE LOCATOR REFERENCES</u>. Bidders shall consult the IL UCP DBE Directory as a reference source for DBE-certified companies. In addition, the Department maintains a letting and item specific DBE locator information system whereby DBE companies can register their interest in providing quotes on particular bid items advertised for letting. Information concerning DBE companies willing to quote work for particular contracts may be obtained by contacting the Department's Bureau of Small Business Enterprises at telephone number (217) 785-4611, or by visiting the Department's website at:

http://www.idot.illinois.gov/doing-business/certifications/disadvantaged-business-enterprisecertification/il-ucp-directory/index.

<u>BIDDING PROCEDURES</u>. Compliance with this Special Provision is a material bidding requirement and failure of the bidder to comply will render the bid not responsive.

The bidder shall submit a DBE Utilization Plan (form SBE 2026), and a DBE Participation Statement (form SBE 2025) for each DBE company proposed for the performance of work to achieve the contract goal, with the bid. If the Utilization Plan indicates the contract goal will not be met, documentation of good faith efforts shall also be submitted. The documentation of good faith efforts must include copies of each DBE and non-DBE subcontractor quote submitted to the bidder when a non-DBE subcontractor is selected over a DBE for work on the contract. The required forms and documentation must be submitted as a single .pdf file using the "Integrated Contractor Exchange (iCX)" application within the Department's "EBids System".

The Department will not accept a Utilization Plan if it does not meet the bidding procedures set forth herein and the bid will be declared not responsive. In the event the bid is declared not responsive, the Department may elect to cause the forfeiture of the penal sum of the bidder's proposal guaranty and may deny authorization to bid the project if re-advertised for bids.

GOOD FAITH EFFORT PROCEDURES. The contract will not be awarded until the Utilization Plan is approved. All information submitted by the bidder must be complete, accurate and adequately document enough DBE participation has been obtained or document the good faith efforts of the bidder, in the event enough DBE participation has not been obtained, before the Department will commit to the performance of the contract by the bidder. The Utilization Plan will be approved by the Department if the Utilization Plan documents sufficient commercially useful DBE work to meet the contract goal or the bidder submits sufficient documentation of a good faith effort to meet the contract goal pursuant to 49 CFR Part 26, Appendix A. This means the bidder must show that all necessary and reasonable steps were taken to achieve the contract goal. Necessary and reasonable steps are those which, by their scope, intensity and appropriateness to the objective, could reasonably be expected to obtain sufficient DBE participation, even if they were not successful. The Department will consider the quality, quantity, and intensity of the kinds of efforts the bidder has made. Mere pro forma efforts, in other words efforts done as a matter of form, are not good faith efforts; rather, the bidder is expected to have taken genuine efforts that would be reasonably expected of a bidder actively and aggressively trying to obtain DBE participation sufficient to meet the contract goal.

- (a) The following is a list of types of action that the Department will consider as part of the evaluation of the bidder's good faith efforts to obtain participation. These listed factors are not intended to be a mandatory checklist and are not intended to be exhaustive. Other factors or efforts brought to the attention of the Department may be relevant in appropriate cases and will be considered by the Department.
  - (1) Soliciting through all reasonable and available means (e.g. attendance at pre-bid meetings, advertising and/or written notices) the interest of all certified DBE companies that have the capability to perform the work of the contract. The bidder must solicit this interest within sufficient time to allow the DBE companies to respond to the solicitation. The bidder must determine with certainty if the DBE companies are interested by taking appropriate steps to follow up initial solicitations.
  - (2) Selecting portions of the work to be performed by DBE companies in order to increase the likelihood that the DBE goals will be achieved. This includes, where appropriate, breaking out contract work items into economically feasible units to facilitate DBE participation, even when the Contractor might otherwise prefer to perform these work items with its own forces.
  - (3) Providing interested DBE companies with adequate information about the plans, specifications, and requirements of the contract in a timely manner to assist them in responding to a solicitation.

- (4) a. Negotiating in good faith with interested DBE companies. It is the bidder's responsibility to make a portion of the work available to DBE subcontractors and suppliers and to select those portions of the work or material needs consistent with the available DBE subcontractors and suppliers, so as to facilitate DBE participation. Evidence of such negotiation includes the names, addresses, and telephone numbers of DBE companies that were considered; a description of the information provided regarding the plans and specifications for the work selected for subcontracting; and evidence as to why additional agreements could not be reached for DBE companies to perform the work.
  - b. A bidder using good business judgment would consider a number of factors in negotiating with subcontractors, including DBE subcontractors, and would take a firm's price and capabilities as well as contract goals into consideration. However, the fact that there may be some additional costs involved in finding and using DBE companies is not in itself sufficient reason for a bidder's failure to meet the contract DBE goal, as long as such costs are reasonable. Also the ability or desire of a bidder to perform the work of a contract with its own organization does not relieve the bidder of the responsibility to make good faith efforts. Bidders are not, however, required to accept higher quotes from DBE companies if the price difference is excessive or unreasonable. In accordance with the above Bidding Procedures, the documentation of good faith efforts must include copies of each DBE and non-DBE subcontractor quote submitted to the bidder when a non-DBE subcontractor was selected over a DBE for work on the contract.
- (5) Not rejecting DBE companies as being unqualified without sound reasons based on a thorough investigation of their capabilities. The bidder's standing within its industry, membership in specific groups, organizations, or associations and political or social affiliations (for example union vs. non-union employee status) are not legitimate causes for the rejection or non-solicitation of bids in the bidder's efforts to meet the project goal.
- (6) Making efforts to assist interested DBE companies in obtaining bonding, lines of credit, or insurance as required by the recipient or Contractor.
- (7) Making efforts to assist interested DBE companies in obtaining necessary equipment, supplies, materials, or related assistance or services.
- (8) Effectively using the services of available minority/women community organizations; minority/women contractors' groups; local, state, and federal minority/women business assistance offices; and other organizations as allowed on a case-by-case basis to provide assistance in the recruitment and placement of DBE companies.
- (b) If the Department determines the bidder has made a good faith effort to secure the work commitment of DBE companies to meet the contract goal, the Department will award the contract provided it is otherwise eligible for award. If the Department determines the

bidder has failed to meet the requirements of this Special Provision or that a good faith effort has not been made, the Department will notify the responsible company official designated in the Utilization Plan that the bid is not responsive. The notification will also include a statement of reasons for the adverse determination. If the Utilization Plan is not approved because it is deficient as a technical matter, unless waived by the Department, the bidder will be notified and will be allowed no more than a five calendar day period to cure the deficiency.

(c) The bidder may request administrative reconsideration of an adverse determination by emailing the Department at "DOT.DBE.UP@illinois.gov" within the five calendar days after the receipt of the notification of the determination. The determination shall become final if a request is not made on or before the fifth calendar day. A request may provide additional written documentation or argument concerning the issues raised in the determination statement of reasons, provided the documentation and arguments address efforts made prior to submitting the bid. The request will be reviewed by the Department's Reconsideration Officer. The Reconsideration Officer will extend an opportunity to the bidder to meet in person to consider all issues of documentation and whether the bidder made a good faith effort to meet the goal. After the review by the Reconsideration Officer, the bidder will be sent a written decision within ten working days after receipt of the request for reconsideration, explaining the basis for finding that the bidder did or did not meet the goal or make adequate good faith efforts to do so. A final decision by the Reconsideration Officer that a good faith effort was made shall approve the Utilization Plan submitted by the bidder and shall clear the contract for award. A final decision that a good faith effort was not made shall render the bid not responsive.

<u>CALCULATING DBE PARTICIPATION</u>. The Utilization Plan values represent work anticipated to be performed and paid for upon satisfactory completion. The Department is only able to count toward the achievement of the overall goal and the contract goal the value of payments made for the work actually performed by DBE companies. In addition, a DBE must perform a commercially useful function on the contract to be counted. A commercially useful function is generally performed when the DBE is responsible for the work and is carrying out its responsibilities by actually performing, managing, and supervising the work involved. The Department and Contractor are governed by the provisions of 49 CFR Part 26.55(c) on questions of commercially useful functions as it affects the work. Specific counting guidelines are provided in 49 CFR Part 26.55, the provisions of which govern over the summary contained herein.

- (a) DBE as the Contractor: 100 percent goal credit for that portion of the work performed by the DBE's own forces, including the cost of materials and supplies. Work that a DBE subcontracts to a non-DBE does not count toward the DBE goals.
- (b) DBE as a joint venture Contractor: 100 percent goal credit for that portion of the total dollar value of the contract equal to the distinct, clearly defined portion of the work performed by the DBE's own forces.

- (c) DBE as a subcontractor: 100 percent goal credit for the work of the subcontract performed by the DBE's own forces, including the cost of materials and supplies, excluding the purchase of materials and supplies or the lease of equipment by the DBE subcontractor from the Contractor or its affiliates. Work that a DBE subcontractor in turn subcontracts to a non-DBE does not count toward the DBE goal.
- (d) DBE as a trucker: 100 percent goal credit for trucking participation provided the DBE is responsible for the management and supervision of the entire trucking operation for which it is responsible. At least one truck owned, operated, licensed, and insured by the DBE must be used on the contract. Credit will be given for the following:
  - (1) The DBE may lease trucks from another DBE firm, including an owner-operator who is certified as a DBE. The DBE who leases trucks from another DBE receives credit for the total value of the transportation services the lessee DBE provides on the contract.
  - (2) The DBE may also lease trucks from a non-DBE firm, including from an owneroperator. The DBE who leases trucks from a non-DBE is entitled to credit only for the fee or commission is receives as a result of the lease arrangement.
- (e) DBE as a material supplier:
  - (1) 60 percent goal credit for the cost of the materials or supplies purchased from a DBE regular dealer.
  - (2) 100 percent goal credit for the cost of materials of supplies obtained from a DBE manufacturer.
  - (3) 100 percent credit for the value of reasonable fees and commissions for the procurement of materials and supplies if not a DBE regular dealer or DBE manufacturer.

<u>CONTRACT COMPLIANCE</u>. Compliance with this Special Provision is an essential part of the contract. The Department is prohibited by federal regulations from crediting the participation of a DBE included in the Utilization Plan toward either the contract goal or the Department's overall goal until the amount to be applied toward the goals has been paid to the DBE. The following administrative procedures and remedies govern the compliance by the Contractor with the contractual obligations established by the Utilization Plan. After approval of the Utilization Plan and award of the contract, the Utilization Plan and individual DBE Participation Statements become part of the contract. If the Contract goal, and the Utilization Plan was approved and contract awarded based upon a determination of good faith, the total dollar value of DBE work calculated in the approved Utilization Plan as a percentage of the awarded contract value shall be come the amended contract goal. All work indicated for performance by an approved DBE shall be performed, managed, and supervised by the DBE executing the DBE Participation Commitment Statement.

- (a) <u>NO AMENDMENT</u>. No amendment to the Utilization Plan may be made without prior written approval from the Department's Bureau of Small Business Enterprises. All requests for amendment to the Utilization Plan shall be emailed to the Department at <u>DOT.DBE.UP@illinois.gov</u>.
- (b) <u>CHANGES TO WORK</u>. Any deviation from the DBE condition-of-award or contract plans, specifications, or special provisions must be approved, in writing, by the Department as provided elsewhere in the Contract. The Contractor shall notify affected DBEs in writing of any changes in the scope of work which result in a reduction in the dollar amount condition-of-award to the contract. Where the revision includes work committed to a new DBE subcontractor, not previously involved in the project, then a Request for Approval of Subcontractor, Department form BC 260A or AER 260A, must be signed and submitted. If the commitment of work is in the form of additional tasks assigned to an existing subcontract, a new Request for Approval of Subcontractor will not be required. However, the Contractor must document efforts to assure the existing DBE subcontractor is capable of performing the additional work and has agreed in writing to the change.
- (c) <u>SUBCONTRACT</u>. The Contractor must provide copies of DBE subcontracts to the Department upon request. Subcontractors shall ensure that all lower tier subcontracts or agreements with DBEs to supply labor or materials be performed in accordance with this Special Provision.
- (d) <u>ALTERNATIVE WORK METHODS</u>. In addition to the above requirements for reductions in the condition of award, additional requirements apply to the two cases of Contractorinitiated work substitution proposals. Where the contract allows alternate work methods which serve to delete or create underruns in condition of award DBE work, and the Contractor selects that alternate method or, where the Contractor proposes a substitute work method or material that serves to diminish or delete work committed to a DBE and replace it with other work, then the Contractor must demonstrate one of the following:
  - (1) The replacement work will be performed by the same DBE (as long as the DBE is certified in the respective item of work) in a modification of the condition of award; or
  - (2) The DBE is aware its work will be deleted or will experience underruns and has agreed in writing to the change. If this occurs, the Contractor shall substitute other work of equivalent value to a certified DBE or provide documentation of good faith efforts to do so; or
  - (3) The DBE is not capable of performing the replacement work or has declined to perform the work at a reasonable competitive price. If this occurs, the Contractor shall substitute other work of equivalent value to a certified DBE or provide documentation of good faith efforts to do so.

(e) <u>TERMINATION AND REPLACEMENT PROCEDURES</u>. The Contractor shall not terminate or replace a DBE listed on the approved Utilization Plan, or perform with other forces work designated for a listed DBE except as provided in this Special Provision. The Contractor shall utilize the specific DBEs listed to perform the work and supply the materials for which each is listed unless the Contractor obtains the Department's written consent as provided in subsection (a) of this part. Unless Department consent is provided for termination of a DBE subcontractor, the Contractor shall not be entitled to any payment for work or material unless it is performed or supplied by the DBE in the Utilization Plan.

As stated above, the Contractor shall not terminate or replace a DBE subcontractor listed in the approved Utilization Plan without prior written consent. This includes, but is not limited to, instances in which the Contractor seeks to perform work originally designated for a DBE subcontractor with its own forces or those of an affiliate, a non-DBE firm, or with another DBE firm. Written consent will be granted only if the Bureau of Small Business Enterprises agrees, for reasons stated in its concurrence document, that the Contractor has good cause to terminate or replace the DBE firm. Before transmitting to the Bureau of Small Business Enterprises any request to terminate and/or substitute a DBE subcontractor, the Contractor shall give notice in writing to the DBE subcontractor, with a copy to the Bureau, of its intent to request to terminate and/or substitute, and the reason for the request. The Contractor shall give the DBE five days to respond to the Contractor's notice. The DBE so notified shall advise the Bureau and the Contractor of the reasons, if any, why it objects to the proposed termination of its subcontract and why the Bureau should not approve the Contractor's action. If required in a particular case as a matter of public necessity, the Bureau may provide a response period shorter than five days.

For purposes of this paragraph, good cause includes the following circumstances:

- (1) The listed DBE subcontractor fails or refuses to execute a written contract;
- (2) The listed DBE subcontractor fails or refuses to perform the work of its subcontract in a way consistent with normal industry standards. Provided, however, that good cause does not exist if the failure or refusal of the DBE subcontractor to perform its work on the subcontract results from the bad faith or discriminatory action of the Contractor;
- (3) The listed DBE subcontractor fails or refuses to meet the Contractor's reasonable, nondiscriminatory bond requirements;
- (4) The listed DBE subcontractor becomes bankrupt, insolvent, or exhibits credit unworthiness;
- (5) The listed DBE subcontractor is ineligible to work on public works projects because of suspension and debarment proceedings pursuant 2 CFR Parts 180, 215 and 1200 or applicable state law.

- (6) The Contractor has determined the listed DBE subcontractor is not a responsible contractor;
- (7) The listed DBE subcontractor voluntarily withdraws from the projects and provides written notice to the Contractor of its withdrawal;
- (8) The listed DBE is ineligible to receive DBE credit for the type of work required;
- (9) A DBE owner dies or becomes disabled with the result that the listed DBE subcontractor is unable to complete its work on the contract;
- (10) Other documented good cause that compels the termination of the DBE subcontractor. Provided, that good cause does not exist if the Contractor seeks to terminate a DBE it relied upon to obtain the contract so that the Contractor can self-perform the work for which the DBE contractor was engaged or so that the Contractor can substitute another DBE or non-DBE contractor after contract award.

When a DBE is terminated or fails to complete its work on the Contract for any reason, the Contractor shall make a good faith effort to find another DBE to substitute for the original DBE to perform at least the same amount of work under the contract as the terminated DBE to the extent needed to meet the established Contract goal. The good faith efforts shall be documented by the Contractor. If the Department requests documentation under this provision, the Contractor shall submit the documentation within seven days, which may be extended for an additional seven days if necessary at the request of the Contractor. The Department will provide a written determination to the Contractor stating whether or not good faith efforts have been demonstrated.

- (f) <u>FINAL PAYMENT</u>. After the performance of the final item of work or delivery of material by a DBE and final payment therefore to the DBE by the Contractor, but not later than 30 calendar days after payment has been made by the Department to the Contractor for such work or material, the Contractor shall submit a DBE Payment Agreement on Department form SBE 2115 to the Resident Engineer. If full and final payment has not been made to the DBE, the DBE Payment Agreement shall indicate whether a disagreement as to the payment required exists between the Contractor and the DBE or if the Contractor believes the work has not been satisfactorily completed. If the Contractor does not have the full amount of work indicated in the Utilization Plan performed by the DBE companies indicated in the Utilization Plan and after good faith efforts are reviewed, the Department may deduct from contract payments to the Contractor the amount of the goal not achieved as liquidated and ascertained damages. The Contractor may request an administrative reconsideration of any amount deducted as damages pursuant to subsection (h) of this part.
- (g) <u>ENFORCEMENT</u>. The Department reserves the right to withhold payment to the Contractor to enforce the provisions of this Special Provision. Final payment shall not be

made on the contract until such time as the Contractor submits sufficient documentation demonstrating achievement of the goal in accordance with this Special Provision or after liquidated damages have been determined and collected.

(h) <u>RECONSIDERATION</u>. Notwithstanding any other provision of the contract, including but not limited to Article 109.09 of the Standard Specifications, the Contractor may request administrative reconsideration of a decision to deduct the amount of the goal not achieved as liquidated damages. A request to reconsider shall be delivered to the Contract Compliance Section and shall be handled and considered in the same manner as set forth in paragraph (c) of "Good Faith Effort Procedures" of this Special Provision, except a final decision that a good faith effort was not made during contract performance to achieve the goal agreed to in the Utilization Plan shall be the final administrative decision of the Department. The result of the reconsideration process is not administratively appealable to the U.S. Department of Transportation.

#### HOT-MIX ASPHALT (BDE)

Revise the second paragraph of Articles 1030.07(a)(11) and 1030.08(a)(9) of the Standard Specifications to read:

"When establishing the target density, the HMA maximum theoretical specific gravity  $(G_{mm})$  will be based on the running average of four available Department test results for that project. If less than four  $G_{mm}$  test results are available, an average of all available Department test results for that project will be used. The initial  $G_{mm}$  will be the last available Department test result from a QMP project. If there is no available Department test result from a QMP project. If there is no available Department test result from a QMP project. If there is no available Department test result from a QMP project. If there is no available Department test result from a QMP project.

In the Supplemental Specifications, replace the revision for the end of the third paragraph of Article 1030.09(h)(2) with the following:

"When establishing the target density, the HMA maximum theoretical specific gravity  $(G_{mm})$  will be the Department mix design verification test result."

Revise the tenth paragraph of Article 1030.10 of the Standard Specifications to read:

"Production is not required to stop after a test strip has been constructed."

## ILLINOIS WORKS APPRENTICESHIP INITIATIVE – STATE FUNDED CONTRACTS (BDE)

Effective: June 2, 2021 Revised: April 2, 2024

<u>Illinois Works Jobs Program Act (30 ILCS 559/20-1 et seq.)</u>. For contracts having an awarded contract value of \$500,000 or more, the Contractor shall comply with the Illinois Works Apprenticeship Initiative (30 ILCS 559/20-20 to 20-25) and all applicable administrative rules. The goal of the Illinois Apprenticeship Works Initiative is that apprentices will perform either 10% of the total labor hours actually worked in each prevailing wage classification or 10% of the estimated labor hours in each prevailing wage classification, whichever is less. Of this goal, at least 50% of the labor hours of each prevailing wage classification performed by apprentices shall be performed by graduates of the Illinois Works Pre-Apprenticeship Program, the Illinois Climate Works Pre-Apprenticeship Program.

The Contractor may seek from the Department of Commerce and Economic Opportunity (DCEO) a waiver or reduction of this goal in certain circumstances pursuant to 30 ILCS 559/20-20(b). The Contractor shall ensure compliance during the term of the contract and will be required to report on and certify its compliance. An apprentice use plan, apprentice hours, and a compliance certification shall be submitted to the Engineer on forms provided by the Department and/or DCEO.

## ILLINOIS WORKS APPRENTICESHIP INITIATIVE – STATE FUNDED CONTRACTS (BDE)

Effective: June 2, 2021 Revised: April 2, 2024

<u>Illinois Works Jobs Program Act (30 ILCS 559/20-1 et seq.)</u>. For contracts having an awarded contract value of \$500,000 or more, the Contractor shall comply with the Illinois Works Apprenticeship Initiative (30 ILCS 559/20-20 to 20-25) and all applicable administrative rules. The Contractor shall ensure compliance during the term of the contract and will be required to report on and certify its compliance. An apprentice use plan, apprentice hours, and a compliance certification shall be submitted to the Engineer on forms provided by the Department and/or DCEO.

## PERFORMANCE GRADED ASPHALT BINDER (BDE)

Effective: January 1, 2023

Revise Article 1032.05 of the Standard Specifications to read:

"1032.05 Performance Graded Asphalt Binder. These materials will be accepted according to the Bureau of Materials Policy Memorandum, "Performance Graded Asphalt Binder Qualification Procedure." The Department will maintain a qualified producer list. These materials shall be free from water and shall not foam when heated to any temperature below the actual flash point. Air blown asphalt, recycle engine oil bottoms (ReOB), and polyphosphoric acid (PPA) modification shall not be used.

When requested, producers shall provide the Engineer with viscosity/temperature relationships for the performance graded asphalt binders delivered and incorporated in the work.

(a) Performance Graded (PG) Asphalt Binder. The asphalt binder shall meet the requirements of AASHTO M 320, Table 1 "Standard Specification for Performance Graded Asphalt Binder" for the grade shown on the plans and the following.

(b) Modified Performance Graded (PG) Asphalt Binder. The asphalt binder shall meet the requirements of AASHTO M 320, Table 1 "Standard Specification for Performance Graded Asphalt Binder" for the grade shown on the plans.

Asphalt binder modification shall be performed at the source, as defined in the Bureau of Materials Policy Memorandum, "Performance Graded Asphalt Binder Qualification Procedure."

Modified asphalt binder shall be safe to handle at asphalt binder production and storage temperatures or HMA construction temperatures. Safety Data Sheets (SDS) shall be provided for all asphalt modifiers.

(1) Polymer Modification (SB/SBS or SBR). Elastomers shall be added to the base asphalt binder to achieve the specified performance grade and shall be either a styrene-butadiene diblock, triblock copolymer without oil extension, or a styrenebutadiene rubber. The polymer modified asphalt binder shall be smooth, homogeneous, and be according to the requirements shown in Table 1 or 2 for the grade shown on the plans.

(2) Ground Tire Rubber (GTR) Modification. GTR modification is the addition of recycled ground tire rubber to liquid asphalt binder to achieve the specified performance grade. GTR shall be produced from processing automobile and/or truck tires by the ambient

grinding method or micronizing through a cryogenic process. GTR shall not exceed 1/16 in. (2 mm) in any dimension and shall not contain free metal particles, moisture that would cause foaming of the asphalt, or other foreign materials. A mineral powder (such as talc) meeting the requirements of AASHTO M 17 may be added, up to a maximum of four percent by weight of GTR to reduce sticking and caking of the GTR particles. When tested in accordance with Illinois Modified AASHTO T 27 "Standard Method of Test for Sieve Analysis of Fine and Coarse Aggregates" or AASHTO PP 74 "Standard Practice for Determination of Size and Shape of Glass Beads Used in Traffic Markings by Means of Computerized Optical Method", a 50 g sample of the GTR shall conform to the following gradation requirements.

GTR modified asphalt binder shall be tested for rotational viscosity according to AASHTO T 316 using spindle S27. GTR modified asphalt binder shall be tested for original dynamic shear and RTFO dynamic shear according to AASHTO T 315 using a gap of 2 mm.

The GTR modified asphalt binder shall meet the requirements of Table 3.

(3) Softener Modification (SM). Softener modification is the addition of organic compounds, such as engineered flux, bio-oil blends, modified vegetable oils, glycol amines, and fatty acid derivatives, to the base asphalt binder to achieve the specified performance grade. Softeners shall be dissolved, dispersed, or reacted in the asphalt binder to enhance its performance and shall remain compatible with the asphalt binder with no separation. Softeners shall not be added to modified PG asphalt binder as defined in Articles 1032.05(b)(1) or 1032.05(b)(2).

An Attenuated Total Reflectance-Fourier Transform Infrared spectrum (ATR-FTIR) shall be collected for both the softening compound as well as the softener modified

asphalt binder at the dose intended for qualification. The ATR-FTIR spectra shall be collected on unaged softener modified binder, 20-hour Pressurized Aging Vessel (PAV) aged softener modified binder, and 40-hour PAV aged softener modified binder. The ATR-FTIR shall be collected in accordance with Illinois Test Procedure 601. The electronic files spectral files (in one of the following extensions or equivalent: \*.SPA, \*.SPG, \*.IRD, \*.IFG, \*.CSV, \*.SP, \*.IRS, \*.GAML, \*.[0-9], \*.IGM, \*.ABS, \*.DRT, \*.SBM, \*.RAS) shall be submitted to the Central Bureau of Materials.

Softener modified asphalt binders shall meet the requirements in Table 4.

The tank shall be heated and capable of maintaining the temperature of the asphalt binder at 300 °F to 350 °F (149 °C to 177 °C). The asphalt binder metering systems of dryer drum plants shall be calibrated with the actual GTR modified asphalt binder material with an accuracy of  $\pm 0.40$  percent."

## PORTLAND CEMENT CONCRETE (BDE)

Effective: August 1, 2023

Revise the second paragraph of Article 1103.03(a)(4) the Standard Specifications to read:

"The dispenser system shall provide a visual indication that the liquid admixture is actually entering the batch, such as via a transparent or translucent section of tubing or by independent check with an integrated secondary metering device. If approved by the Engineer, an alternate indicator may be used for admixtures dosed at rates of 25 oz/cwt (1630 mL/100 kg) or greater, such as accelerating admixtures, corrosion inhibitors, and viscosity modifying admixtures."

## RAILROAD PROTECTIVE LIABILITY INSURANCE (BDE)

Effective: December 1, 1986 Revised: January 1, 2022

<u>Description</u>. Railroad Protective Liability and Property Damage Liability Insurance shall be carried according to Article 107.11 of the Standard Specifications. A separate policy is required for each railroad unless otherwise noted.

#### REMOVAL AND DISPOSAL OF REGULATED SUBSTANCES (BDE)

Effective: January 1, 2024 Revised: April 1, 2024

Revise the first paragraph of Article 669.04 of the Standard Specifications to read:

"669.04 Regulated Substances Monitoring. Regulated substances monitoring includes environmental observation and field screening during regulated substances management activities. The excavated soil and groundwater within the work areas shall be managed as either uncontaminated soil, hazardous waste, special waste, or non-special waste.

As part of the regulated substances monitoring, the monitoring personnel shall perform and document the applicable duties listed on form BDE 2732 "Regulated Substances Monitoring Daily Record (RSMDR)"."

Revise the first two sentences of the nineteenth paragraph of Article 669.05 of the Standard Specifications to read:

"The Contractor shall coordinate waste disposal approvals with the disposal facility and provide the specific analytical testing requirements of that facility. The Contractor shall make all arrangements for collection, transportation, and analysis of landfill acceptance testing."

Revise the last paragraph of Article 669.05 of the Standard Specifications to read:

"The Contractor shall select a permitted landfill facility or CCDD/USFO facility meeting the requirements of 35 III. Admin. Code Parts 810-814 or Part 1100, respectively. The Department will review and approve or reject the facility proposed by the Contractor based upon information provided in BDE 2730. The Contractor shall verify whether the selected facility is compliant with those applicable standards as mandated by their permit and whether the facility is presently, has previously been, or has never been, on the United States Environmental Protection Agency (U.S. EPA) National Priorities List or the Resource Conservation and Recovery Act (RCRA) List of Violating Facilities. The use of a Contractor selected facility shall in no manner delay the construction schedule or alter the Contractor's responsibilities as set forth."

Revise the first paragraph of Article 669.07 of the Standard Specifications to read:

"669.07 Temporary Staging. Soil classified according to Articles 669.05(a)(2), (b)(1), or (c) may be temporarily staged at the Contractor's option. All other soil classified according to Articles 669.05(a)(1), (a)(3), (a)(4), (a)(5), (a)(6), or (b)(2) shall be managed and disposed of without temporary staging to the greatest extent practicable. If circumstances beyond the Contractor's control require temporary staging of these latter materials, the Contractor shall request approval from the Engineer in writing.

Topsoil for re-use as final cover which has been field screened and found not to exhibit PID readings over daily background readings as documented on the BDE 2732, visual staining or

odors, and is classified according to Articles 669.05(a)(2), (a)(3), (a)(4), (b)(1), or (c) may be temporarily staged at the Contractor's option."

Add the following paragraph after the sixth paragraph of Article 669.11 of the Standard Specifications.

"The sampling and testing of effluent water derived from dewatering discharges for priority pollutants volatile organic compounds (VOCs), priority pollutants semi-volatile organic compounds (SVOCs), or priority pollutants metals, will be paid for at the contract unit price per each for VOCS GROUNDWATER ANALYSIS using EPA Method 8260B, SVOCS GROUNDWATER ANALYSIS using EPA Method 8270C, or RCRA METALS GROUNDWATER ANALYSIS using EPA Methods 6010B and 7471A. This price shall include transporting the sample from the job site to the laboratory."

Revise the first sentence of the eight paragraph of Article 669.11 of the Standard Specifications to read:

"Payment for temporary staging of soil classified according to Articles 669.05(a)(1), (a)(3), (a)(4), (a)(5), (a)(6), or (b)(2) to be managed and disposed of, if required and approved by the Engineer, will be paid according to Article 109.04."

## SEEDING (BDE)

Effective: November 1, 2022

Revise Article 250.07 of the Standard Specifications to read:

"**250.07 Seeding Mixtures.** The classes of seeding mixtures and combinations of mixtures will be designated in the plans.

When an area is to be seeded with two or more seeding classes, those mixtures shall be applied separately on the designated area within a seven day period. Seeding shall occur prior to placement of mulch cover. A Class 7 mixture can be applied at any time prior to applying any seeding class or added to them and applied at the same time.

- 1/ Seeding shall be performed when the ambient temperature has been between 45 °F (7 °C) and 80 °F (27 °C) for a minimum of seven (7) consecutive days and is forecasted to be the same for the next five (5) days according to the National Weather Service.
- 2/ Seeding shall be performed in late fall through spring beginning when the ambient temperature has been below 45 °F (7 °C) for a minimum of seven (7) consecutive days and ending when the ambient temperature exceeds 80 °F (27 °C) according to the National Weather Service.

After the period of establishment, areas not exhibiting 75 percent uniform growth shall be interseeded or reseeded, as determined by the Engineer, at no additional cost to the Department."

## SUBCONTRACTOR AND DBE PAYMENT REPORTING (BDE)

Effective: April 2, 2018

Add the following to Section 109 of the Standard Specifications.

"**109.14 Subcontractor and Disadvantaged Business Enterprise Payment Reporting.** The Contractor shall report all payments made to the following parties:

- (a) first tier subcontractors;
- (b) lower tier subcontractors affecting disadvantaged business enterprise (DBE) goal credit;
- (c) material suppliers or trucking firms that are part of the Contractor's submitted DBE utilization plan.

The report shall be made through the Department's on-line subcontractor payment reporting system within 21 days of making the payment."

#### SUBCONTRACTOR MOBILIZATION PAYMENTS (BDE)

Effective: November 2, 2017 Revised: April 1, 2019

Replace the second paragraph of Article 109.12 of the Standard Specifications with the following:

"This mobilization payment shall be made at least seven days prior to the subcontractor starting work. The amount paid shall be at the following percentage of the amount of the subcontract reported on form BC 260A submitted for the approval of the subcontractor's work.

#### SUBMISSION OF PAYROLL RECORDS (BDE)

Effective: April 1, 2021 Revised: November 2, 2023

<u>FEDERAL AID CONTRACTS</u>. Revise the following section of Check Sheet #1 of the Recurring Special Provisions to read:

#### **"STATEMENTS AND PAYROLLS**

The payroll records shall include the worker's name, social security number, last known address, telephone number, email address, classification(s) of work actually performed, hourly rates of wages paid (including rates of contributions or costs anticipated for bona fide fringe benefits or cash equivalents thereof), daily and weekly number of hours actually worked in total, deductions made, and actual wages paid.

The Contractor and each subcontractor shall submit certified payroll records to the Department each week from the start to the completion of their respective work, except that full social security numbers, last known addresses, telephone numbers, and email addresses shall not be included on weekly submittals. Instead, the payrolls need only include an identification number for each employee (e.g., the last four digits of the employee's social security number). The submittals shall be made using LCPtracker Pro software. The software is web-based and can be accessed at <a href="https://lcptracker.com/">https://lcptracker.com/</a>. When there has been no activity during a work week, a payroll record shall still be submitted with the appropriate option ("No Work", "Suspended", or "Complete") selected."

<u>STATE CONTRACTS</u>. Revise Item 3 of Section IV of Check Sheet #5 of the Recurring Special Provisions to read:

"3. Submission of Payroll Records. The Contractor and each subcontractor shall, no later than the 15<sup>th</sup> day of each calendar month, file a certified payroll for the immediately preceding month to the Illinois Department of Labor (IDOL) through the Illinois Prevailing Wage Portal in compliance with the State Prevailing Wage Act (820 ILCS 130). The portal can be found on the IDOL website at <u>https://www2.illinois.gov/idol/Laws-Rules/CONMED/Pages/Prevailing-Wage-Portal.aspx</u>. Payrolls shall be submitted in the format prescribed by the IDOL.

In addition to filing certified payroll(s) with the IDOL, the Contractor and each subcontractor shall certify and submit payroll records to the Department each week from the start to the completion of their respective work, except that full social security numbers shall not be included on weekly submittals. Instead, the payrolls shall include an identification number for each employee (e.g., the last four digits of the employee's social security number). In addition, starting and ending times of work each day may be omitted from the payroll records submitted. The submittals shall be made using LCPtracker Pro software. The software is web-based and can be accessed at <a href="https://lcptracker.com/">https://lcptracker.com/</a>.

When there has been no activity during a work week, a payroll record shall still be submitted with the appropriate option ("No Work", "Suspended", or "Complete") selected."

#### VEHICLE AND EQUIPMENT WARNING LIGHTS (BDE)

Effective: November 1, 2021 Revised: November 1, 2022

Add the following paragraph after the first paragraph of Article 701.08 of the Standard Specifications:

"The Contractor shall equip all vehicles and equipment with high-intensity oscillating, rotating, or flashing, amber or amber-and-white, warning lights which are visible from all directions. In accordance with 625 ILCS 5/12-215, the lights may only be in operation while the vehicle or equipment is engaged in construction operations."

#### WEEKLY DBE TRUCKING REPORTS (BDE)

Effective: June 2, 2012 Revised: November 1, 2021

The Contractor shall submit a weekly report of Disadvantaged Business Enterprise (DBE) trucks hired by the Contractor or subcontractors (i.e. not owned by the Contractor or subcontractors) that are used for DBE goal credit.

The report shall be submitted to the Engineer on Department form "SBE 723" within ten business days following the reporting period. The reporting period shall be Sunday through Saturday for each week reportable trucking activities occur.

Any costs associated with providing weekly DBE trucking reports shall be considered as included in the contract unit prices bid for the various items of work involved and no additional compensation will be allowed.

## WORK ZONE TRAFFIC CONTROL DEVICES (BDE)

Effective: March 2, 2020

Add the following to Article 701.03 of the Standard Specifications:

"(q) Temporary Sign Supports ......1106.02"

Revise the third paragraph of Article 701.14 of the Standard Specifications to read:

"For temporary sign supports, the Contractor shall provide a FHWA eligibility letter for each device used on the contract. The letter shall provide information for the set-up and use of the device as well as a detailed drawing of the device. The signs shall be supported within 20 degrees of vertical. Weights used to stabilize signs shall be attached to the sign support per the manufacturer's specifications."

Revise the first paragraph of Article 701.15 of the Standard Specifications to read:

"**701.15 Traffic Control Devices.** For devices that must meet crashworthiness standards, the Contractor shall provide a manufacturer's self-certification or a FHWA eligibility letter for each Category 1 device and a FHWA eligibility letter for each Category 2 and Category 3 device used on the contract. The self-certification or letter shall provide information for the set-up and use of the device as well as a detailed drawing of the device."

Revise the first six paragraphs of Article 1106.02 of the Standard Specifications to read:

"**1106.02 Devices.** Work zone traffic control devices and combinations of devices shall meet crashworthiness standards for their respective categories. The categories are as follows.

Category 1 includes small, lightweight, channelizing and delineating devices that have been in common use for many years and are known to be crashworthy by crash testing of similar devices or years of demonstrable safe performance. These include cones, tubular markers, plastic drums, and delineators, with no attachments (e.g. lights). Category 1 devices manufactured after December 31, 2019 shall be MASH-16 compliant. Category 1 devices manufactured on or before December 31, 2019, and compliant with NCHRP 350 or MASH 2009, may be used on contracts let before December 31, 2024.

Category 2 includes devices that are not expected to produce significant vehicular velocity change but may otherwise be hazardous. These include vertical panels with lights, barricades, temporary sign supports, and Category 1 devices with attachments (e.g. drums with lights). Category 2 devices manufactured after December 31, 2019 shall be MASH-16 compliant. Category 2 devices manufactured on or before December 31, 2019, and compliant with NCHRP 350 or MASH 2009, may be used on contracts let before December 31, 2024.

Category 3 includes devices that are expected to cause significant velocity changes or other potentially harmful reactions to impacting vehicles. These include crash cushions (impact

attenuators), truck mounted attenuators, and other devices not meeting the definitions of Category 1 or 2. Category 3 devices manufactured after December 31, 2019 shall be MASH-16 compliant. Category 3 devices manufactured on or before December 31, 2019, and compliant with NCHRP 350 or MASH 2009, may be used on contracts let before December 31, 2029. Category 3 devices shall be crash tested for Test Level 3 or the test level specified.

Category 4 includes portable or trailer-mounted devices such as arrow boards, changeable message signs, temporary traffic signals, and area lighting supports. It is preferable for Category 4 devices manufactured after December 31, 2019 to be MASH-16 compliant; however, there are currently no crash tested devices in this category, so it remains exempt from the NCHRP 350 or MASH compliance requirement.

For each type of device, when no more than one MASH-16 compliant is available, an NCHRP 350 or MASH-2009 compliant device may be used, even if manufactured after December 31, 2019."

Revise Articles 1106.02(g), 1106.02(k), and 1106.02(l) to read:

- "(g) Truck Mounted/Trailer Mounted Attenuators. The attenuator shall be approved for use at Test Level 3. Test Level 2 may be used for normal posted speeds less than or equal to 45 mph.
- (k) Temporary Water Filled Barrier. The water filled barrier shall be a lightweight plastic shell designed to accept water ballast and be on the Department's qualified product list.

Shop drawings shall be furnished by the manufacturer and shall indicate the deflection of the barrier as determined by acceptance testing; the configuration of the barrier in that test; and the vehicle weight, velocity, and angle of impact of the deflection test. The Engineer shall be provided one copy of the shop drawings.

(I) Movable Traffic Barrier. The movable traffic barrier shall be on the Department's qualified product list.

Shop drawings shall be furnished by the manufacturer and shall indicate the deflection of the barrier as determined by acceptance testing; the configuration of the barrier in that test; and the vehicle weight, velocity, and angle of impact of the deflection test. The Engineer shall be provided one copy of the shop drawings. The barrier shall be capable of being moved on and off the roadway on a daily basis."

# WORKING DAYS (BDE)

Effective: January 1, 2002

The Contractor shall complete the work within **90** working days.

## **REVISIONS TO THE ILLINOIS PREVAILING WAGE RATES**

The Prevailing rates of wages are included in the Contract proposals which are subject to Check Sheet #5 of the Supplemental Specifications and Recurring Special Provisions. The rates have been ascertained and certified by the Illinois Department of Labor for the locality in which the work is to be performed and for each craft or type of work or mechanic needed to execute the work of the Contract. As required by Prevailing Wage Act (820 ILCS 130/0.01, et seq.) and Check Sheet #5 of the Contract, not less than the rates of wages ascertained by the Illinois Department of Labor and as revised during the performance of a Contract shall be paid to all laborers, workers and mechanics performing work under the Contract. Post the scale of wages in a prominent and easily accessible place at the site of work.

If the Illinois Department of Labor revises the prevailing rates of wages to be paid as listed in the specification of rates, the contractor shall post the revised rates of wages and shall pay not less than the revised rates of wages. Current wage rate information shall be obtained by visiting the Illinois Department of Labor web site at <a href="http://www.state.il.us/agency/idol/">http://www.state.il.us/agency/idol/</a> or by calling 312-793-2814. It is the responsibility of the contractor to review the rates applicable to the work of the contract at regular intervals in order to insure the timely payment of current rates. Provision of this information to the contractor by means of the Illinois Department of Labor web site satisfies the notification of revisions by the Department to the contractor pursuant to the Act, and the contractor agrees that no additional notice is required. The contractor shall notify each of its subcontractors of the revised rates of wages.
