BLANDINGS TURTLE'S COMMITMENTS

Add the following paragraph to the end of Article 107.23:

“Potential habitat for the Blanding’s Turtle has been identified within the project limits and has been protected as outlined in the Erosion and Sediment Control Plans. If additional areas are identified by the Engineer, the Contractor shall erect temporary chain link fence with no intrusion signing and be paid for this work accordingly. Additional awareness training shall be provided for all Contractors. All Contractor and Sub-Contractor employees shall be made aware of the possibility that Blanding’s Turtles may be present and that they are a protected species. The Contractor shall be responsible for coordinating this training with the Engineer prior to the commencement of any construction activities. A picture of the Blanding’s Turtle will be provided to the workers so they can be informed of the particular turtle in need of protection. If a turtle is found in the project area, a contact phone number will be available so the proper identification and handling of the turtle is afforded. This will be a qualified person from IDNR, INHS or an environmental consultant. The Contractor is responsible for obtaining the contact information of the qualified handler from the Engineer, ensuring all relevant staff is trained, and that the Blanding’s Turtle photograph and qualified handler contact information is made available to all workers and properly posted within the job site.”

This work will not be paid for separately but be considered incidental to the contract. Installation of additional chain link fence and No Intrusion Signing shall be paid per lineal feet for TEMPORARY CHAIN LINK FENCE.
