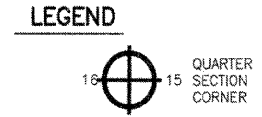

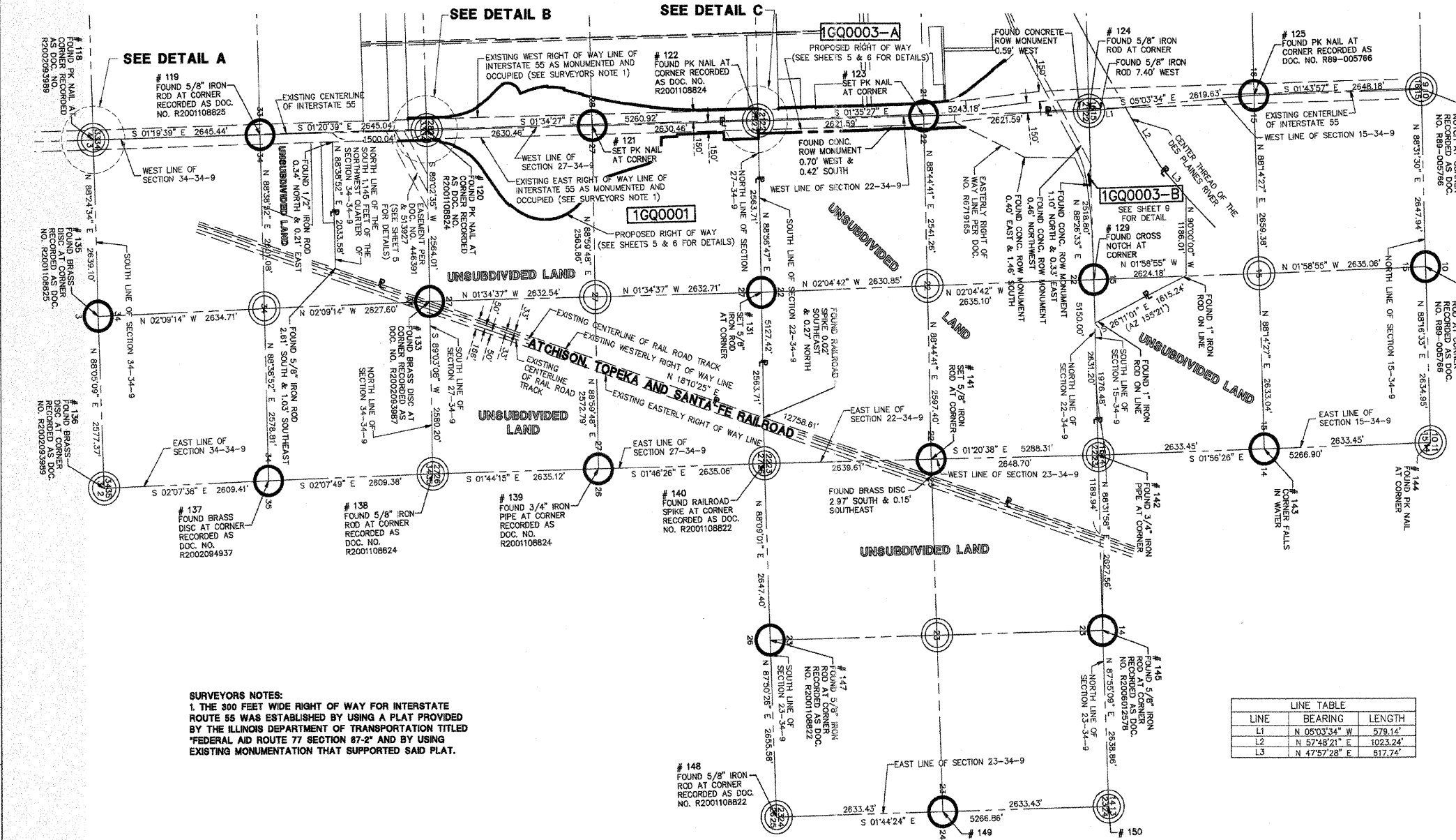

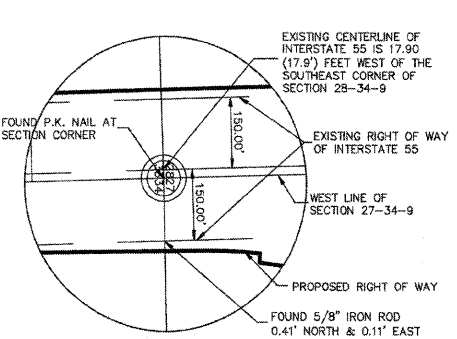


**SURVEYORS NOTES:**

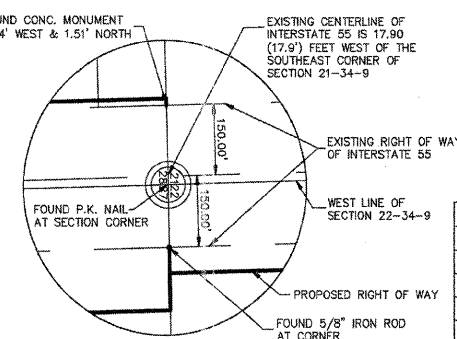
