## **WORK WITHIN NICOR GAS COMPANY RIGHT OF WAY**

This project involves work within the proposed right of way of Nicor Gas Company's property on US 20 east of Old Barn Road at the following locations:

Sta. 152+31 to Sta. 154+40 (40 ft LT to 49 ft LT)  
Sta. 152+13 to Sta. 152+82 (40 ft RT to 46 ft RT)

The following conditions shall apply to this contract:

1. Any operations in or around the Premises shall at all times be performed to the satisfaction of Nicor so as to not interfere with the operation, maintenance, and access to Nicor Gas Company's gas mains and facilities located within Nicor Gas Company's property;
2. Nicor Gas Company's System Operations – Transmission Department, Shorewood, Illinois, Telephone Number (815) 272-2587, or any other substitute office which Nicor Gas Company provides written notice to IDOT, must be notified 48 hours prior to commencement of any work around Nicor Gas Company's facilities; unless such work constitutes an emergency to the health or safety of the public generally or other individuals in the area of the Premises; in case of such an emergency notice will be given to the above office as soon as possible, but in no event later than 24 hours after commencement of such work;
3. Prior to any work being performed by IDOT, or its contractors, on the Premises, IDOT, or its contractor, shall erect, install and maintain adequate barriers, shoring and sheeting necessary which will meet IDOT specifications as approved by the Nicor Gas Company.
4. Upon request by the Nicor Gas Company there shall be furnished to Nicor prior to commencing the work of installing, repairing, replacing or removing any improvements on the Premises, a copy of each policy of insurance or a Certificate of Insurance issued pursuant to the requirements contained herein.
5. When excavating or boring within five feet of the Nicor Gas Company's pipeline on Nicor Gas Company's property, the contractor shall expose and locate the pipe utilizing vacuum or hand excavation at the Contractor's expense. If excavating under the pipeline, it shall be properly supported as approved by the Department during and after construction.
6. The Department shall provide all applicable as built drawings for work constructed on the proposed Nicor Gas Company's property.

## **INSURANCE**

The Contractor shall obtain and thereafter keep in force the coverage in accordance with Article 107.27 of the Standard Specifications with the exception to the following:

The limits of the comprehensive general liability insurance shall initially be not less than \$3,000,000 for each occurrence with respect to bodily injury or death and property damage. In addition, worker's compensation (with statutory limits) and employer liability (with initial limits of not less than \$1,000,000) shall be procured.

Nicor Gas Company shall be listed as the additional insured.

Copies of the certificates of said policies of insurance shall be delivered to the Nicor Gas Company, Real Estate Department, 1844 Ferry Road, Naperville, Illinois, 60563-9600 for approval prior to the start of work.
