## **PAVEMENT PROTECTION**

Description: This work shall consist of protecting the existing roadway on FAI-74 during demolition and removal of the existing structure.

General: The Contractor shall provide a protection method designed to prevent damage to the existing roadway by either equipment or structure impact during demolition and debris removal of the existing structure and as approved by the Engineer. The protection system is to be removed and pavement restored to a clean condition prior to opening the lanes to traffic. Any damage done by the Contractor to the existing roadway will be repaired at his/her own expense, as directed by the Engineer.

Method of Measurement: Pavement protection shall not be measured for payment.

Basis of Payment: This work will not be paid for separately but shall be included in the lump sum cost for REMOVAL OF EXISTING STRUCTURE.
