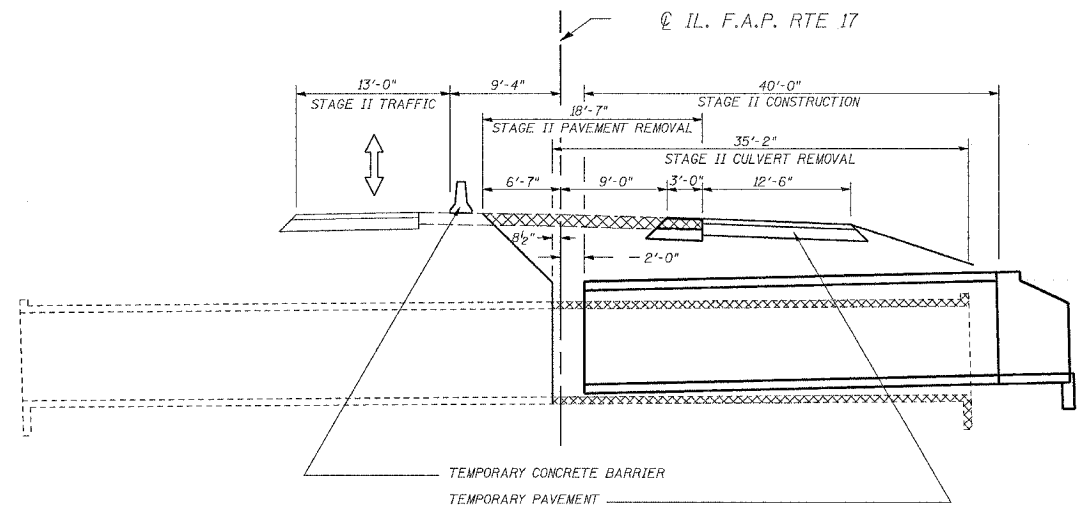
STAGE IA CONSTRUCTION

ALL DIMENSIONS MEASURED PERPENDICULAR TO C OF ROADWAY



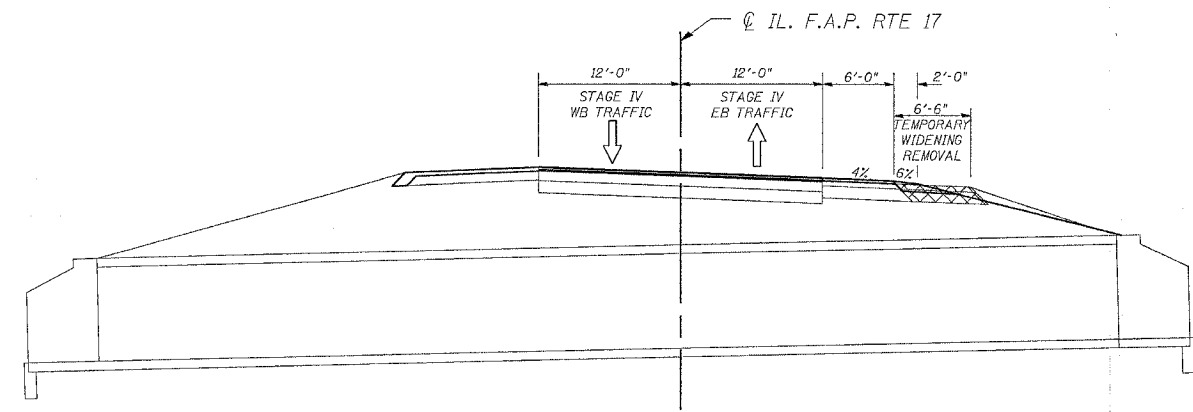
STAGE III REMOVAL AND CONSTRUCTION
