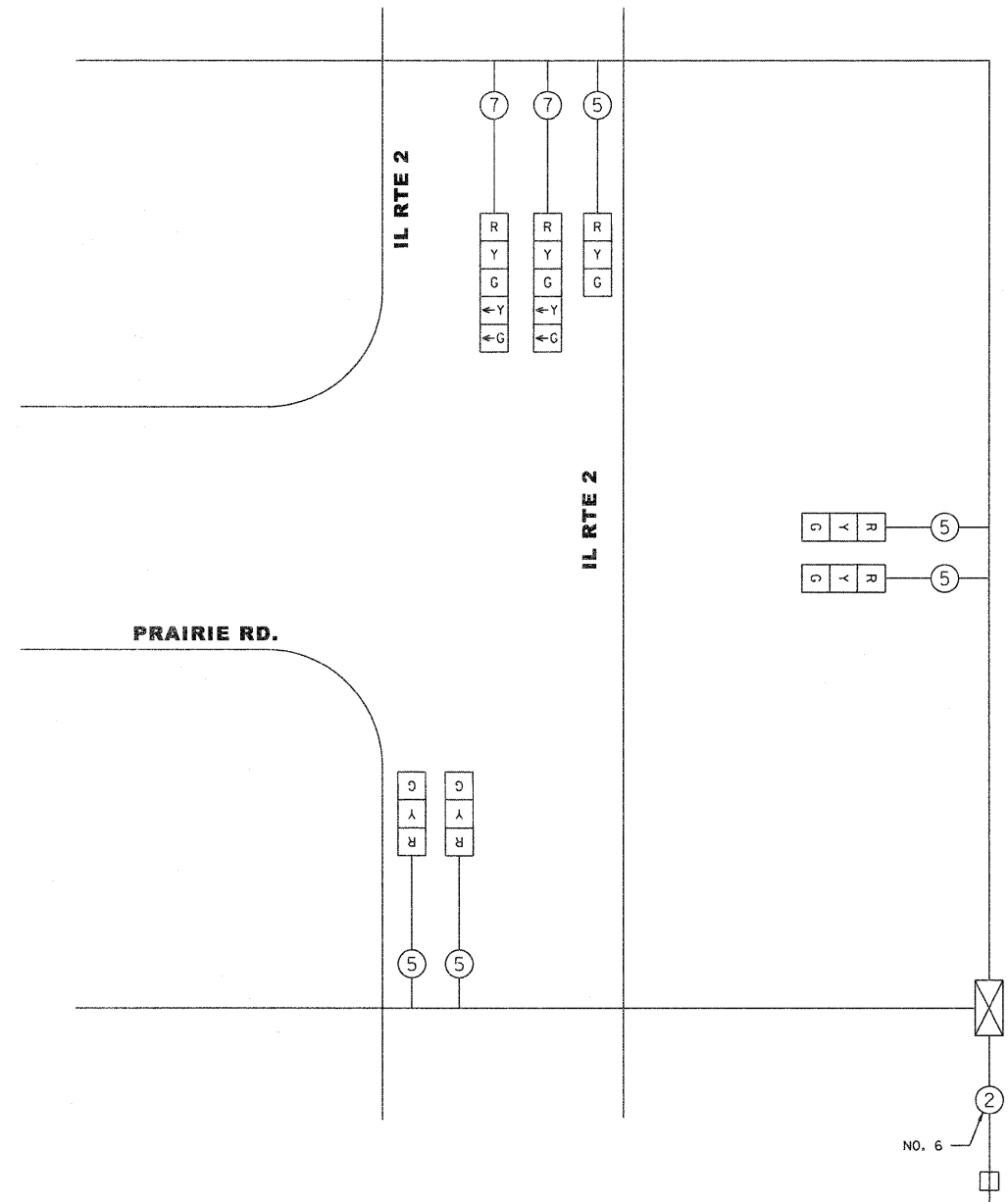
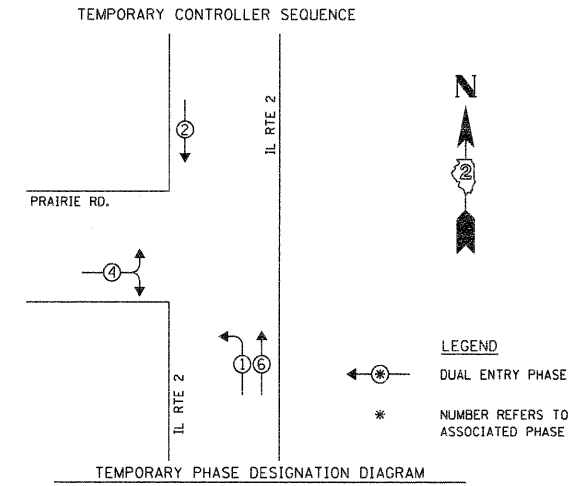


ANY TRAFFIC SIGNAL CONTROL EQUIPMENT DAMAGED OR NOT OPERATING PROPERLY FROM ANY CAUSE WHATSOEVER SHALL BE REPAIRED WITH NEW EQUIPMENT PROVIDED BY THE CONTRACTOR AT NO ADDITIONAL COST TO THE CONTRACT AND OR OWNER OF THE TRAFFIC SIGNAL SYSTEM, ALL AS APPROVED BY THE ENGINEER.

RESTORATION OF WORK AREA. RESTORATION OF THE TRAFFIC SIGNAL WORK AREA SHALL BE INCIDENTAL TO THE RELATED PAY ITEM SUCH AS FOUNDATION, CONDUIT, HANDHOLE, TRENCH AND BACKFILL, ETC., AND NO EXTRA COMPENSATION SHALL BE ALLOWED. ALL ROADWAY SURFACES SUCH AS SHOULDERS, MEDIANS, SIDEWALKS, PAVEMENT, ETC. SHALL BE REPLACED IN KIND. ALL DAMAGE TO MOWED LAWNS SHALL BE REPLACED WITH AN APPROVED SOD, AND ALL DAMAGE TO UNMOWED FIELDS SHALL BE SEEDED IN ACCORDANCE WITH STANDARD SPECIFICATIONS 252 AND 250 RESPECTIVELY.
