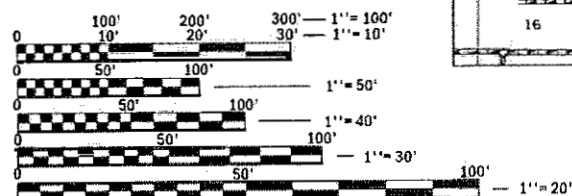

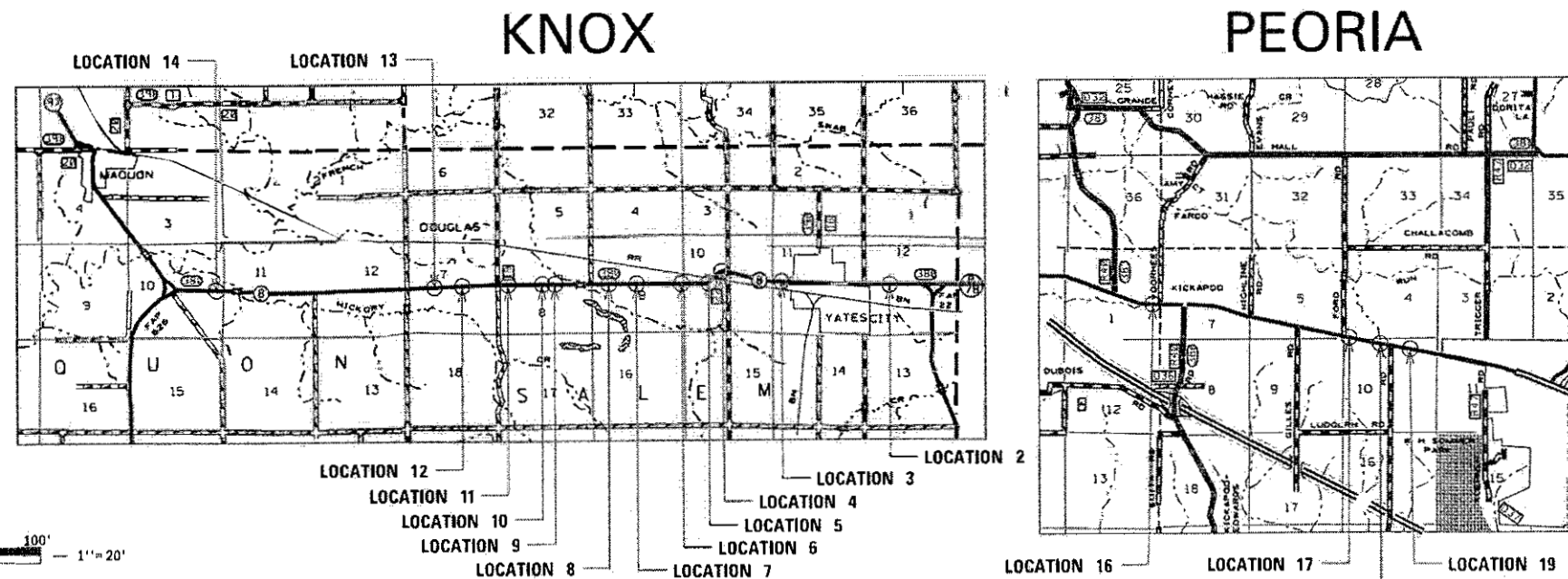

GENERAL NOTES

AVAILABILITY OF ELECTRONIC FILES

Micro Station and GEOPAK files of this project will be made available to the Contractor after contract award. If there is a conflict between the electronic files and the printed contract plans and documents, the printed contract plans and documents shall take precedence over the electronic files. The Contractor shall accept all risk associated with using the electronic files and shall hold the Department harmless for any errors or omissions in the electronic files and the data contained therein. Errors or delays resulting from the use of the electronic files by the Contractor shall not result in an extension of time for any interim or final completion date or shall not be considered cause for additional compensation. The Contractor shall not use, share, or distribute these electronic files except for the purpose of constructing this contract. Any claims by third parties due to use or errors shall be the responsibility of the Contractor. The Contractor shall include this disclaimer with the transfer of these electronic files to any other parties and shall include appropriate language binding them to similar responsibilities.

PROPERTY OWNER ACCESS REQUIREMENTS

Access must be maintained to all existing properties during construction per Article 107.09 unless arrangements are made in writing by the Contractor with the property owners with a copy to the Engineer for short-term closures.

CRITICAL PATH WORK SCHEDULE REQUIREMENT

The Contractor will submit to the Engineer a satisfactory progress schedule and critical path schedule which shall show the proposed sequence of work at the time of the pre-construction conference.

AGGREGATE FOR DRIVEWAY REPLACEMENT

The material used for construction of permanent aggregate driveways shall be gravel or crushed stone as directed by the Engineer, to replace in kind the existing aggregate driveways.

No additional compensation shall be provided for this requirement but shall be considered as included in the cost of the pay item for the aggregate as specified on the plans.

ORDERING LENGTH CONFIRMATION – DRAINAGE ITEMS

The Contractor shall consult with the Engineer in regard to the exact length of the box/pipe culverts, storm sewers, and/or pipe drains required prior to ordering these items.

ENVIRONMENTAL REVIEWS

Prior to the use of any proposed borrow areas, use areas (temporary access roads, detours, run-arounds, etc.) and/or waste areas, the Contractor shall file the required environmental resource request surveys according to Section 107.22 of the Standard Specifications. These surveys are required in order for the Department to conduct cultural and biological resource surveys for the proposed site.

Prior to any waste materials being removed from the construction site the required environmental resource surveys will need to be obtained and filed by the Contractor. Excess waste products removed from the construction site shall be disposed of as required in Section 202.03 of the Standard Specifications.

Any protruding metal bars shall be removed prior to the disposal of broken concrete at approved disposal sites.

The required environmental resource documentation shall include the following:

- * BDE Form 2289 (Environmental Survey Request)
- * BDE Form 2290 (Waste/Use Area Review)
- * A location map showing the size limits and location of the use area
- * Color photographs depicting the use area
- * Borrow Area Entry Agreement form-D4 PI0101

Please note that a minimum of four weeks shall be allowed for the District to obtain the required environmental clearances and six weeks for the required borrow site environmental clearances.

GENERAL NOTES (CONT.)

EXISTING DRAINAGE PIPES CONNECTED TO NEW STRUCTURES

In accordance with Section 602 of the Standard Specifications, the connecting of existing drain tiles, pipe culverts, or storm sewers to the proposed drainage system structures will not be paid for separately but shall be considered as included in the pay items provided.

RAILROAD FLAGGERS

Railroad Flaggers shall be paid according to Art. 109.05.

NO PASSING ZONE VERIFICATION

The resident shall contact Operations to verify the location of no passing zones prior to placement of centerline striping.

JOB SPECIFIC NOTES

TREE REMOVAL

Resident Engineer will keep track of the total number of removed trees to be included in the tree bank by District Landscape Architect.

DRAINAGE STRUCTURE RELOCATIONS

All field tile stand pipes or drop boxes shall be relocated with the coordination with the property owners. All work will be paid for under art. 109.04

EXISTING UTILITIES

All existing utilities shown in the plans and the cross sections are for information only. The offset and depth shown is approximate. The contractor needs to verify the location of all the utilities shown by calling JULIE.

ENDANGERED SPECIES

Station 1912+15 on IL 8 was identified as a suitable habitat for two species of bats listed as endangered. This location is outside of project limits, and will not be disturbed by construction activities.

COMMITMENTS

Commitments are not to be altered without the written approval of all parties to which the commitment was made.

A commitment has been made to Ms. Sarah J. McKeighan (Parcel No. 4AJF003) that all erosion control for this site will be maintained during construction of the project. Also, any tile outlets encountered during construction will be reinstalled to IDOT specifications.

A commitment has been made to Mr. and Mrs. Dennis E. Ramp (Parcel No. 4AJF005) that the property owner shall be contacted ten (10) days prior to any excavation on the property. Also, the contractor shall take care not to damage the existing field tile and shall be responsible for any damages incurred during the project.

A commitment has been made to Mr. and Mrs. Michael D. Thurman (Parcel 4AJF006) that all erosion control for this site will be maintained during construction of the project. Also, any tile outlets encountered during construction will be reinstalled to IDOT specifications.

A commitment has been made to Mr. and Mrs. Michael D. Thurman (Parcel 4AJF006) that the property owner shall be contacted ten (10) days prior to any excavation on the property. Also, the contractor shall take care not to damage the existing field tile and shall be responsible for any damages incurred during the project.

A commitment has been made to Mr. and Mrs. James A. Stone (Parcel No. 4AJF032) that the pile of topsoil located on the east side of the creek where the existing and proposed right of way meet, (Station 442+50.00, Offset 55.00 ft Right) shall not be disturbed.

A commitment has been made to Mr. and Mrs. John and Christine Gilles (Parcel No. 4AJF031) that Mr. and Mrs. John and Christine Gilles will be contacted by April 1st, 2018, in order to discuss the project timeline with the State Resident Engineer. The Engineer will contact Mr. and Mrs. Gilles at home number (309) 691-2086 or Mrs. Christine Gilles at cell number (309) 635-5555.

A commitment has been made to Mr. Dave Shipley (Parcel No. 4AJF010) that any field tile intercepted or disturbed during construction will be replaced or repaired. Also, Mr. Shipley will be contacted ten (10) days prior to construction on his land, in order to discuss the previously mentioned field tile with the State Resident Engineer at phone number (309) 369-5343.

A commitment has been made to Ms. Donna A. Coffman (Parcel No. 4AJF004) that the field entrance on the south side of IL 8 and approximately 1,550 feet east of Knox County Road 1800 E (Sta. 1799+50) shall be removed and replaced. The existing 20 feet wide access will be upgraded to a 30 feet wide field entrance. Access shall be maintained throughout construction. Also, Ms. Coffman shall be allowed to remove the six inch riser located within the right of way area. To allow for this, the property owner shall be notified ten (10) days in advance of any earthwork to be performed at this location.

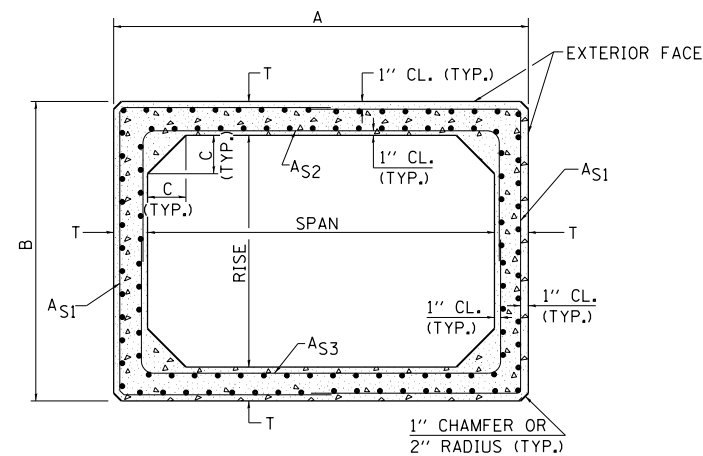

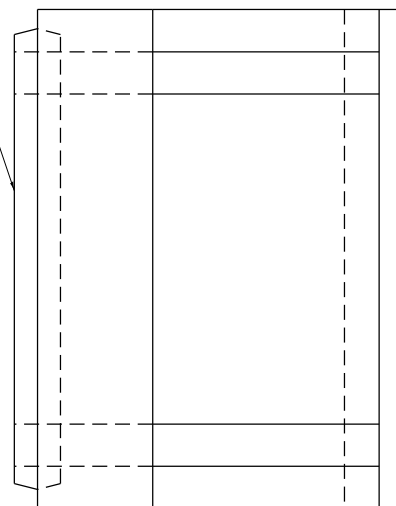

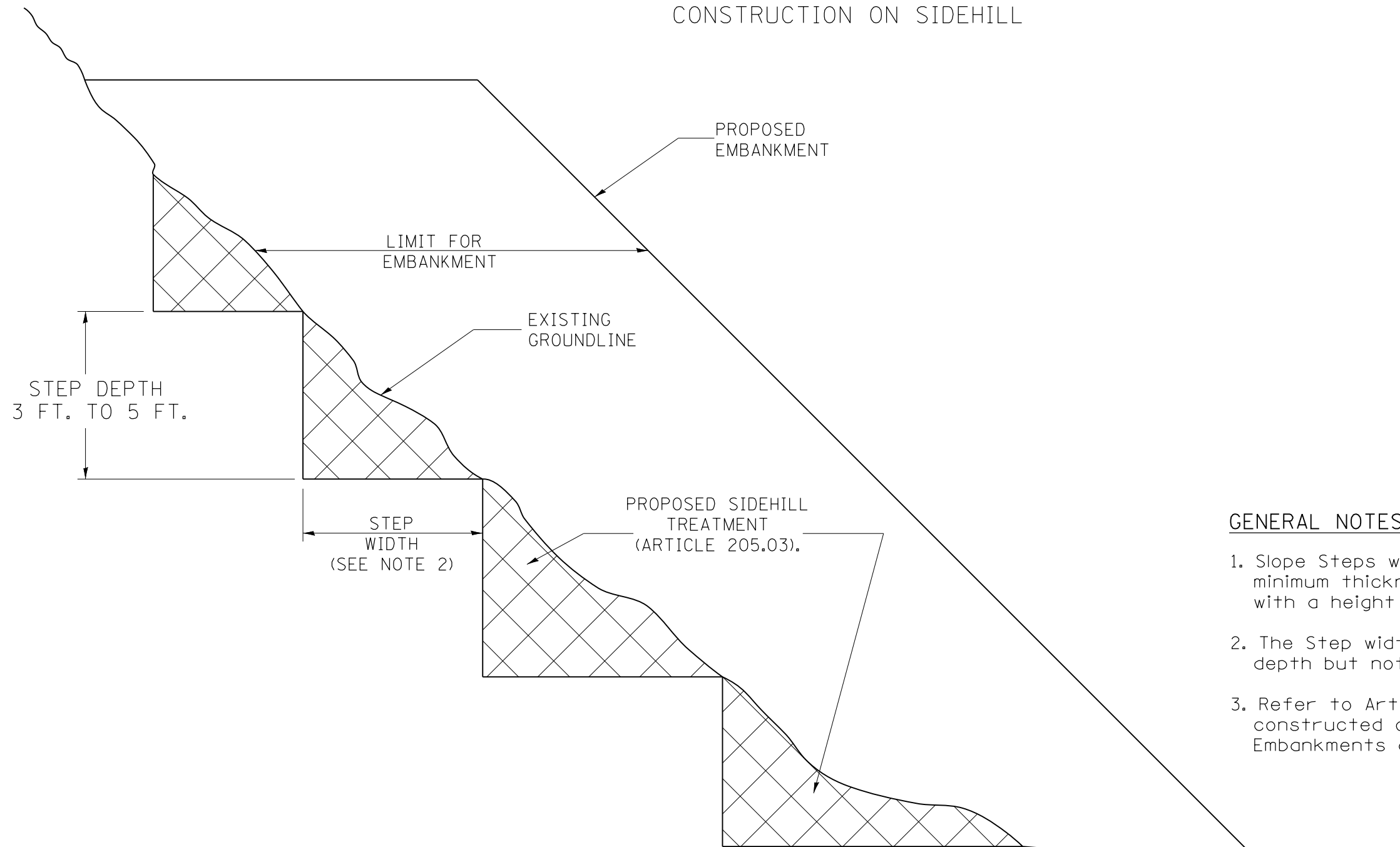

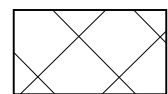
TYPICAL CROSS-SECTION EMBANKMENT CONSTRUCTION ON SIDEHILL

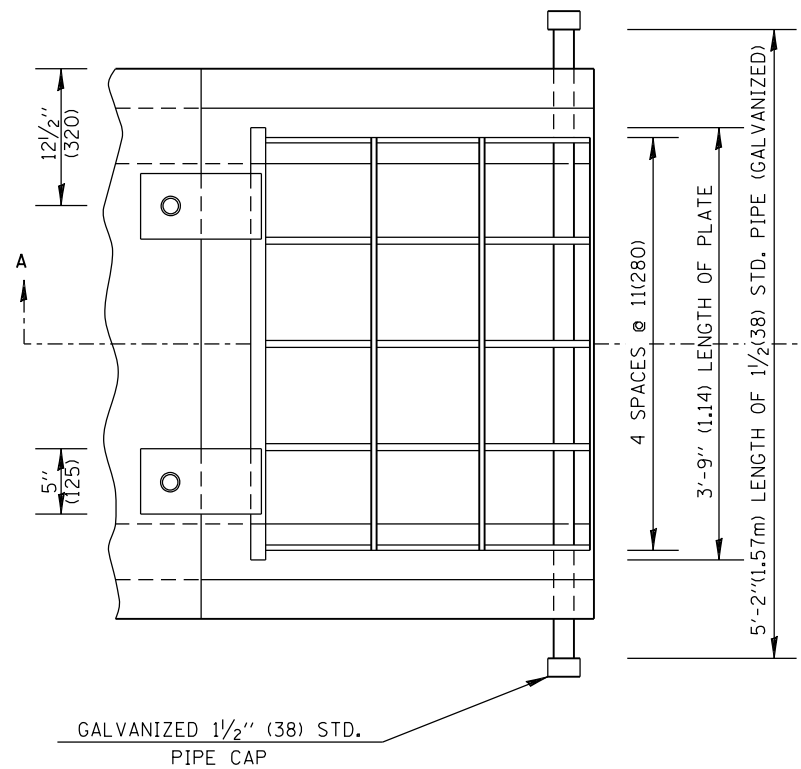

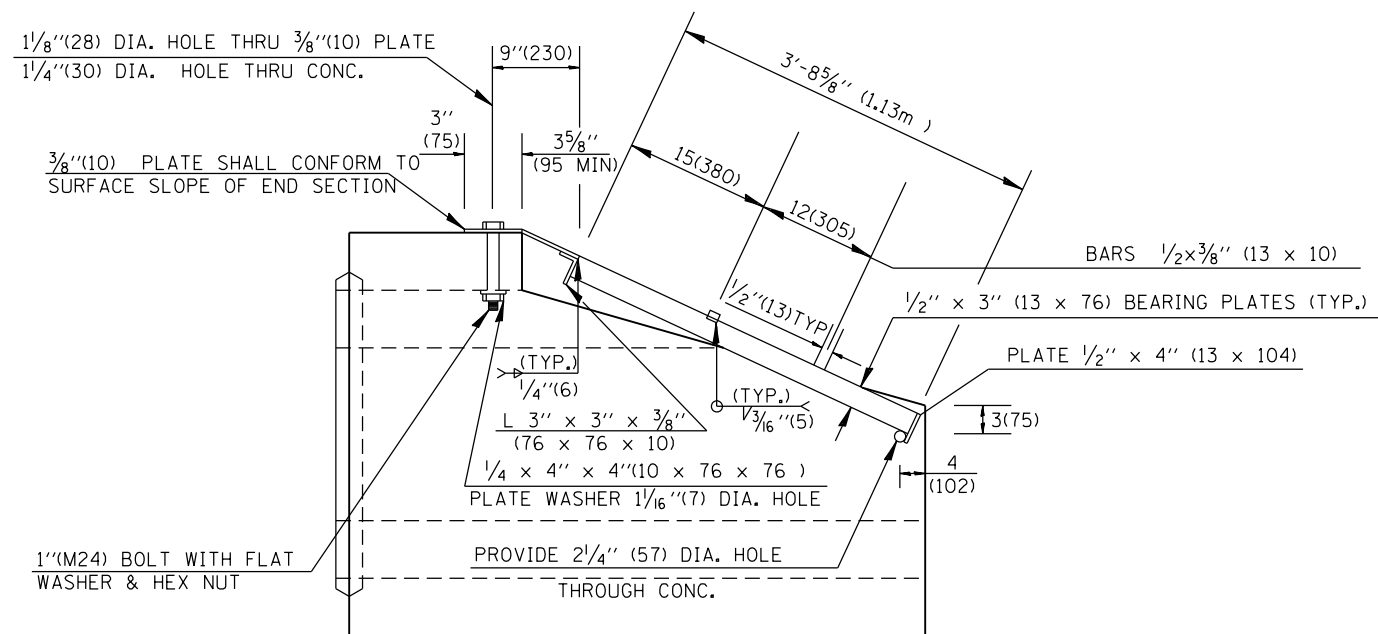
