BID PROPOSAL INSTRUCTIONS

ABOUT IDOT PROPOSALS: All proposals are potential bidding proposals. Each proposal contains all certifications and affidavits, a proposal signature sheet and a proposal bid bond.

PREQUALIFICATION

Any contractor who desires to become pre-qualified to bid on work advertised by IDOT must submit the properly completed pre-qualification forms to the Bureau of Construction no later than 4:30 p.m. prevailing time twenty-one days prior to the letting of interest. This pre-qualification requirement applies to first time contractors, contractors renewing expired ratings, contractors maintaining continuous pre-qualification or contractors requesting revised ratings. To be eligible to bid, existing pre-qualification ratings must be effective through the date of letting.

WHO CAN BID?

Bids will be accepted from only those companies that request and receive written Authorization to Bid from IDOT's Central Bureau of Construction.

REQUESTS FOR AUTHORIZATION TO BID

Contractors wanting to bid on items included in a particular letting must submit the properly completed "Request for Authorization to Bid/or Not For Bid Status" (BDE 124) and the ORIGINAL "Affidavit of Availability" (BC 57) to the proper office no later than 4:30 p.m. prevailing time, three (3) days prior to the letting date.

WHAT CONSTITUTES WRITTEN AUTHORIZATION TO BID?

When a prospective prime bidder submits a "Request for Authorization to Bid/or Not For Bid Status" (BDE 124) he/she must indicate at that time which items are being requested For Bidding purposes. Only those items requested For Bidding will be analyzed. After the request has been analyzed, the bidder will be issued an **Authorization to Bid or Not for Bid Report**, approved by the Central Bureau of Construction and the Chief Procurement Officer that indicates which items have been approved For Bidding. If **Authorization to Bid** cannot be approved, the **Authorization to Bid or Not for Bid Report** will indicate the reason for denial.

ABOUT AUTHORIZATION TO BID

Firms that have not received an Authorization to Bid or Not For Bid Report within a reasonable time of complete and correct original document submittal should contact the Department as to the status. Firms unsure as to authorization status should call the Prequalification Section of the Bureau of Construction at the number listed at the end of these instructions.

ADDENDA AND REVISIONS

It is the bidder's responsibility to determine which, if any, addenda or revisions pertain to any project they may be bidding. Failure to incorporate all relevant addenda or revisions may cause the bid to be declared unacceptable.

Each addendum or revision will be included with the Electronic Plans and Proposals. Addenda and revisions will also be placed on the Addendum/Revision Checklist and each subscription service subscriber will be notified by e-mail of each addendum and revision issued.

The Internet is the Department's primary way of doing business. The subscription service emails are an added courtesy the Department provides. It is suggested that bidders check IDOT's website at http://www.idot.illinois.gov/doing-business/procurements/construction-services/construction-bulletins/transportation-bulletin/index#TransportationBulletin before submitting final bid information.

STANDARD GUIDELINES FOR SUBMITTING PAPER BIDS

- All pages should be single sided.
- Use the Cover Page that is provided in the Bid Proposal (posted on the IDOT Web Site) as the first page of your submitted bid. It has the item number in large bold type in the upper left-hand corner and lines provided for your company name and address in the upper right-hand corner.
- Do not use report covers, presentation folders or special bindings and do not staple multiple times on left side like a book. Use only 1 staple in the upper left hand corner. Make sure all elements of your bid are stapled together including the bid bond or guaranty check (if required).
- Do not include any certificates of eligibility, your authorization to bid, Addendum Letters or affidavit of availability.
- Do not include the Subcontractor Documentation with your bid (pages i iii and pages a g). This documentation is required only if you are awarded the project.
- Use the envelope cover sheet (provided with the proposal) as the cover for the proposal envelope.
- Do not rely on overnight services to deliver your proposal prior to 10 AM on letting day. It will not be read if it is delivered after 10 AM.
- Do not submit your Substance Abuse Prevention Program (SAPP) with your bid. If you are awarded the contract this form is to be submitted to the district engineer at the pre-construction conference.

BID SUBMITTAL CHECKLIST

Cover page (the sheet that has the item number on it) – This should be the first page of your bid proposal, followed by your bid (the Schedule of Prices/Pay Items). If you are using special software or CBID to generate your schedule of prices, <u>do not include the blank pages of the schedule of prices that came with the proposal package.</u>
Page 4 (Item 9) – Check "YES" if you will use a subcontractor(s) with an annual value over \$50,000. Include the subcontractor(s) name, address, general type of work to be performed and the dollar amount. If you will use subcontractor(s) but are uncertain who or the dollar amount; check "YES" but leave the lines blank.
After page 4 – Insert the following documents: Cost Adjustments for Steel, Bituminous and Fuel (if applicable) and the Contractor Letter of Assent (if applicable). The general rule should be, if you don't know where it goes, put it after page 4.
Page 10 (Paragraph J) - Check "YES" or "NO" whether your company has any business in Iran.
Page 10 (Paragraph K) – (Not applicable to federally funded projects) List the name of the apprenticeship and training program sponsor holding the certificate of registration from the US Department of Labor. If no applicable program exists, please indicate the work/job category. Do not include certificates with your bid. Keep the certificates in your office in case they are requested by IDOT.
Page 11 (Paragraph L) – Your State Board of Elections certificate of registration is no longer required with your bid.
Page 11 (Paragraph M) – Indicate if your company has hired a lobbyist in connection with the job for which you are submitting the bid proposal.
Page 12 (Paragraph C) – This is a work sheet to determine if a completed Form A is required. It is not part of the form and you do not need to make copies for each completed Form A.
Pages 14-17 (Form A) – One Form A (4 pages) is required for each applicable person in your company. Copies of the forms can be used and only need to be changed when the information changes. The certification signature and date must be original for each letting. Do not staple the forms together. If you answered "NO" to all of the questions in Paragraph C (page 12), complete the first section (page 14) with your company information and then sign and date the Not Applicable statement on page 17.
Page 18 (Form B) - If you check "YES" to having other current or pending contracts it is acceptable to use the phrase, "See Affidavit of Availability on file". Ownership Certification (at the bottom of the page) - Check N/A if the Form A(s) you submitted accounts for 100 percent of the company ownership. Check YES if any percentage of ownership falls outside of the parameters that require reporting on the Form A. Checking NO indicates that the Form A(s) you submitted is not correct and you will be required to submit a revised Form A.
Page 20 (Workforce Projection) – Be sure to include the Duration of the Project. It is acceptable to use the phrase "Per Contract Specifications".

☐ Proposal Bid Bond – (Insert after the proposal signature page) Submit your Proposal Bid Bond (if applicable) using the current Proposal Bid Bond form provided in the proposal package. The Power of Attorney page should be stapled to the Proposal Bid Bond. If you are using an electronic bond, include your bid bond number on the Proposal Bid Bond and attach the Proof of Insurance printed from the Surety's Web Site.
Disadvantaged Business Utilization Plan and/or Good Faith Effort – Do Not Submit with Bid The bidder shall submit an Disadvantaged Business Utilization Plan on completed Department forms SBE 2025 and 2026. (1) The final Utilization Plan must be submitted within five calendar days after the date of the letting. STATE REQUIRED ETHICAL STANDARDS GOVERNING CONTRACT PROCUREMENT: ASSURANCES, CERTIFICATIONS AND DISCLOSURES

I. GENERAL

- **A.** Article 50 of the Code establishes the duty of all State CPOs, SPOs, and their designees to maximize the value of the expenditure of public moneys in procuring goods, services, and contracts for the State of Illinois and to act in a manner that maintains the integrity and public trust of State government. In discharging this duty, they are charged by law to use all available information, reasonable efforts, and reasonable actions to protect, safeguard, and maintain the procurement process of the State of Illinois.
- **B.** In order to comply with the provisions of Article 50 and to carry out the duty established therein, all bidders are to adhere to ethical standards established for the procurement process, and to make such assurances, disclosures and certifications required by law. Except as otherwise required in subsection III, paragraphs J-M, by execution of the Proposal Signature Sheet, the bidder indicates that each of the mandated assurances have been read and understood, that each certification is made and understood, and that each disclosure requirement has been understood and completed.
- **C.** In addition to all other remedies provided by law, failure to comply with any assurance, failure to make any disclosure or the making of a false certification shall be grounds for the CPO to void the contract, and may result in the suspension or debarment of the bidder or subcontractor. If a false certification is made by a subcontractor the contractor's submitted bid and the executed contract may not be declared void unless the contractor refuses to terminate the subcontract upon the State's request after a finding that the subcontractor's certification was false.

II. ASSURANCES

The assurances hereinafter made by the bidder are each a material representation of fact upon which reliance is placed should the Department enter into the contract with the bidder.

A. Conflicts of Interest

Section 50-13. Conflicts of Interest.

- (a) Prohibition. It is unlawful for any person holding an elective office in this State, holding a seat in the General Assembly, or appointed to or employed in any of the offices or agencies of state government and who receives compensation for such employment in excess of 60% of the salary of the Governor of the State of Illinois, or who is an officer or employee of the Capital Development Board or the Illinois State Toll Highway Authority, or who is the spouse or minor child of any such person to have or acquire any contract, or any direct pecuniary interest in any contract therein, whether for stationery, printing, paper, or any services, materials, or supplies, that will be wholly or partially satisfied by the payment of funds appropriated by the General Assembly of the State of Illinois or in any contract of the Capital Development Board or the Illinois State Toll Highway Authority.
- (b) Interests. It is unlawful for any firm, partnership, association or corporation, in which any person listed in subsection (a) is entitled to receive (i) more than 7 1/2% of the total distributable income or (ii) an amount in excess of the salary of the Governor, to have or acquire any such contract or direct pecuniary interest therein.
- (c) Combined interests. It is unlawful for any firm, partnership, association, or corporation, in which any person listed in subsection (a) together with his or her spouse or minor children is entitled to receive (i) more than 15%, in the aggregate, of the total distributable income or (ii) an amount in excess of 2 times the salary of the Governor, to have or acquire any such contract or direct pecuniary interest therein.
- (d) Securities. Nothing in this Section invalidates the provisions of any bond or other security previously offered or to be offered for sale or sold by or for the State of Illinois.
- (e) Prior interests. This Section does not affect the validity of any contract made between the State and an officer or employee of the State or member of the General Assembly, his or her spouse, minor child or any combination of those persons if that contract was in existence before his or her election or employment as an officer, member, or employee. The contract is voidable, however, if it cannot be completed within 365 calendar days after the officer, member, or employee takes office or is employed. The current salary of the Governor is \$177,412.00. Sixty percent of the salary is \$106,447.20.

The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-13, or that an effective exemption has been issued by the Board of Ethics to any individual subject to the Section 50-13 prohibitions pursuant to the provisions of Section 50-20 of the Code. Information concerning the exemption process is available from the Department upon request.

B. Negotiations

Section 50-15. Negotiations.

It is unlawful for any person employed in or on a continual contractual relationship with any of the offices or agencies of State government to participate in contract negotiations on behalf of that office or agency with any firm, partnership, association, or corporation with whom that person has a contract for future employment or is negotiating concerning possible future employment.

The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-15, and that the bidder has no knowledge of any facts relevant to the kinds of acts prohibited therein.

C. Inducements

Section 50-25. Inducement.

Any person who offers or pays any money or other valuable thing to any person to induce him or her not to provide a submission to a vendor portal or to bid for a State contract or as recompense for not having bid on a State contract is guilty of a Class 4 felony. Any person who accepts any money or other valuable thing for not bidding for a State contract, not making a submission to a vendor portal, or who withholds a bid or submission to a vendor portal in consideration of the promise for the payment of money or other valuable thing is guilty of a Class 4 felony.

The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-25, and that the bidder has no knowledge of any facts relevant to the kinds of acts prohibited therein.

D. Revolving Door Prohibition

Section 50-30. Revolving door prohibition.

CPOs, SPOs, procurement compliance monitors, their designees whose principal duties are directly related to State procurement, and executive officers confirmed by the Senate are expressly prohibited for a period of 2 years after terminating an affected position from engaging in any procurement activity relating to the State agency most recently employing them in an affected position for a period of at least 6 months. The prohibition includes, but is not limited to: lobbying the procurement process; specifying; bidding; proposing bid, proposal, or contract documents; on their own behalf or on behalf of any firm, partnership, association, or corporation. This Section applies only to persons who terminate an affected position on or after January 15, 1999.

The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-30, and that the bidder has no knowledge of any facts relevant to the kinds of acts prohibited therein.

E. Reporting Anticompetitive Practices

Section 50-40. Reporting anticompetitive practices.

When, for any reason, any vendor, bidder, contractor, CPO, SPO, designee, elected official, or State employee suspects collusion or other anticompetitive practice among any bidders, offerors, contractors, proposers, or employees of the State, a notice of the relevant facts shall be transmitted to the Attorney General and the CPO.

The bidder assures the Department that it has not failed to report any relevant facts concerning the practices addressed in Section 50-40 which may involve the contract for which the bid or submission to a vendor portal is submitted.

F. Confidentiality

Section 50-45. Confidentiality.

Any CPO, SPO, designee, or executive officer who willfully uses or allows the use of specifications, competitive bid documents, proprietary competitive information, proposals, contracts, or selection information to compromise the fairness or integrity of the procurement, bidding, or contract process shall be subject to immediate dismissal, regardless of the Personnel code, any contract, or any collective bargaining agreement, and may in addition be subject to criminal prosecution.

The bidder assures the Department that it has no knowledge of any fact relevant to the practices addressed in Section 50-45 which may involve the contract for which the bid is submitted.

G. Insider Information

Section 50-50. Insider information.

It is unlawful for any current or former elected or appointed State official or State employee to knowingly use confidential information available only by virtue of that office or employment for actual or anticipated gain for themselves or another person.

The bidder assures the Department that it has no knowledge of any facts relevant to the practices addressed in Section 50-50 which may involve the contract for which the bid is submitted.

III. CERTIFICATIONS

The certifications hereinafter made by the bidder are each a material representation of fact upon which reliance is placed should the Department enter into the contract with the bidder. Section 50-2 of the Code provides that every person that has entered into a multi-year contract and every subcontractor with a multi-year subcontract shall certify, by July 1 of each fiscal year covered by the contract after the initial fiscal year, to the responsible CPO whether it continues to satisfy the requirements of Article 50 pertaining to the eligibility for a contract award. If a contractor or subcontractor is not able to truthfully certify that it continues to meet all requirements, it shall provide with its certification a detailed explanation of the circumstances leading to the change in certification status. A contractor or subcontractor that makes a false statement material to any given certification required under Article 50 is, in addition to any other penalties or consequences prescribed by law, subject to liability under the Whistleblower Reward and Protection Act for submission of a false claim.

A. Bribery

Section 50-5. Bribery.

- (a) Prohibition. No person or business shall be awarded a contract or subcontract under this Code who:
 - (1) has been convicted under the laws of Illinois or any other state of bribery or attempting to bribe an officer or employee of the State of Illinois or any other state in that officer's or employee's official capacity; or
 - (2) has made an admission of guilt of that conduct that is a matter of record but has not been prosecuted for that conduct.
- (b) Businesses. No business shall be barred from contracting with any unit of State or local government, or subcontracting under such a contract, as a result of a conviction under this Section of any employee or agent of the business if the employee or agent is no longer employed by the business and:
 - (1) the business has been finally adjudicated not guilty; or
 - (2) the business demonstrates to the governmental entity with which it seeks to contract, or which is signatory to the contract which the subcontract relates, and that entity finds that the commission of the offense was not authorized, requested, commanded, or performed by a director, officer, or high managerial agent on behalf of the business as provided in paragraph (2) of subsection (a) of Section 5-4 of the Criminal Code of 2012.
- (c) Conduct on behalf of business. For purposes of this Section, when an official, agent, or employee of a business committed the bribery or attempted bribery on behalf of the business and in accordance with the direction or authorization of a responsible official of the business, the business shall be chargeable with the conduct.
- (d) Certification. Every bid submitted to and contract executed by the State, and every subcontract subject to Section 20-120 of the Code shall contain a certification by the contractor or the subcontractor, respectively, that the contractor or subcontractor is not barred from being awarded a contract or subcontract under this Section and acknowledges that the CPO may declare the related contract void if any certifications required by this Section are false. A contractor who makes a false statement, material to the certification, commits a Class 3 felony.

The contractor or subcontractor certifies that it is not barred from being awarded a contract under Section 50-5.

B. Felons

Section 50-10. Felons.

- (a) Unless otherwise provided, no person or business convicted of a felony shall do business with the State of Illinois or any State agency, or enter into a subcontract, from the date of conviction until 5 years after the date of completion of the sentence for that felony, unless no person held responsible by a prosecutorial office for the facts upon which the conviction was based continues to have any involvement with the business.
- (b) Certification. Every bid submitted to and contract executed by the State and every subcontract subject to Section 20-120 of the Code and every vendor's submission to a vendor portal shall contain a certification by the bidder or contractor or subcontractor, respectively, that the bidder, contractor, or subcontractor is not barred from being awarded a contract or subcontract under this Section and acknowledges that the CPO may declare the related contract void if any of the certifications required by this Section are false.

C. Debt Delinquency

Section 50-11 and 50-12. Debt Delinquency.

The contractor or bidder or subcontractor, respectively, certifies that it, or any affiliate, is not barred from being awarded a contract or subcontract under the Code. Section 50-11 prohibits a person from entering into a contract with a State agency, or entering into a subcontract, if it knows or should know that it, or any affiliate, is delinquent in the payment of any debt to the State as defined by the Debt Collection Board. Section 50-12 prohibits a person from entering into a contract with a State agency, or entering into a subcontract, if it, or any affiliate, has failed to collect and remit Illinois Use Tax on all sales of tangible personal property into the State of Illinois in accordance with the provisions of the Illinois Use Tax Act. The bidder or contractor or subcontractor, respectively, further acknowledges that the CPO may declare the related contract void if this certification is false or if the bidder, contractor, or subcontractor, or any affiliate, is determined to be delinquent in the payment of any debt to the State during the term of the contract.

D. Prohibited Bidders, Contractors and Subcontractors

Section 50-10.5 and 50-60(c). Prohibited bidders, contractors and subcontractors.

The bidder or contractor or subcontractor, respectively, certifies in accordance with Section 50-10.5 that no officer, director, partner or other managerial agent of the contracting business has been convicted of a felony under the Sarbanes-Oxley Act of 2002 or a Class 3 or Class 2 felony under the Illinois Securities Law of 1953 or if in violation of Subsection (c) for a period of five years from the date of conviction. Every bid submitted to and contract executed by the State and every subcontract subject to Section 20-120 of the Code shall contain a certification by the bidder, contractor, or subcontractor, respectively, that the bidder, contractor, or subcontract under this Section and acknowledges that the CPO shall declare the related contract void if any of the certifications completed pursuant to this Section are false.

E. Section 42 of the Environmental Protection Act

Section 50-14 Environmental Protection Act violations.

The bidder or contractor or subcontractor, respectively, certifies in accordance with Section 50-14 that the bidder, contractor, or subcontractor, is not barred from being awarded a contract or entering into a subcontract under this Section which prohibits the bidding on or entering into contracts with the State of Illinois or a State agency, or entering into any subcontract, that is subject to the Code by a person or business found by a court or the Pollution Control Board to have committed a willful or knowing violation of Section 42 of the Environmental Protection Act for a period of five years from the date of the order. The bidder or contractor or subcontractor, respectively, acknowledges that the CPO may declare the contract void if this certification is false.

F. Educational Loan

Section 3 of the Educational Loan Default Act, 5 ILCS 385/3.

Pursuant to the Educational Loan Default Act no State agency shall contract with an individual for goods or services if that individual is in default on an educational loan.

The bidder, if an individual as opposed to a corporation, partnership or other form of business organization, certifies that the bidder is not in default on an educational loan as provided in Section 3 of the Act.

G. Bid-Rigging/Bid Rotating

Section 33E-11 of the Criminal Code of 2012, 720 ILCS 5/3BE-11.

- (a) Every bid submitted to and public contract executed pursuant to such bid by the State or a unit of local government shall contain a certification by the prime contractor that the prime contractor is not barred from contracting with any unit of State or local government as a result of a violation of either Section 33E-3 or 33E-4 of this Article.
- (b) A contractor who makes a false statement, material to the certification, commits a Class 3 felony.

A violation of Section 33E-3 would be represented by a conviction of the crime of bid-rigging which, in addition to Class 3 felony sentencing, provides that any person convicted of this offense or any similar offense of any state or the United States which contains the same elements as this offense shall be barred for 5 years from the date of conviction from contracting with any unit of State or local government. No corporation shall be barred from contracting with any unit of State or local government as a result of a conviction under this Section of any employee or agent of such corporation if the employee so convicted is no longer employed by the corporation and: (1) it has been finally adjudicated not guilty or (2) if it demonstrates to the governmental entity with which it seeks to contract and that entity finds that the commission of the offense was neither authorized, requested, commanded, nor performed by a director, officer or a high managerial agent in behalf of the corporation.

The bidder certifies that it is not barred from contracting with the Department by reason of a violation of either Section 33E-3 or Section 33E-4.

H. International Anti-Boycott

Section 5 of the International Anti-Boycott Certification Act provides every contract entered into by the State of Illinois for the manufacture, furnishing, or purchasing of supplies, material, or equipment or for the furnishing of work, labor, or services, in an amount exceeding the threshold for small purchases according to the purchasing laws of this State or \$10,000.00, whichever is less, shall contain certification, as a material condition of the contract, by which the contractor agrees that neither the contractor nor any substantially-owned affiliated company is participating or shall participate in an international boycott in violation of the provisions of the U.S. Export Administration Act of 1979 or the regulations of the U.S. Department of Commerce promulgated under that Act.

The bidder makes the certification set forth in Section 5 of the Act.

I. Drug Free Workplace

The Illinois "Drug Free Workplace Act" applies to this contract and it is necessary to comply with the provisions of the "Act" if the contractor is a corporation, partnership, or other entity (including a sole proprietorship) which has 25 or more employees.

The bidder certifies that if awarded a contract in excess of \$5,000 it will provide a drug free workplace in compliance with the provisions of the Act.

J. Disclosure of Business Operations in Iran

Section 50-36 of the Code provides that each bid, offer, or proposal submitted for a State contract shall include a disclosure of whether or not the Company acting as the bidder, offeror, or proposing entity, or any of its corporate parents or subsidiaries, within the 24 months before submission of the bid, offer, or proposal had business operations that involved contracts with or provision of supplies or services to the Government of Iran, companies in which the Government of Iran has any direct or indirect equity share, consortiums or projects commissioned by the Government of Iran, or companies involved in consortiums or projects commissioned by the Government of Iran and either of the following conditions apply:

- (1) More than 10% of the Company's revenues produced in or assets located in Iran involve oil-related activities or mineral-extraction activities; less than 75% of the Company's revenues produced in or assets located in Iran involve contracts with or provision of oil-related or mineral-extraction products or services to the Government of Iran or a project or consortium created exclusively by that government; and the Company has failed to take substantial action.
- (2) The Company has, on or after August 5, 1996, made an investment of \$20 million or more, or any combination of investments of at least \$10 million each that in the aggregate equals or exceeds \$20 million in any 12-month period, which directly or significantly contributes to the enhancement of Iran's ability to develop petroleum resources of Iran.

The terms "Business operations", "Company", "Mineral-extraction activities", "Oil-related activities", "Petroleum resources", and "Substantial action" are all defined in the Code.

Failure to make the disclosure required by the Code may cause the bid, offer or proposal to be considered not responsive. The disclosure will be considered when evaluating the bid or awarding the contract. The name of each Company disclosed as doing business or having done business in Iran will be provided to the State Comptroller.

Check the appro	priate statement:

K. Apprenticeship and Training Certification (Does not apply to federal aid projects)

In accordance with the provisions of Section 30-22 (6) of the Code, the bidder certifies that it is a participant, either as an individual or as part of a group program, in the approved apprenticeship and training programs applicable to each type of work or craft that the bidder will perform with its own forces. The bidder further certifies for work that will be performed by subcontract that each of its subcontractors submitted for approval either (a) is, at the time of such bid, participating in an approved, applicable apprenticeship and training program; or (b) will, prior to commencement of performance of work pursuant to this contract, begin participation in an approved apprenticeship and training program applicable to the work of the subcontract. The Department, at any time before or after award, may require the production of a copy of each applicable Certificate of Registration issued by the United States Department of Labor evidencing such participation by the contractor and any or all of its subcontractors. Applicable apprenticeship and training programs are those that have been approved and registered with the United States Department of Labor. The bidder shall list in the space below, the official name of the program sponsor holding the Certificate of Registration for all of the types of work or crafts in which the bidder is a participant and that will be performed with the bidder's forces. Types of work or craft work that will be subcontracted shall be included and listed as subcontract work. The list shall also indicate any type of work or craft job category that does not have an applicable apprenticeship or training program. The bidder is responsible for making a complete report and shall make certain that each type of work or craft job category that will be utilized on the project as reported on the Construction Employee Workforce Projection (Form BC-1256) and returned with the bid is accounted for and listed.

Addtionally, Section 30-22 of the Code requires that the bidder certify that an Illinois office be maintained as the primary place of employment for persons employed for this contract.

NA-FEDERAL_	

The requirements of these certifications and disclosures are a material part of the contract, and the contractor shall require these certification provisions to be included in all approved subcontracts. In order to fulfill this requirement, it shall not be necessary that an applicable program sponsor be currently taking, or that it will take applications for apprenticeship, training or employment during the performance of the work of this contract.

L. Political Contributions and Registration with the State Board of Elections

Sections 20-160 and 50-37 of the Code regulate political contributions from business entities and any affiliated entities or affiliated persons bidding on or contracting with the state. Generally under Section 50-37, any business entity, and any affiliated entity or affiliated person of the business entity, whose current year contracts with all state agencies exceed an awarded value of \$50,000, are prohibited from making any contributions to any political committees established to promote the candidacy of the officeholder responsible for the awarding of the contracts or any other declared candidate for that office for the duration of the term of office of the incumbent officeholder or a period 2 years after the termination of the contract, whichever is longer. Any business entity and affiliated entities or affiliated persons whose state contracts in the current year do not exceed an awarded value of \$50,000, but whose aggregate pending bids and proposals on state contracts exceed \$50,000, either alone or in combination with contracts not exceeding \$50,000, are prohibited from making any political contributions to any political committee established to promote the candidacy of the officeholder responsible for awarding the pending contract during the period beginning on the date the invitation for bids or request for proposals or any other procurement opportunity is issued and ending on the day after the date of award or selection if the entity was not awarded or selected. Section 20-160 requires certification of registration of affected business entities in accordance with procedures found in Section 9-35 of The Election Code.

By submission of a bid, the contractor business entity acknowledges and agrees that it has read and understands Sections 20-160 and 50-37 of the Code, and that it makes the following certification:

The undersigned bidder certifies that it has registered as a business with the State Board of Elections and acknowledges a continuing duty to update the registration in accordance with the above referenced statutes. If the business entity is required to register, the CPO shall verify that it is in compliance on the date the bid or proposal is due. The CPO shall not accept a bid or proposal if the business entity is not in compliance with the registration requirements.

These requirements and compliance with the above referenced statutory sections are a material part of the contract, and any breach thereof shall be cause to void the contract under Section 50-60 of the Code. This provision does not apply to Federal-aid contracts.

M. Lobbyist Disclosure

Section 50-38 of the Code requires that any bidder or offeror on a State contract that hires a person required to register under the Lobbyist Registration Act to assist in obtaining a contract shall:

- (i) Disclose all costs, fees, compensation, reimbursements, and other remunerations paid or to be paid to the lobbyist related to the contract.
- (ii) Not bill or otherwise cause the State of Illinois to pay for any of the lobbyist's costs, fees, compensation, reimbursements, or other remuneration, and
- (iii) Sign a verification certifying that none of the lobbyist's costs, fees, compensation, reimbursements, or other remuneration were billed to the State.

This information, along with all supporting documents, shall be filed with the agency awarding the contract and with the Secretary of State. The CPO shall post this information, together with the contract award notice, in the online Procurement Bulletin.

Pursuant to Subsection (c) of this Section, no person or entity shall retain a person or entity to attempt to influence the outcome of a procurement decision made under the Code for compensation contingent in whole or in part upon the decision or procurement. Any person who violates this subsection is guilty of a business offense and shall be fined not more than \$10,000.

Bidder acknowledges that it is required to disclose the hiring of any person required to register pursuant to the Illinois Lobbyist Registration Act (25 ILCS 170) in connection with this contract.

IV. DISCLOSURES

A. The disclosures hereinafter made by the bidder are each a material representation of fact upon which reliance is placed should the Department enter into the contract with the bidder. The bidder further certifies that the Department has received the disclosure forms for each bid.

The CPO may void the bid, or contract, respectively, if it is later determined that the bidder or subcontractor rendered a false or erroneous disclosure. A contractor or subcontractor may be suspended or debarred for violations of the Code. Furthermore, the CPO may void the contract and the surety providing the performance bond shall be responsible for completion of the contract.

B. Financial Interests and Conflicts of Interest

1. Section 50-35 of the Code provides that all bids of more than \$50,000 and all submissions to a vendor portal shall be accompanied by disclosure of the financial interests of the bidder. This disclosed information for the successful bidder, will be maintained as public information subject to release by request pursuant to the Freedom of Information Act, filed with the Procurement Policy Board, and shall be incorporated as a material term of the contract. Furthermore, pursuant to Section 5-5, the Procurement Policy Board may review a proposal, bid, or contract and issue a recommendation to void a contract or reject a proposal or bid based on any violation of the Code or the existence of a conflict of interest as provided in subsections (b) and (d) of Section 50-35.

The financial interests to be disclosed shall include ownership or distributive income share that is in excess of 5%, or an amount greater than 60% of the annual salary of the Governor, of the bidding entity or its parent entity, whichever is less, unless the contractor or bidder is a publicly traded entity subject to Federal 10K reporting, in which case it may submit its 10K disclosure in place of the prescribed disclosure. If a bidder is a privately held entity that is exempt from Federal 10K reporting, but has more than 100 shareholders, it may submit the information that Federal 10K companies are required to report, and list the names of any individual or entity holding any ownership share that is in excess of 5%. The disclosure shall include the names, addresses, and dollar or proportionate share of ownership of each individual making the disclosure, their instrument of ownership or beneficial relationship, and notice of any potential conflict of interest resulting from the current ownership or beneficial interest of each individual making the disclosure having any of the relationships identified in Section 50-35 and on the disclosure form.

The current annual salary of the Governor is \$177,412.00.

In addition, all disclosures shall indicate any other current or pending contracts, proposals, leases, or other ongoing procurement relationships the bidding entity has with any other unit of state government and shall clearly identify the unit and the contract, proposal, lease, or other relationship.

2. <u>Disclosure Forms</u>. Disclosure Form A is attached for use concerning the individuals meeting the above ownership or distributive share requirements. SUBCONTRACTOR DOCUMENTATION

Public Acts 96-0795, 96-0920, and 97-0895 enacted substantial changes to the provisions of the Code (30 ILCS 500). Among the changes are provisions affecting subcontractors. The Contractor awarded this contract will be required as a material condition of the contract to implement and enforce the contract requirements applicable to subcontractors that entered into a contractual agreement with a total value of \$50,000 or more with a person or entity who has a contract subject to the Code and approved in accordance with article 108.01 of the Standard Specifications for Road and Bridge Construction.

The subcontract shall contain the certifications required to be made by subcontractors pursuant to Article 50 of the Code. This Notice to Bidders includes a document incorporating all required subcontractor certifications and disclosures for use by the Contractor in compliance with this mandate. The document is entitled <u>State Required Ethical Standards Governing Subcontractors</u>.

STATE ETHICAL STANDARDS GOVERNING SUBCONTRACTORS

Article 50 of the Code establishes the duty of all State CPOs, SPOs, and their designees to maximize the value of the expenditure of public moneys in procuring goods, services, and contracts for the State of Illinois and to act in a manner that maintains the integrity and public trust of State government. In discharging this duty, they are charged by law to use all available information, reasonable efforts, and reasonable actions to protect, safeguard, and maintain the procurement process of the State of Illinois.

The certifications hereinafter made by the subcontractor are each a material representation of fact upon which reliance is placed should the Department approve the subcontractor. The CPO may terminate or void the contract approval if it is later determined that the bidder or subcontractor rendered a false or erroneous certification. If a false certification is made by a subcontractor the contractor's submitted bid and the executed contract may not be declared void unless the contractor refuses to terminate the subcontract upon the State's request after a finding that the subcontractor's certification was false.

A. Bribery

Section 50-5. Bribery.

- (a) Prohibition. No person or business shall be awarded a contract or subcontract under this Code who:
 - (1) has been convicted under the laws of Illinois or any other state of bribery or attempting to bribe an officer or employee of the State of Illinois or any other state in that officer's or employee's official capacity; or
 - (2) has made an admission of guilt of that conduct that is a matter of record but has not been prosecuted for that conduct.
- (b) Businesses. No business shall be barred from contracting with any unit of State or local government, or subcontracting under such a contract, as a result of a conviction under this Section of any employee or agent of the business if the employee or agent is no longer employed by the business and:
 - (1) the business has been finally adjudicated not guilty; or
 - (2) the business demonstrates to the governmental entity with which it seeks to contract, or which is signatory to the contract to which the subcontract relates, and that entity finds that the commission of the offense was not authorized, requested, commanded, or performed by a director, officer, or high managerial agent on behalf of the business as provided in paragraph (2) of subsection (a) of Section 5-4 of the Criminal Code of 2012.
- (c) Conduct on behalf of business. For purposes of this Section, when an official, agent, or employee of a business committed the bribery or attempted bribery on behalf of the business and in accordance with the direction or authorization of a responsible official of the business, the business shall be chargeable with the conduct.
- (d) Certification. Every bid submitted to and contract executed by the State, and every subcontract subject to Section 20-120 of the Code shall contain a certification by the contractor or the subcontractor, respectively, that the contractor or subcontractor is not barred from being awarded a contract or subcontract under this Section and acknowledges that the CPO may declare the related contract void if any certifications required by this Section are false. A contractor who makes a false statement, material to the certification, commits a Class 3 felony.

The contractor or subcontractor certifies that it is not barred from being awarded a contract under Section 50-5.

B. Felons

Section 50-10. Felons.

- (a) Unless otherwise provided, no person or business convicted of a felony shall do business with the State of Illinois or any State agency, or enter into a subcontract, from the date of conviction until 5 years after the date of completion of the sentence for that felony, unless no person held responsible by a prosecutorial office for the facts upon which the conviction was based continues to have any involvement with the business.
- (b) Certification. Every bid submitted to and contract executed by the State and every subcontract subject to Section 20-120 of the Code shall contain a certification by the bidder or contractor or subcontractor, respectively, that the bidder, contractor, or subcontractor is not barred from being awarded a contract or subcontract under this Section and acknowledges that the CPO may declare the related contract void if any of the certifications required by this Section are false.

C. <u>Debt Delinquency</u>

Section 50-11 and 50-12. Debt Delinquency.

The contractor or bidder or subcontractor, respectively, certifies that it, or any affiliate, is not barred from being awarded a contract or subcontract under the Code. Section 50-11 prohibits a person from entering into a contract with a State agency, or entering into a subcontract, if it knows or should know that it, or any affiliate, is delinquent in the payment of any debt to the State as defined by the Debt Collection Board. Section 50-12 prohibits a person from entering into a contract with a State agency, or entering into a subcontract, if it, or any affiliate, has failed to collect and remit Illinois Use Tax on all sales of tangible personal property into the State of Illinois in accordance with the provisions of the Illinois Use Tax Act. The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction", adopted April 1, 2016 (hereinafter referred to as "Standard Specifications"); the "Standard Specifications for Water and Sewer Construction in Illinois", 7th Edition/2014 (hereinafter referred to as "Standard Specifications for Water and Sewer"), the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways", and the "Manual of Test Procedures for Materials" in effect on the date of the invitation for bids, and the Supplemental Specifications and Recurring Special Provisions indicated on the Check Sheet included herein which apply to and govern the construction of FAU 9415 (Taylor Street, Bissel Street and Buena Vista Street) from State Street to Hancock Street in Chester, Illinois, and in case of conflict with any part, or parts, of said Specifications, the said Special Provisions shall take precedence and shall govern.

DESCRIPTION OF WORK: The proposed improvement consists of providing all materials, labor and equipment required to reconstruct FAU 9415 (Taylor Street, Bissel Street and Buena Vista Street) from State to Hancock Street. Items of work include the excavation, removal and disposal of the existing PCC pavement, aggregate base, concrete curb and gutter, driveway pavement and sidewalks along with the construction of a new PCC pavement (8") on an aggregate base course, type A (4") and a lime modified subgrade. PCC driveways and sidewalks, combination concrete curb and gutters, seeding, mulching, and all miscellaneous items of work. It should be noted here that there exists retaining walls located at various locations along Buena Vista, Bissel and Taylor Streets. These walls are made of various materials (i.e. concrete, concrete blocks, rock, railroad ties, etc.) and are specified to remain in place. It will be the Contractor's responsibility to complete all of the reconstruction work of the streets as shown on the plans and as specified herein without damaging any of the retaining walls. The Contractor will repair any damaged walls to the satisfaction of the Engineer and will pay for all costs of making these repairs. Prior to the start of any construction on this project, the Contractor and the Engineer will get together and videotape the entire length of the proposed improvement.

JOINT UTILITY LOCATING INFORMATION FOR EXCAVATORS (J.U.L.I.E.): The Contractor's attention is directed to the fact that there exists within the State of Illinois, a Joint Utility Locating Information for Excavators (J.U.L.I.E.) System. Most utility companies are a part of this system.

Instead of the Contractor notifying each individual utility owner that he will be working in the area, it will only be necessary to call the number of the Joint Utility Locating Information for Excavators System which is (800) 892-0123, and they will notify all utility companies involved, that their respective utility should be located. A minimum of forty-eight (48) hours advance notice is required and the political name of the township where the work is located along with other location information, such as land section and quarter section, will have to be given.

<u>UTILITIES</u>: Ameren Illinois, Frontier Communications, Clear Wave Communications, and New Wave Communications have facilities within the limits of the improvement which may require adjustments/relocations. Arrangements for the adjustments/relocations will be made by the Contractor. No additional compensation will be allowed for any delays or inconveniences in the adjustment of the utilities.

The City of Chester has water and gas utilities that shall be adjusted, abandoned and/or relocated as shown on the plan. This work will be performed by The Contractor during the work specified herein. The Contractor will be responsible for coordinating all work with the relocation/adjustments of the gas and water utilities. All abandoned water mains, gas mains and services will remain in place at locations shown on the plans. During pavement removal, earth excavation and lime modification procedures the Contractor may be excavating the abandoned water and gas main, service, valves, etc. All of the existing water and gas mains and appurtenances shall be removed from the excavated earth material and disposed of as specified herein. All existing water and gas mains which do not interfere with the proposed roadway work shall remain in place. The cost of removing and disposing of all existing water and gas main and appurtenances will not be paid for separately, but shall be included in the cost of the various water and gas main pay items and no addition compensation will be allowed.

<u>EARTH EXCAVATION:</u> This item of work shall consist of providing all materials, labor and equipment necessary to construct the earth subgrade to the lines and grades shown on the plans for the proposed concrete pavement, driveways, sidewalks and curb and gutters and also to construct the finished grades in the areas to be seeded. This work shall be performed in accordance with the applicable portions of Sections 202, 204 and 205 of the "Standard Specifications" and as directed by the Engineer. Due to the small quantity of proposed earth excavation, it is anticipated that all excavated material will not be acceptable for fill or seed bed areas (i.e. weeds, grass, small rocks, etc.). Therefore, the Contractor will be required to waste all the excavated material at an off-site location. It is anticipated that the following work will be required:

- The difference between the Buena Vista, Bissel and Taylor Streets: proposed concrete pavement and existing centerline grades of the roadway pavement varies from a minus 0.26 ft. to a plus 0.17 ft. with the average being a plus 0.003 ft. or a little over 0.036 inches. It is, therefore, anticipated that after the Contractor removes all existing concrete pavement and curb and gutters, he will only be required to perform a minimal amount of earthwork in this area to attain the required subgrade elevation prior to the lime modification process. Therefore, the cost of any earthwork required to attain the subgrade for the proposed Portland cement concrete pavement, sidewalks and concrete curb and gutter will not be paid for separately, but shall be included in the costs of the various items of work involved. The above earthwork estimation is being made considering the following assumptions: The existing concrete pavement thickness is 5 – 6 inches with a small amount of rock base (3 – 4 inches) throughout the entire section as indicated in the 9 cores taken at various locations and that the new roadway concrete pavement thickness is 8 inches on a 4 inch aggregate base course. It should be noted here that the Contractor should take into account for swell factor resulting from the lime modification process when preparing the subgrade.
- II. <u>Payment</u>: Due to the small quantity payment for earth excavation will not be paid for separately, but shall be considered as included in the contract unit prices of the various related items of work involved and no additional compensation will be allowed.

<u>FURNISHED EXCAVATION</u>: This item of work shall consist of providing all borrow excavation and furnished excavation including all materials, labor and equipment necessary to construct the earth subgrade to the lines and grades shown on the plans for the proposed concrete pavement, driveways, sidewalks and curb and gutters and also to construct the finished grades in the areas to be seeded. This work shall be performed in accordance with the applicable portions of Sections 202, 204 and 205 of the "Standard Specifications" and as directed by the Engineer. Furnished excavation from a location approved by the Engineer will be required to fill 100% of the proposed embankment areas. It is anticipated that the following work will be required:

- I. <u>Area Within R.O.W.</u>: The Contractor will be required to perform all earthwork (earth excavation, special and embankment) necessary to attain the final lines and grades shown on the cross sections in the plans between the back of the concrete curb and gutter and the right-of-way in all areas to be seeded prior to any seeding work. This work will be completed to the satisfaction of the Engineer.
- II. <u>Payment</u>: Borrow and Furnished Excavation will be paid for at the contract unit prices per cubic yard for FURNISHED EXCAVATION. A shrinkage factor of 25% will be used in calculating payment quantities of furnished excavation per Section 204.

SEEDING, CLASS 1 (SPECIAL): This item of work shall consist of furnishing all materials, labor and equipment necessary for seeding (class 1), fertilizing, liming, and mulching all bare ground areas within the existing right-of-way in accordance with the applicable portions of Sections 250 and 251 of the "Standard Specifications" and as directed by the Engineer. Mulch shall be applied by method 2, procedure 1. Since this work is only required in a small area, payment will not be made for separately, but shall be considered as included in the contract and no additional compensation will be allowed.

EROSION CONTROL BLANKET: This item of work shall consist of furnishing all materials, labor and equipment necessary to install an erosion control blanket at locations as directed by the Engineer in accordance with the applicable portions of Section 251 of the "Standard Specifications". Payment for this item of work will be made at the contract unit price per square yard for EROSION CONTROL BLANKET and no additional compensation will be allowed. Material for this item of work shall be knitted straw blanket.

LIME AND PROCESSING MODIFIED SOIL 12": This item of work shall consist of furnishing all materials, labor, and equipment necessary to construct one course of a mixture of soil, code L lime and water in accordance with Section 302 of the "Standard Specifications" and in conformity with the lines, grades, thicknesses, and typical cross sections shown on the plans and as directed by the Engineer. This work shall be considered as subgrade modification. Code L lime meeting the requirements of Article 1012.03 of the "Standard Specifications" shall be applied at a rate of six (6%) percent by weight and shall be incorporated into the subgrade to a minimum depth of twelve (12") inches. At this rate, approximately 62 lbs/yd² or 0.031 tons/yd² will be required. Payment for this item of work will be made at the contract unit prices per ton for LIME and per square yard for PROCESSING MODIFIED SOIL 12" and no additional compensation will be allowed. Lime slurry will not be allowed.

AGGREGATE BASE COURSE, TYPE A: This item of work shall consist of furnishing all materials, labor and equipment necessary to construct an aggregate base course, Type A in accordance with the applicable portions of Section 351 of the "Standard Specifications" at the locations and to the lines and grades shown on the plans as

specified herein or as directed by the Engineer. Materials for this item shall pugmilled coarse aggregate, gradation CA-6 or CA-10. This work shall be paid for at the contract unit price per ton for AGGREGATE BASE COURSE, TYPE A and no additional compensation will be allowed.

INCIDENTAL HOT-MIXED ASPHALT SURFACE REMOVAL: This item of work shall consist of furnishing all labor and equipment necessary to remove and dispose of existing hot-mix asphalt surfaces and aggregate bases at the locations shown on the plans (mainly in the courthouse parking lot behind the new curb along Taylor St. and Bissel St.). This work shall be performed in accordance with the applicable portions of Section 440 of the "Standard Specifications" and as directed by the Engineer. This work will not be paid for separately, but shall be considered as included in the cost of the pay item for Incidental Hot-Mix Asphalt Surfacing and no additional compensation will be allowed.

INCIDENTAL HOT-MIX ASPHALT SURFACING: This item of work shall consist of furnishing all materials, labor and equipment necessary to install hot-mix asphalt surface course at various locations along Buena Vista, Bissel and Taylor Streets as directed by the Engineer in accordance with the applicable portions of Section 406 and 408 of the "Standard Specifications". This work will consist primarily of placing hot-mix asphalt surface course at all locations where new concrete pavement, driveways, sidewalks and curb and gutter is constructed adjacent to existing bituminous concrete surfaces. The new hot-mix asphalt surface course shall be place on a prepared base approved by the Engineer and compacted to the satisfaction of the Engineer. Materials for this item of work shall be hot-mix asphalt surface course, mix C, N70 meeting the following requirements:

Sawed butt joints shall be provided at all locations, where possible, as directed by the Engineer. This work shall be paid for at the contract unit price per ton for INCIDENTAL HOT-MIX ASPHALT SURFACING and no additional compensation will be allowed.

This item of work shall be performed mainly in the area located in the Randolph County Courthouse parking lot adjacent to the new curb and gutter on Taylor St., Bissel

St. and Buena Vista St., however, it will also be required at the ends of new construction of all side streets and driveways. The Contractor will be required to construct an aggregate base course, type A (8" min. thickness) in all areas where this work will be performed. If requested by the Engineer, the Contractor shall hand apply bituminous materials (prime cost) to this aggregate base course (HFE-90 applied as a fog coat). The prime coat, if applied, will not be paid for separately, but shall be consider as included in the cost of this pay item. The minimum thickness of the Incidental Hot-Mix Asphalt Surfacing is 3 inches. The aggregate base course, type A will be paid for by the ton for that pay item.

CONCRETE REINFORCEMENT: All Portland cement concrete used on this project for PCC pavement, PCC driveways, PCC sidewalks and combination concrete curb and gutter shall contain micro-fibrous concrete reinforcement incorporated at the redi-mix plant at a rate of 1.5 lbs. per cubic yard of concrete. All tickets delivered to the job site from the concrete plant shall indicate the amount of fibrous reinforcement added to the concrete. This item of work will not be paid for separately, but shall be included in the cost of the pay items for the various items of work involved that are noted above.

PORTLAND CEMENT CONCRETE PAVEMENT 8" (JOINTED): This item of work shall consist of furnishing all materials, labor and equipment necessary to construct a Portland cement concrete pavement at the locations shown on the plans and as directed by the Engineer in accordance with the applicable portions of Section 420 of the "Standard Specifications". Payment for this item of work will be made at the contract unit price per square yard for PORTLAND CEMENT CONCRETE PAVEMENT 8" (JOINTED) and no additional compensation will be allowed. The final finish of the concrete pavement shall be type A and all joints shall be sealed as specified herein. All reinforcement bars and dowel bars shall be epoxy coated. The cost of constructing longitudinal construction joints, sawed longitudinal joints, sawed transverse contraction joints, transverse construction joints and construction joints, special, will not be paid for separately, but shall be considered as included in the cost of this item of work. Please refer to the joint details on sheets 5 and 6 of the plans.

PORTLAND CEMENT CONCRETE DRIVEWAY PAVEMENT: This item of work shall consist of furnishing all materials, labor and equipment necessary to construct Portland cement concrete driveways at the locations and to the dimensions shown on the plans. This work shall be performed in accordance with the applicable portions of Section 423 of the "Standard Specifications". The Portland cement concrete driveway pavement shall be constructed to a minimum thickness of 6 inches and shall be placed on a compacted aggregate base course (4-inch minimum thickness). This work shall be paid for at the contract unit price per square yard for PORTLAND CEMENT CONCRETE DRIVEWAY PAVEMENT, 6 INCH and per ton for AGGREGATE BASE COURSE, TYPE A and no additional compensation will be allowed.

PORTLAND CEMENT CONCRETE SIDEWALK, 5 INCH: This item of work shall consist of furnishing all materials, labor and equipment necessary to construct Portland cement concrete sidewalks at the locations and to the dimensions shown on the plans. This work shall be performed in accordance with the applicable portions of Section 424 of the "Standard Specifications". The Portland cement concrete sidewalk shall be constructed to a minimum thickness of 5 inches and shall be on a 1 inch aggregate base course. This work shall be paid for at the contract unit price per square foot for PORTLAND CEMENT CONCRETE SIDEWALK 5 INCH and no additional compensation will be allowed.

<u>SIDEWALK REMOVAL</u>: This item of work shall consist of furnishing all labor and equipment necessary to remove the existing concrete sidewalks at the locations shown on the plans. This item of work shall be performed in accordance with applicable portions of Section 440 of the "Standard Specifications" and shall be paid for at the contract unit price per square foot for SIDEWALK REMOVAL and no additional compensation will be allowed.

INLETS TO BE ADJUSTED: This item of work shall consist of furnishing all materials, labor and equipment necessary to adjust the tops of four (4) existing stormwater inlets at Sta. 3+50 on left, Sta. 3+60 on right, Sta. 16+40 on left and so they match the elevations of the new PCC pavement and/or top of curb elevations. This work shall be performed in accordance with the applicable portions of Section 602 of the "Standard Specifications" and to the satisfaction of the Engineer. The Contractor will be required to adjust the tops and grout the entire insides of the inlets to be water tight. This item of work will be paid for at the contract unit price per each for INLETS TO BE ADJUSTED and no additional compensation will allowed.

SIGNS AND POSTS: This item of work shall consist of furnishing all materials, labor and equipment necessary to install sign panels, type 1; metal posts, type B and wood sign supports at the locations shown on the plans and signage schedule. This work shall be performed in accordance with the applicable portions of Sections 720, 729 and 730 of the "Standard Specifications" and as directed by the Engineer. Stop signs shall be mounted on wood sign supports. All other signs shall be mounted on type B metal posts. All posts shall be 16 ft. in length. Sign sheeting shall be High Intensity Prismatic meeting the requirements of ASTM D 4956-04, Type IV and the Illinois Department of Transportation Type AP. This work shall be paid for at the contract unit prices per square foot for SIGN PANEL - TYPE 1 and per foot for METAL POST - TYPE B and WOOD SIGN SUPPORT and no additional compensation will be allowed. It should be noted here that some signs and posts are to be removed and reinstalled. This work will not be paid for separately but shall be considered as included in the contract and no additional compensation will be allowed.

<u>PAVEMENT MARKING</u>: This item of work shall consist of furnishing all materials, labor and equipment necessary to install paint pavement marking at the locations shown on the plans or as directed by the Engineer in accordance with the applicable portions of Section 780 of the "Standard Specifications", the "Standard Specifications for Traffic Control Items" and the "Manual on Uniform Traffic Control Devices". The following pavement marking will be required:

- a) Centerlines shall be 4" double solid yellow.
- b) Stop bars shall be 24" single solid white.
- c) Crosswalks shall be 12" solid white.
- d) Face and top of curb shall be 12" solid yellow.

This work shall be paid for at the contract unit prices per foot for PAINT PAVEMENT MARKING - LINE 4"; PAINT PAVEMENT MARKING - LINE 12" and for PAINT PAVEMENT MARKING - LINE 24" and no additional compensation will be allowed. Please refer to the Pavement Marking Plan on sheet 33 of the plans and the Pavement Marking Schedule on sheet 4 of the plans along with Highway Standard 780001-05 included in the plans.

BRICK SIDEWALK: This item of work shall consist of furnishing all materials, labor and equipment necessary to construct a brick paver sidewalk at all locations shown on the plans and as directed by the Engineer. The Contractor will be required to clean the existing stockpiled brick pavers and install them in the new brick sidewalks. He will also be required to purchase new brick pavers to complete the construction of the new brick sidewalks. The purchased brick pavers shall have dimensions and color as close as possible to the existing brick pavers. The new brick sidewalk shall be constructed with a pattern as close as possible to the existing sidewalk's pattern. The brick sidewalk shall be constructed on a prepared dirt sub-grade, a four inch (4") compacted aggregate base course, type A (CA-6 or CA-10) covered with plastic forms and a one inch (1") layer of stone dust. Bricks shall be installed on compacted processed aggregate with filter fabric placed on top of the aggregate. The leveling course on top of the filter fabric shall consist of a minimum ¾ inches (maximum 1 ¼ inches) of compacted crushed stone dust or washed sand. When placed, the bricks shall tightly abut each other. Exposed edges of bricks shall be set on a plastic angle edge restraint. Final setting of brick shall be with a plate compactor. All joints shall be filled with crushed stone dust orwashed sand and then sprinkled with water to ensure longevity. The Contractor shall use the adjacent existing retaining walls or new concrete curb and gutter, sidewalks, driveways, pavement, etc., to border the proposed BRICK SIDEWALK. The above work shall be paid for at the contract unit price per square foot for BRICK SIDEWALK and no additional compensation will be allowed.

BRICK SIDEWALK REMOVAL: This item of work shall consist of furnishing all labor and equipment necessary to remove the existing brick paver sidewalks at the locations shown on the plans. The Contractor will be required to remove the brick pavers and stock pile all of the unbroken pavers at a location on site for future use. The Contractor shall exhibit great care while doing so to ensure the pavers remain unbroken. Please refer to the special provision for "Brick Sidewalk" contained herein. This item of work shall be performed in accordance with applicable portions of Section 440 of the "Standard Specifications" and shall be paid for at the contract unit price per square foot for BRICK SIDEWALK REMOVAL and no additional compensation will be allowed. TRENCH BACKFILL, SPECIAL: This item of work shall include furnishing and installing

TRENCH BACKFILL, SPECIAL: This item of work shall include furnishing and installing select granular backfill (where ordered) in accordance with Section 20 of the "Standard Specifications for Water and Sewer" and as shown on the plans.

Measurement shall be by the cubic yard in place based upon measurements and locations ordered by the Engineer. Maximum quantities shall not exceed those shown in Table 1 contained herein for the respective size of conduit. Quantities in excess of the maximum quantity therein specified shall be furnished and placed by the Contractor at his own expense.

Payment for this item of work will be made at the contract unit price per cubic yard for TRENCH BACKFILL, SPECIAL and no additional compensation will be allowed.

TRAFFIC CONTROL AND PROTECTION (SPECIAL): The Contractor will not be required to maintain thru traffic during construction of the proposed improvement. The Contractor will be required to place lighted type III barricades with road closed to thru traffic signs and all other traffic control and detour route signs as shown on the Traffic Control and Detour Route Plan on sheet 2 of the plans or as directed by the Engineer. The Contractor will be required to provide access to residents that live within the construction limits to their residences at all times during the construction period in accordance with Article 107.09 of the "Standard Specifications" except that any costs incurred by the Contractor to provide these accesses will not be paid for separately but shall be considered as included in the cost of this pay item and no additional compensation will be allowed. The Contractor will also be required to provide access to the entire project area at all times for emergency vehicles in the same manner as stated above for residents. The Contractor shall provide access to all mailboxes located within the project area for employees of the U.S. Postal Service in accordance with the applicable portions of Article 107.20 of the "Standard Specifications". Special attention is called to Articles 107.09 and 107.14 of the "Standard Specifications" and the following:

Highway Standards: BLR 21-9, BLR 22-7 and 701901

The cost for providing the materials, equipment and labor necessary for the installation and maintenance of the traffic control devices in accordance with the roadway plans, special provisions, and applicable highway standards will be paid for at the contract lump sum price for TRAFFIC CONTROL AND PROTECTION, (SPECIAL) and no additional compensation will be allowed. All traffic control signs shall be 48" x 48" fluorescent orange signs with flashing warning lights as specified.

MATERIAL TESTING: The Contractor shall be responsible for providing and paying for all materials testing on this project including but not limited to all of the Portland cement concrete used to construct the new pavement, driveways, curb and gutter and sidewalks along with aggregate base and lime modified earth subgrade as specified in the applicable sections of the latest editions of the "Standard Specifications" and the "Manual of Test Procedures for Materials" and as directed by the Engineer. All material testing shall be performed by an independent material testing firm approved by the City of Chester. The cost of this item of work will not be paid for separately, but shall be considered as included in the contract and no additional compensation will be allowed.

POTABLE WATER SPECIFICATIONS

<u>WATER MAIN:</u> This item of work shall consist of furnishing all materials, labor and equipment necessary to construct the water main shown on the plans in accordance with Section 41 of the "Standard Specifications for Water and Sewer" including excavation and backfill, clearing and site restoration.

Materials shall be as follows:

- 1. Pipe: Polyvinyl Chloride (PVC) Pipe shall conform to the requirements of Section 40 of the "Standard Specifications for Water and Sewer" and shall conform to the requirements of NSF Standard 14 and be designated Class 12454C in conformance with ASTM D 1784. The standard dimension ration pressure rating (SDR-PR) shall be in accordance with ASTM F 442. The SDR rating of the pipe shall be SDR-21 or SDR-17 as noted on the plans. All piping shall bear the NSF seal of approval. The piping shall be visibly marked with the specific SDR rating number. Joints shall be elastomeric seals (gaskets) complying with ASTM Standard F477 and shall be pressure rated in accordance with ASTM D3139.
- 2. Fittings: Fittings shall be ductile iron conforming to AWWA C 153. The exterior of the fittings shall be tar coated. The interior of the fittings shall be cement lined in accordance with AWWA C 104.
- 3. Thrust Blocking 3,000 psi (28 days) ready-mix concrete installed in strict accordance with the plan details and with Section 41-2.10 of the "Standard Specifications for Water and Sewer". Contractor shall provide a minimum of 600 sq. in. of concrete thrust blocking.
- 4. Tracer Wire #12 plastic coated solid copper wire. Tracer wire shall be installed in the water main trench one (1) foot above the pipe. Wires shall be brought up from trench and twisted in all valve boxes.

The water main shall be pressure and leakage tested in accordance with the requirements of Section 41 of the "Standard Specifications for Water and Sewer". The water main shall be disinfected, flushed and tested for bacterial contamination in accordance with the requirements of Section 41 of the "Standard Specifications for Water and Sewer".

Payment for this item of work will be made at the contract unit price per foot for WATER MAIN of the size and pressure rating shown on the plans and no additional compensation will be allowed. Fittings, thrust blocking and tracer wire will not be paid for separately but shall be considered as incidental to the installation of the water main.

<u>TAPPING VALVES AND SLEEVES</u>: This item of work shall include furnishing all labor, equipment, tools, labor, materials, excavation and backfill required to furnish and install

pressure connections of the various sizes and types shown on the plans in accordance with Section 46 of the "Standard Specifications for Water and Sewer." Tapping sleeves shall be of stainless steel construction and shall have a carbon steel flange with fusion bonded epoxy coating. The tapping sleeves shall be Mueller Model H-304 and shall have a stainless steel test plug and a pressure rating of 250 psi for sleeve sizes 3" to 12" and 200 psi for sleeve sizes 14" to 24". The valve shall feature fl x mj connections, O-ring stem seals and stainless steel fasteners. The tapping valves shall be Mueller Model T-2360.

Payment for this item of work will be made at the contract unit price per each for TAPPING VALVES AND SLEEVES of the size and type specified and no additional compensation will be allowed. The unit price shall include all labor, materials and equipment required to make a complete installation.

<u>WATER SERVICE LINE:</u> This item of work shall include furnishing all labor, equipment, tools, materials, excavation, backfill and other necessary appurtenances required to install copper service line to existing services in accordance with Sections 40 and 41 of the "Standard Specifications for Water and Sewer"

The copper service line shall be copper water tube, 3/4" or 1" diameter, Type K or greater soft temper, for underground service and conforming to ASTM B88 and ASTM B251.

Payment for this item of work shall be made at the contract unit price per foot for WATER SERVICE LINE of the size indicated on the bid form and no additional compensation will be allowed.

FIRE HYDRANTS TO BE REMOVED: This item of work shall include furnishing all labor, equipment, tools, materials, excavation, backfill and other necessary appurtenances required to remove existing fire hydrants at the locations shown on the plans. The Contractor shall fill and restore the site to existing grade. Mueller brand hydrants removed by the Contractor shall become the property of the City after removal and delivery to the Chester Water Department by the Contractor. All other materials removed shall become the property of the Contractor and shall be disposed of at his expense.

Payment for this item of work shall be made at the contract unit price per each for FIRE HYDRANTS TO BE REMOVED and no additional compensation will be allowed.

<u>FIRE HYDRANTS:</u> This item of work shall consist of furnishing and installing hydrant, auxiliary gate valve and cast iron valve box of the specified size, at the locations shown on the Plans, and in accordance with Sections 42, 44, and 45 of the "Standard Specifications for Water and Sewer".

Materials shall be as follows:

- 1. Hydrant: The hydrant shall be Mueller Super Centurion 250 hydrant with two 2-1/2" hose nozzles and one pumper nozzle. Hydrant size shall be 5-1/4" and the hydrants shall be equipped with tamper resistant hydrant hold down nut. Hydrants shall have replaceable, breakable sections or components, such that in the event the barrel is broken off, the valve will remain closed, the barrel will not be damaged, and the stem will not be bent. All hydrants shall have connections of the same type as that on the pipe to which they are to be connected. Hose nozzle threads shall be National Standard. The hydrants shall be furnished with two (2) coats of suitable paint. Depth of bury shall be 3' 6" unless otherwise indicated on the Drawings. Contractor shall note distance required from ground elevation to center of nozzles. No additional compensation shall be given to adjust hydrants to achieve clearance. Hydrants installed at dead end lines shall utilize a tee fitting with a blind flange for connection to auxiliary gate valve.
- 2. Auxiliary Gate Valve: Auxiliary Gate Valve shall be Mueller Model 2360 with mechanical joint connections, non-rising stem, O-ring stem seals and stainless steel fasteners.
- 3. Valve Box: Valve box shall be of cast iron construction with screw type adjustment as shown on the plans. The lid shall be of cast iron construction and shall have "WATER" cast into the lid.
- 4. Joint Restraints shall be installed from the water main tee to the auxiliary gate valve and from the auxiliary gate valve to the hydrant connection. Adequate thrust blocking as specified under Water Main is also required.
- 5. Operation Wrenches and Repair Kits: The Contractor shall furnish the Owner three (3) operating wrenches and three (3) safety flange repair kits for each hydrant size.

Payment for this item of work will be made at the contract unit price per each for FIRE HYDRANT WITH AUXILIARY VALVE AND VALVE BOX of the size shown on the plans, including auxiliary gate valve and box, and no additional compensation will be allowed.

<u>WATER SERVICE CONNECTION:</u> This item of work shall include furnishing all labor, equipment, tools, materials, excavation, backfill and other necessary appurtenances required to transfer existing water services from existing water main to new water main including all necessary fittings, corporation stops, service saddles and service pipe (10 ft. maximum length) in accordance with Sections 40 and 41 of the "Standard Specifications for Water and Sewer".

Materials shall be as follows:

- 1. Pipe: Copper water tube, ¾" diameter and 1" diameter, Type K or greater soft temper, for underground service and conforming to ASTM B88 and ASTM B251.
- 2. Service Saddles: Service saddles shall be H-13000 Series as manufactured by Mueller with brass body.
- 3. Corporation Stops: Corporation stops shall be H-15000 Series as manufactured by Mueller.

Installation: After approval and acceptance of new water main, tap new line, close existing corporation stop, make necessary reconnection of new service line to existing service line or existing service meter as shown on the plans.

Payment for this item of work will be made at the contract unit price per each for WATER SERVICE CONNECTION of the size indicated on the bid form and no additional compensation will be allowed. Note that water service line installed in excess of 10 feet in length per service will be paid for under Water Service Line contained herein.

<u>CUT AND CAP EXISTING WATER MAINS:</u> This item of work shall include furnishing all labor, equipment, tools, materials, excavation, backfill and other necessary appurtenances required to cut and cap the existing water mains at the locations shown on the plans and where directed by the Engineer in accordance with Sections 40 and 41 of the "Standard Specifications for Water and Sewer".

Fittings shall be ductile iron conforming to AWWA C 153. The exterior of the fittings shall be tar coated. The interior of the fittings shall be cement lined in accordance with AWWA C 104.

Payment for this item of work shall be made at the contract unit price per each for CUT AND CAP EXISTING 4" or 10" WATER MAIN and no additional compensation will be allowed.

<u>VALVE VAULTS TO BE REMOVED:</u> This item of work shall include furnishing all labor, equipment, tools, materials, excavation, backfill and other necessary appurtenances required to remove and properly dispose of existing valve vaults at the locations shown on the plans and fill the resulting hole in accordance with the applicable portions of the "Standard Specifications for Water and Sewer". Payment for this item of work will be made at the contract unit price per each for VALVE VAULTS TO BE REMOVED and no additional compensation will be allowed.

<u>SEWER SERVICE LINE REPLACEMENT:</u> This item of work shall include furnishing all labor, equipment, tools, materials, excavation, backfill and other necessary appurtenances required to remove existing sewer service pipe and install new sewer service pipe within ten (10) feet on each side of the new water main in accordance with the Sections 30 and 33 of the "Standard Specifications for Water and Sewer".

Materials shall be as follows:

- 1. Pipe shall be water main quality polyvinyl chloride (PVC), SDR-26, 160 psi minimum pressure rating.
- 2. Connections to existing sewer line shall be made with flexible couplers.

Payment for this item of work shall be made at the contract unit price per each for SANITARY SEWER of the size shown, and no additional compensation will be allowed.

STEEL PIPE CASING AND CARRIER PIPE: This item of work shall include furnishing all labor, equipment, tools, labor, materials, excavation and backfill required to furnish and install steel pipe casing and carrier pipe at the locations and by the methods shown on the plans and in accordance with Sections 20, 23 and 41 of the "Standard Specifications for Water and Sewer".

Materials shall be as follows:

- 1. Encasement Pipe:
 - (a) Minimum thickness 0.25" for casings 12" or less in diameter 0.3125" for casings over 12" to 18" diameter
 - (b) Minimum tensile strength: 35,000 psi
 - (c) Bituminous coated welded steel pipe in accordance with ASTM A 139B.
- 2. Carrier Pipe: Same as specified under Water Main above, including tracer wire.
- 3. Spacers shall be high density polyethylene and the diameter shall match casing I.D. within ½ inch.
- 4. End Seal shall EPDM rubber with reinforced nylon polymer pressure plates, the bolts and nuts shall be steel with 2-part zinc dichromate and a corrosion inhibiting coating. The seals shall be specified for use in temperatures ranging from 40°F to +250°F.

Installation:

- 1. Encasement Pipe: Horizontal Directional Drilling (HDD) or Open Cut as noted on the plans.
- 2. Carrier Pipe: Shall be continuous along with tracer wire through casing with an effort to minimize the number of joints within the casing.
- 3. Spacers: Shall be attached to pipe at 6 foot intervals. Double spacers shall be installed near each end of casing.
- 4. End Seals: Shall be installed at each end of casing.
 Payment for this item of work will be made at the contract unit price per foot for STEEL CASINGS of the sizes shown on the plans, measured in place, and no additional compensation will be allowed. The contract unit price shall include the casing, carrier pipe, spacers, end seals and tracer wire. Excavation and backfill of bore pits shall be considered incidental.

GATE VALVE AND BOX: This item of work shall include furnishing all labor, equipment, tools, labor, materials, excavation and backfill required to furnish and install gate valves at the locations shown on the plans and in accordance with Sections 20, 40, 41, 42 and 44 of the "Standard Specifications for Water and Sewer". Valve shall be resilient seat design Mueller Model 2360 with mechanical joint connections, non-rising stem, O-ring stem seals and stainless steel fasteners. A cast iron valve box as shown on the plans shall be furnished and installed with each valve.

Payment for this item of work will be made at the contract unit price per each for GATE VALVE AND BOX of the size shown on the plans, including valve box, and no additional compensation will be allowed.

<u>2" PVC SANITARY FORCE MAIN:</u> This item of work shall consist of furnishing all materials, labor and equipment necessary to install a 2" PVC sanitary sewer force main at the location shown on the plans and as directed by the Engineer. Material for this item of work shall be 2" diameter PVC pipe (SDR-26) meeting all requirements of the applicable portions of the "Standard Specifications for Water and Sewer". Installation of the force main shall also meet all requirements of the applicable portions of the "Standard Specifications for Water and Sewer". This item of work shall be paid for at the contract unit price per foot for 2" PVC SANITARY FORCE MAIN and no additional compensation will be allowed.

NATURAL GAS SPECIFICATIONS

SECTION 3.1 GENERAL

3.1.01 ENUMERATION OF DRAWINGS, SPECIFICATIONS AND ADDENDA

The following Drawings and Specifications for <u>Improvement to Buena Vista Street – Phase II</u> form a part of the Contract as set forth in the General Conditions.

3.1.02 QUANTITIES OF ESTIMATE

Wherever the estimated quantities of work to be done and materials to be furnished under this Contract are shown in any of the Documents, including the Bid Schedule, they are given for use in comparing Bids and the right is especially reserved, except as herein otherwise specifically limited, to increase or diminish them as may be deemed reasonably necessary or desirable by the Owner to complete the work contemplated by this Contract.

3.1.03 SEQUENCE OF CONSTRUCTION AND CONSTRUCTION SCHEDULE

The sequence of construction and construction schedule shall be filed with the Engineer for his approval prior to construction. They shall show order of construction and starting/completion dates and shall be adhered to with reasonable accuracy.

3.1.04 APPLICABLE CODES

All of the Work shall be governed by and shall be performed in accordance with the following codes and standards, except where the Contract Documents specifically require a greater degree or quality of work: 49 Code of Federal Regulations, Part 192; Illinois Commerce Commission Rules; and the latest Edition of GPTC Guide. Contractor must meet Owners Operator Qualification and drug plan requirements and provide copies to the Owner. If there is any conflict or discrepancy among these codes and standards, Contractor shall perform in accordance with the code or standard requiring the greater degree or higher quality of work.

3.1.05 QUALIFICATION OF WELDERS AND FUSERS

A) Steel Pipe and Fittings

Contractor shall comply with the test requirements of API 1104 Multiple Qualification. The test (at least 6" butt and branch) must be completed by using a qualified procedure as supplied by the contractor, and passed by each individual welder under inspection of the Engineer prior to work being done. Testing completed by the welder(s) in the 6 months prior to the commencement of the job may be considered by the Engineer in lieu of an on-site test. Contractor shall provide the Engineer a copy of Contractor's Welding Qualification and Operator Qualification prior to construction.

3.1.06 WELDING OF PIPELINE

A) Inspection and Test of Welds

Inspection and test of welds shall be performed in accordance with 49 CFR Part 192.241. All welds will be inspected and tested according to the standards set forth in American Petroleum Institute's Standard 1104. The Contractor shall be responsible for the cost of all testing.

B) Repair and Removal of Defects

Each weld that is unacceptable under 49 CFR Part 192.241must be removed or repaired. Repairs shall be performed in accordance with 49 CFR Part 192.245. The Contractor shall be responsible for the cost to repair all welds.

C) Welding Procedure

Contractor shall use an approved welding procedure for the joining of the new pipeline that will meet or exceed the specified minimum yield strength of 52,000 psi. In addition, when the Contractor is making tie-in welds of the new pipeline to the existing pipeline, the weld procedure will meet or exceed the specified minimum yield strength of 52,000 psi for the new pipeline.

SECTION 3.2 SCOPE OF WORK

3.2.01 GENERAL

The proposed work consists of furnishing all labor, new materials, tools, equipment and services necessary for the construction of the <u>Improvement to Buena Vista Street – Phase II</u>, including all other incidental work as shown on the Drawings and as herein specified.

The project includes the installation of approximately 1,100' of 4" and 250' of 2" Steel pipeline along with 14 service lines and 5 tie-in locations.

Mueller line stopper fittings and service tees (4" and 2") will be utilized to connect to the existing steel mains. Tapping and stopping services for the Mueller fittings will be provided by the contractor or approved subcontractor. Contractor will provide a 2 week notice for scheduling of tapping and stopping services. Contractor will provide assistance during tapping and stopping services such as lifting/lowering and bolting/unbolting of tapping and stopping equipment. Contractor will also provide an air compressor that will be used during the tapping and stopping operations.

After joints have passed visual inspection, coat and wrap steel joints, fittings, and other uncoated steel pipe with material typical to Denso or Tapecoat (provided by Contractor). Joints at bores are to be coated with two-part epoxy. Joints are to be properly prepared by grit blasting or using an industrial grade surface preparation tool prior to applying two-part epoxy.

The exact course and depth of the pipeline is indicated on the associated Drawings with the centerline staked by the Owner's Representative prior to construction. The stakes shall be of such regularity that the continuity of the line is maintained throughout its course.

Contractor shall be charged with full responsibility for agreement of the work with the staked route. Preservation of the stakes shall be the responsibility of the Contractor. Any carelessness or negligence on the part of the Contractor, sub-contractor, or employees that results in loss or misalignment of the stakes will require that the cost of replacement be borne by Contractor.

As construction requires movement of the station stakes, Contractor will relocate the stakes to the edge of the right-of-way approximately perpendicular to the centerline of the pipeline location and across the backfill.

Owner retains the right to make changes or alterations in the routing.

3.2.02 RESPONSIBILITY

It shall be the responsibility of the Contractor to furnish and install a complete and working system to perform the intended purposes as required by the Drawings and these Specifications. The Contractor shall be responsible for all details which may be necessary to properly install, adjust, pig and test and place into operation the complete installation. The work shall not be considered complete until all required records (see Section 3.5.14) have been turned in to the City of Chester Gas Supt. Costs of all such details shall be included in the bid.

The Contractor shall Guarantee that the materials furnished shall be properly installed and, when properly operated, shall perform the duty for which it is intended. He shall guarantee all materials, workmanship, and completed installation to be first class in every particular and shall, at his own expense, furnish and replace any part or parts that may prove defective in workmanship within one (1) year from the date of substantial completion.

SECTION 3.3 MATERIALS

3.3.01 GENERAL

Materials and material handling associated with the gas mains and appurtenances to be constructed shall be in compliance with this specification and the following specifications for materials.

All materials to be utilized in this replacement are to be new and are to be thoroughly examined by the Contractor prior to installation. Any cracked, chipped, bent, scarred, or otherwise damaged material shall be returned to the supplier for replacement by the Contractor.

3.3.02 CONTRACTOR FURNISHED MATERIALS

The Contractor will be responsible for furnishing all materials necessary for the complete construction of the <u>Improvement to Buena Vista Street – Phase II</u> project. It shall include, but not limited to, the following items:

4" AND 2" STEEL PIPE

The Contractor will furnish all of the 4", 2" and 34" Steel pipe and fittings required for the construction of the new pipeline. The 4" main will be .188 wall API5L- X52 pipe with fusion bonded epoxy coating. The 2" main will be .154 wall and the 34" will be .113 wall. Refer to Design Drawings for other material specifications.

SERVICE LINE PIPING AND FITTINGS

The Contractor will furnish all piping and fittings necessary for the installation of the service lines, and other appurtenances as shown on the Design Drawings.

TIE IN PIPING AND FITTINGS

The Contractor will furnish all piping and fittings necessary for the tie in locations, and other appurtenances as shown on the Design Drawings.

Contractor shall furnish all necessary supervision labor, equipment, and supplies to promptly move and string on right-of-way all pipe required for the Project. All handling of pipe shall be in such a manner that will avoid damage to the pipe.

The Contractor will also provide the following:

- A) All test equipment necessary to complete pressure testing of new pipeline and station piping.
- B) All sand, gravel, concrete, and reinforcement necessary to construct the system as specified on the Design Drawings.

Contractor shall notify Engineer prior to start of construction of any materials that he is not able to procure. Engineer or Owner can assist Contractor in procuring materials if notified prior to construction.

3.3.04 CARE AND HANDLING

Care shall be exercised to avoid rough handling. Pipe shall not be dragged, dropped or have other objects dropped on it. Caution shall be exercised to prevent kinking, buckling, flattening, or other damage. Any damage which occurs shall be removed by cutting out as a cylinder.

Coated pipe shall be carefully inspected prior to use for cuts, scratches, gouges, and other imperfections. A jeep or "electric holiday detector" shall be used to test and identify any defects in the mill applied and field applied coating. The Contractor shall use the manufacturer's recommended testing voltages for the jeep according to the thickness of the pipeline coating. Defects shall be repaired according to Owner's O&M requirements. Repairs shall be rechecked with a jeep to confirm repair. Defective pipe shall not be used. Coated pipe shall also be protected from fire, excessive heat, or harmful chemicals.

Special padded forks, padded calipers or nylon slings shall be used in handling, and storage shall be on padded skids spaced to give adequate support on all pipe.

SECTION 3.4 EXCAVATING, BORING, TRENCHING AND BACKFILLING

3.4.01 **SCOPE** - Furnish all materials, equipment, labor, and related items required to complete work indicated on the Drawings and/or Specifications. Attention is directed to the General Conditions and also other Sections of the Specifications which affect the work under this Section. The work under this Section includes, but is not limited to, the following items:

Excavation, Sheeting and Backfill of gas main, bores and related items.

3.4.02 GENERAL

Excavating and backfill shall include all excavation, backfilling, compacting, and disposal of surplus material, restoration of all disturbed surfaces and all other work incidental to the construction of trenches, including any additional excavation which may be required for the installation of the pipeline.

A) Risk - The Contractor must assume the risk of encountering quicksand, hardpan, high water tables, and other soil types which might hinder or slow his progress. No claim for additional compensation shall be entertained on account of the character of the ground in which the excavation is being made.

3.4.03 SURFACE AND SUBSURFACE STRUCTURES AND OBSTRUCTIONS

Various underground and surface structures may, or may not, be shown on the Drawings. The location and dimensions of such structures, where given, do not purport to be absolutely correct. The structures are plotted on the Drawings for the information of the Contractor, but information so given is not to be construed as a representation that such structures will be found or encountered as plotted. Other structures may also be encountered which are not shown on the Drawings.

A) Utilities - The Contractor shall be aware that utility companies may have buried facilities in some areas of the gas line construction. Before the Contractor begins operations, he shall notify all utility companies affected by construction and request their assistance. Contractor shall also comply with Illinois law and the Illinois One Call System requirements. The Contractor, however, shall be solely responsible for the location of all utilities.

The Contractor shall maintain, in operating condition, all utilities encountered in his work. When the Contractor intends to interrupt utility service, the owner of the utility, the Owner's Representative and the Contractor shall mutually agree upon a date and time for interruptions which are convenient for the utility and to the utility customer. The Contractor shall indicate to the Owner's Representative at the Pre-Construction Meeting where, and how long, the service interruption will occur. No additional compensation shall be allowed if it is determined necessary to interrupt the existing utility at a time which is beyond regular working hours.

- B) Utility Damage Any damage to existing utilities as a result of this construction shall be repaired to the satisfaction of the owner of the utility at the Contractor's expense, whether or not said utilities are shown on the Drawings. If such repairs are not made promptly or satisfactorily, the Owner's Representative may have the repairs made, or may deduct the cost thereof from any moneys due, or become due, the Contractor.
- C) Clearance With Underground Utility Structures Hidden structures should be located in advance of ditching and the owner consulted to co-ordinate activities. Presence of the utility Owner's representative should be requested to observe work and protect the owner's property. A minimum clearance of twelve to eighteen inches (12-18") should be provided from foreign structures, unless otherwise approved by the Owner's Representative.
- D) Property Damage The Contractor shall be entirely responsible for all damages to streets, pavements, sidewalks, curbs, fences, culverts, buildings, or other structures of any kind met with during the completion of the work; and shall be liable for damages to public or private property resulting therein, which amount may be deducted from any moneys due him for work done.
- E) Restoration of Property All existing streets, sidewalks, alleys, driveways, entrances, road shoulders, parking areas, lawns, signs, fences, sheds, and other miscellaneous property and drainage features which are removed to allow for the construction, or damaged by it, whether or not the Contractor has paid for the damage under a specific measurement and payment section, shall be restored to a condition at least equivalent to that which existed at the commencement of the work; unless additional written arrangements are made satisfactory to the owner of said property. The Contractor shall be solely liable for damages to items described herein and moneys due him may be withheld to cover such damages.

Suitable crossings shall be provided and maintained over the open ditch, where necessary, to permit property owners and the general public to move equipment, or vehicular traffic, over the excavation.

- rights-of-way shall be protected from damage and when such trees and shrubs are in the way of construction, the Owner's Representative may instruct the Contractor to prune branches interfering with the work, or remove and dispose of trees and shrubs, or transplant trees and shrubs out of the way of the construction, and the Contract Price shall not be increased for the performance of such work. The Contractor shall be liable for damages to trees and shrubs which were to have been protected as directed by the Owner's Representative, unless such damages are determined by the Owner's Representative to have been unavoidable, and moneys due to Contractor may be withheld to cover such damages.
- G) Area Utilities Before beginning work in an area, the Contractor shall comply with Illinois law for location of utilities and contact Illinois One Call System, (JULIE) (811 or 1-800-892-0123) and any companies maintaining utilities along the right-of-way and request their assistance in locating utilities in that area. The Contractor, however, shall be solely responsible for the location of the utilities.
- H) Equipment Tool boxes, equipment, and materials shall not be placed in roadways, driveways, walkways, or any place where they will interfere with pedestrian or vehicular traffic. If it is necessary to obstruct a driveway or walkway, prior permission must be obtained from the owner involved.
- 3.4.04 **SURFACE REMOVAL** The Contractor shall remove the surface materials along the proposed pipeline if indicated on the Drawings only to such widths as will permit a trench to be excavated, which will afford sufficient room for proper safety and construction. Where driveways, pavements, drainage, and utilities are encountered, care shall be taken to protect such against fracture or disturbance beyond reasonable working limits.
 - A) Trenches in Lawns and Agricultural Areas Care shall be taken in making excavations in lawns, farm fields, or other grassed areas, to preserve the sod and topsoil so that it may be replaced in proper sequence when backfilling. The topsoil shall be kept in spoil piles separate from other backfilling materials to preserve the fertility of the lawns and agricultural areas.

When trenching equipment is to be used for excavation in grassed areas, the sod shall be removed along the trench line prior to the start of actual excavation. Wood planks shall be used as a platform for the trenching equipment, when necessary, to avoid damage to grassed areas.

B) Piling Earth - The soil shall be piled in such a manner that it will not prevent access to fire hydrants, mailboxes, or valve boxes of other utilities. The soil shall not be placed in the gutter, unless other drainage is provided, such as placing boards to span the gutter so that water can drain through the gutter beneath the boards. If at all possible, the soil should be kept between the trench and road traffic. The soil shall clear the trench excavation by at least twelve inches (12") and twenty four inches (24") is recommended.

3.4.05 WIDTH OF EXCAVATION

- A) The Bottom Width of the trench at and below the top of the pipe and inside the sheeting and bracing, if used, shall be a minimum of the outside diameter of the pipe, plus six inches (6") and a maximum of the outside diameter of the pipe, plus twenty inches (20").
- B) Trench Sheeting and bracing, or a trench shield, shall be used as required by the Rules and Regulations of OSHA.
- 3.4.06 **EXPLORATORY EXCAVATION** Whenever, in the opinion of the Engineer, it is necessary to explore and excavate to determine the best line for the construction of the proposed pipeline, the Contractor shall make explorations and excavations for such purposes.

3.4.07 **ROCK EXCAVATION** - Wherever "rock" is used as the name of excavated material, it shall mean boulders or pieces of natural rock measuring one (1) cubic yard, or more, hard shale or solid ledge rock which, in the opinion of the Engineer is required for its removal continuous use of pneumatic tools, or drilling and blasting.

A) Extra Payment for rock excavation may be allowed as per General Conditions. Before extra payment is allowed, however, the Contractor shall be required to demonstrate the material cannot be removed by hand pick, or by power operated excavator or shovel.

B) No payment shall be made for rock excavations, unless air tools or explosives are used by the Contractor. Any blasting done to facilitate rock excavation shall be done according to Federal Regulations and the Standard Specifications.

3.4.08 BRACED AND SHEETED TRENCHES

- A) Open cut Trenches shall be sheeted and braced, or otherwise protected as required by any governing Federal or State Laws and Municipal Ordinances, and as may be necessary to protect life, property, or the Work. In any event, the minimum protection shall conform to the recommendations in OSHA Safety and Health Standards of Construction.
- B) A Sand Box, or trench shield, may be used in lieu of sheeting as permitted by OSHA.
- C) When Close Sheeting is used, it shall be so driven as to prevent adjacent soil from entering the trench either below, or through, such sheeting.
- 3.4.09 **TRENCHES WITH SLOPING SIDES, LIMITED -** The Contractor may, at his option, where working conditions, easements, and rights-of-way permit (as determined by the Owner's Representative), excavate pipeline trenches with sloping sides, but with the following limitations:
 - A) Limited In general, only braced and vertical trenches will be permitted where trenches endanger structures and buildings.
 - B) Sloping Sides Where trenches with sloping sides are permitted, the slopes shall not extend below the top of the pipeline and trench excavations below this point shall be made with vertical sides, with widths not exceeding those specified in Paragraph 3.4.05 for the various sizes of pipes. Sloping sides above the pipe shall be as OSHA Regulations required.
- 3.4.10 **PILING EXCAVATED MATERIAL** All excavated material shall be piled in a manner that will not endanger the WORK and that will avoid obstructing roadways and driveways.
- 3.4.11 **REMOVAL OF WATER** The Contractor shall, at all times during construction, be responsible for all erosion control, provide and maintain ample means and devices with which to

promptly remove and properly dispose of all water entering the excavations, or other parts of the Work, until all work to be performed therein has been completed.

- 3.4.12 **EXCAVATION PROTECTION** Excavations shall be protected by barricades. The entire excavation shall be roped off or fenced and flagged when the work area is unattended. All barricades, signs, fencing, etc. shall be supplied by the Contractor. No excavations may be left open over weekends or holidays.
 - A) Safety Signs and Flags Safety signs and flags shall be used when a trench is opened and when men are working. Special care shall be taken in placing safety signs, or flags, so that traffic will be adequately warned of the danger. Material and equipment shall be kept out of the way of pedestrians and traffic and shall be stored in a safe manner.
 - B) The Rules and Regulations by OSHA, and appropriate authorities (such as the Illinois Department of Transportation) respecting safety provisions shall be observed. The IDOT manual on Uniform Traffic Control Devices for streets and highways shall be followed.

3.4.13 CONSTRUCTION IN EASEMENTS

- A) Private Property In easements across private property, the Contractor shall confine all operations in the easement area and shall be responsible and liable for all damage outside of the easement area, including crop damage.
- B) Surface Improvements Trees, fences, shrubbery, or other types of surface improvements located in easements shall require protection during construction.

3.4.14 BACKFILL

Remove all timber, chunks of wood, or other organic material from the backfill. No trash or debris will be allowed in the backfill at any time. Special precautions must be taken with frozen backfill material to prevent clods from falling directly on the pipe.

In rocky soil, a minimum of twelve inches (12") of rock-free soil padding should be provided beneath, around, and above the pipe. Rock shield may be used in lieu of dirt padding to protect the pipe.

Sufficient backfill shall be used so that no depressions remain after settling to interfere with traffic or drainage. Excessive mounds shall be avoided. The backfill shall be compacted by use of tamping machines, rolling or wetting down.

Avoid delays in backfilling to prevent the open ditch from interfering with traffic or normal activities. Special attention must be given to adjacent structures to prevent damage during backfilling. Any tile runs interrupted by the ditch shall be carefully restored and protected.

Ditch checks shall be installed, where required, by use of sandbags or other methods.

Granular backfill shall be used at all road and driveway crossings above sand fill around pipe. Sand fill shall be at least twelve inches (12") above the top of pipe.

Special care shall be taken to fill voids due to settling or cave-ins caused by boring equipment.

3.4.15 ROAD CROSSINGS

A) All highway and road crossings shall be continuously maintained to insure safe passage of traffic. Where crossing is made by the open ditch method, by-pass roads, temporary backfill, or temporary bridging shall be installed to permit the uninterrupted flow of traffic. At all crossings, adequate and proper traffic aids such as warning signs, flares, guards and other safeguards shall be utilized to insure the safety of the public.

All open cut crossings, driveways or roads shall be backfilled with sand to twelve inches (12") above top of pipe and should contain no stones, and should be spread in uniform layers as to completely fill the trench with a uniform dense backfill on the pipe. The remainder of the trench shall be filled with Aggregate Surface Course, Type B, CA-6 or CA-10. In instances where the trench for the crossing leaves voids around the pipe due to cave-ins, washouts, or shifting of the soil, these shall be backfilled with granular backfills above and compacted by hand tamping or machine tamping.

3.4.16 DIRECTIONAL BORING

The procedures outlined in this section should be followed whenever directional boring is being used.

DAMAGE PREVENTION WHEN BORING

- A) Use the Illinois One Call notification system to have facilities within the immediate area located and marked. Directly contact known, non-participating utility owners for facility location.
- B) Ensure that known facilities are located and marked prior to commencing work.
- C) Expose facilities within the immediate work area by hand excavation before starting a bore if the depths of the facilities are not established by other means.
- D) Consider sewer systems within the area. Sewer systems are especially vulnerable to damage from boring operations for the following reasons:
 - 1. Lines are often non-metallic, making them difficult to locate.
 - 2. Clean-outs or other indications of laterals may be hidden or non-existent.
 - 3. Damage may not be readily apparent when a sewer, particularly a gravity flow system, is pierced by a boring machine.
- E) Notify residential and business neighbors in the area of impending work.
- F) Ensure adequate clearance of overhead electric, telephone, or cable lines.
- G) Bore pits shall be located outside proposed rail loop construction limits.

PROTECTING EXISTING GAS FACILITIES

- A) When it is anticipated that the bore will cross or come near the edge of an underground facility, expose that facility to determine its precise location to ensure adequate separation between the existing and proposed facilities.
- B) When the bore will run parallel to an existing facility, expose that facility (pothole) or use locating technology to verify that adequate clearance is maintained between the bore and the existing facilities during the boring operation (for both the drilling of the pilot hole and the back reaming operation). Calculation of the separation distance should account for the largest diameter back reamer that will be used in the boring process.
- C) Where potholes are used for visual inspection, they should be placed at intervals that will ensure that clearance is maintained during boring operations. Factors to consider for pothole intervals include the following:
 - 1. Proximity of proposed bore path to the pipeline facilities.
 - 2. Type of facility (existing and proposed).
 - 3. Type of soil.
 - 4. Size and controllability of the bore.

- D) Locate the existing facility and the newly installed facility to ensure that the installation is in the intended location.
- E) Conduct a leakage survey over pipelines that could have been affected by the trenchless installation.

LIMITS AND OBSTRUCTIONS

Obstructions that should be considered include the following.

- A) Magnetic influences within 75 feet of the proposed bore path.
- B) Buried or abandoned structures.
- C) Utility infrastructure.
- D) Underground or elevated pipelines.
- E) Overhead obstructions at the drill site or exit areas.
- F) Geotechnical characteristics.

INSTRUMENTATION

- A) A surface monitoring system may be used to track the location of the down-hole probe during the pilot hole drilling. The installer should ensure that such monitoring controls the drilling path accuracy and allows for necessary corrections. The space between monitor readings is determined by the need for accuracy in placement of the pipeline.
- B) Some form of gauging should be used to monitor the pulling force.

CONSTRUCTION INSPECTION

- A) The installers should ensure that the pipe pull section is adequately supported during pullback.
- B) The proper containment and disposal of drilling mud or fluids should be verified to ensure compliance with applicable requirements.
- C) Other considerations are as follows.
 - 1. Pipe handling during stringing, welding, and pullback operations. Care should be taken to prevent dents, gouges, or scrapes along the pipeline.
 - 2. Pipeline testing process.
 - 3. Weld joints for bore string are properly prepared by grit blasting or an industrial surface preparation tool.
 - 4. Contractor is to use a jeep at the correct voltage setting during pullback or before placing into trench in order to detect and repair any coating flaws on the pipeline.

DAMAGE CAUSED BY DIRECTIONAL DRILLING

If damage is done to existing utilities, the following shall be done.

- A) The situation shall be stabilized to prevent additional safety hazards and to prevent more damage to utilities. (Note: Safety hazards can include electrocution, explosion, and contamination depending on the type and size of pipeline damaged.)
- B) The affected utility shall be notified of the damage created, including preliminary observations by the boring machine operator of the location and nature of the damage.
- C) One call enforcement shall be notified of the damage. Information needed by one call includes dig number for the area, type of facility, the affected utility, and the location of the damage at the dig site. See Section 3 for more details on reporting main line damages to one call.
- D) Boring in the affected area shall be delayed until the hazard is removed and additional locating is done to prevent future damage. This additional locating can include hand digging and additional line locates. Once an area is determined to be safe and the true location of the damaged utility is located boring can resume.

3.4.17 CLEAN-UP

Following the installation and backfilling of the pipe line, the right-of-way and the surrounding area traversed shall be restored to its former condition. All holes and ruts shall be repaired and smoothed over and the area restored to a stable and usable condition consistent with the use intended prior to building of the pipe line.

The good will of the property owner, private or public, is essential. All temporary roads, bridges and culverts shall be removed, unless required for permanent access and meet with the land Owner's approval.

Fences shall be restored in kind to their former strength and condition, or better. Other types of enclosures, such as hedges, require special attention.

All surplus materials and all tools and temporary structures shall be removed from the site by the Contractor. All dirt, rubbish, and excess earth from the excavation shall be hauled to a dump provided by the Contractor and the construction site left clean and acceptable to the Owner Representative's discretion at the earliest possible date. No open burning will be allowed.

Clean-up shall be performed as nearly as practicable behind the rest of the construction to prevent inconvenience to the property owner. Complete cooperation with the owner is essential to insure that all requirements of right-of-way agreements are satisfied.

3.4.18 **SEEDING**

Where existing grassed areas have been disturbed by construction operation, or where designated by the Engineer, the Contractor shall prepare seed beds, furnish and spread fertilizers and lime and furnish and plant seeding as specified below.

A) Material

- 1. Fertilizer shall be standard commercial 10-8-6 grade, uniform in composition, free flowing and suitable for application with approved equipment.
- 2. Lime shall be ground limestone containing all of the finer particles obtained in the grinding process and ground sufficiently fine so that not less than eighty percent (80%) will pass through a No. 8 sieve.

B) Preparation of Seed Bed

- 1. After the areas to be seeded have been brought to the proper grades and cleared of all stones, boulders and debris, the areas shall be thoroughly tilled to a depth of at least three inches (3") by discing, harrowing, or other approved methods.
- 2. Fertilizer shall be distributed uniformly at the rate of four hundred (400) pounds per acre, over the area indicated to be fertilized, and shall be incorporated into the soil to a depth of at least three (3) inches by discing, harrowing or other approved methods acceptable to the Engineer. The incorporation of fertilizer may be a part of the tillage operation specified above.
- 3. Lime shall be distributed uniformly on all areas to be fertilized at the rate of one (1) ton to one (1) acre and shall be incorporated in the soil to a depth of at least three (3) inches by discing, harrowing, or by other methods acceptable to the Engineer, immediately following or simultaneously with the incorporation of the fertilizing.

- C) Seeding Methods No seed shall be sown during high winds or when the ground is not in a proper condition for seeding. Equipment shall be operated in a manner to insure complete coverage of the entire area to be seeded.
 - Within 12 hours all seed areas shall be rolled at right angles to the runoff with an approved type roller or culti-packer to compact the seed bed and place the seed in contact with the soil. The optimum depth for seeding shall be one quarter inch. Following installation of the fertilizer and seed, straw should be placed over the area seeded as needed.
- D) Disposal of Surplus Excavated Material Surplus excavated material not seeded for backfill shall be promptly removed from the site by the Contractor.

The cost of removal and disposal of surplus excavated materials will be included in the price bid and no additional payment shall be allowed therefore.

SECTION 3.5 INSTALLATION

3.5.01 **GENERAL**

The Work to be performed under this Specification includes the installation of all steel pipeline, casings, and bores, cathodic protection and associated appurtenances. The Contractor shall be responsible for the safe storage of all materials to be used in this Work until it has been incorporated into the Work. Attention is directed to the General Conditions and also other sections of the Specifications which offset the Work under this section.

3.5.02 SUPERVISION AND EMPLOYEES

The Contractor shall have an experienced Superintendent on the job at all times. He shall have read and be familiar with these Specifications and the Drawings, and be prepared to direct the work in such a manner as to obtain compliance with these Specifications and Contract Documents. Lack of experience with gas piping construction will constitute a valid reason for complete removal of any Superintendent. All employees engaged in the execution of this Contract shall be experienced and qualified in the work they perform so as to produce a first class installation.

3.5.03 LAYING OF PIPE

Under normal circumstances, a minimum of twenty four inches (24") of cover below future finished grade of the surrounding area is required. Road crossings will require thirty six (36") of cover.

- A) Pipeline Installation Pipe shall be supported by a firm rock-free bed so as to avoid shear or tensile stresses resulting from backfill, thermal expansion and contraction, or external loading.
- B) Skids Skids used to support pipe alongside ditch prior to lowering shall be of sufficient cross-section and strength to support pipe without danger of breaking. They shall be of sufficient length and bearing to provide necessary support at each side of the ditch when used to support pipe over the ditch. Padding shall be used where skids are in contact with coating.
 - C) Bends The number of bends shall be kept to a minimum by proper grading of the ditch in approaches to road crossings, streams, shallow water coarse, across rises in the ground, and other obstructions. Changes in vertical or horizontal directions

shall be accomplished by use of fittings, if possible, as indicated on the Drawings.

D) Night Capping - The open ends of the pipe shall be securely closed (water tight under 10 ft. head of water) at the end of each day's work, or when work is discontinued on a section, and shall not be reopened until work on the section is resumed.

3.5.04 **DETAILS OF WORK**

CLEARING

- A) Clearing is defined as the removal of boulders, rocks, trees, shrubs, grass, weeds, crops, or other obstacles on the construction area or right-of-way which of necessity must be removed to accomplish the work.
 - 1. Contractor shall preserve without injury all roads, poles, lawns, stone walls, ditches, canals, and similar property, as well as trees (in farm yards, groves, orchards, windbreak areas and casual shade trees), shrubs and similar desirable growths, to the full extent consistent with the performance of the work.
 - 2. The method of clearing rights-of-way should take into account matters of soil stability, protection of natural vegetation, and the protection of adjacent resources.
- B) Contractor shall clear the right-of-way only to a width sufficient for his needs in constructing the line, and within the limits of the rights-of-way furnished by Owner. Clearing is not anticipated for this project.
- C) Contractor shall protect Owner's survey stakes while clearing and thereafter as long as useful.

3.5.05 STRINGING PIPE

A) All pipe, valves, fittings, pipe coating, casing and material of any description to be used in or about the construction of the facilities hereunder shall be strung on the right-of-way provided by Owner.

- B) Contractor shall take all necessary precautions to prevent injury or damage to pipe and casing during stringing and shall lift all pipe and casing from trucks with slings equipped with padded hooks or padded calipers.
- C) Contractor shall string the pipe so as to leave gaps across the right-of-way where requested by the landowner, tenants, or Owners Representative to facilitate the movement of vehicles, or equipment.
- D) It will be the responsibility of the Contractor to see that the pipe is strung for proper placement of the pipe by size, weight and Specifications as called for herein. Any moving of pipe resulting from failure to comply with these requirements shall be at Contractor's expense.
- E) In muddy and other areas designated by the Owner's Representative, pipe shall be strung on skids high enough to keep foreign matter from entering the pipe.

3.5.06 CROSSING OTHER UNDER GROUND FACILITIES

- A) Protect all underground facilities encountered in the progress of the work.
- B) Underground facilities located at points where excavation is required shall be uncovered by hand before machine excavation will be permitted.
- C) The exact location of all underground facilities (except tile lines) shall be marked with appropriate signs by Contractor prior to the commencement of machine excavation.

3.5.07 **JOINTS**

- A) All pipe joints shall be cleaned and all pipe shall be free from obstructions before pipe connections are made. All main line pipe and fittings will be fused using a butt or electrofusion process.
- B) All pipe joints are to be properly aligned in accordance with manufacturers instructions or Owner's O&M prior to performing the fusion process.
- C) All open ends must be thoroughly protected.

- D) All steel pipe joints shall be cool to the touch before applying any protective coatings.
- E) All buried steel pipe joints and fittings shall be coated with Denso Densotherm hot tape or other approved coating by the Owner or Engineer.

3.5.08 LOWERING PIPE

- A) All pipe shall be placed on skids at the side of the trench.
- B) The pipe shall be lowered into the trench gradually and uniformly so that each point of suspension bears its proportional part of its total weight.
- C) Pipe shall not be lowered into the trench unless Owner's Representative is present.
 - 1. Contractor shall, before installation of pipe, remove water from the trench to the extent necessary to prevent floating of pipe, and pipe must be kept dry until coating is repaired.
 - 2. Mechanical means or devices shall not be used to force pipe into the trench.
 - 3. Pipe shall not be hauled or handled by any means or process which allows risks of injury to the pipeline or prevents inspection of the pipeline in place in the trench before same is covered, except as and to the extent that the Owner's Representative does not prohibit another method of handling.
 - 4. If rock is encountered, padding material free from rock or gravel, (subject to approval of the Engineer) and rock shield shall be placed around the pipe to protect the pipe coating from injury.
 - 5. Distribution of slack in the line shall conform to the following:
 - a. Contractor shall construct pipelines hereunder so as to provide adequate slack and properly distribute such slack throughout the pipeline.
 - b. Sag bends will conform to the bottom of the ditch.

3.5.09 CLEANING AND PIGGING

The entire length of installed main shall be cleaned by the Contractor with suitable purging process prior to testing and completion of tie-ins.

3.5.10 MISCELLANEOUS

- A) Any gouges, grooves, dents or arc burns in the pipeline resulting from Contractor's operations, as further defined below, shall be removed by Contractor, at no expense to Owner.
- B) Welding or fusion operations shall not be performed during periods of rain or excessive wind, unless such operations can be properly protected by the use of shields or other shelter.
- C) Pipe Damage No dents, gouges, or grooves shall be permitted in the pipeline.

3.5.11 TESTING AND PURGING OF PIPELINE AND FITTINGS

- A) The new fittings and sections of the 4", 2" and service lines shall be <u>pressure</u> tested prior to being placed in service. All new sections of pipeline shall be subjected to a leak and strength test using air or nitrogen to at one hundred (100) psig and no more than one hundred twenty (120) psig. All new sections of pipeline shall be strength tested for a minimum of eight (8) hours to establish a maximum allowable operating pressure (MAOP) of 66 psig. All testing of the pipeline shall be conducted using a pressure recording chart. Any drop in the initial test pressure not explained by a temperature change shall result in a failed test. No test shall be terminated without the approval of the Owner. Air or nitrogen can be used as the test medium. A copy of the pressure test record form can be found at the end of this section.
- B) Prior to being placed in service, (test required), all piping shall be purged with gas until completely air free. A moderately rapid and continuous flow of gas shall be introduced at the one end of the gas line and air vented at the other end. The gas flow shall be continued without interruption until vented gas is free from air. No

purging will be allowed through PE pipe.

3.5.12 RECORDKEEPING

All test records of the pipeline shall be turned in to the Gas Superintendent <u>daily</u>. Additionally, all as-built drawings, contractor daily logs, bore profiles, and other construction information that is requested by Owner or Engineer shall be turned in to Owner prior to request of final inspection.

3.5.13 CUSTOMER RE-LIGHTING

Any relighting will be the responsibility of the City of Chester unless necessary due to negligence of the Contractor.

3.5.14 CLEAN-UP

- A) General Contractor shall keep all working areas clear and free from any accumulation of defective material, junk, brush, trees, rock and boulders and similar movable objects during the entire process of the work.
 - 1. All such movable objects shall be accumulated, segregated and disposed of by Contractor in areas approved by the Owner and at Contractor's expense.
 - a. Each of Contractor's crews shall keep all working areas completely clear and free from junk and debris resulting from their particular operation, including immediate disposal of discarded welding rod, pipe trimmings, paint containers, broken skids or any other similar material that might become hazardous if worked into the surface of the ground by traffic.
 - b. In all phases of cleanup, there shall be no open burning.

 Contractor shall, as a contingency of the work, haul and dispose of any material, debris, trees, stumps or vegetation from the right-of-way.
 - 2. Contractor shall restore drainage ditches as required for the continuation of gravity flow.
- B) As soon as the work is completed, Contractor shall clean the entire area utilized

by his organization.

- 1. All new or used construction materials not incorporated in the work shall be neatly piled or stacked on the site of the work, as designated by the Owner's Representative.
- 2. In respect to pipeline construction, final cleanup work along the right-of-way shall be done continuously as the work progresses and shall follow the lowering operation.
- 3. The work shall not be deemed completed for the purpose of payment until all provisions have been complied with to the satisfaction of the Owner.

 - Deployment of Sediment Control Practices (including stabilized construction entrances/exits)
 - Deployment of Construction Site Management Practices (including concrete washout facilities, chemical storage, refueling locations, etc.)
 - Paving, saw-cutting, and any other pavement related operations
 - Major planned stockpiling operations
 - Timeframe for other significant long-term operations or activities that may plan non-storm water discharges such as dewatering, grinding, etc.
 - Permanent stabilization activities for each area of the project
 - The Contractor and each subcontractor shall provide, as an attachment to their signed Contractor Certification Statement, a discussion of how they will comply with the requirements of the permit in regard to the following items and provide a graphical representation showing location and type of BMPs to be used when applicable:

- Vehicle Entrances and Exits Identify type and location of stabilized construction entrances and exits to be used and how they will be maintained.
- Material Delivery, Storage and Use Discuss where and how materials including chemicals, concrete
 curing compounds, petroleum products, etc. will be stored for this project.
- Stockpile Management Identify the location of both on-site and off-site stockpiles. Discuss what BMPs will be used to prevent pollution of storm water from stockpiles.

III. Maintenance:

The following additional procedures will be used to maintain, in good and effective operating conditions, the vegetation, erosion and sediment control measures and other protective measures identified in this plan. It will be the Contractor's responsibility to attain maintenance guidelines for any manufactured BMPs which are to be installed and maintained per manufacture's specifications.

Qualified personnel shall inspect disturbed areas of the construction site which have not yet been finally stabilized, structural control measures, and locations where vehicles and equipment enter and exit the site using IDOT Storm Water Pollution Prevention Plan Erosion Control Inspection Report (BC 2259). Such inspections shall be conducted at least once every seven (7) calendar days and within twenty-four (24) hours of the end of a storm or by the end of the following business or work day that is 0.5 inch or greater or equivalent snowfall.

Inspections may be reduced to once per month when construction activities have ceased due to frozen conditions. Weekly inspections will recommence when construction activities are conducted, or if there is 0.5" or greater rain event, or a discharge due to snowmelt occurs.

If any violation of the provisions of this plan is identified during the conduct of the construction work covered by this plan, the Resident Engineer shall notify the appropriate IEPA Field Operations Section office by email at: epa.swnoncomp@illinois.gov, telephone or fax within twenty-four (24) hours of the incident. The Resident Engineer shall then complete and submit an "Incidence of Non-Compliance" (ION) report for the identified violation within five (5) days of the incident. The Resident Engineer shall use forms provided by IEPA and shall include specific information on the cause of noncompliance, actions which were taken to prevent any further causes of noncompliance, and a statement detailing any environmental impact which may have resulted from the noncompliance. All reports of non-compliance shall be signed by a responsible authority in accordance with Part VI. G of the Permit ILR10.

All warning signs shall have minimum dimensions of 1200 mm x 1200 mm (48" x 48") and have a black legend on a fluorescent orange reflectorized background, meeting, as a minimum, Type AP reflectivity requirements of Table 1091-2 in Article 1091.02.

ADJUSTING FRAMES AND GRATES (BDE)

Effective: April 1, 2017

Add the following to Article 602.02 of the Standard Specifications:

- - Note 4. High density expanded polystyrene adjusting rings with polyurea coating shall meet the design load requirements of AASHTO HS20/25. The rings may be used to adjust the frames and grates of drainage and utility structures up to a maximum of 6 in. (150 mm). They shall be installed and sealed underneath the frames according to the manufacturer's specifications.

Note 5. Riser rings fabricated from EPP may be used to adjust the frames and grates of drainage and utility structures up to a maximum of 6 in. (150 mm). An adhesive meeting ASTM C 920, Type S, Grade N5, Class 25 shall be used with EPP adjustment rings. The top ring of the adjustment stack shall be a finish ring with grooves on the lower surface and flat upper surface. The joints between all manhole adjustment rings and the frame and cover shall be sealed using the approved adhesive. In lieu of the use of an adhesive, an internal or external mechanical frame-chimney seal may be used for watertight installation. EPP adjustment rings shall not be used with heat shrinkable infiltration barriers."

Add the following to Section 1043 of the Standard Specifications:

"1043.04 High Density Expanded Polystyrene Adjusting Rings with Polyurea Coating. High density expanded polystyrene adjustment rings with polyurea coating shall be designed and tested to meet or exceed an HS25 wheel load according to the AASHTO Standard Specifications for Highway Bridges (AASHTO M306 HS-25). The raw material suppliers shall provide certifications of quality or testing using the following ASTM standards, and upon request, certify that only virgin material was used in the manufacturing of the expanded polystyrene rings.

High density expanded polystyrene adjustment rings with polyurea coating shall have no void areas, cracks, or tears. The actual diameter or length shall not vary more than 0.125 in. (3 mm) from the specified diameter or length. Variations in height are limited to \pm 0.063 in. (\pm 1.6 mm). Variations shall not exceed 0.25 in. (6 mm) from flat (dish, bow, or convoluting edge) or 0.125 in. (3 mm) for bulges or dips in the surface.

1043.05 Expanded Polypropylene (EPP) Adjusting Rings. The EPP adjusting rings shall be manufactured using a high compression molding process to produce a minimum finished density of 7.5 lb/cu ft (120 g/l). The EPP rings shall be made of materials meeting ASTM D 3575 and ASTM D 4819-13. The grade adjustments shall be designed and tested according to the AASHTO Standard Specifications for Highway Bridges (AASHTO M 306 HS-25).

Grade rings shall contain upper and lower keyways (tongue and groove) for proper vertical alignment and sealing. The top ring, for use directly beneath the cast iron frame, shall have keyways (grooves) on the lower surface with a flat upper surface.

Adhesive or sealant used for watertight installation of the manhole grade adjustment rings shall meet ASTM C 920, Type S, Grade NS, Class 25, Uses NT, T, M, G, A, and O.

EPP adjustment rings shall have no void areas, cracks, or tears. The actual diameter or length shall not vary more than 0.125 in. (3 mm) from the specified diameter or length. Variations in height are limited to ± 0.063 in. $(\pm 1.6 \text{ mm})$. Variations shall not exceed 0.25 in. (6 mm) from flat (dish, bow, or convoluting edge) or 0.125 in. (3 mm) for bulges or dips in the surface."

COMPENSABLE DELAY COSTS (BDE)

Effective: June 2, 2017

Revise Article 107.40(b) of the Standard Specifications to read:

- "(b) Compensation. Compensation will not be allowed for delays, inconveniences, or damages sustained by the Contractor from conflicts with facilities not meeting the above definition; or if a conflict with a utility in an unanticipated location does not cause a shutdown of the work or a documentable reduction in the rate of progress exceeding the limits set herein. The provisions of Article 104.03 notwithstanding, compensation for delays caused by a utility in an unanticipated location will be paid according to the provisions of this Article governing minor and major delays or reduced rate of production which are defined as follows.
 - (1) Minor Delay. A minor delay occurs when the work in conflict with the utility in an unanticipated location is completely stopped for more than two hours, but not to exceed two weeks.
 - (2) Major Delay. A major delay occurs when the work in conflict with the utility in an unanticipated location is completely stopped for more than two weeks.
 - (3) Reduced Rate of Production Delay. A reduced rate of production delay occurs when the rate of production on the work in conflict with the utility in an unanticipated location decreases by more than 25 percent and lasts longer than seven calendar days."

Revise Article 107.40(c) of the Standard Specifications to read:

- "(c) Payment. Payment for Minor, Major, and Reduced Rate of Production Delays will be made as follows.
 - (1) Minor Delay. Labor idled which cannot be used on other work will be paid for according to Article 109.04(b)(1) and (2) for the time between start of the delay and the minimum remaining hours in the work shift required by the prevailing practice in the area.

Equipment idled which cannot be used on other work, and which is authorized to standby on the project site by the Engineer, will be paid for according to Article 109.04(b)(4).

(2) Major Delay. Labor will be the same as for a minor delay.

Equipment will be the same as for a minor delay, except Contractor-owned equipment will be limited to two weeks plus the cost of move-out to either the Contractor's yard or another job and the cost to re-mobilize, whichever is less.

Rental equipment may be paid for longer than two weeks provided the Contractor presents adequate support to the Department (including lease agreement) to show retaining equipment on the job is the most economical course to follow and in the public interest.

(3) Reduced Rate of Production Delay. The Contractor will be compensated for the reduced productivity for labor and equipment time in excess of the 25 percent threshold for that portion of the delay in excess of seven calendar days. Determination of compensation will be in accordance with Article 104.02, except labor and material additives will not be permitted.

Payment for escalated material costs, escalated labor costs, extended project overhead, and extended traffic control will be determined according to Article 109.13."

Revise Article 108.04(b) of the Standard Specifications to read:

- "(b) No working day will be charged under the following conditions.
 - (1) When adverse weather prevents work on the controlling item.
 - (2) When job conditions due to recent weather prevent work on the controlling item.
 - (3) When conduct or lack of conduct by the Department or its consultants, representatives, officers, agents, or employees; delay by the Department in making the site available; or delay in furnishing any items required to be furnished to the Contractor by the Department prevents work on the controlling item.
 - (4) When delays caused by utility or railroad adjustments prevent work on the controlling item.
 - (5) When strikes, lock-outs, extraordinary delays in transportation, or inability to procure critical materials prevent work on the controlling item, as long as these delays are not due to any fault of the Contractor.
 - (6) When any condition over which the Contractor has no control prevents work on the controlling item."

Revise Article 109.09(f) of the Standard Specifications to read:

"(f) Basis of Payment. After resolution of a claim in favor of the Contractor, any adjustment in time required for the work will be made according to Section 108. Any adjustment in the costs to be paid will be made for direct labor, direct materials, direct equipment, direct jobsite overhead, direct offsite overhead, and other direct costs allowed by the resolution. Adjustments in costs will not be made for interest charges, loss of anticipated profit, undocumented loss of efficiency, home office overhead and unabsorbed overhead



other than as allowed by Article 109.13, lost opportunity, preparation of claim expenses and other consequential indirect costs regardless of method of calculation.

The above Basis of Payment is an essential element of the contract and the claim cost recovery of the Contractor shall be so limited."

Add the following to Section 109 of the Standard Specifications.

"109.13 Payment for Contract Delay. Compensation for escalated material costs, escalated labor costs, extended project overhead, and extended traffic control will be allowed when such costs result from a delay meeting the criteria in the following table.

Payment for each of the various costs will be according to the following.

When the delay causes work, which would have otherwise been completed, to be done after material and/or labor costs have increased, such increases will be paid. Payment for escalated material costs will be limited to the increased costs substantiated by documentation furnished by the Contractor. Payment for escalated labor costs will be limited to those items in Article 109.04(b)(1) and (2), except the 35 percent and 10 percent additives will not be permitted.
- (b) Extended Project Overhead. For the duration of the delay, payment for extended project overhead will be paid as follows.
 - (1) Direct Jobsite and Offsite Overhead. Payment for documented direct jobsite overhead and documented direct offsite overhead, including onsite supervisory and administrative personnel, will be allowed according to the following table.

- (2) Home Office and Unabsorbed Overhead. Payment for home office and unabsorbed overhead will be calculated as 8 percent of the total delay cost.
- (c) Extended Traffic Control. Traffic control required for an extended period of time due to the delay will be paid. For working day contracts the payment will be made according to Article 109.04. For completion date contracts, an adjustment will be determined as follows.

Extended Traffic Control occurs between April 1 and November 30:

ETCP Adjustment (\$) = TE x ($\%/100 \times CUP / OCT$)

Extended Traffic Control occurs between December 1 and March 31:

The Contractor shall fully cooperate with the Department in its efforts to recover from another party any money paid to the Contractor for delay damages under this provision."

STATE OBLIGATION. This Special Provision will also be used by the Department to satisfy the requirements of the Business Enterprise for Minorities, Females, and Persons with Disabilities Act, 30 ILCS 575. When this Special Provision is used to satisfy state law requirements on 100 percent state-funded contracts, the federal government has no involvement in such contracts (not a federal-aid contract) and no responsibility to oversee the implementation of this Special Provision by the Department on those contracts. DBE participation on 100 percent state-funded contracts will not be credited toward fulfilling the Department's annual overall DBE goal required by the US Department of Transportation to comply with the federal DBE program requirements.

<u>CONTRACTOR ASSURANCE</u>. The Contractor makes the following assurance and agrees to include the assurance in each subcontract that the Contractor signs with a subcontractor.

The Contractor, subrecipient, or subcontractor shall not discriminate on the basis of race, color, national origin, or sex in the performance of this contract. The Contractor shall carry out applicable requirements of 49 CFR Part 26 in the award and administration of contracts funded in whole or in part with federal or state funds. Failure by the Contractor to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy as the recipient deems appropriate, which may include, but is not limited to:

- (a) Withholding progress payments;
- (b) Assessing sanctions;
- (c) Liquidated damages; and/or
- (d) Disgualifying the Contractor from future bidding as non-responsible.

OVERALL GOAL SET FOR THE DEPARTMENT. As a requirement of compliance with 49 CFR Part 26, the Department has set an overall goal for DBE participation in its federally assisted contracts. That goal applies to all federal-aid funds the Department will expend in its federally assisted contracts for the subject reporting fiscal year. The Department is required to make a

good faith effort to achieve the overall goal. The dollar amount paid to all approved DBE companies performing work called for in this contract is eligible to be credited toward fulfillment of the Department's overall goal.

CONTRACT GOAL TO BE ACHIEVED BY THE CONTRACTOR. This contract includes a specific DBE utilization goal established by the Department. The subject line must include the bid Item Number and the Letting date. The Utilization Plan should be sent as one .pdf file, rather than multiple files and emails for the same Item Number. It is the responsibility of the bidder to obtain confirmation of email or fax delivery.

Alternatively, the Utilization Plan may be sent by certified mail or delivery service within the five calendar day period. If a question arises concerning the mailing date of a Utilization Plan, the mailing date will be established by the U.S. Postal Service postmark on the certified mail receipt from the U.S. Postal Service or the receipt issued by a delivery service when the Utilization Plan is received by the Department. It is the responsibility of the bidder to ensure the postmark or receipt date is affixed within the five days if the bidder intends to rely upon mailing or delivery to satisfy the submission day requirement. The Utilization Plan is to be submitted to:

The Department will not accept a Utilization Plan if it does not meet the five day submittal requirement and the bid will be declared not responsive. In the event the bid is declared not responsive due to a failure to submit a Utilization Plan or failure to comply with the bidding procedures set forth herein, the Department may elect to cause the forfeiture of the penal sum of the bidder's proposal guaranty, and may deny authorization to bid the project if re-advertised for bids. The Department reserves the right to invite any other bidder to submit a Utilization Plan at any time for award consideration.

- (b) The Utilization Plan shall indicate that the bidder either has obtained sufficient DBE participation commitments to meet the contract goal or has not obtained enough DBE participation commitments in spite of a good faith effort to meet the goal. The Utilization Plan shall further provide the name, telephone number, and telefax number of a responsible official of the bidder designated for purposes of notification of Utilization Plan approval or disapproval under the procedures of this Special Provision.
- (c) The Utilization Plan shall include a DBE Participation Commitment Statement, Department form SBE 2025, for each DBE proposed for the performance of work to achieve the contract goal. For bidding purposes, submission of the completed SBE 2025 forms, signed by the DBEs and scanned or faxed to the bidder will be acceptable as long as the original is available and provided upon request. All elements of information indicated on the said form shall be provided, including but not limited to the following:

- (1) The names and addresses of DBE firms that will participate in the contract;
- (2) A description, including pay item numbers, of the work each DBE will perform;
- (3) The dollar amount of the participation of each DBE firm participating. The dollar amount of participation for identified work shall specifically state the quantity, unit price, and total subcontract price for the work to be completed by the DBE. If partial pay items are to be performed by the DBE, indicate the portion of each item, a unit price where appropriate and the subcontract price amount;
- (4) DBE Participation Commitment Statements, form SBE 2025, signed by the bidder and each participating DBE firm documenting the commitment to use the DBE subcontractors whose participation is submitted to meet the contract goal;
- (5) If the bidder is a joint venture comprised of DBE companies and non-DBE companies, the Utilization Plan must also include a clear identification of the portion of the work to be performed by the DBE partner(s); and,
- (6) If the contract goal is not met, evidence of good faith efforts; the documentation of good faith efforts must include copies of each DBE and non-DBE subcontractor quote submitted to the bidder when a non-DBE subcontractor is selected over a DBE for work on the contract.

GOOD FAITH EFFORT PROCEDURES. The contract will not be awarded until the Utilization Plan submitted by the apparent successful bidder is approved. All information submitted by the bidder must be complete, accurate and adequately document that enough DBE participation has been obtained or document that good faith efforts of the bidder, in the event enough DBE participation has not been obtained, before the Department will commit to the performance of the contract by the bidder. The Utilization Plan will be approved by the Department if the Utilization Plan documents sufficient commercially useful DBE work to meet the contract goal or the bidder submits sufficient documentation of a good faith effort to meet the contract goal pursuant to 49 CFR Part 26, Appendix A. The Utilization Plan will not be approved by the Department if the Utilization Plan does not document sufficient DBE participation to meet the contract goal unless the apparent successful bidder documented in the Utilization Plan that it made a good faith effort to meet the goal. This means that the bidder must show that all necessary and reasonable steps were taken to achieve the contract goal. Necessary and reasonable steps are those which, by their scope, intensity and appropriateness to the objective, could reasonably be expected to obtain sufficient DBE participation, even if they were not successful. The Department will consider the quality, quantity, and intensity of the kinds of efforts that the bidder has made. Mere pro forma efforts, in other words, efforts done as a matter of form, are not good faith efforts; rather, the bidder is expected to have taken genuine efforts that would be reasonably expected of a bidder actively and aggressively trying to obtain DBE participation sufficient to meet the contract goal.

(a) The following is a list of types of action that the Department will consider as part of the evaluation of the bidder's good faith efforts to obtain participation. These listed factors

are not intended to be a mandatory checklist and are not intended to be exhaustive. Other factors or efforts brought to the attention of the Department may be relevant in appropriate cases, and will be considered by the Department.

- (1) Soliciting through all reasonable and available means (e.g. attendance at pre-bid meetings, advertising and/or written notices) the interest of all certified DBE companies that have the capability to perform the work of the contract. The bidder must solicit this interest within sufficient time to allow the DBE companies to respond to the solicitation. The bidder must determine with certainty if the DBE companies are interested by taking appropriate steps to follow up initial solicitations.
- (2) Selecting portions of the work to be performed by DBE companies in order to increase the likelihood that the DBE goals will be achieved. This includes, where appropriate, breaking out contract work items into economically feasible units to facilitate DBE participation, even when the prime Contractor might otherwise prefer to perform these work items with its own forces.
- (3) Providing interested DBE companies with adequate information about the plans, specifications, and requirements of the contract in a timely manner to assist them in responding to a solicitation.
- (4) a. Negotiating in good faith with interested DBE companies. It is the bidder's responsibility to make a portion of the work available to DBE subcontractors and suppliers and to select those portions of the work or material needs consistent with the available DBE subcontractors and suppliers, so as to facilitate DBE participation. Evidence of such negotiation includes the names, addresses, and telephone numbers of DBE companies that were considered; a description of the information provided regarding the plans and specifications for the work selected for subcontracting; and evidence as to why additional agreements could not be reached for DBE companies to perform the work.
 - b. A bidder using good business judgment would consider a number of factors in negotiating with subcontractors, including DBE subcontractors, and would take a firm's price and capabilities as well as contract goals into consideration. However, the fact that there may be some additional costs involved in finding and using DBE companies is not in itself sufficient reason for a bidder's failure to meet the contract DBE goal, as long as such costs are reasonable. Also the ability or desire of a bidder to perform the work of a contract with its own organization does not relieve the bidder of the responsibility to make good faith efforts. Bidders are not, however, required to accept higher quotes from DBE companies if the price difference is excessive or unreasonable. In accordance with subsection (c)(6) of the above Bidding Procedures, the documentation of good faith efforts must include copies of each DBE and non-DBE subcontractor quote submitted to the bidder when a non-DBE subcontractor was selected over a DBE for work on the contract.



- (5) Not rejecting DBE companies as being unqualified without sound reasons based on a thorough investigation of their capabilities. The bidder's standing within its industry, membership in specific groups, organizations, or associations and political or social affiliations (for example union vs. non-union employee status) are not legitimate causes for the rejection or non-solicitation of bids in the bidder's efforts to meet the project goal.
- (6) Making efforts to assist interested DBE companies in obtaining bonding, lines of credit, or insurance as required by the recipient or Contractor.
- (7) Making efforts to assist interested DBE companies in obtaining necessary equipment, supplies, materials, or related assistance or services.
- (8) Effectively using the services of available minority/women community organizations; minority/women contractors' groups; local, state, and federal minority/women business assistance offices; and other organizations as allowed on a case-by-case basis to provide assistance in the recruitment and placement of DBE companies.
- (b) If the Department determines that the apparent successful bidder has made a good faith effort to secure the work commitment of DBE companies to meet the contract goal, the Department will award the contract provided that it is otherwise eligible for award. If the Department determines that the bidder has failed to meet the requirements of this Special Provision or that a good faith effort has not been made, the Department will notify the responsible company official designated in the Utilization Plan that the bid is not responsive. The notification shall include a statement of reasons for the determination. If the Utilization Plan is not approved because it is deficient as a technical matter, unless waived by the Department, the bidder will be notified and will be allowed no more than a five calendar day period in order to cure the deficiency.
- (c) The bidder may request administrative reconsideration of a determination adverse to the bidder within the five working days after the receipt of the notification date of the determination by delivering the request to the Department of Transportation, Bureau of Small Business Enterprises, Contract Compliance Section, 2300 South Dirksen Parkway, Room 319, Springfield, Illinois 62764 (Telefax: (217) 785-1524). Deposit of the request in the United States mail on or before the fifth business day shall not be deemed delivery. The determination shall become final if a request is not made and delivered. A request may provide additional written documentation or argument concerning the issues raised in the determination statement of reasons, provided the documentation and arguments address efforts made prior to submitting the bid. The request will be forwarded to the Department's Reconsideration Officer. Reconsideration Officer will extend an opportunity to the bidder to meet in person in order to consider all issues of documentation and whether the bidder made a good faith effort to meet the goal. After the review by the Reconsideration Officer, the bidder will be sent a written decision within ten working days after receipt of the request for consideration, explaining the basis for finding that the bidder did or did not meet the goal or make adequate good faith efforts to do so. A final decision by the Reconsideration

Officer that a good faith effort was made shall approve the Utilization Plan submitted by the bidder and shall clear the contract for award. A final decision that a good faith effort was not made shall render the bid not responsive.

CALCULATING DBE PARTICIPATION. The Utilization Plan values represent work anticipated to be performed and paid for upon satisfactory completion. The Department is only able to count toward the achievement of the overall goal and the contract goal the value of payments made for the work actually performed by DBE companies. In addition, a DBE must perform a commercially useful function on the contract to be counted. A commercially useful function is generally performed when the DBE is responsible for the work and is carrying out its responsibilities by actually performing, managing, and supervising the work involved. The Department and Contractor are governed by the provisions of 49 CFR Part 26.55(c) on questions of commercially useful functions as it affects the work. Specific counting guidelines are provided in 49 CFR Part 26.55, the provisions of which govern over the summary contained herein.

- (a) DBE as the Contractor: 100 percent goal credit for that portion of the work performed by the DBE's own forces, including the cost of materials and supplies. Work that a DBE subcontracts to a non-DBE does not count toward the DBE goals.
- (b) DBE as a joint venture Contractor: 100 percent goal credit for that portion of the total dollar value of the contract equal to the distinct, clearly defined portion of the work performed by the DBE's own forces.
- (c) DBE as a subcontractor: 100 percent goal credit for the work of the subcontract performed by the DBE's own forces, including the cost of materials and supplies, excluding the purchase of materials and supplies or the lease of equipment by the DBE subcontractor from the prime Contractor or its affiliates. Work that a DBE subcontractor in turn subcontracts to a non-DBE does not count toward the DBE goal.
- (d) DBE as a trucker: 100 percent goal credit for trucking participation provided the DBE is responsible for the management and supervision of the entire trucking operation for which it is responsible. At least one truck owned, operated, licensed, and insured by the DBE must be used on the contract. Credit will be given for the following:
 - (1) The DBE may lease trucks from another DBE firm, including an owner-operator who is certified as a DBE. The DBE who leases trucks from another DBE receives credit for the total value of the transportation services the lessee DBE provides on the contract.
 - (2) The DBE may also lease trucks from a non-DBE firm, including from an owner-operator. The DBE who leases trucks from a non-DBE is entitled to credit only for the fee or commission is receives as a result of the lease arrangement.
- (e) DBE as a material supplier:

- (1) 60 percent goal credit for the cost of the materials or supplies purchased from a DBE regular dealer.
- (2) 100 percent goal credit for the cost of materials of supplies obtained from a DBE manufacturer.
- (3) 100 percent credit for the value of reasonable fees and commissions for the procurement of materials and supplies if not a DBE regular dealer or DBE manufacturer.

CONTRACT COMPLIANCE. Compliance with this Special Provision is an essential part of the contract. The Department is prohibited by federal regulations from crediting the participation of a DBE included in the Utilization Plan toward either the contract goal or the Department's overall goal until the amount to be applied toward the goals has been paid to the DBE. The following administrative procedures and remedies govern the compliance by the Contractor with the contractual obligations established by the Utilization Plan. After approval of the Utilization Plan and award of the contract, the Utilization Plan and individual DBE Participation Statements become part of the contract. If the Contractor did not succeed in obtaining enough DBE participation to achieve the advertised contract goal, and the Utilization Plan was approved and contract awarded based upon a determination of good faith, the total dollar value of DBE work calculated in the approved Utilization Plan as a percentage of the awarded contract value shall become the amended contract goal. All work indicated for performance by an approved DBE shall be performed, managed, and supervised by the DBE executing the DBE Participation Commitment Statement.

- (a) NO AMENDMENT. No amendment to the Utilization Plan may be made without prior written approval from the Department's Bureau of Small Business Enterprises. All requests for amendment to the Utilization Plan shall be submitted to the Department of Transportation, Bureau of Small Business Enterprises, Contract Compliance Section, 2300 South Dirksen Parkway, Room 319, Springfield, Illinois 62764. Telephone number (217) 785-4611. Telefax number (217) 785-1524.
- (b) <u>CHANGES TO WORK</u>. Any deviation from the DBE condition-of-award or contract plans, specifications, or special provisions must be approved, in writing, by the Department as provided elsewhere in the Contract. The Contractor shall notify affected DBEs in writing of any changes in the scope of work which result in a reduction in the dollar amount condition-of-award to the contract. Where the revision includes work committed to a new DBE subcontractor, not previously involved in the project, then a Request for Approval of Subcontractor, Department form BC 260A or AER 260A, must be signed and submitted. If the commitment of work is in the form of additional tasks assigned to an existing subcontract, than a new Request for Approval of Subcontractor shall not be required. However, the Contractor must document efforts to assure that the existing DBE subcontractor is capable of performing the additional work and has agreed in writing to the change.

- (c) <u>SUBCONTRACT</u>. The Contractor must provide DBE subcontracts to IDOT upon request. Subcontractors shall ensure that all lower tier subcontracts or agreements with DBEs to supply labor or materials be performed in accordance with this Special Provision.
- (d) <u>ALTERNATIVE WORK METHODS</u>. In addition to the above requirements for reductions in the condition of award, additional requirements apply to the two cases of Contractorinitiated work substitution proposals. Where the contract allows alternate work methods which serve to delete or create underruns in condition of award DBE work, and the Contractor selects that alternate method or, where the Contractor proposes a substitute work method or material that serves to diminish or delete work committed to a DBE and replace it with other work, then the Contractor must demonstrate one of the following:
 - (1) That the replacement work will be performed by the same DBE (as long as the DBE is certified in the respective item of work) in a modification of the condition of award; or
 - (2) That the DBE is aware that its work will be deleted or will experience underruns and has agreed in writing to the change. If this occurs, the Contractor shall substitute other work of equivalent value to a certified DBE or provide documentation of good faith efforts to do so; or
 - (3) That the DBE is not capable of performing the replacement work or has declined to perform the work at a reasonable competitive price. If this occurs, the Contractor shall substitute other work of equivalent value to a certified DBE or provide documentation of good faith efforts to do so.
- (e) TERMINATION AND REPLACEMENT PROCEDURES. The Contractor shall not terminate or replace a DBE listed on the approved Utilization Plan, or perform with other forces work designated for a listed DBE except as provided in this Special Provision. The Contractor shall utilize the specific DBEs listed to perform the work and supply the materials for which each is listed unless the Contractor obtains the Department's written consent as provided in subsection (a) of this part. Unless Department consent is provided for termination of a DBE subcontractor, the Contractor shall not be entitled to any payment for work or material unless it is performed or supplied by the DBE in the Utilization Plan.

As stated above, the Contractor shall not terminate or replace a DBE subcontractor listed in the approved Utilization Plan without prior written consent. This includes, but is not limited to, instances in which the Contractor seeks to perform work originally designated for a DBE subcontractor with its own forces or those of an affiliate, a non-DBE firm, or with another DBE firm. Written consent will be granted only if the Bureau of Small Business Enterprises agrees, for reasons stated in its concurrence document, that the Contractor has good cause to terminate or replace the DBE firm. Before transmitting to the Bureau of Small Business Enterprises any request to terminate and/or substitute a DBE subcontractor, the Contractor shall give notice in writing to the DBE subcontractor,

with a copy to the Bureau, of its intent to request to terminate and/or substitute, and the reason for the request. The Contractor shall give the DBE five days to respond to the Contractor's notice. The DBE so notified shall advise the Bureau and the Contractor of the reasons, if any, why it objects to the proposed termination of its subcontract and why the Bureau should not approve the Contractor's action. If required in a particular case as a matter of public necessity, the Bureau may provide a response period shorter than five days.

For purposes of this paragraph, good cause includes the following circumstances:

- (1) The listed DBE subcontractor fails or refuses to execute a written contract;
- (2) The listed DBE subcontractor fails or refuses to perform the work of its subcontract in a way consistent with normal industry standards. Provided, however, that good cause does not exist if the failure or refusal of the DBE subcontractor to perform its work on the subcontract results from the bad faith or discriminatory action of the prime contractor;
- (3) The listed DBE subcontractor fails or refuses to meet the prime Contractor's reasonable, nondiscriminatory bond requirements;
- (4) The listed DBE subcontractor becomes bankrupt, insolvent, or exhibits credit unworthiness;
- (5) The listed DBE subcontractor is ineligible to work on public works projects because of suspension and debarment proceedings pursuant 2 CFR Parts 180, 215 and 1200 or applicable state law.
- (6) You have determined that the listed DBE subcontractor is not a responsible contractor:
- (7) The listed DBE subcontractor voluntarily withdraws from the projects and provides to you written notice of its withdrawal;
- (8) The listed DBE is ineligible to receive DBE credit for the type of work required;
- (9) A DBE owner dies or becomes disabled with the result that the listed DBE subcontractor is unable to complete its work on the contract;
- (10) Other documented good cause that compels the termination of the DBE subcontractor. Provided, that good cause does not exist if the prime Contractor seeks to terminate a DBE it relied upon to obtain the contract so that the prime Contractor can self-perform the work for which the DBE contractor was engaged or so that the prime Contractor can substitute another DBE or non-DBE contractor after contract award.

When a DBE is terminated, or fails to complete its work on the Contract for any reason the Contractor shall make a good faith effort to find another DBE to substitute for the original DBE to perform at least the same amount of work under the contract as the terminated DBE to the extent needed to meet the established Contract goal. The good faith efforts shall be documented by the Contractor. If the Department requests documentation under this provision, the Contractor shall submit the documentation within seven days, which may be extended for an additional seven days if necessary at the request of the Contractor. The Department shall provide a written determination to the Contractor stating whether or not good faith efforts have been demonstrated.

- (f) PAYMENT RECORDS. The Contractor shall maintain a record of payments for work performed to the DBE participants. The records shall be made available to the Department for inspection upon request. After the performance of the final item of work or delivery of material by a DBE and final payment therefore to the DBE by the Contractor, but not later than thirty calendar days after payment has been made by the Department to the Contractor for such work or material, the Contractor shall submit a DBE Payment Agreement on Department form SBE 2115 to the Resident Engineer. If full and final payment has not been made to the DBE, the DBE Payment Agreement shall indicate whether a disagreement as to the payment required exists between the Contractor and the DBE or if the Contractor believes that the work has not been satisfactorily completed. If the Contractor does not have the full amount of work indicated in the Utilization Plan performed by the DBE companies indicated in the Utilization Plan and after good faith efforts are reviewed, the Department may deduct from contract payments to the Contractor the amount of the goal not achieved as liquidated and ascertained damages. The Contractor may request an administrative reconsideration of any amount deducted as damages pursuant to subsection (h) of this part.
- (g) <u>ENFORCEMENT</u>. The Department reserves the right to withhold payment to the Contractor to enforce the provisions of this Special Provision. Final payment shall not be made on the contract until such time as the Contractor submits sufficient documentation demonstrating achievement of the goal in accordance with this Special Provision or after liquidated damages have been determined and collected.
- (h) <u>RECONSIDERATION</u>. Notwithstanding any other provision of the contract, including but not limited to Article 109.09 of the Standard Specifications, the Contractor my request administrative reconsideration of a decision to deduct the amount of the goal not achieved as liquidated damages. A request to reconsider shall be delivered to the Contract Compliance Section and shall be handled and considered in the same manner as set forth in paragraph (c) of "Good Faith Effort Procedures" of this Special Provision, except a final decision that a good faith effort was not made during contract performance to achieve the goal agreed to in the Utilization Plan shall be the final administrative decision of the Department. The result of the reconsideration process is not administratively appealable to the U.S. Department of Transportation.

DOWEL BAR INSERTER (BDE)

Effective: January 1, 2017

Add the following to Article 420.03 of the Standard Specifications.

"(I) Mechanical Dowel Bar Inserter1103.20"

Revise Article 420.05(c) of the Standard Specifications to read:

"(c) Transverse Contraction Joints. Transverse contraction joints shall consist of planes of weakness created by sawing grooves in the surface of the pavement and shall include load transfer devices consisting of dowel bars. Transverse contraction joints shall be according to the following."

Revise Article 420.05(c)(2) of the Standard Specifications to read:

- "(2) Dowel Bars. Dowel Bars shall be installed parallel to the centerline of the pavement and parallel to the proposed pavement surface. Installation shall be according to one of the following methods.
 - a. Dowel Bar Assemblies. The assembly shall act as a rigid unit with each component securely held in position relative to the other members of the assembly. The entire assembly shall be held securely in place by means of nails which shall penetrate the stabilized subbase. At least ten nails shall be used for each 10, 11, or 12 ft (3, 3.3, or 3.6 m) section of assembly.

Metal stakes shall be used instead of nails, with soil or granular subbase. The stakes shall loop over or attach to the top parallel spacer bar of the assembly and penetrate the subgrade or subbase at least 12 in. (300 mm).

At the location of each dowel bar assembly, the subgrade or subbase shall be reshaped and re-tamped when necessary.

Prior to placing concrete, any deviation of the dowel bars from the correct horizontal or vertical alignment (horizontal skew or vertical tilt) greater than 3/8 in. in 12 in (9 mm in 300 mm) shall be corrected and a light coating of oil shall be uniformly applied to all dowel bars.

Care shall be exercised in depositing the concrete at the dowel bar assemblies so the horizontal and vertical alignment will be retained.

 b. Dowel Bar Insertion. The dowel bars may be placed in the pavement slab with a mechanical dowel bar inserter (DBI) attached to a formless paver for pavements ≥ 7.0 in. (175 mm) in thickness. A light coating of oil shall be uniformly applied to all dowel bars. The DBI shall insert the dowel bars with vibration into the plastic concrete after the concrete has been struck off and consolidated without deformation of the slab. After the bars have been inserted, the concrete shall be refinished and no voids shall exist around the dowel bars. The forward movement of the paver shall not be interrupted by the inserting of the dowel bars.

The location of each row of dowel bars shall be marked in a manner to facilitate where to insert the bars, and where to saw the transverse joint.

- 1. Placement Tolerances for Dowel Bars. The DBI shall place the dowel bars in the concrete pavement within the following tolerances.
 - (a.) Longitudinal Translation (Mislocation). Longitudinal translation (mislocation) shall be defined as the position of the center of the dowel bar along the longitudinal axis, in relation to the sawed joint.

The quality control tolerance for longitudinal translation shall not exceed 2.0 in (50 mm). If this tolerance is exceeded, adjustments shall be made to the paving operation.

Any joint having two or more dowel bars with an embedment length less than 4.0 in. (100 mm) within 12 in. (300 mm) of the same wheelpath will be considered unacceptable. Any joint having an average dowel bar embedment length less than 5.25 in. (130 mm) will also be considered unacceptable. Embedment length shall be defined as the length of dowel bar embedded on the short side of the sawed joint. An unacceptable joint shall be replaced with a minimum of 6 ft (1.8 m) of pavement centered over the joint according to Section 442 for Class B patches.

(b.) Horizontal Translation (Mislocation). Horizontal translation (mislocation) shall be defined as the difference in the actual dowel bar location parallel to the longitudinal or edge joint from its theoretical position as shown on the plans.

The quality control tolerance for horizontal translation shall not exceed 2.0 in. (50 mm). If this tolerance is exceeded, adjustments shall be made to the paving operation.

Any joint having a dowel bar with a translation greater than 4.0 in. (100 mm) will be considered unacceptable, but may remain in place unless the Engineer determines the joint will not function. If the joint is unable to remain in place, the joint shall be replaced with a minimum of 6 ft (1.8 m) of pavement centered over the joint according to Section 442 for Class B patches.

(c.) Vertical Translation (Mislocation). Vertical translation (mislocation) shall be defined as the difference in the vertical position of the dowel bar relative to the theoretical midpoint of the slab.

The quality control tolerance for vertical translation shall be as shown in the following table. If these tolerances are exceeded, adjustments shall be made to the paving operation.

Any joint having a dowel bar with top concrete cover less than T/3, where T is slab thickness, will be considered unacceptable. Any joint having 2 or more dowel bars with bottom concrete cover less than 2.0 in. (50 mm) will also be considered unacceptable. An unacceptable joint shall be replaced with a minimum of 6 ft (1.8 m) of pavement according to Section 442 for Class B patches.

(d.) Vertical Tilt or Horizontal Skew (Misalignment). Vertical tilt or horizontal skew (misalignment) shall be defined as the difference in position of the dowel bar ends with respect to each other. Vertical tilt is measured in the vertical axis whereas horizontal skew is measured in the horizontal axis. Misalignment shall be measured in terms of a joint score. The joint score shall be defined as the degree of misalignment evaluated for a single transverse joint for each lane of pavement. The joint score shall be determined as follows:

Joint Score =

where:

 W_i = weighting factor (Table 1) for dowel i x = number of dowels in a single joint

n = number of dowels excluded from the joint score calculation due to measurement interference

Single Dowel Misalignment – The degree of misalignment applicable to a single dowel bar, calculated as:

Single Dowel Misalignment = $\sqrt{(Horizontal\ Skew)^2 + (Vertical\ Tilt)^2}$

The quality control tolerance for vertical tilt or horizontal skew shall not exceed 0.6 in. (15 mm). If the tolerance is exceeded for either one, adjustments shall be made to the paving operation.

Any joint having a dowel bar with a vertical tilt or horizontal skew greater than 1.5 in. (38 mm) shall be cut. If more than one dowel bar is required to be cut in the joint, the joint will be considered unacceptable and shall be replaced with a minimum of 6 ft (1.8 m) of pavement centered over the joint according to Section 442 for Class B patches.

Single dowel bar misalignment shall be controlled to provide the joint scores shown in the following table.

A joint score greater than the specified maximum will be considered locked. Three consecutive joints with a score greater than the specified maximum total score will all be considered unacceptable.

Three consecutive locked joints shall be corrected by selecting one joint and cutting a dowel bar. Preference shall be given to cutting a dowel bar within the middle 2.5 ft (0.8 m) of the pavement lane to avoid the wheelpaths. If none of the three locked joints will have a joint score less than or equal to the specified maximum after selecting one dowel bar to cut, one of the joints shall be replaced with a minimum of 6 ft (1.8 m) of



pavement centered over the joint according to Section 442 for Class B patches.

- (e.) For unacceptable work, the Contractor may propose alternative repairs for consideration by the Engineer.
- Testing of Dowel Bar Placement. The placement of the dowel bars shall be tested within 24 hours of paving with a calibrated MIT Scan-2 device according to "Use of Magnetic Tomography Technology to Evaluate Dowel Placement" (Publication No. FHWA-IF-06-006) by the Federal Highway Administration.

A trained operator shall perform the testing, and all testing shall be performed in the presence of the Engineer. The device shall be calibrated to the type and size dowel bar used in the work according to the manufacturer's instructions. Calibration documentation shall be provided to the Engineer prior to construction. The device shall be recalibrated and/or validate readings as required by the Engineer. The device may be utilized as a process control and make necessary adjustments to ensure the dowel bars are placed in the correct location.

- (a.) Test Section. Prior to start of production paving, a test section consisting of 30 transverse joints shall be constructed. The test section may be performed on the actual pavement, but production paving shall not begin until an acceptable test section has been constructed. The test section will be considered acceptable when all of the following are met:
 - (1.) 90 percent of the dowel bars meet the quality control tolerance for longitudinal, horizontal, or vertical translation (mislocation);
 - (2.) 90 percent of the dowel bars meet the quality control tolerance for vertical tilt or horizontal skew deviation (misalignment); and
 - (3.) none of the joints are considered unacceptable prior to a corrective measure for mislocation or misalignment.

If the test section fails, another test section consisting of 30 joints shall be constructed.

The test section requirement may be waived by the Engineer if the Contractor has constructed an acceptable test section and successfully used the DBI on a Department contract within the same calendar year.

(b.) Production Paving. After the test section is approved, production paving may begin. The mislocation and misalignment of each dowel bar for the

first ten joints constructed, and every tenth joint thereafter, shall be tested.

If two consecutive days of paving result in 5 percent or more of the joints on each day being unacceptable prior to a corrective measure, production paving shall be discontinued and a new test section shall be constructed.

If any joint is found to be unacceptable prior to a corrective measure, testing of additional joints on each side of the unacceptable joint shall be performed until acceptable joints are found.

- (c.) Test Report. Test reports shall be provided to the Engineer within two working days of completing each day's testing. The test report shall include the following.
 - (1.) Contract number, placement date, county-route-section, direction of traffic, scan date, Contractor, and name of individual performing the tests.
 - (2.) Provide the standard report generated from the on-board printer of the imaging technology used for every dowel and joint measured.
 - (3.) For every dowel measured, provide the joint identification number, lane number and station, dowel bar number or x-location, direction of testing and reference joint location/edge location, longitudinal translation, horizontal translation, vertical translation, vertical tilt, and horizontal skew.
 - (4.) Identify each dowel bar with a maximum longitudinal, horizontal, or vertical translation that has been exceeded. Identify each dowel bar with a maximum vertical tilt or horizontal skew deviation that has been exceeded.
 - (5.) Joint Score Details: Provide the joint identification number, lane number, station, and calculated joint score for each joint.
 - (6.) Locked Joint Identification: Identify each joint with a joint score > 12.
- (d.) Exclusions. Exclude the following from dowel bar mislocation and misalignment measurements.
 - (1.) Transverse construction joints (headers).
 - (2.) Dowel bars within 24 in. (610 mm) of metallic manholes, inlets, metallic castings, or other nearby or underlying steel reinforced objects.

- (3.) The outside dowel bar when tie bars are installed with mechanical equipment in fresh concrete. For tie bar installations involving preformed or drilled holes, installation shall be performed after testing with the MIT Scan-2 device.
- (4.) Joints located directly under high voltage power lines.
- (5.) Subject to the approval of the Engineer, any other contributors to magnetic interference.
- (e.) Deficiency Deduction. When the Contractor has cut 25 dowel bars to correct unacceptable joints, the Contractor shall be liable and shall pay to the Department a deficiency deduction of \$500.00 for the cost of the bars. Thereafter, an additional deficiency deduction of \$20.00 for each additional bar cut will be assessed."

Add the following to Section 1103 of the Standard Specifications.

"1103.20 Mechanical Dowel Bar Inserter. The mechanical dowel bar inserter (DBI) shall be self-contained and supported on the formless paver with the ability to move separately from the paver. The DBI shall be equipped with insertion forks along with any other devices necessary for finishing the concrete the full width of the pavement. The insertion forks shall have the ability to vibrate at a minimum frequency of 3000 VPM."

PROGRESS PAYMENTS (BDE)

Effective: November 2, 2013

Revise Article 109.07(a) of the Standard Specifications to read:

"(a) Progress Payments. At least once each month, the Engineer will make a written estimate of the quantity of work performed in accordance with the contract, and the value thereof at the contract unit prices. The amount of the estimate approved as due for payment will be vouchered by the Department and presented to the State Comptroller for payment. No amount less than \$1000.00 will be approved for payment other than the final payment.

Progress payments may be reduced by liens filed pursuant to Section 23(c) of the Mechanics' Lien Act, 770 ILCS 60/23(c).

If a Contractor or subcontractor has defaulted on a loan issued under the Department's Disadvantaged Business Revolving Loan Program (20 ILCS 2705/2705-610), progress payments may be reduced pursuant to the terms of that loan agreement. In such cases, the amount of the estimate related to the work performed by the Contractor or subcontractor, in default of the loan agreement, will be offset, in whole or in part, and vouchered by the Department to the Working Capital Revolving Fund or designated escrow account. Payment for the work shall be considered as issued and received by the Contractor or subcontractor on the date of the offset voucher. Further, the amount of the offset voucher shall be a credit against the Department's obligation to pay the Contractor, the Contractor's obligation to pay the subcontractor, and the Contractor's or subcontractor's total loan indebtedness to the Department. The offset shall continue until such time as the entire loan indebtedness is satisfied. The Department will notify the Contractor and Fund Control Agent in a timely manner of such offset. The Contractor or subcontractor shall not be entitled to additional payment in consideration of the offset.

The failure to perform any requirement, obligation, or term of the contract by the Contractor shall be reason for withholding any progress payments until the Department determines that compliance has been achieved."

RECLAIMED ASPHALT PAVEMENT AND RECLAIMED ASPHALT SHINGLES (BDE)

Effective: November 1, 2012

Revise: April 1, 2014

Revise Section 1031 of the Standard Specifications to read:

"SECTION 1031. RECLAIMED ASPHALT PAVEMENT AND RECLAIMED ASPHALT SHINGLES

1031.01 Description. Reclaimed asphalt pavement and reclaimed asphalt shingles shall be according to the following.

- (a) Reclaimed Asphalt Pavement (RAP). RAP is the material produced by cold milling or crushing an existing hot-mix asphalt (HMA) pavement. The Contractor shall supply written documentation that the RAP originated from routes or airfields under federal, state, or local agency jurisdiction.
- (b) Reclaimed Asphalt Shingles (RAS). Reclaimed asphalt shingles (RAS). RAS is from the processing and grinding of preconsumer or post-consumer shingles. RAS shall be a clean and uniform material with a maximum of 0.5 percent unacceptable material, as defined in Bureau of Materials and Physical Research Policy Memorandum "Reclaimed Asphalt Shingle (RAS) Sources", by weight of RAS. All RAS used shall come from a Bureau of Materials and Physical Research approved processing facility where it shall be ground and processed to 100 percent passing the 3/8 in. (9.5 mm) sieve and 93 percent passing the #4 (4.75 mm) sieve based on a dry shake gradation. RAS shall be uniform in gradation and asphalt binder content and shall meet the testing requirements specified herein. In addition, RAS shall meet the following Type 1 or Type 2 requirements.
 - (1) Type 1. Type 1 RAS shall be processed, preconsumer asphalt shingles salvaged from the manufacture of residential asphalt roofing shingles.
 - (2) Type 2. Type 2 RAS shall be processed post-consumer shingles only, salvaged from residential, or four unit or less dwellings not subject to the National Emission Standards for Hazardous Air Pollutants (NESHAP).

1031.02 Stockpiles. RAP and RAS stockpiles shall be according to the following.

(a) RAP Stockpiles. The Contractor shall construct individual, sealed RAP stockpiles meeting one of the following definitions. No additional RAP shall be added to the pile after the pile has been sealed. Stockpiles shall be sufficiently separated to prevent intermingling at the base. Stockpiles shall be identified by signs indicating the type as listed below (i.e. "Homogeneous Surface").

Prior to milling, the Contractor shall request the District provide documentation on the quality of the RAP to clarify the appropriate stockpile.

(1) Fractionated RAP (FRAP). FRAP shall consist of RAP from Class I, HMA (High and Low ESAL) mixtures. The coarse aggregate in FRAP shall be crushed aggregate and may represent more than one aggregate type and/or quality but shall be at least C quality. All FRAP shall be fractionated prior to testing by screening into a minimum of two size fractions with the separation occurring on or between the #4 (4.75 mm) and 1/2 in. (12.5 mm) sieves. Agglomerations shall be minimized such that 100 percent of the RAP shall pass the sieve size specified below for the mix into which the FRAP will be incorporated.

- (2) Homogeneous. Homogeneous RAP stockpiles shall consist of RAP from Class I, HMA (High and Low ESAL) mixtures and represent: 1) the same aggregate quality, but shall be at least C quality; 2) the same type of crushed aggregate (either crushed natural aggregate, ACBF slag, or steel slag); 3) similar gradation; and 4) similar asphalt binder content. If approved by the Engineer, combined single pass surface/binder millings may be considered "homogenous" with a quality rating dictated by the lowest coarse aggregate quality present in the mixture.
- (3) Conglomerate. Conglomerate RAP stockpiles shall consist of RAP from Class I, HMA (High and Low ESAL) mixtures. The coarse aggregate in this RAP shall be crushed aggregate and may represent more than one aggregate type and/or quality but shall be at least C quality. This RAP may have an inconsistent gradation and/or asphalt binder content prior to processing. All conglomerate RAP shall be processed prior to testing by crushing to where all RAP shall pass the 5/8 in. (16 mm) or smaller screen. Conglomerate RAP stockpiles shall not contain steel slag.
- (4) Conglomerate "D" Quality (DQ). Conglomerate DQ RAP stockpiles shall consist of RAP from Class I, HMA (High or Low ESAL), or "All Other" (as defined by Article 1030.04(a)(3)) mixtures. The coarse aggregate in this RAP may be crushed or round but shall be at least D quality. This RAP may have an inconsistent gradation and/or asphalt binder content. Conglomerate DQ RAP stockpiles shall not contain steel slag.
- (5) Non-Quality. RAP stockpiles that do not meet the requirements of the stockpile categories listed above shall be classified as "Non-Quality".

RAP/FRAP containing contaminants, such as earth, brick, sand, concrete, sheet asphalt, bituminous surface treatment (i.e. chip seal), pavement fabric, joint sealants, etc., will be unacceptable unless the contaminants are removed to the satisfaction of the Engineer. Sheet asphalt shall be stockpiled separately.

(b) RAS Stockpiles. Type 1 and Type 2 RAS shall be stockpiled separately and shall not be intermingled. Each stockpile shall be signed indicating what type of RAS is present.

Unless otherwise specified by the Engineer, mechanically blending manufactured sand (FM 20 or FM 22) up to an equal weight of RAS with the processed RAS will be permitted to improve workability. The sand shall be "B Quality" or better from an approved Aggregate Gradation Control System source. The sand shall be accounted for in the mix design and during HMA production.

Records identifying the shingle processing facility supplying the RAS, RAS type and lot number shall be maintained by project contract number and kept for a minimum of three years.

1031.03 Testing. RAP/FRAP and RAS testing shall be according to the following.

- (a) RAP/FRAP Testing. When used in HMA, the RAP/FRAP shall be sampled and tested either during or after stockpiling.
 - (1) During Stockpiling. For testing during stockpiling, washed extraction samples shall be run at the minimum frequency of one sample per 500 tons (450 metric tons) for the first 2000 tons (1800 metric tons) and one sample per 2000 tons (1800 metric tons) thereafter. A minimum of five tests shall be required for stockpiles less than 4000 tons (3600 metric tons).
 - (2) After Stockpiling. For testing after stockpiling, the Contractor shall submit a plan for approval to the District proposing a satisfactory method of sampling and testing the RAP/FRAP pile either in-situ or by restockpiling. The sampling plan shall meet the minimum frequency required above and detail the procedure used to obtain representative samples throughout the pile for testing.

Each sample shall be split to obtain two equal samples of test sample size. One of the two test samples from the final split shall be labeled and stored for Department use. The Contractor shall extract the other test sample according to Department procedure. The Engineer reserves the right to test any sample (split or Department-taken) to verify Contractor test results.

(b) RAS Testing. RAS or RAS blended with manufactured sand shall be sampled and tested during stockpiling according to Illinois Department of Transportation Policy Memorandum, "Reclaimed Asphalt Shingle (RAS) Source".

Samples shall be collected during stockpiling at the minimum frequency of one sample per 200 tons (180 metric tons) for the first 1000 tons (900 metric tons) and one sample per 250 tons (225 metric tons) thereafter. A minimum of five samples are required for stockpiles less than 1000 tons (900 metric tons). Once a \leq 1000 ton (900 metric ton), five-sample/test stockpile has been established it shall be sealed. Additional incoming RAS or RAS blended with manufactured sand shall be stockpiled in a separate working pile as designated in the Quality Control plan and only added to the sealed stockpile when the test results of the working pile are complete and are found to meet the tolerances specified herein for the original sealed RAS stockpile.

Before testing, each sample shall be split to obtain two test samples. One of the two test samples from the final split shall be labeled and stored for Department use. The Contractor shall perform a washed extraction and test for unacceptable materials on the other test sample according to Department procedures. The Engineer reserves the right to test any sample (split or Department-taken) to verify Contractor test results.

If the sampling and testing was performed at the shingle processing facility in accordance with the QC Plan, the Contractor shall obtain and make available all of the test results from start of the initial stockpile.

1031.04 Evaluation of Tests. Evaluation of tests results shall be according to the following.

(a) Evaluation of RAP/FRAP Test Results. All of the extraction results shall be compiled and averaged for asphalt binder content and gradation and, when applicable G_{mm} . Individual extraction test results, when compared to the averages, will be accepted if within the tolerances listed below.

If more than 20 percent of the individual sieves and/or asphalt binder content tests are out of the above tolerances, the RAP/FRAP shall not be used in HMA unless the

RAP/FRAP representing the failing tests is removed from the stockpile. All test data and acceptance ranges shall be sent to the District for evaluation.

With the approval of the Engineer, the ignition oven may be substituted for extractions according to the Illinois Test Procedure, "Calibration of the Ignition Oven for the Purpose of Characterizing Reclaimed Asphalt Pavement (RAP)".

(b) Evaluation of RAS and RAS Blended with Manufactured Sand Test Results. All of the test results, with the exception of percent unacceptable materials, shall be compiled and averaged for asphalt binder content and gradation. Individual test results, when compared to the averages, will be accepted if within the tolerances listed below.

If more than 20 percent of the individual sieves and/or asphalt binder content tests are out of the above tolerances, or if the percent unacceptable material exceeds 0.5 percent by weight of material retained on the # 4 (4.75 mm) sieve, the RAS or RAS blend shall not be used in Department projects. All test data and acceptance ranges shall be sent to the District for evaluation.

1031.05 Quality Designation of Aggregate in RAP/FRAP.

- (a) RAP. The aggregate quality of the RAP for homogenous, conglomerate, and conglomerate "D" quality stockpiles shall be set by the lowest quality of coarse aggregate in the RAP stockpile and are designated as follows.
 - (1) RAP from Class I, Superpave/HMA (High ESAL), or (Low ESAL) IL-9.5L surface mixtures are designated as containing Class B quality coarse aggregate.
 - (2) RAP from Superpave/HMA (Low ESAL) IL-19.0L binder mixture is designated as Class D quality coarse aggregate.
 - (3) RAP from Class I, Superpave/HMA (High ESAL) binder mixtures, bituminous base course mixtures, and bituminous base course widening mixtures are designated as containing Class C quality coarse aggregate.
 - (4) RAP from bituminous stabilized subbase and BAM shoulders are designated as containing Class D quality coarse aggregate.
- (b) FRAP. If the Engineer has documentation of the quality of the FRAP aggregate, the Contractor shall use the assigned quality provided by the Engineer.

If the quality is not known, the quality shall be determined as follows. Coarse and fine FRAP stockpiles containing plus #4 (4.75 mm) sieve coarse aggregate shall have a maximum tonnage of 5,000 tons (4,500 metric tons). The Contractor shall obtain a representative sample witnessed by the Engineer. The sample shall be a minimum of 50 lb (25 kg). The sample shall be extracted according to Illinois Modified AASHTO T 164 by a consultant prequalified by the Department for the specified testing. The consultant shall submit the test results along with the recovered aggregate to the District Office. The cost for this testing shall be paid by the Contractor. The District will forward the sample to the BMPR Aggregate Lab for MicroDeval Testing, according to Illinois Modified AASHTO T 327. A maximum loss of 15.0 percent will be applied for all HMA applications.

1031.06 Use of RAP/FRAP and/or RAS in HMA. The use of RAP/FRAP and/or RAS shall be a Contractor's option when constructing HMA in all contracts.

- (a) RAP/FRAP. The use of RAP/FRAP in HMA shall be as follows.
 - (1) Coarse Aggregate Size. The coarse aggregate in all RAP shall be equal to or less than the nominal maximum size requirement for the HMA mixture to be produced.
 - (2) Steel Slag Stockpiles. Homogeneous RAP stockpiles containing steel slag will be approved for use in all HMA (High ESAL and Low ESAL) Surface and Binder Mixture applications.
 - (3) Use in HMA Surface Mixtures (High and Low ESAL). RAP/FRAP stockpiles for use in HMA surface mixtures (High and Low ESAL) shall be FRAP or homogeneous in which the coarse aggregate is Class B quality or better. RAP/FRAP from Conglomerate stockpiles shall be considered equivalent to limestone for frictional considerations. Known frictional contributions from plus #4 (4.75 mm) homogeneous RAP and FRAP stockpiles will be accounted for in meeting frictional requirements in the specified mixture.
 - (4) Use in HMA Binder Mixtures (High and Low ESAL), HMA Base Course, and HMA Base Course Widening. RAP/FRAP stockpiles for use in HMA binder mixtures (High and Low ESAL), HMA base course, and HMA base course widening shall be FRAP, homogeneous, or conglomerate, in which the coarse aggregate is Class C quality or better.
 - (5) Use in Shoulders and Subbase. RAP/FRAP stockpiles for use in HMA shoulders and stabilized subbase (HMA) shall be FRAP, homogeneous, conglomerate, or conglomerate DQ.
 - (6) When the Contractor chooses the RAP option, the percentage of RAP shall not exceed the amounts indicated in Article 1031.06(c)(1) below for a given N Design.

- (b) RAS. RAS meeting Type 1 or Type 2 requirements will be permitted in all HMA applications as specified herein.
- (c) RAP/FRAP and/or RAS Usage Limits. Type 1 or Type 2 RAS may be used alone or in conjunction with RAP or FRAP in HMA mixtures up to a maximum of 5.0% by weight of the total mix.
 - (1) RAP/RAS. When RAP is used alone or RAP is used in conjunction with RAS, the percentage of virgin asphalt binder replacement shall not exceed the amounts listed in the Max RAP/RAS ABR table listed below for the given Ndesign.

- 2/ When FRAP/RAS ABR exceeds 20 percent for all mixes the high and low virgin asphalt binder grades shall each be reduced by one grade (i.e. 25 percent ABR would require a virgin asphalt binder grade of PG64-22 to be reduced to a PG58-28). 1031.07 HMA Mix Designs. At the Contractor's option, HMA mixtures may be constructed utilizing RAP/FRAP and/or RAS material meeting the detailed requirements specified herein.

- (a) RAP/FRAP and/or RAS. RAP/FRAP and/or RAS mix designs shall be submitted for verification. If additional RAP/FRAP stockpiles are tested and found that no more than 20 percent of the results, as defined under "Testing" herein, are outside of the control tolerances set for the original RAP/FRAP stockpile and HMA mix design, and meets all of the requirements herein, the additional RAP/FRAP stockpiles may be used in the original mix design at the percent previously verified.
- (b) RAS. Type 1 and Type 2 RAS are not interchangeable in a mix design. A RAS stone bulk specific gravity (Gsb) of 2.500 shall be used for mix design purposes.

1031.08 HMA Production. HMA production utilizing RAP/FRAP and/or RAS shall be as follows.

(a) RAP/FRAP. The coarse aggregate in all RAP/FRAP used shall be equal to or less than the nominal maximum size requirement for the HMA mixture being produced.

To remove or reduce agglomerated material, a scalping screen, gator, crushing unit, or comparable sizing device approved by the Engineer shall be used in the RAP feed system to remove or reduce oversized material. If material passing the sizing device adversely affects the mix production or quality of the mix, the sizing device shall be set at a size specified by the Engineer.

If the RAP/FRAP control tolerances or QC/QA test results require corrective action, the Contractor shall cease production of the mixture containing RAP/FRAP and either switch to the virgin aggregate design or submit a new RAP/FRAP design.

- (b) RAS. RAS shall be incorporated into the HMA mixture either by a separate weight depletion system or by using the RAP weigh belt. Either feed system shall be interlocked with the aggregate feed or weigh system to maintain correct proportions for all rates of production and batch sizes. The portion of RAS shall be controlled accurately to within ± 0.5 percent of the amount of RAS utilized. When using the weight depletion system, flow indicators or sensing devices shall be provided and interlocked with the plant controls such that the mixture production is halted when RAS flow is interrupted.
- (c) RAP/FRAP and/or RAS. HMA plants utilizing RAP/FRAP and/or RAS shall be capable of automatically recording and printing the following information.
 - (1) Dryer Drum Plants.
 - a. Date, month, year, and time to the nearest minute for each print.
 - b. HMA mix number assigned by the Department.
 - c. Accumulated weight of dry aggregate (combined or individual) in tons (metric tons) to the nearest 0.1 ton (0.1 metric ton).
 - d. Accumulated dry weight of RAP/FRAP/RAS in tons (metric tons) to the nearest 0.1 ton (0.1 metric ton).
 - e. Accumulated mineral filler in revolutions, tons (metric tons), etc. to the nearest 0.1 unit.
 - f. Accumulated asphalt binder in gallons (liters), tons (metric tons), etc. to the nearest 0.1 unit.
 - g. Residual asphalt binder in the RAP/FRAP material as a percent of the total mix to the nearest 0.1 percent.
 - h. Aggregate and RAP/FRAP moisture compensators in percent as set on the control panel. (Required when accumulated or individual aggregate and RAP/FRAP are printed in wet condition.)
 - (2) Batch Plants.
 - a. Date, month, year, and time to the nearest minute for each print.
 - b. HMA mix number assigned by the Department.

- c. Individual virgin aggregate hot bin batch weights to the nearest pound (kilogram).
- d. Mineral filler weight to the nearest pound (kilogram).
- e. RAP/FRAP/RAS weight to the nearest pound (kilogram).
- f. Virgin asphalt binder weight to the nearest pound (kilogram).
- g. Residual asphalt binder in the RAP/FRAP/RAS material as a percent of the total mix to the nearest 0.1 percent.

The printouts shall be maintained in a file at the plant for a minimum of one year or as directed by the Engineer and shall be made available upon request. The printing system will be inspected by the Engineer prior to production and verified at the beginning of each construction season thereafter.

1031.09 RAP in Aggregate Surface Course and Aggregate Shoulders. The use of RAP in aggregate surface course (temporary access entrances only) and aggregate wedge shoulders Type B shall be as follows.

- (a) Stockpiles and Testing. RAP stockpiles may be any of those listed in Article 1031.02, except "Non-Quality" and "FRAP". The testing requirements of Article 1031.03 shall not apply. RAP used to construct aggregate surface course and aggregate shoulders shall be according to the current Bureau of Materials and Physical Research's Policy Memorandum, "Reclaimed Asphalt Pavement (RAP) for Aggregate Applications".
- (b) Gradation. One hundred percent of the RAP material shall pass the 1 1/2 in. (37.5 mm) sieve. The RAP material shall be reasonably well graded from coarse to fine. RAP material that is gap-graded or single sized will not be accepted."

WEEKLY DBE TRUCKING REPORTS (BDE)

Effective: June 2, 2012 Revised: April 2, 2015

The Contractor shall submit a weekly report of Disadvantaged Business Enterprise (DBE) trucks hired by the Contractor or subcontractors (i.e. not owned by the Contractor or subcontractors) that are used for DBE goal credit.

The report shall be submitted to the Engineer on Department form "SBE 723" within ten business days following the reporting period. The reporting period shall be Monday through Sunday for each week reportable trucking activities occur.

Any costs associated with providing weekly DBE trucking reports shall be considered as included in the contract unit prices bid for the various items of work involved and no additional compensation will be allowed.

ATTACHMENTS

A. Employment and Materials Preference for Appalachian Development Highway System or Appalachian Local Access Road Contracts (included in Appalachian contracts only)

I. GENERAL

1. Form FHWA-1273 must be physically incorporated in each construction contract funded under Title 23 (excluding emergency contracts solely intended for debris removal). The contractor (or subcontractor) must insert this form in each subcontract and further require its inclusion in all lower tier subcontracts (excluding purchase orders, rental agreements and other agreements for supplies or services).

The applicable requirements of Form FHWA-1273 are incorporated by reference for work done under any purchase order, rental agreement or agreement for other services. The prime contractor shall be responsible for compliance by any subcontractor, lower-tier subcontractor or service provider.

Form FHWA-1273 must be included in all Federal-aid design-build contracts, in all subcontracts and in lower tier subcontracts (excluding subcontracts for design services, purchase orders, rental agreements and other agreements for supplies or services). The design-builder shall be responsible for compliance by any subcontractor, lower-tier subcontractor or service provider.

Contracting agencies may reference Form FHWA-1273 in bid proposal or request for proposal documents, however, the Form FHWA-1273 must be physically incorporated (not referenced) in all contracts, subcontracts and lower-tier subcontracts (excluding purchase orders, rental agreements and other agreements for supplies or services related to a construction contract).

- 2. Subject to the applicability criteria noted in the following sections, these contract provisions shall apply to all work performed on the contract by the contractor's own organization and with the assistance of workers under the contractor's immediate superintendence and to all work performed on the contract by piecework, station work, or by subcontract.
- 3. A breach of any of the stipulations contained in these Required Contract Provisions may be sufficient grounds for withholding of progress payments, withholding of final payment, termination of the contract, suspension / debarment or any other action determined to be appropriate by the contracting agency and FHWA.
- 4. Selection of Labor: During the performance of this contract, the contractor shall not use convict labor for any purpose within the limits of a construction project on a Federal-aid highway unless it is labor performed by convicts who are on parole, supervised release, or probation. The term Federal-aid highway does not include roadways functionally classified as local roads or rural minor collectors.

II. NONDISCRIMINATION

The provisions of this section related to 23 CFR Part 230 are applicable to all Federal-aid construction contracts and to all related construction subcontracts of \$10,000 or more. The provisions of 23 CFR Part 230 are not applicable to material supply, engineering, or architectural service contracts.

In addition, the contractor and all subcontractors must comply with the following policies: Executive Order 11246, 41 CFR 60, 29 CFR 1625-1627, Title 23 USC Section 140, the Rehabilitation Act of 1973, as amended (29 USC 794), Title VI of the Civil Rights Act of 1964, as amended, and related regulations including 49 CFR Parts 21, 26 and 27; and 23 CFR Parts 200, 230, and 633.

The contractor and all subcontractors must comply with: the requirements of the Equal Opportunity Clause in 41 CFR 60-1.4(b) and, for all construction contracts exceeding \$10,000, the Standard Federal Equal Employment Opportunity Construction Contract Specifications in 41 CFR 60-4.3.

Note: The U.S. Department of Labor has exclusive authority to determine compliance with Executive Order 11246 and the policies of the Secretary of Labor including 41 CFR 60, and 29 CFR 1625-1627. The contracting agency and the FHWA have the authority and the responsibility to ensure compliance with Title 23 USC Section 140, the Rehabilitation Act of 1973, as amended (29 USC 794), and Title VI of the Civil Rights Act of 1964, as amended, and related regulations including 49 CFR Parts 21, 26 and 27; and 23 CFR Parts 200, 230, and 633.

The following provision is adopted from 23 CFR 230, Appendix A, with appropriate revisions to conform to the U.S. Department of Labor (US DOL) and FHWA requirements.

- 1. Equal Employment Opportunity: Equal employment opportunity (EEO) requirements not to discriminate and to take affirmative action to assure equal opportunity as set forth under laws, executive orders, rules, regulations (28 CFR 35, 29 CFR 1630, 29 CFR 1625-1627, 41 CFR 60 and 49 CFR 27) and orders of the Secretary of Labor as modified by the provisions prescribed herein, and imposed pursuant to 23 U.S.C. 140 shall constitute the EEO and specific affirmative action standards for the contractor's project activities under this contract. The provisions of the Americans with Disabilities Act of 1990 (42 U.S.C. 12101 et seq.) set forth under 28 CFR 35 and 29 CFR 1630 are incorporated by reference in this contract. In the execution of this contract, the contractor agrees to comply with the following minimum specific requirement activities of EEO:
- a. The contractor will work with the contracting agency and the Federal Government to ensure that it has made every good faith effort to provide equal opportunity with respect to all of its terms and conditions of employment and in their review of activities under the contract.
- b. The contractor will accept as its operating policy the following statement:
 - "It is the policy of this Company to assure that applicants are employed, and that employees are treated during employment, without regard to their race, religion, sex, color, national origin, age or disability. Such action shall include: employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship, pre-apprenticeship, and/or onthe-job training."
- 2. EEO Officer: The contractor will designate and make known to the contracting officers an EEO Officer who will have the responsibility for and must be capable of effectively administering and promoting an active EEO program and who must be assigned adequate authority and responsibility to do so.

- 3. Dissemination of Policy: All members of the contractor's staff who are authorized to hire, supervise, promote, and discharge employees, or who recommend such action, or who are substantially involved in such action, will be made fully cognizant of, and will implement, the contractor's EEO policy and contractual responsibilities to provide EEO in each grade and classification of employment. To ensure that the above agreement will be met, the following actions will be taken as a minimum:
- a. Periodic meetings of supervisory and personnel office employees will be conducted before the start of work and then not less often than once every six months, at which time the contractor's EEO policy and its implementation will be reviewed and explained. The meetings will be conducted by the EEO Officer.
- b. All new supervisory or personnel office employees will be given a thorough indoctrination by the EEO Officer, covering all major aspects of the contractor's EEO obligations within thirty days following their reporting for duty with the contractor.
- c. All personnel who are engaged in direct recruitment for the project will be instructed by the EEO Officer in the contractor's procedures for locating and hiring minorities and women.
- d. Notices and posters setting forth the contractor's EEO policy will be placed in areas readily accessible to employees, applicants for employment and potential employees.
- e. The contractor's EEO policy and the procedures to implement such policy will be brought to the attention of employees by means of meetings, employee handbooks, or other appropriate means.
- **4. Recruitment:** When advertising for employees, the contractor will include in all advertisements for employees the notation: "An Equal Opportunity Employer." All such advertisements will be placed in publications having a large circulation among minorities and women in the area from which the project work force would normally be derived.
- a. The contractor will, unless precluded by a valid bargaining agreement, conduct systematic and direct recruitment through public and private employee referral sources likely to yield qualified minorities and women. To meet this requirement, the contractor will identify sources of potential minority group employees, and establish with such identified sources procedures whereby minority and women applicants may be referred to the contractor for employment consideration.
- b. In the event the contractor has a valid bargaining agreement providing for exclusive hiring hall referrals, the contractor is expected to observe the provisions of that agreement to the extent that the system meets the contractor's compliance with EEO contract provisions. Where implementation of such an agreement has the effect of discriminating against minorities or women, or obligates the contractor to do the same, such implementation violates Federal nondiscrimination provisions.
- c. The contractor will encourage its present employees to refer minorities and women as applicants for employment. Information and procedures with regard to referring such applicants will be discussed with employees.
- **5. Personnel Actions:** Wages, working conditions, and employee benefits shall be established and administered, and personnel actions of every type, including hiring, upgrading, promotion, transfer, demotion, layoff, and termination, shall be taken without regard to race, color, religion, sex, national origin, age or disability. The following procedures shall be followed:
- a. The contractor will conduct periodic inspections of project sites to insure that working conditions and employee facilities do not indicate discriminatory treatment of project site personnel.
- b. The contractor will periodically evaluate the spread of wages paid within each classification to determine any evidence of discriminatory wage practices.
- c. The contractor will periodically review selected personnel actions in depth to determine whether there is evidence of discrimination. Where evidence is found, the contractor will promptly take corrective action. If

the review indicates that the discrimination may extend beyond the actions reviewed, such corrective action shall include all affected persons.

d. The contractor will promptly investigate all complaints of alleged discrimination made to the contractor in connection with its obligations under this contract, will attempt to resolve such complaints, and will take appropriate corrective action within a reasonable time. If the investigation indicates that the discrimination may affect persons other than the complainant, such corrective action shall include such other persons. Upon completion of each investigation, the contractor will inform every complainant of all of their avenues of appeal.

6. Training and Promotion:

- a. The contractor will assist in locating, qualifying, and increasing the skills of minorities and women who are applicants for employment or current employees. Such efforts should be aimed at developing full journey level status employees in the type of trade or job classification involved.
- b. Consistent with the contractor's work force requirements and as permissible under Federal and State regulations, the contractor shall make full use of training programs, i.e., apprenticeship, and on-the-job training programs for the geographical area of contract performance. In the event a special provision for training is provided under this contract, this subparagraph will be superseded as indicated in the special provision. The contracting agency may reserve training positions for persons who receive welfare assistance in accordance with 23 U.S.C. 140(a).
- c. The contractor will advise employees and applicants for employment of available training programs and entrance requirements for each.
- d. The contractor will periodically review the training and promotion potential of employees who are minorities and women and will encourage eligible employees to apply for such training and promotion.
- **7. Unions:** If the contractor relies in whole or in part upon unions as a source of employees, the contractor will use good faith efforts to obtain the cooperation of such unions to increase opportunities for minorities and women. Actions by the contractor, either directly or through a contractor's association acting as agent, will include the procedures set forth below:
- a. The contractor will use good faith efforts to develop, in cooperation with the unions, joint training programs aimed toward qualifying more minorities and women for membership in the unions and increasing the skills of minorities and women so that they may qualify for higher paying employment.
- b. The contractor will use good faith efforts to incorporate an EEO clause into each union agreement to the end that such union will be contractually bound to refer applicants without regard to their race, color, religion, sex, national origin, age or disability.
- c. The contractor is to obtain information as to the referral practices and policies of the labor union except that to the extent such information is within the exclusive possession of the labor union and such labor union refuses to furnish such information to the contractor, the contractor shall so certify to the contracting agency and shall set forth what efforts have been made to obtain such information.
- d. In the event the union is unable to provide the contractor with a reasonable flow of referrals within the time limit set forth in the collective bargaining agreement, the contractor will, through independent recruitment efforts, fill the employment vacancies without regard to race, color, religion, sex, national origin, age or disability; making full efforts to obtain qualified and/or qualifiable minorities and women. The failure of a union to provide sufficient referrals (even though it is obligated to provide exclusive referrals under the terms of a collective bargaining agreement) does not relieve the contractor from the requirements of this paragraph. In the event the union referral practice prevents the contractor from meeting the obligations pursuant to Executive Order 11246, as amended, and these special provisions, such contractor shall immediately notify the contracting agency.

- 8. Reasonable Accommodation for Applicants / Employees with Disabilities: The contractor must be familiar with the requirements for and comply with the Americans with Disabilities Act and all rules and regulations established there under. Employers must provide reasonable accommodation in all employment activities unless to do so would cause an undue hardship.
- 9. Selection of Subcontractors, Procurement of Materials and Leasing of Equipment: The contractor shall not discriminate on the grounds of race, color, religion, sex, national origin, age or disability in the selection and retention of subcontractors, including procurement of materials and leases of equipment. The contractor shall take all necessary and reasonable steps to ensure nondiscrimination in the administration of this contract.
- a. The contractor shall notify all potential subcontractors and suppliers and lessors of their EEO obligations under this contract.
- b. The contractor will use good faith efforts to ensure subcontractor compliance with their EEO obligations.

10. Assurance Required by 49 CFR 26.13(b):

- a. The requirements of 49 CFR Part 26 and the State DOT's U.S. DOT-approved DBE program are incorporated by reference.
- b. The contractor or subcontractor shall not discriminate on the basis of race, color, national origin, or sex in the performance of this contract. The contractor shall carry out applicable requirements of 49 CFR Part 26 in the award and administration of DOT-assisted contracts. Failure by the contractor to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy as the contracting agency deems appropriate.
- 11. Records and Reports: The contractor shall keep such records as necessary to document compliance with the EEO requirements. Such records shall be retained for a period of three years following the date of the final payment to the contractor for all contract work and shall be available at reasonable times and places for inspection by authorized representatives of the contracting agency and the FHWA.
 - a. The records kept by the contractor shall document the following:
- (1) The number and work hours of minority and nonminority group members and women employed in each work classification on the project;
 - (2) The progress and efforts being made in cooperation with unions, when applicable, to increase employment opportunities for minorities and women; and
 - (3) The progress and efforts being made in locating, hiring, training, qualifying, and upgrading minorities and women;
- b. The contractors and subcontractors will submit an annual report to the contracting agency each July for the duration of the project, indicating the number of minority, women, and non-minority group employees currently engaged in each work classification required by the contract work. This information is to be reported on Form FHWA-1391. The staffing data should represent the project work force on board in all or any part of the last payroll period preceding the end of July. If on-the-job training is being required by special provision, the contractor will be required to collect and report training data. The employment data should reflect the work force on board during all or any part of the last payroll period preceding the end of July.

III. NONSEGREGATED FACILITIES

This provision is applicable to all Federal-aid construction contracts and to all related construction subcontracts of \$10,000 or more.

The contractor must ensure that facilities provided for employees are provided in such a manner that segregation on the basis of race, color,

religion, sex, or national origin cannot result. The contractor may neither require such segregated use by written or oral policies nor tolerate such use by employee custom. The contractor's obligation extends further to ensure that its employees are not assigned to perform their services at any location, under the contractor's control, where the facilities are segregated. The term "facilities" includes waiting rooms, work areas, restaurants and other eating areas, time clocks, restrooms, washrooms, locker rooms, and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing provided for employees. The contractor shall provide separate or single-user restrooms and necessary dressing or sleeping areas to assure privacy between sexes.

IV. Davis-Bacon and Related Act Provisions

This section is applicable to all Federal-aid construction projects exceeding \$2,000 and to all related subcontracts and lower-tier subcontracts (regardless of subcontract size). The requirements apply to all projects located within the right-of-way of a roadway that is functionally classified as Federal-aid highway. This excludes roadways functionally classified as local roads or rural minor collectors, which are exempt. Contracting agencies may elect to apply these requirements to other projects.

The following provisions are from the U.S. Department of Labor regulations in 29 CFR 5.5 "Contract provisions and related matters" with minor revisions to conform to the FHWA-1273 format and FHWA program requirements.

1. Minimum wages

a. All laborers and mechanics employed or working upon the site of the work, will be paid unconditionally and not less often than once a week, and without subsequent deduction or rebate on any account (except such payroll deductions as are permitted by regulations issued by the Secretary of Labor under the Copeland Act (29 CFR part 3)), the full amount of wages and bona fide fringe benefits (or cash equivalents thereof) due at time of payment computed at rates not less than those contained in the wage determination of the Secretary of Labor which is attached hereto and made a part hereof, regardless of any contractual relationship which may be alleged to exist between the contractor and such laborers and mechanics.

Contributions made or costs reasonably anticipated for bona fide fringe benefits under section 1(b)(2) of the Davis-Bacon Act on behalf of laborers or mechanics are considered wages paid to such laborers or mechanics, subject to the provisions of paragraph 1.d. of this section; also, regular contributions made or costs incurred for more than a weekly period (but not less often than quarterly) under plans, funds, or programs which cover the particular weekly period, are deemed to be constructively made or incurred during such weekly period. Such laborers and mechanics shall be paid the appropriate wage rate and fringe benefits on the wage determination for the classification of work actually performed, without regard to skill, except as provided in 29 CFR 5.5(a)(4). Laborers or mechanics performing work in more than one classification may be compensated at the rate specified for each classification for the time actually worked therein: Provided, That the employer's payroll records accurately set forth the time spent in each classification in which work is performed. The wage determination (including any additional classification and wage rates conformed under paragraph 1.b. of this section) and the Davis-Bacon poster (WH-1321) shall be posted at all times by the contractor and its subcontractors at the site of the work in a prominent and accessible place where it can be easily seen by the workers.

b.(1) The contracting officer shall require that any class of laborers or mechanics, including helpers, which is not listed in the wage determination and which is to be employed under the contract shall be classified in conformance with the wage determination. The contracting officer shall approve an additional classification and wage rate and fringe benefits therefore only when the following criteria have been met:

- (i) The work to be performed by the classification requested is not performed by a classification in the wage determination; and
- (ii) The classification is utilized in the area by the construction industry; and
- (iii) The proposed wage rate, including any bona fide fringe benefits, bears a reasonable relationship to the wage rates contained in the wage determination.
- (2) If the contractor and the laborers and mechanics to be employed in the classification (if known), or their representatives, and the contracting officer agree on the classification and wage rate (including the amount designated for fringe benefits where appropriate), a report of the action taken shall be sent by the contracting officer to the Administrator of the Wage and Hour Division, Employment Standards Administration, U.S. Department of Labor, Washington, DC 20210. The Administrator, or an authorized representative, will approve, modify, or disapprove every additional classification action within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30-day period that additional time is necessary.
- (3) In the event the contractor, the laborers or mechanics to be employed in the classification or their representatives, and the contracting officer do not agree on the proposed classification and wage rate (including the amount designated for fringe benefits, where appropriate), the contracting officer shall refer the questions, including the views of all interested parties and the recommendation of the contracting officer, to the Wage and Hour Administrator for determination. The Wage and Hour Administrator, or an authorized representative, will issue a determination within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30-day period that additional time is necessary.
- (4) The wage rate (including fringe benefits where appropriate) determined pursuant to paragraphs 1.b.(2) or 1.b.(3) of this section, shall be paid to all workers performing work in the classification under this contract from the first day on which work is performed in the classification.
- c. Whenever the minimum wage rate prescribed in the contract for a class of laborers or mechanics includes a fringe benefit which is not expressed as an hourly rate, the contractor shall either pay the benefit as stated in the wage determination or shall pay another bona fide fringe benefit or an hourly cash equivalent thereof.
- d. If the contractor does not make payments to a trustee or other third person, the contractor may consider as part of the wages of any laborer or mechanic the amount of any costs reasonably anticipated in providing bona fide fringe benefits under a plan or program, Provided, That the Secretary of Labor has found, upon the written request of the contractor, that the applicable standards of the Davis-Bacon Act have been met. The Secretary of Labor may require the contractor to set aside in a separate account assets for the meeting of obligations under the plan or program.

2. Withholding

The contracting agency shall upon its own action or upon written request of an authorized representative of the Department of Labor, withhold or cause to be withheld from the contractor under this contract, or any other Federal contract with the same prime contractor, or any other federally-assisted contract subject to Davis-Bacon prevailing wage requirements, which is held by the same prime contractor, so much of the accrued payments or advances as may be considered necessary to pay laborers and mechanics, including apprentices, trainees, and helpers, employed by the contractor or any subcontractor the full amount of wages required by the contract. In the event of failure to pay any laborer or mechanic, including any apprentice, trainee, or helper, employed or working on the site of the work, all or part of the wages required by the contract, the contracting agency may, after written notice to the contractor, take such

action as may be necessary to cause the suspension of any further payment, advance, or guarantee of funds until such violations have ceased.

3. Payrolls and basic records

- a. Payrolls and basic records relating thereto shall be maintained by the contractor during the course of the work and preserved for a period of three years thereafter for all laborers and mechanics working at the site of the work. Such records shall contain the name, address, and social security number of each such worker, his or her correct classification, hourly rates of wages paid (including rates of contributions or costs anticipated for bona fide fringe benefits or cash equivalents thereof of the types described in section 1(b)(2)(B) of the Davis-Bacon Act), daily and weekly number of hours worked, deductions made and actual wages paid. Whenever the Secretary of Labor has found under 29 CFR 5.5(a)(1)(iv) that the wages of any laborer or mechanic include the amount of any costs reasonably anticipated in providing benefits under a plan or program described in section 1(b)(2)(B) of the Davis-Bacon Act, the contractor shall maintain records which show that the commitment to provide such benefits is enforceable, that the plan or program is financially responsible, and that the plan or program has been communicated in writing to the laborers or mechanics affected, and records which show the costs anticipated or the actual cost incurred in providing such benefits. Contractors employing apprentices or trainees under approved programs shall maintain written evidence of the registration of apprenticeship programs and certification of trainee programs, the registration of the apprentices and trainees, and the ratios and wage rates prescribed in the applicable programs.
- (1) The contractor shall submit weekly for each week in which any contract work is performed a copy of all payrolls to the contracting agency. The payrolls submitted shall set out accurately and completely all of the information required to be maintained under 29 CFR 5.5(a)(3)(i), except that full social security numbers and home addresses shall not be included on weekly transmittals. Instead the payrolls shall only need to include an individually identifying number for each employee (e.g., the last four digits of the employee's social security number). The required weekly payroll information may be submitted in any form desired. Optional Form WH-347 is available for this purpose Wage and Hour Division Web http://www.dol.gov/esa/whd/forms/wh347instr.htm or its successor site. The prime contractor is responsible for the submission of copies of payrolls by all subcontractors. Contractors and subcontractors shall maintain the full social security number and current address of each covered worker, and shall provide them upon request to the contracting agency for transmission to the State DOT, the FHWA or the Wage and Hour Division of the Department of Labor for purposes of an investigation or audit of compliance with prevailing wage requirements. It is not a violation of this section for a prime contractor to require a subcontractor to provide addresses and social security numbers to the prime contractor for its own records, without weekly submission to the contracting agency..
- (2) Each payroll submitted shall be accompanied by a "Statement of Compliance," signed by the contractor or subcontractor or his or her agent who pays or supervises the payment of the persons employed under the contract and shall certify the following:
 - (i) That the payroll for the payroll period contains the information required to be provided under §5.5 (a)(3)(ii) of Regulations, 29 CFR part 5, the appropriate information is being maintained under §5.5 (a)(3)(i) of Regulations, 29 CFR part 5, and that such information is correct and complete;
 - (ii) That each laborer or mechanic (including each helper, apprentice, and trainee) employed on the contract during the payroll period has been paid the full weekly wages earned, without rebate, either directly or indirectly, and that no deductions have been made either directly or indirectly from the full wages earned, other than permissible deductions as set forth in Regulations, 29 CFR part 3;

- (iii) That each laborer or mechanic has been paid not less than the applicable wage rates and fringe benefits or cash equivalents for the classification of work performed, as specified in the applicable wage determination incorporated into the contract.
- (3) The weekly submission of a properly executed certification set forth on the reverse side of Optional Form WH–347 shall satisfy the requirement for submission of the "Statement of Compliance" required by paragraph 3.b.(2) of this section.
- (4) The falsification of any of the above certifications may subject the contractor or subcontractor to civil or criminal prosecution under section 1001 of title 18 and section 231 of title 31 of the United States Code.
- c. The contractor or subcontractor shall make the records required under paragraph 3.a. of this section available for inspection, copying, or transcription by authorized representatives of the contracting agency, the State DOT, the FHWA, or the Department of Labor, and shall permit such representatives to interview employees during working hours on the job. If the contractor or subcontractor fails to submit the required records or to make them available, the FHWA may, after written notice to the contractor, the contracting agency or the State DOT, take such action as may be necessary to cause the suspension of any further payment, advance, or guarantee of funds. Furthermore, failure to submit the required records upon request or to make such records available may be grounds for debarment action pursuant to 29 CFR 5.12.

4. Apprentices and trainees

a. Apprentices (programs of the USDOL).

Apprentices will be permitted to work at less than the predetermined rate for the work they performed when they are employed pursuant to and individually registered in a bona fide apprenticeship program registered with the U.S. Department of Labor, Employment and Training Administration, Office of Apprenticeship Training, Employer and Labor Services, or with a State Apprenticeship Agency recognized by the Office, or if a person is employed in his or her first 90 days of probationary employment as an apprentice in such an apprenticeship program, who is not individually registered in the program, but who has been certified by the Office of Apprenticeship Training, Employer and Labor Services or a State Apprenticeship Agency (where appropriate) to be eligible for probationary employment as an apprentice.

The allowable ratio of apprentices to journeymen on the job site in any craft classification shall not be greater than the ratio permitted to the contractor as to the entire work force under the registered program. Any worker listed on a payroll at an apprentice wage rate, who is not registered or otherwise employed as stated above, shall be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed. In addition, any apprentice performing work on the job site in excess of the ratio permitted under the registered program shall be paid not less than the applicable wage rate on the wage determination for the work actually performed. Where a contractor is performing construction on a project in a locality other than that in which its program is registered, the ratios and wage rates (expressed in percentages of the journeyman's hourly rate) specified in the contractor's or subcontractor's registered program shall be observed.

Every apprentice must be paid at not less than the rate specified in the registered program for the apprentice's level of progress, expressed as a percentage of the journeymen hourly rate specified in the applicable wage determination. Apprentices shall be paid fringe benefits in accordance with the provisions of the apprenticeship program. If the apprenticeship program does not specify fringe benefits, apprentices must be paid the full amount of fringe benefits listed on the wage determination for the applicable classification. If the Administrator determines that a different practice prevails for the applicable apprentice classification, fringes shall be paid in accordance with that determination.

In the event the Office of Apprenticeship Training, Employer and Labor Services, or a State Apprenticeship Agency recognized by the Office, withdraws approval of an apprenticeship program, the contractor will no longer be permitted to utilize apprentices at less than the applicable predetermined rate for the work performed until an acceptable program is approved.

b. Trainees (programs of the USDOL).

Except as provided in 29 CFR 5.16, trainees will not be permitted to work at less than the predetermined rate for the work performed unless they are employed pursuant to and individually registered in a program which has received prior approval, evidenced by formal certification by the U.S. Department of Labor, Employment and Training Administration.

The ratio of trainees to journeymen on the job site shall not be greater than permitted under the plan approved by the Employment and Training Administration.

Every trainee must be paid at not less than the rate specified in the approved program for the trainee's level of progress, expressed as a percentage of the journeyman hourly rate specified in the applicable wage determination. Trainees shall be paid fringe benefits in accordance with the provisions of the trainee program. If the trainee program does not mention fringe benefits, trainees shall be paid the full amount of fringe benefits listed on the wage determination unless the Administrator of the Wage and Hour Division determines that there is an apprenticeship program associated with the corresponding journeyman wage rate on the wage determination which provides for less than full fringe benefits for apprentices. Any employee listed on the payroll at a trainee rate who is not registered and participating in a training plan approved by the Employment and Training Administration shall be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed. In addition, any trainee performing work on the job site in excess of the ratio permitted under the registered program shall be paid not less than the applicable wage rate on the wage determination for the work actually performed.

In the event the Employment and Training Administration withdraws approval of a training program, the contractor will no longer be permitted to utilize trainees at less than the applicable predetermined rate for the work performed until an acceptable program is approved.

- c. Equal employment opportunity. The utilization of apprentices, trainees and journeymen under this part shall be in conformity with the equal employment opportunity requirements of Executive Order 11246, as amended, and 29 CFR part 30.
- d. Apprentices and Trainees (programs of the U.S. DOT).

Apprentices and trainees working under apprenticeship and skill training programs which have been certified by the Secretary of Transportation as promoting EEO in connection with Federal-aid highway construction programs are not subject to the requirements of paragraph 4 of this Section IV. The straight time hourly wage rates for apprentices and trainees under such programs will be established by the particular programs. The ratio of apprentices and trainees to journeymen shall not be greater than permitted by the terms of the particular program.

- **5. Compliance with Copeland Act requirements.** The contractor shall comply with the requirements of 29 CFR part 3, which are incorporated by reference in this contract.
- **6. Subcontracts.** The contractor or subcontractor shall insert Form FHWA-1273 in any subcontracts and also require the subcontractors to include Form FHWA-1273 in any lower tier subcontracts. The prime contractor shall be responsible for the compliance by any subcontractor or lower tier subcontractor with all the contract clauses in 29 CFR 5.5.
- **7. Contract termination: debarment.** A breach of the contract clauses in 29 CFR 5.5 may be grounds for termination of the contract, and for

debarment as a contractor and a subcontractor as provided in 29 CFR 5.12.

- **8. Compliance with Davis-Bacon and Related Act requirements.** All rulings and interpretations of the Davis-Bacon and Related Acts contained in 29 CFR parts 1, 3, and 5 are herein incorporated by reference in this contract.
- **9. Disputes concerning labor standards.** Disputes arising out of the labor standards provisions of this contract shall not be subject to the general disputes clause of this contract. Such disputes shall be resolved in accordance with the procedures of the Department of Labor set forth in 29 CFR parts 5, 6, and 7. Disputes within the meaning of this clause include disputes between the contractor (or any of its subcontractors) and the contracting agency, the U.S. Department of Labor, or the employees or their representatives.

10. Certification of eligibility.

- a. By entering into this contract, the contractor certifies that neither it (nor he or she) nor any person or firm who has an interest in the contractor's firm is a person or firm ineligible to be awarded Government contracts by virtue of section 3(a) of the Davis-Bacon Act or 29 CFR 5.12(a)(1).
- b. No part of this contract shall be subcontracted to any person or firm ineligible for award of a Government contract by virtue of section 3(a) of the Davis-Bacon Act or 29 CFR 5.12(a)(1).
- c. The penalty for making false statements is prescribed in the U.S. Criminal Code, 18 U.S.C. 1001.

V. CONTRACT WORK HOURS AND SAFETY STANDARDS ACT

The following clauses apply to any Federal-aid construction contract in an amount in excess of \$100,000 and subject to the overtime provisions of the Contract Work Hours and Safety Standards Act. These clauses shall be inserted in addition to the clauses required by 29 CFR 5.5(a) or 29 CFR 4.6. As used in this paragraph, the terms laborers and mechanics include watchmen and guards.

- 1. Overtime requirements. No contractor or subcontractor contracting for any part of the contract work which may require or involve the employment of laborers or mechanics shall require or permit any such laborer or mechanic in any workweek in which he or she is employed on such work to work in excess of forty hours in such workweek unless such laborer or mechanic receives compensation at a rate not less than one and one-half times the basic rate of pay for all hours worked in excess of forty hours in such workweek.
- 2. Violation; liability for unpaid wages; liquidated damages. In the event of any violation of the clause set forth in paragraph (1.) of this section, the contractor and any subcontractor responsible therefor shall be liable for the unpaid wages. In addition, such contractor and subcontractor shall be liable to the United States (in the case of work done under contract for the District of Columbia or a territory, to such District or to such territory), for liquidated damages. Such liquidated damages shall be computed with respect to each individual laborer or mechanic, including watchmen and guards, employed in violation of the clause set forth in paragraph (1.) of this section, in the sum of \$10 for each calendar day on which such individual was required or permitted to work in excess of the standard workweek of forty hours without payment of the overtime wages required by the clause set forth in paragraph (1.) of this section.
- 3. Withholding for unpaid wages and liquidated damages. The FHWA or the contacting agency shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the contractor or subcontractor under any such

contract or any other Federal contract with the same prime contractor, or any other federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph (2.) of this section.

4. Subcontracts. The contractor or subcontractor shall insert in any subcontracts the clauses set forth in paragraph (1.) through (4.) of this section and also a clause requiring the subcontractors to include these clauses in any lower tier subcontracts. The prime contractor shall be responsible for compliance by any subcontractor or lower tier subcontractor with the clauses set forth in paragraphs (1.) through (4.) of this section.

VI. SUBLETTING OR ASSIGNING THE CONTRACT

This provision is applicable to all Federal-aid construction contracts on the National Highway System.

- 1. The contractor shall perform with its own organization contract work amounting to not less than 30 percent (or a greater percentage if specified elsewhere in the contract) of the total original contract price, excluding any specialty items designated by the contracting agency. Specialty items may be performed by subcontract and the amount of any such specialty items performed may be deducted from the total original contract price before computing the amount of work required to be performed by the contractor's own organization (23 CFR 635.116).
- a. The term "perform work with its own organization" refers to workers employed or leased by the prime contractor, and equipment owned or rented by the prime contractor, with or without operators. Such term does not include employees or equipment of a subcontractor or lower tier subcontractor, agents of the prime contractor, or any other assignees. The term may include payments for the costs of hiring leased employees from an employee leasing firm meeting all relevant Federal and State regulatory requirements. Leased employees may only be included in this term if the prime contractor meets all of the following conditions:
- (1) the prime contractor maintains control over the supervision of the day-to-day activities of the leased employees;
- (2) the prime contractor remains responsible for the quality of the work of the leased employees:
- (3) the prime contractor retains all power to accept or exclude individual employees from work on the project; and
 - (4) the prime contractor remains ultimately responsible for the payment of predetermined minimum wages, the submission of payrolls, statements of compliance and all other Federal regulatory requirements.
- b. "Specialty Items" shall be construed to be limited to work that requires highly specialized knowledge, abilities, or equipment not ordinarily available in the type of contracting organizations qualified and expected to bid or propose on the contract as a whole and in general are to be limited to minor components of the overall contract.
- 2. The contract amount upon which the requirements set forth in paragraph (1) of Section VI is computed includes the cost of material and manufactured products which are to be purchased or produced by the contractor under the contract provisions.
- 3. The contractor shall furnish (a) a competent superintendent or supervisor who is employed by the firm, has full authority to direct performance of the work in accordance with the contract requirements, and is in charge of all construction operations (regardless of who performs the work) and (b) such other of its own organizational resources (supervision, management, and engineering services) as the contracting officer determines is necessary to assure the performance of the contract.

- 4. No portion of the contract shall be sublet, assigned or otherwise disposed of except with the written consent of the contracting officer, or authorized representative, and such consent when given shall not be construed to relieve the contractor of any responsibility for the fulfillment of the contract. Written consent will be given only after the contracting agency has assured that each subcontract is evidenced in writing and that it contains all pertinent provisions and requirements of the prime contract.
- 5. The 30% self-performance requirement of paragraph (1) is not applicable to design-build contracts; however, contracting agencies may establish their own self-performance requirements.

VII. SAFETY: ACCIDENT PREVENTION

This provision is applicable to all Federal-aid construction contracts and to all related subcontracts.

- 1. In the performance of this contract the contractor shall comply with all applicable Federal, State, and local laws governing safety, health, and sanitation (23 CFR 635). The contractor shall provide all safeguards, safety devices and protective equipment and take any other needed actions as it determines, or as the contracting officer may determine, to be reasonably necessary to protect the life and health of employees on the job and the safety of the public and to protect property in connection with the performance of the work covered by the contract.
- 2. It is a condition of this contract, and shall be made a condition of each subcontract, which the contractor enters into pursuant to this contract, that the contractor and any subcontractor shall not permit any employee, in performance of the contract, to work in surroundings or under conditions which are unsanitary, hazardous or dangerous to his/her health or safety, as determined under construction safety and health standards (29 CFR 1926) promulgated by the Secretary of Labor, in accordance with Section 107 of the Contract Work Hours and Safety Standards Act (40 U.S.C. 3704).
- 3. Pursuant to 29 CFR 1926.3, it is a condition of this contract that the Secretary of Labor or authorized representative thereof, shall have right of entry to any site of contract performance to inspect or investigate the matter of compliance with the construction safety and health standards and to carry out the duties of the Secretary under Section 107 of the Contract Work Hours and Safety Standards Act (40 U.S.C.3704).

VIII. FALSE STATEMENTS CONCERNING HIGHWAY PROJECTS

This provision is applicable to all Federal-aid construction contracts and to all related subcontracts.

In order to assure high quality and durable construction in conformity with approved plans and specifications and a high degree of reliability on statements and representations made by engineers, contractors, suppliers, and workers on Federal-aid highway projects, it is essential that all persons concerned with the project perform their functions as carefully, thoroughly, and honestly as possible. Willful falsification, distortion, or misrepresentation with respect to any facts related to the project is a violation of Federal law. To prevent any misunderstanding regarding the seriousness of these and similar acts, Form FHWA-1022 shall be posted on each Federal-aid highway project (23 CFR 635) in one or more places where it is readily available to all persons concerned with the project:

18 U.S.C. 1020 reads as follows:

"Whoever, being an officer, agent, or employee of the United States, or of any State or Territory, or whoever, whether a person, association, firm, or corporation, knowingly makes any false statement, false representation, or false report as to the character, quality, quantity, or cost of the material used or to be used, or the quantity or quality of the work performed or to be performed, or the cost thereof in connection with the submission of plans, maps, specifications, contracts, or costs of construction on any highway or related project submitted for approval to the Secretary of Transportation; or

Whoever knowingly makes any false statement, false representation, false report or false claim with respect to the character, quality, quantity, or cost of any work performed or to be performed, or materials furnished or to be furnished, in connection with the construction of any highway or related project approved by the Secretary of Transportation; or

Whoever knowingly makes any false statement or false representation as to material fact in any statement, certificate, or report submitted pursuant to provisions of the Federal-aid Roads Act approved July 1, 1916, (39 Stat. 355), as amended and supplemented;

Shall be fined under this title or imprisoned not more than 5 years or both."

IX. IMPLEMENTATION OF CLEAN AIR ACT AND FEDERAL WATER POLLUTION CONTROL ACT

This provision is applicable to all Federal-aid construction contracts and to all related subcontracts.

By submission of this bid/proposal or the execution of this contract, or subcontract, as appropriate, the bidder, proposer, Federal-aid construction contractor, or subcontractor, as appropriate, will be deemed to have stipulated as follows:

- 1. That any person who is or will be utilized in the performance of this contract is not prohibited from receiving an award due to a violation of Section 508 of the Clean Water Act or Section 306 of the Clean Air Act.
- 2. That the contractor agrees to include or cause to be included the requirements of paragraph (1) of this Section X in every subcontract, and further agrees to take such action as the contracting agency may direct as a means of enforcing such requirements.

X. CERTIFICATION REGARDING DEBARMENT, SUSPENSION, INELIGIBILITY AND VOLUNTARY EXCLUSION

This provision is applicable to all Federal-aid construction contracts, design-build contracts, subcontracts, lower-tier subcontracts, purchase orders, lease agreements, consultant contracts or any other covered transaction requiring FHWA approval or that is estimated to cost \$25,000 or more — as defined in 2 CFR Parts 180 and 1200.

1. Instructions for Certification – First Tier Participants:

- a. By signing and submitting this proposal, the prospective first tier participant is providing the certification set out below.
- b. The inability of a person to provide the certification set out below will not necessarily result in denial of participation in this covered transaction. The prospective first tier participant shall submit an explanation of why it cannot provide the certification set out below. The certification or explanation will be considered in connection with the department or agency's determination whether to enter into this transaction. However, failure of the prospective first tier participant to furnish a certification or an explanation shall disqualify such a person from participation in this transaction.
- c. The certification in this clause is a material representation of fact upon which reliance was placed when the contracting agency determined to enter into this transaction. If it is later determined that the prospective participant knowingly rendered an erroneous certification, in addition to other remedies available to the Federal Government, the contracting agency may terminate this transaction for cause of default.
- d. The prospective first tier participant shall provide immediate written notice to the contracting agency to whom this proposal is submitted if any time the prospective first tier participant learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
- e. The terms "covered transaction," "debarred," "suspended," "ineligible," "participant," "person," "principal," and "voluntarily excluded,"

as used in this clause, are defined in 2 CFR Parts 180 and 1200. "First Tier Covered Transactions" refers to any covered transaction between a grantee or subgrantee of Federal funds and a participant (such as the prime or general contract). "Lower Tier Covered Transactions" refers to any covered transaction under a First Tier Covered Transaction (such as subcontracts). "First Tier Participant" refers to the participant who has entered into a covered transaction with a grantee or subgrantee of Federal funds (such as the prime or general contractor). "Lower Tier Participant" refers any participant who has entered into a covered transaction with a First Tier Participant or other Lower Tier Participants (such as subcontractors and suppliers).

- f. The prospective first tier participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized by the department or agency entering into this transaction.
- g. The prospective first tier participant further agrees by submitting this proposal that it will include the clause titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion-Lower Tier Covered Transactions," provided by the department or contracting agency, entering into this covered transaction, without modification, in all lower tier covered transactions and in all solicitations for lower tier covered transactions exceeding the \$25,000 threshold.
- h. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that is not debarred, suspended, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is erroneous. A participant is responsible for ensuring that its principals are not suspended, debarred, or otherwise ineligible to participate in covered transactions. To verify the eligibility of its principals, as well as the eligibility of any lower tier prospective participants, each participant may, but is not required to, check the Excluded Parties List System website (https://www.epls.gov/), which is compiled by the General Services Administration.
- i. Nothing contained in the foregoing shall be construed to require the establishment of a system of records in order to render in good faith the certification required by this clause. The knowledge and information of the prospective participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.
- j. Except for transactions authorized under paragraph (f) of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible, or voluntarily excluded from participation in this transaction, in addition to other remedies available to the Federal Government, the department or agency may terminate this transaction for cause or default.

* * * * *

2. Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion – First Tier Participants:

- a. The prospective first tier participant certifies to the best of its knowledge and belief, that it and its principals:
- (1) Are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participating in covered transactions by any Federal department or agency;
- (2) Have not within a three-year period preceding this proposal been convicted of or had a civil judgment rendered against them for commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a public (Federal, State or local) transaction or contract under a public transaction; violation of Federal or State antitrust statutes or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property;
- (3) Are not presently indicted for or otherwise criminally or civilly charged by a governmental entity (Federal, State or local) with

commission of any of the offenses enumerated in paragraph (a)(2) of this certification; and

- (4) Have not within a three-year period preceding this application/proposal had one or more public transactions (Federal, State or local) terminated for cause or default.
- b. Where the prospective participant is unable to certify to any of the statements in this certification, such prospective participant shall attach an explanation to this proposal.

2. Instructions for Certification - Lower Tier Participants:

(Applicable to all subcontracts, purchase orders and other lower tier transactions requiring prior FHWA approval or estimated to cost \$25,000 or more - 2 CFR Parts 180 and 1200)

- a. By signing and submitting this proposal, the prospective lower tier is providing the certification set out below.
- b. The certification in this clause is a material representation of fact upon which reliance was placed when this transaction was entered into. If it is later determined that the prospective lower tier participant knowingly rendered an erroneous certification, in addition to other remedies available to the Federal Government, the department, or agency with which this transaction originated may pursue available remedies, including suspension and/or debarment.
- c. The prospective lower tier participant shall provide immediate written notice to the person to which this proposal is submitted if at any time the prospective lower tier participant learns that its certification was erroneous by reason of changed circumstances.
- d. The terms "covered transaction," "debarred," "suspended," "ineligible," "participant," "person," "principal," and "voluntarily excluded," as used in this clause, are defined in 2 CFR Parts 180 and 1200. You may contact the person to which this proposal is submitted for assistance in obtaining a copy of those regulations. "First Tier Covered Transactions" refers to any covered transaction between a grantee or subgrantee of Federal funds and a participant (such as the prime or general contract). "Lower Tier Covered Transactions" refers to any covered transaction under a First Tier Covered Transaction (such as subcontracts). "First Tier Participant" refers to the participant who has entered into a covered transaction with a grantee or subgrantee of Federal funds (such as the prime or general contractor). "Lower Tier Participant" refers any participant who has entered into a covered transaction with a First Tier Participant or other Lower Tier Participants (such as subcontractors and suppliers).
- e. The prospective lower tier participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized by the department or agency with which this transaction originated.
- f. The prospective lower tier participant further agrees by submitting this proposal that it will include this clause titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion-Lower Tier Covered Transaction," without modification, in all lower tier covered transactions and in all solicitations for lower tier covered transactions exceeding the \$25,000 threshold.
- g. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that is not debarred, suspended, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is erroneous. Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion--Lower Tier Participants:

- 1. The prospective lower tier participant certifies, by submission of this proposal, that neither it nor its principals is presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participating in covered transactions by any Federal department or agency.
- 2. Where the prospective lower tier participant is unable to certify to any of the statements in this certification, such prospective participant shall attach an explanation to this proposal.

XI. CERTIFICATION REGARDING USE OF CONTRACT FUNDS FOR LOBBYING

This provision is applicable to all Federal-aid construction contracts and to all related subcontracts which exceed \$100,000 (49 CFR 20).

- 1. The prospective participant certifies, by signing and submitting this bid or proposal, to the best of his or her knowledge and belief, that:
- a. No Federal appropriated funds have been paid or will be paid, by or on behalf of the undersigned, to any person for influencing or attempting to influence an officer or employee of any Federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.
- b. If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any Federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the undersigned shall complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.
- 2. This certification is a material representation of fact upon which reliance was placed when this transaction was made or entered into. Submission of this certification is a prerequisite for making or entering into this transaction imposed by 31 U.S.C. 1352. Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.
- 3. The prospective participant also agrees by submitting its bid or proposal that the participant shall require that the language of this certification be included in all lower tier subcontracts, which exceed \$100,000 and that all such recipients shall certify and disclose accordingly.

Contract Provision - Cargo Preference Requirements

In accordance with Title 46 CFR § 381.7 (b), the contractor agrees—

- "(1) To utilize privately owned United States-flag commercial vessels to ship at least 50 percent of the gross tonnage (computed separately for dry bulk carriers, dry cargo liners, and tankers) involved, whenever shipping any equipment, material, or commodities pursuant to this contract, to the extent such vessels are available at fair and reasonable rates for United States-flag commercial vessels.
- (2) To furnish within 20 days following the date of loading for shipments originating within the United States or within 30 working days following the date of loading for shipments originating outside the United States, a legible copy of a rated, 'on-board' commercial ocean bill-of-lading in English for each shipment of cargo described in paragraph (b) (1) of this section to both the Contracting Officer (through the prime contractor in the case of subcontractor bills-of-lading) and to the Division of National Cargo, Office of Market Development, Maritime Administration, Washington, DC 20590.
- (3) To insert the substance of the provisions of this clause in all subcontracts issued pursuant to this contract."

Provisions (1) and (2) apply to materials or equipment that are acquired solely for the project. The two provisions do not apply to goods or materials that come into inventories independent of the project, such as shipments of Portland cement, asphalt cement, or aggregates, when industry suppliers and contractors use these materials to replenish existing inventories.

MINIMUM WAGES FOR FEDERAL AND FEDERALLY ASSISTED CONSTRUCTION CONTRACTS

This project is funded, in part, with Federal-aid funds and, as such, is subject to the provisions of the Davis-Bacon Act of March 3, 1931, as amended (46 Sta. 1494, as amended, 40 U.S.C. 276a) and of other Federal statutes referred to in a 29 CFR Part 1, Appendix A, as well as such additional statutes as may from time to time be enacted containing provisions for the payment of wages determined to be prevailing by the Secretary of Labor in accordance with the Davis-Bacon Act and pursuant to the provisions of 29 CFR Part 1. The prevailing rates and fringe benefits shown in the General Wage Determination Decisions issued by the U.S. Department of Labor shall, in accordance with the provisions of the foregoing statutes, constitute the minimum wages payable on Federal and federally assisted construction projects to laborers and mechanics of the specified classes engaged on contract work of the character and in the localities described therein.

General Wage Determination Decisions, modifications and supersedes decisions thereto are to be used in accordance with the provisions of 29 CFR Parts 1 and 5. Accordingly, the applicable decision, together with any modifications issued, must be made a part of every contract for performance of the described work within the geographic area indicated as required by an applicable DBRA Federal prevailing wage law and 29 CFR Part 5. The wage rates and fringe benefits contained in the General Wage Determination Decision shall be the minimum paid by contractors and subcontractors to laborers and mechanics.
