(7) Residual asphalt binder in the RAS material as a percent of the total mix to the nearest 0.1 percent.

The printouts shall be maintained in a file at the plant for a minimum of one year or as directed by the Engineer and shall be made available upon request. The printing system will be inspected by the Engineer prior to production and verified at the beginning of each construction season thereafter.

CENTER LINE-RUMBLE STRIP

This item shall be constructed as shown on the plans and in accordance with the applicable portions of Section 642 of the Standard specifications for Road and Bridge Construction, except that the rumble strips are to be constructed on the centerline of pavement instead of on the shoulder area.

After the rumble strips are installed, the pavement surface shall be swept clean to the satisfaction of the Engineer, prior to the placement of the new pavement markings.

This work will be measured along the centerline and paid for at the contract unit price per foot for CENTER LINE – RUMBLE STRIP.
