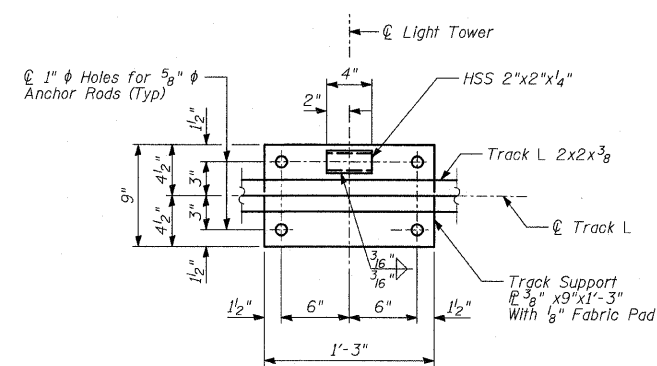
PLAN - GATE IN OPEN POSITION

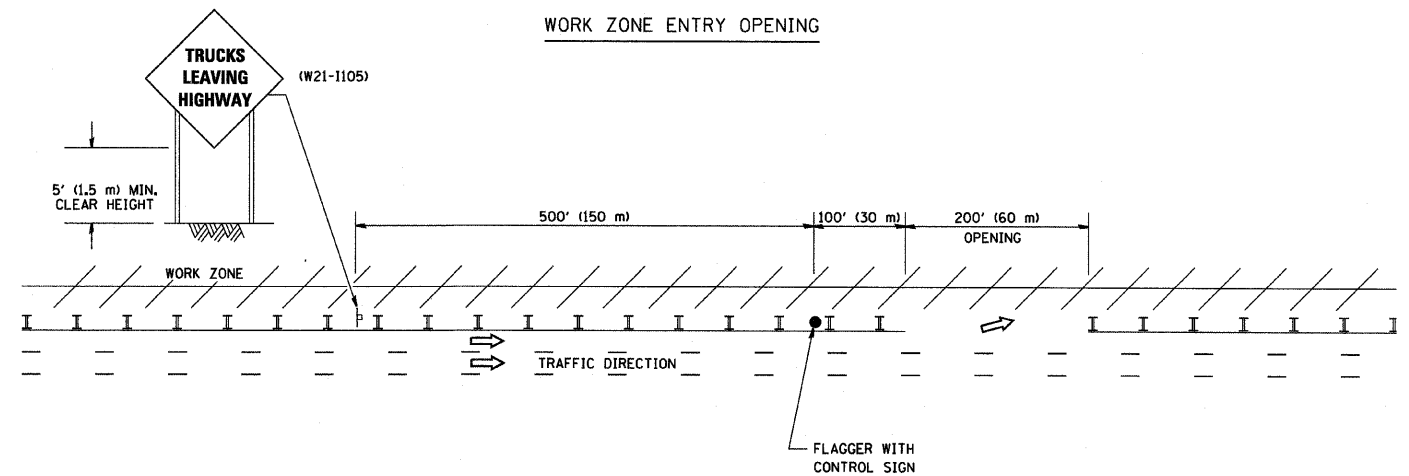
