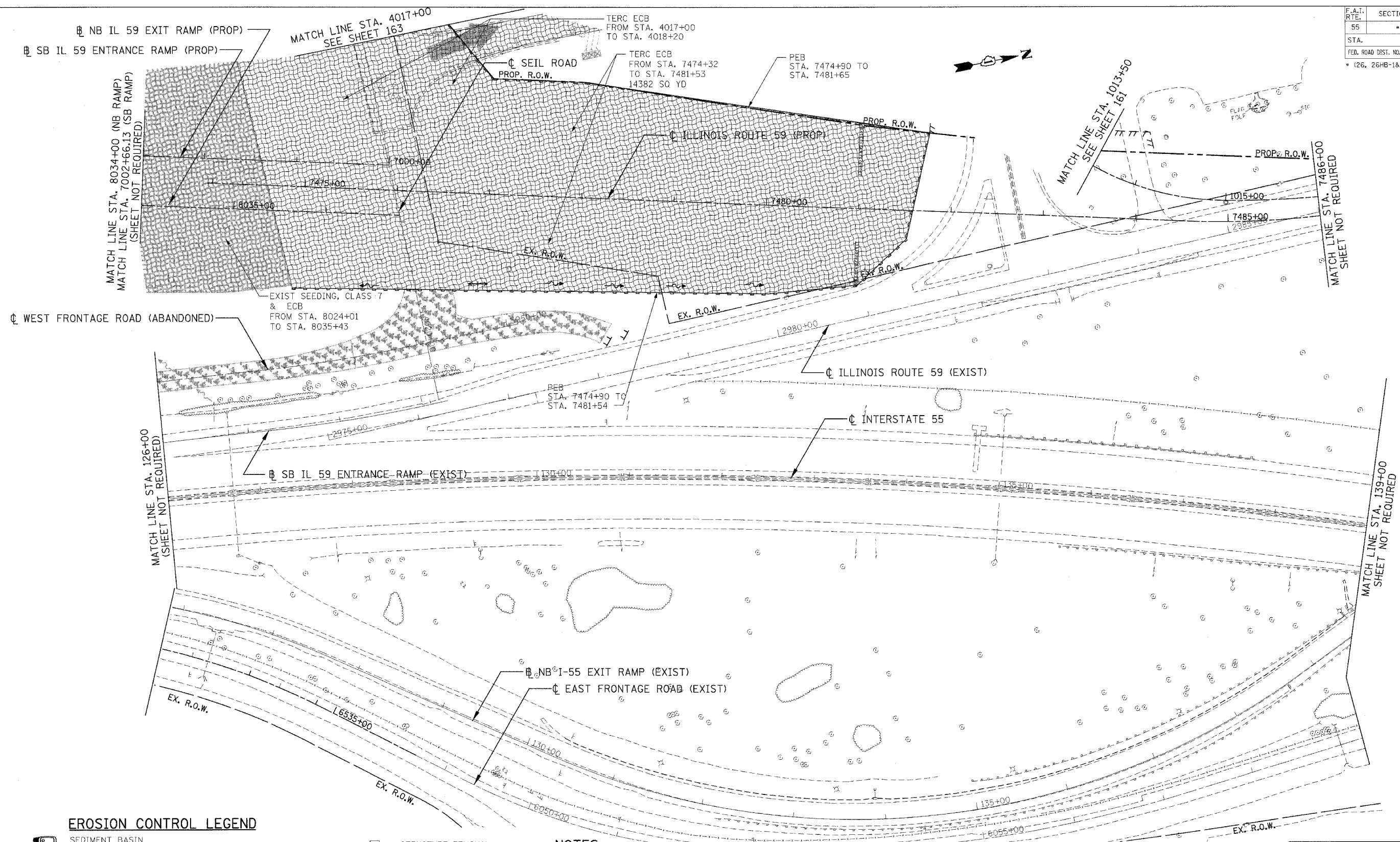

NOTES:

- FOR PERMANENT DRAINAGE STRUCTURE AND PIPE INFORMATION SEE SHEETS 216 TO 221
- PER STANDARD 2800001, ALL SEDIMENT BASINS TO BE PLACED AS SHOWN AND REMOVED AT THE END OF THE PROJECT. THE COST WILL BE INCLUDED IN THE CONTRACT UNIT PRICE BID PER CUBIC YARD FOR "EARTH EXCAVATION FOR EROSION CONTROL".
- AGGREGATE EROSION CONTROL IS NOT REQUIRED FOR SEDIMENT BASINS WHERE THESE DISCHARGE TO STONE RIPRAP.
- LATERAL SEWER PIPE TO MAINLINE SEWER SHALL HAVE THEIR UPSTREAM ENDS TEMPORARILY PLUGGED ACCORDING TO DETAILS OF SHEET 410, OR AS DIRECTED BY THE ENGINEER. PLUG WILL BE REMOVED UPON CONSTRUCTION OF REMAINING LATERAL PIPE, AS DIRECTED BY THE ENGINEER. COST OF TEMPORARY PLUG AND SUBSEQUENT REMOVAL FOR LATERAL STORM SEWER CONNECTIONS WILL NOT BE PAID FOR SEPARATELY, BUT WILL BE INCLUDED IN THE CONTRACT UNIT PRICE BID PER FOOT FOR STORM SEWERS, OF THE CLASS AND TYPE SPECIFIED.
