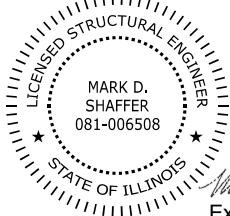


STRUCTURE GENERAL NOTES

Reinforcement bars designated (E) shall be epoxy coated.
Plan dimensions and details relative to the existing structure have been taken from existing plans are subject to nominal construction variations. The Contactor shall field verify existing dimensions and details affecting new construction and make necessary approved adjustments prior to construction or ordering of materials. Such variations shall not be cause for additional compensation for a change in scope of the work, however, the Contractor will be paid for the quantity actually furnished at the unit price bid for the work.
Existing reinforcement shall be cleaned, straightened, and incorporated into the new construction. Cost included with Concrete Removal.
All structural steel and exposed surfaces and bearings within a distance of 10 ft. each way from the deck joints shall be painted using the OZ/E/U paint system as specified in Section 506 of the Standard Specifications.
Cleaning and painting of the existing structural steel shall be as specified in the special provision for "Cleaning and Painting Existing Steel Structures". Steel to be cleaned shall be cleaned per Near White Blast Cleaning - SSPC-SP10. Steel to be painted shall be painted according to the requirements of Paint System 1 - OZ/E/U. The color of the final finish coat for all interior steel surfaces shall be Gray, Munsell No. 5B 7/1. The color of the final finish coat for the exterior and bottom flange of the fascia beams shall be Reddish Brown, 2.5YR 3/4. Containment of cleaning residue is required to control nuisance dust. See special provisions.
SSPC QP1 (and QP2) Contractor Certification is required for this Contract. Joint openings shall be adjusted according to Article 520.04 of the Standard Specifications when the deck is poured at an ambient temperature other than 50° F.
Prior to pouring the new concrete deck, all heavy or loose rust, loose mill scale, and other loose detrimental foreign material shall be removed from the surfaces in contact with concrete (SSPC-SP3 standards). Tightly adhered paint may remain unless otherwise noted. Removal shall be accomplished by methods that will not damage the steel and the cost will be paid for according to Article 109.04 of the Standard Specifications.
Synthetic fibers will not be required in the microsilica concrete overlay.
Abandoned shoulder inlets in the approaches shall be removed with the approaches. Cost included in Approach Slab Removal.
The contractor may elect to remove and re-erect SPBGR to facilitate approach slab reconstruction at his own expense.

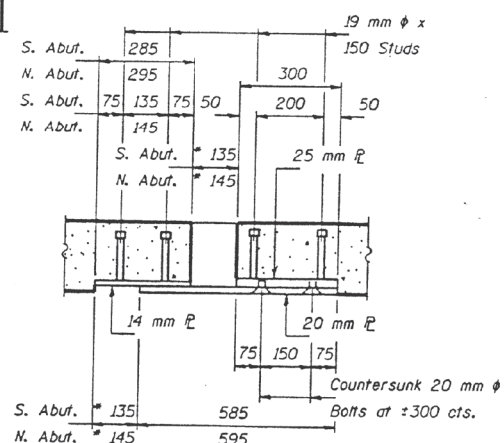


FINGER CUTTING DIAGRAM

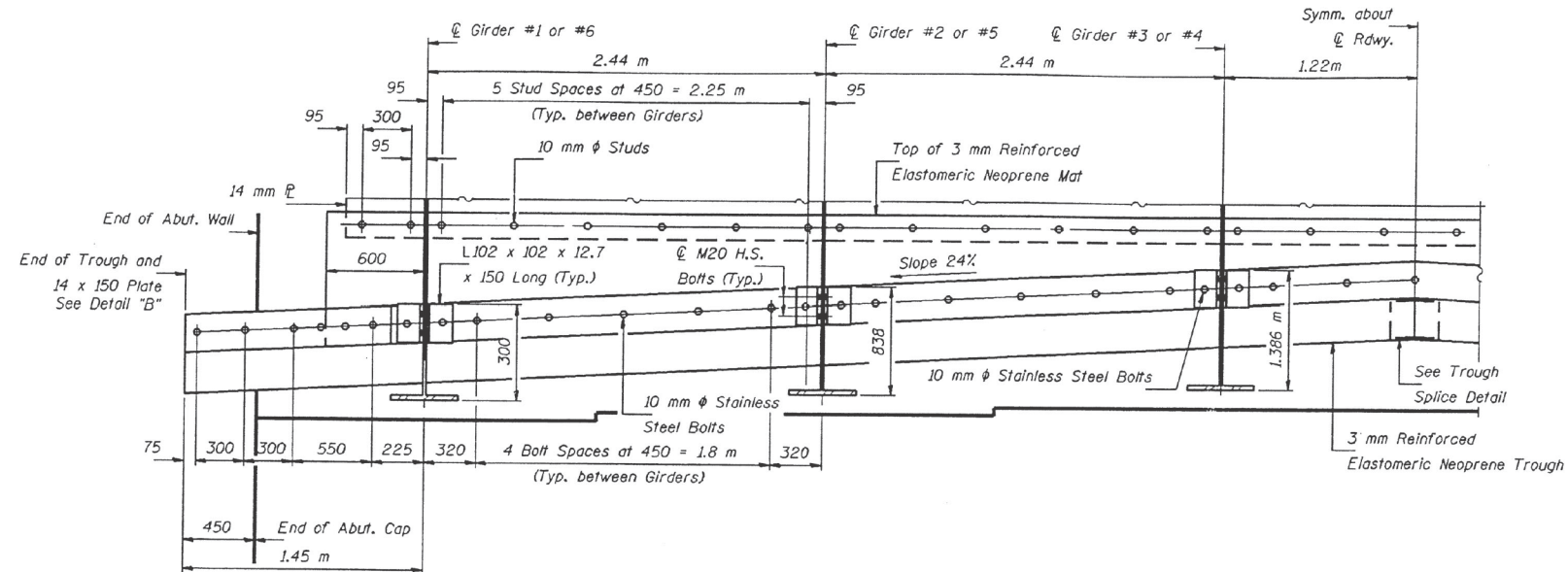

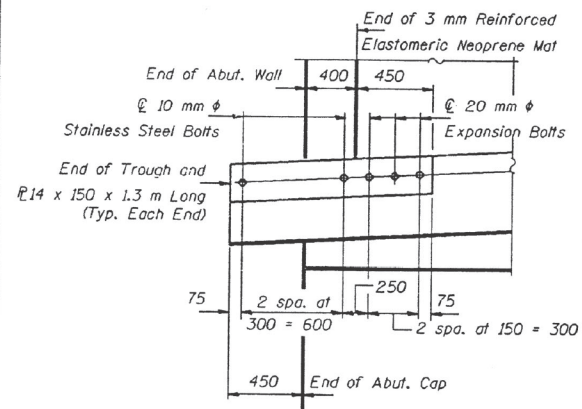

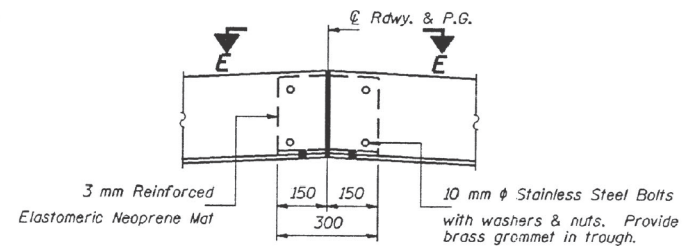


HALF ELEVATION - SHOWING TROUGH

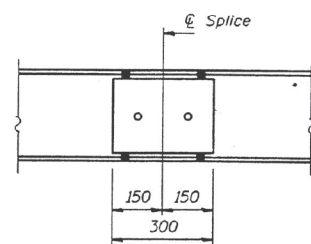

TROUGH SPLICE DETAIL

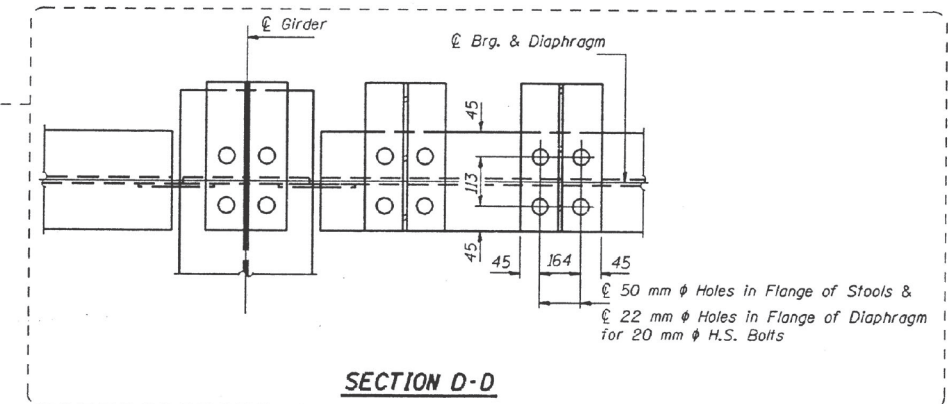

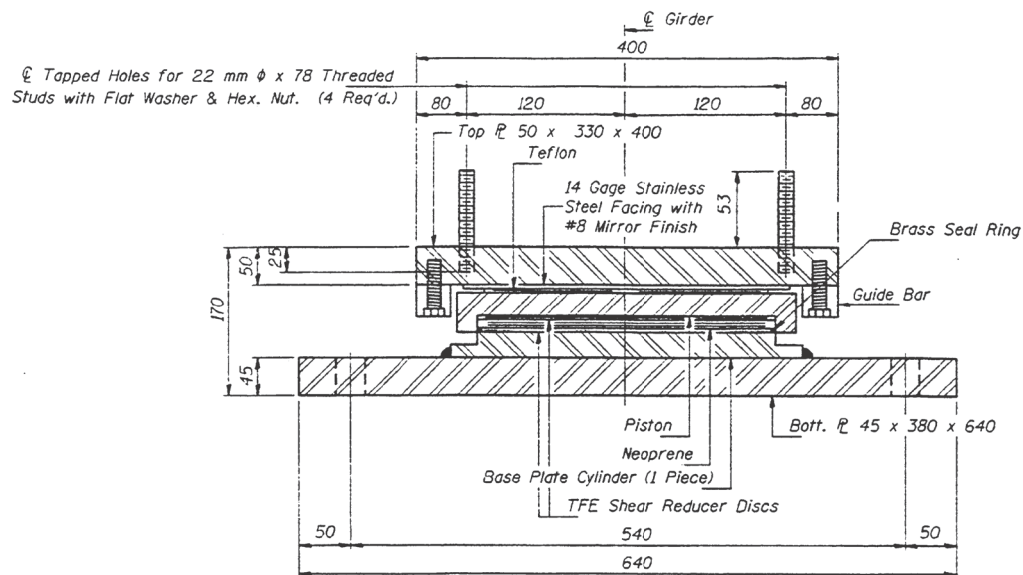

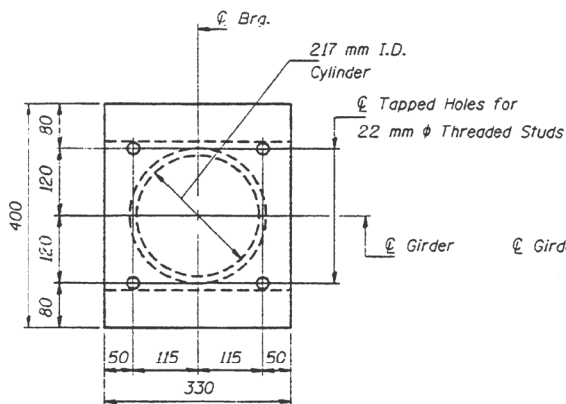
ELEVATION AT ABUTMENTS

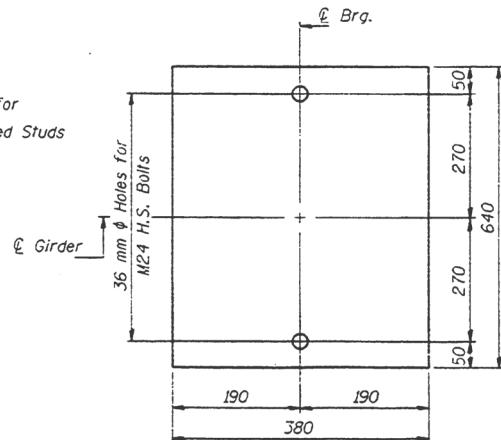

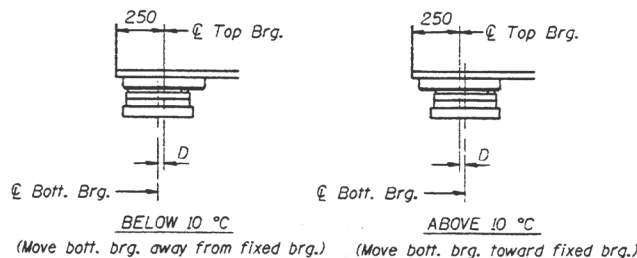
EXPANSION BEARING ASSEMBLY
