



IN THE EVENT AN UNEXPECTED UTILITY INTERFERENCE IS ENCOUNTERED DURING CONSTRUCTION, THE CONTRACTOR SHALL IMMEDIATELY NOTIFY THE UTILITY COMPANY OF JURISDICTION. THE OWNER'S REPRESENTATIVE AND/OR THE RESIDENT ENGINEER SHALL ALSO BE IMMEDIATELY NOTIFIED. ANY DAMAGE TO SUCH MAINS AND SERVICES SHALL BE RESTORED TO SERVICE AT ONCE AND PAID FOR BY THE CONTRACTOR AT NO ADDITIONAL COST TO THE CONTRACT.
- 5. THE RULES, REGULATIONS, AND SPECIFICATIONS ENUMERATED HEREIN SHALL BE CONSIDERED AS MINIMUM REQUIREMENTS. THEY SHALL NOT PROHIBIT THE CONTRACTOR FROM FURNISHING AND INSTALLING HIGHER GRADES OF MATERIAL THAN ARE SPECIFIED HEREIN.
- 4. THE CONTRACTOR SHALL COORDINATE HIS START OF WORK OPERATIONS IN ADVANCE WITH THE RESIDENT ENGINEER AND THE AIRPORT MANAGEMENT. THE AIRPORT MANAGEMENT SHALL NOTIFY THE IMPACTED PROPERTY OWNERS THAT TREE CLEARING AND GROUND SURFACE RESTORATION (SHAPING, SEEDING, MULCHING, ETC.) WILL BE ACCOMPLISHED WITHIN THE LIMITS OF THE AVIGATION EASEMENT THAT HAS BEEN GRANTED OVER THEIR PROPERTY.
- 5. THE CONTRACTOR SHALL FURNISH ALL LABOR, MATERIAL, EQUIPMENT, AND TRANSPORTATION NECESSARY TO CONSTRUCT ALL ELEMENTS OF THE PROJECT AS DESCRIBED IN THE CONSTRUCTION PLANS AND SPECIFICATIONS
- 6. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING PERMITS FOR HAULING ON PUBLIC ROADS, AS APPLICABLE. THE CONTRACTOR SHALL BE RESPONSIBLE FOR CORRECTING ANY DAMAGES TO ANY PAVEMENTS (PUBLIC OR PRIVATE) CAUSED BY HIS/HER CONSTRUCTION EQUIPMENT OR PERSONNEL.
- 7. IT SHALL BE THE RESPONSIBILITY OF THE CONTRACTOR TO PROTECT, PRESERVE AND REPAIR THE EXISTING TURF, LANDSCAPING, UTILITIES, DRAINAGE, PAVEMENTS AND ROADWAY PAVEMENTS AND STRUCTURES DISTURBED BY THE CONTRACTOR'S CONSTRUCTION OPERATIONS, STAGING AREA AND CONSTRUCTION ACCESS ROUTES AT ALL TIMES. THE CONTRACTOR SHALL RESTORE TO ORIGINAL CONDITION ANY DAMAGE TO TURF LANDSCAPING, UTILITIES, DRAINAGE, PAVEMENTS OR ROADWAY PAVEMENTS AND STRUCTURES AT NO ADDITIONAL COST TO THE CONTRACT.
- 8. ALL TURF AREAS OUTSIDE OF THE TREE REMOVAL LIMITS DISTURBED BY THE PROJECT SHALL BE RESTORED BY SMOOTH GRADING AND SEEDING AND MULCHING OR SODDING IN ACCORDANCE WITH THE SPECIFICATIONS. THIS WORK SHALL NOT BE MEASURED DIRECTLY, BUT SHALL BE INCLUDED IN THE COST OF OTHER PROJECT ITEMS AND NO ADDITIONAL COMPENSATION WILL BE ALLOWED.
- 9. ALL MULCH MUST BE SPREAD EVENLY OVER THE DIRECTED LOCATIONS.
- ALL TREES AND SPOIL MATERIAL RESULTING FROM THE CLEARING SITES SHALL BE DISPOSED OF OFF THE PROPERTY BY THE CONTRACTOR.
- 11. THE OWNER SHALL HAVE THE RIGHT OF FIRST REFUSAL FOR ALL SALVAGEABLE MATERIAL REMOVED ON THE PROJECT
- 12. BURNING OF THE SPOIL MATERIAL WILL NOT BE ALLOWED.
- 3. THE PROJECT PAY ITEMS ARE INTENDED TO BE INCLUSIVE OF ALL WORK TO BE PERFORMED AS SHOWN IN THESE PLANS. ALL INCIDENTAL WORK REQUIRED TO COMPLETE THE PROJECT TO THE SATISFACTION OF THE RESIDENT ENGINEER IS TO BE INCLUDED IN THE COSTS OF PERFORMING THESE ITEMS.
- 14. ALL COSTS ASSOCIATED WITH DISPOSING OF THE REMOVED TREES AND SPOIL MATERIAL SHALL BE INCLUDED IN THE RESPECTIVE PAY ITEM.
- 15. THE OWNER'S DESIGNATED REPRESENTATIVE SHALL OBSERVE THAT EACH TREE HAS BEEN SUFFICIENTLY REMOVED PRIOR TO APPROVAL FOR PAYMENT.
- 16. THE CLEARING OPERATIONS SHALL NOT IMPEDE OR OBSTRUCT ANY DRAINAGE IN THE AREA. ANY DISTURBANCE OF DRAINAGE PATHS RESULTING FROM THE CLEARING OPERATIONS SHALL BE RESTORED AT NO ADDITIONAL COST TO THE CONTRACT BY THE CONTRACTOR.
- 17. THE LOCATIONS AND LIMITS OF SEEDING OR SODDING WILL BE AS DIRECTED IN THE FIELD BY THE OWNER'S DESIGNATED REPRESENTATIVE
- 18. CONTRACTOR IS REQUIRED TO PROVIDE THEIR OWN RESTROOM FACILITIES.
- 19. QUANTITI

PAYMENT WILL BE MADE UNDER THE ITEM NUMBERS, DESCRIPTIONS AND UNITS NOTED IN THE SUMMARY OF QUANTITIES TABLE IN ACCORDANCE WITH THE BASIS OF PAYMENT FOR EACH RESPECTIVE WORK ITEM COMPLETED AND ACCEPTED BY THE ENGINEER.



SCOPE OF WORK

THE PROJECT SHALL CONSIST OF CLEARING AND TRIMMING TREES WITHIN THE APPROACH TO RUNWAY ENDS 14 AND 21. THE WORK SHALL REQUIRE THE TRIMMING OF TREES OF VARYING DIAMETER, CLEARING TREES, STUMP REMOVAL, DISPOSAL OF ALL TREES AND DEBRIS OFF THE SITE, SITE RESTORATION, PLANTING REPLACEMENT TREES AS SPECIFIED, AND INCIDENTAL WORK.

GENERAL NOTES

- THE SCOPE OF WORK SHEET IS INTENDED ONLY AS A GENERAL DESCRIPTION OF WORK ITEMS AND THEIR APPROXIMATE LOCATIONS AND LIMITS, FOR THE PURPOSE OF UNDERSTANDING THE SCOPE OF THE PROJECT. THIS SHEET SHALL NOT BE USED AS A CONSTRUCTION PLAN. REFER TO THE FOLLOWING PLAN SHEETS FOR DETAILED CONSTRUCTION REQUIREMENTS, LOCATIONS, AND ITEMS OF WORK.
- 2. ACCESS TO THE PROJECT FOR ALL HAULING OF MATERIALS AND EQUIPMENT SHALL BE RESTRICTED TO THE DESIGNATED SITE ACCESS. ACCESS TO THE WORK AREAS FROM THE EQUIPMENT AND MATERIAL STORAGE AREA SHALL BE COORDINATED WITH THE OWNER'S DESIGNATED REPRESENTATIVE.
- NO EQUIPMENT SHALL BE PERMITTED TO CROSS OR USE ANY EXISTING PAVEMENT OUTSIDE THE CONSTRUCTION LIMITS, GENERAL PROJECT AREA OR HAUL ROUTE.

SAFETY NOTES

- 1. ALL PROVISIONS OF THE LATEST EDITION OF FAA ADVISORY CIRCULAR AC 150/5370-2 (CURRENT EDITION), "OPERATIONAL SAFETY ON AIRPORTS DURING CONSTRUCTION", APPLY TO THIS CONTRACT, EXCEPT AS MODIFIED BY THESE CONSTRUCTION PLANS, OR AS MODIFIED BY THE OWNER THROUGH THE RESIDENT ENGINEER AT THE PRECONSTRUCTION CONFERENCE.
- CONTRACTOR EQUIPMENT, VEHICLES, AND PROJECT MATERIALS SHALL BE STORED AT THE EQUIPMENT AND MATERIAL STORAGE AREA SHOWN ON THE PLAN VIEW, EXCEPT AS OTHERWISE PROVIDED FOR AT THE PRECONSTRUCTION CONFERENCE.
- 3. THE MAXIMUM ANTICIPATED HEIGHT OF THE CONSTRUCTION EQUIPMENT WILL BE 60 FEET, WHICH IS EXPECTED TO BE A CRANE AND/OR A BUCKET TRUCK USED DURING TREE TRIMMING AND REMOVAL. THE CRANE OR BUCKET TRUCK SHALL BE USED DURING THE DAYLIGHT HOURS AND VFR CONDITIONS ONLY AND SHALL BE LOWERED WHEN NOT IN USE, DURING THE HOURS BETWEEN SUNSET AND SUNRISE, AND/OR DURING IFR WEATHER CONDITIONS.
- 4. ALL CRANES, BOOM TRUCKS, AND OTHER CONSTRUCTION EQUIPMENT OPERATING ON THE PROJECT IS REQUIRED TO DISPLAY A 3' SQUARE INTERNATIONAL ORANGE AND WHITE CHECKERBOARD FLAG PROPERLY LOCATED AND ROTATING BEACON/STROBE AS SPECIFIED IN AC 150/5210-5, "PAINTING, MARKING, AND LIGHTING OF VEHICLES USED ON AN AIRPORT" LATEST EDITION.
- 5. ALL CONTRACTOR PERSONNEL SHALL HAVE IDENTIFICATION MAKING IT OBVIOUS THEY ARE A MEMBER OF THE CONSTRUCTION CREW. THE CONTRACTOR, HIS EMPLOYEES AND EQUIPMENT SHALL BE RESTRICTED TO THE PROJECT WORK APERS
- OPEN TRENCHES, EXCAVATIONS, AND STOCKPILED MATERIALS AT THE CONSTRUCTION SITE SHOULD BE PROMINENTLY MARKED WITH ORANGE FLAGS AND LIGHTED WITH FLASHING RED LIGHTS DURING HOURS OF RESTRICTED VISIBILITY AND/OR DARKNESS.
- 7. CONTRACTOR SHALL MAINTAIN FLASHERS, SIGNS AND/OR BARRICADES AS REQUIRED BY THE PLANS, CITY OR COUNTY REGULATIONS OR CONTRACTOR ACTIVITIES. CONTRACTOR SHALL OBTAIN ANY AND ALL REQUIRED LOCAL PERMITS UNLESS SPECIFIED OTHERWISE.
- 8. THE CONTRACTOR SHALL UTILIZE WATER AND/OR CHEMICALS APPROVED BY THE RESIDENT ENGINEER AS NECESSARY TO CONTROL DUST.
- A NOTICE TO AIRMEN (NOTAM) WILL BE ISSUED TO INDICATE THAT MEN AND EQUIPMENT WILL BE WORKING IN THE APPROACH TO THE RESPECTIVE RUNWAY ENDS. IT IS THE RESPONSIBILITY OF THE AIRPORT DIRECTOR/MANAGER TO ISSUE ALL NOTAMS REQUIRED THROUGHOUT THE CONTRACT TIME.
- 10. UNLESS SPECIFIED OTHERWISE, COST FOR THE ABOVE IS TO BE CONSIDERED INCIDENTAL TO THE PROJECT. SEPARATE PAYMENT SHALL NOT BE MADE.





- TREES SHALL BE PLANTED IN ACCORDANCE WITH THE STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION, JANUARY 1, 2012, SECTION 253, PLANTING WOODY PLANTS.
- 2. TREES SHOWN TO BE REPLACED (MITIGATED) ON THE PLANS SHALL BE REPLACED WITH A TREE FROM THE LIST OF ACCEPTABLE MITIGATION TREES IN THE SPECIAL PROVISIONS.
- 3. TREES SUPPLIED TO THE PROJECT SHALL MEET THE FOLLOWING MINIMUM REQUIREMENTS. REFER TO THE SPECIAL PROVISIONS FOR ADDITIONAL INFORMATION
 - a. TREES SHALL HAVE A STRAIGHT TRUNK WITH SYMMETRICAL CROWN.
 - . TREES SHALL HAVE A SUBSTANTIAL, SINGLE, CENTRAL LEADER.
 - TREE BARK SHALL NOT BE DISCOLORED, SUNKEN, OR SWOLLEN, AND SHALL BE FREE OF CUTS, SCRAPES, OR OTHER DAMAGE.
 - I. TREES SHOWING GALLERIES, SUNSCALD, OR FROST DAMAGE WILL NOT BE ACCEPTED.
 - e. THE CALIPER OF THE TREE SHALL BE IN PROPORTION TO THE ROOTBALL.
 - TREES WITH GIRDLING ROOTS WRAPPING AROUND THE TRUNK OR OTHERWISE ROOTBOUND WILL NOT BE ACCEPTED.
 - g. TREE TRUNKS SHALL NOT BE MORE THAN 10% OFF CENTER.
 h. TREES SHALL BE FREE OF CROSSING BRANCHES AND BRANCHES
 - GROWING TOO CLOSE TO ONE ANOTHER.

 i. FRESHLY PRUNED TREES WILL NOT BE ACCEPTED.

4. AN APPROVED PRE-EMERGENT TREATMENT MAY BE USED PRIOR TO THE APPLICATION OF THE WEED BARRIER FABRIC BUT MAY NOT BE USED IN LIEU

TREE TRIMMING AND SHAPING

- TREE TRIMMING AND SHAPING SHALL BE COMPLETED BY AN ARBORIST CERTIFIED BY THE INTERNATIONAL SOCIETY OF ARBORICULTURE (ISA).
- 2. TRIMMING SHALL BE TO THE STATED ELEVATIONS AND SHALL RESULT IN A TREE UNIFORM IN APPEARANCE AND SHAPE. BOTH THE CONTRACTOR AND THE RESIDENT PROJECT REPRESENTATIVE (RPR) SHALL OBSERVE AND DOCUMENT THE BEGINNING AND END ELEVATIONS OF THE RESPECTIVE TREE BEING TRIMMED TO CONFIRM THE PROPOSED LIMITS ARE MET.
- 3. ALL DEBRIS AND LOOSE VEGETATION GENERATED FROM THE TRIMMING ACTIVITIES SHALL BE COLLECTED AND DISPOSED OF OFF-SITE BY THE CONTRACTOR. THE DISTURBED AREAS SHALL BE RAKED TO LEAVE THE PROPERTY IN A CONDITION COMPARABLE TO THAT WHICH EXISTED PRIOR TO THE START OF TRIMMING AND SHAPING OPERATIONS.
- 4. THE CONTRACTOR SHALL COORDINATE THE ACTIVITIES WITH BOTH THE HOMEOWNER AND THE RPR ON THE PROJECT, FOR THE AIRPORT.
- THE TRIMMING AND SHAPING SHALL BE COMPLETED IN ACCORDANCE WITH PAY ITEM AR151413, PER LUMP SUM.

CLEARING

- ALL TREE CLEARING SHALL BE IN ACCORDANCE WITH ITEM 151. ALL DEBRIS
 AND LOOSE VEGETATION SHALL BE COLLECTED AND DISPOSED OF OFFSITE
 BY THE CONTRACTOR.
- 2. CLEARING SHALL BE ACCOMPLISHED BETWEEN OCTOBER 1 AND MARCH 31.

STUMP REMOVAL

- ALL STUMPS REMAINING AFTER THE REMOVAL OF THE RESPECTIVE TREE SHALL BE REMOVED BY GRINDING ONLY. GRINDING SHALL CONTINUE TO A DEPTH OF 12" BELOW THE ADJACENT GRADE.
- ALL DEBRIS, MULCH, ETC. RESULTING FROM THE GRINDING SHALL BE REMOVED FROM THE VOID CREATED BY THE GRINDING. THE SPOIL MATERIAL SHALL BE COLLECTED AND REMOVED AND DISPOSED OF OFF-SITE BY THE CONTRACTOR.
- 3. THE VOID RESULTING FROM THE STUMP REMOVAL SHALL BE BACKFILLED USING TOPSOIL MEETING THE REQUIREMENTS OF ITEM 905, AND PLACED IN ACCORDANCE WITH THE SAME. THE MATERIAL SHALL BE FROM OFF-SITE. THE DISTURBED AREA SHALL BE SEEDED AND MULCHED IN ACCORDANCE WITH ITEM 901 AND 908, RESPECTIVELY.
- 4. IF THE STUMP REMOVAL IS REQUIRED IN AN AREA ADJACENT TO A PROPOSED TREE PLANTING, THE BACKFILL, GRADING, SEEDING AND MULCHING MAY BE ACCOMPLISHED AFTER THE INSTALLATION OF THE PROPOSED TREE. THERE SHALL BE NO ADDITIONAL COMPENSATION SHOULD AN AREA BE GRADED, SEEDED AND MULCHED PRIOR TO THE INSTALLATION OF A TREE THAT IS DISTURBED AND REQUIRED TO BE ADDITIONALLY ADDRESSED.
