CONT. STAGING OVERVIEW

STAGE IIA
 DURING THIS STAGE, TRAFFIC PATTERN ON THE EB I-94/90 IS THE SAME AS STAGE I. ON THE WB I-94/90, OPEN TRAFFIC LANES ARE SHIFTED TO THE INSIDE LANES WHILE JOINT REPAIR, SCARIFICATION AND OVERLAY IS DONE IN THE OUTSIDE LANES OF WB I-94/90. RAMPS CLOSED TO TRAFFIC UNDER THIS STAGE ARE: RAMP "B", ENTRANCE RAMP FROM 18TH ST TO WB I-94/90 AND EXIT RAMP FROM WB I-94/90 TO ROOSEVELT RD, WHILE JOINT REPAIR, SCARIFICATION AND OVERLAY IS DONE. SEE CORRESPONDING DETOUR SHEETS FOR CLOSED RAMPS. THE CROSSOVER NORTH OF 31ST BRIDGE CHANGES. RAMPS "D" AND "E" ARE OPEN TO TRAFFIC.

STAGE IIB
 DURING THIS STAGE, TRAFFIC PATTERN ON THE EB I-94/90 IS THE SAME AS STAGE I. TRAFFIC PATTERN ON THE WB I-94/90 IS THE SAME AS STAGE IIA. RAMPS CLOSED TO TRAFFIC EXIT RAMP FROM WB I-94/90 TO S CANALPORT AND ENTRANCE RAMP FROM 18TH ST TO WB I-94/90. RAMPS "D", "E" AND "B" ARE OPEN TO TRAFFIC.

FOR RAMP CLOSURE DATES DURING THE DIFFERENT MOT STAGES, SEE SPECIAL PROVISIONS. APPLICABLE SIGNS FOR RAMPS OPEN AND CLOSE TO TRAFFIC SHOULD BE ADJUSTED AS NEEDED.

THE COVERING OR REMOVAL OF SIGNS WILL NOT BE PAID FOR SEPARATELY, BUT PAID FOR UNDER THE CONTRACT LUMP SUM PRICE FOR 'TRAFFIC CONTROL AND PROTECTION (EXPRESSWAY)'
2. SIGNS: W2-1115(O), R2-1-3648, W4-1, W5-4, W4-2, G20-2a, R3-7R, W1-4L, W1-4R, W13-1, R2-1106-3618, W20-I(O)-48, W4-3L, W6-3(O)-48, W18-1100(O)-2430, R1-2 AND ALL OTHERS USED IN A HIGHWAY STANDARD AND IDOT DISTRICT ONE STANDARD WILL BE PAID FOR UNDER THE CONTRACT LUMP SUM PRICE FOR 'TRAFFIC CONTROL AND PROTECTION (EXPRESSWAY)'
3. SIGN PANELS THAT NEED TO BE REMOVE, STORE AND REINSTALL WILL BE PAID FOR AS 'REMOVE, STORE AND RE-ERECT SIGN PANEL'
