## I. SITE DESCRIPTION:

A. THE FOLLOWING IS A DESCRIPTION OF THE PROJECT LOCATION:

THE PROJECT CONSISTS OF THE PROPOSED IMPROVEMENTS OF 9.33 MILES OF I-55, SPECIFICALLY, I-55 FROM 0.5 MILES SOUTH OF FRUIT ROAD (ABANDONED RAILROAD) TO 1 MI NORTH OF IL ROUTE 4.

B. THE FOLLOWING IS A DESCRIPTION OF THE CONSTRUCTION ACTIVITY WHICH IS THE SUBJECT OF THIS PLAN:

CONSTRUCTION WILL INCLUDE THE PLACEMENT OF A HOT-MIX ASPHALT SHOULDER, HIGH TENSION CABLE MEDIAN BARRIER AND TERMINALS, AND SEEDING.

TAMALCO SILT LOAM (58182) - A MODERATELY WELL DRAINED SOIL WITH VERY SLOW PERMEABILITY. THIS SOIL DOES NOT FLOOD WITH 2-5% SLOPES. THIS SOIL HAS A MODERATE SUSCEPTIBLITY TO WATER EROSION AND A SLIGHT SUSCEPTIBILITY TO WIND EROSION.

HOMEN SILT LOAM (582B) - A MODERATELY WELL DRAINED SOIL WITH MODERATE PERMEABILITY. THIS SOIL DOES NOT FLOOD WITH 2-5% SLOPES. THIS SOIL HAS A MODERATE SUSCEPTIBILITY TO WATER EROSION AND A SLIGHT SUSCEPTBILITY TO WIND EROSION.

ORTHENTS LOAM (802D) - A MODERATELY WELL DRAINED SOIL WITH VARIOUS PERMEABILITY. THIS SOIL DOES NOT FLOOD WITH HILLY SLOPES, THIS SOIL HAS A HIGH SUSCEPTIBILITY TO WATER EROSION AND A HIGH SUSCEPTIBILITY TO WIND EROSION.

DOWNSOUTH SILT LOAM (283B) - A MODERATELY WELL DRAINED SOIL WITH MODERATE PERMEABILITY. THIS SOIL DOES NOT FLOOD WITH 2-5% SLOPES. THIS SOIL HAS A MODERATE SUSCEPTIBILITY TO WATER EROSION AND A SIGHT SUSCEPTIBILITY TO WIND FROSION.
