

Inform Sue Eckhoff (Railroad Coordinator) when this item has been revised.

Designer Notes: This special provision will be required in your contract if the construction work in any way is on, over, under, or abuts the railroad right-of-way of a short-line (minor) railroad. When a Class 1 railroad is involved use Railroad Protective Liability Insurance (5 and 10). All resurfacing projects that abut the railroad tracks will also require this special provision. A railroad agreement may be necessary and a minimum one (1) year lead time is required to develop and obtain approval. Class 1 railroads include the following:

Description. Railroad Protective Liability and Property Damage Liability Insurance shall be carried according to Article 107.11 of the Standard Specifications. A separate policy is required for each railroad unless otherwise noted.

The Contractor shall also provide the Engineer with the expiration date of each required policy.

Basis of Payment. Providing Railroad Protective Liability and Property Damage Liability Insurance will be paid for at the contract unit price per Lump Sum for RAILROAD PROTECTIVE LIABILITY INSURANCE.
