WEEKLY DBE TRUCKING REPORTS (BDE)

Effective: June 2, 2012 Revised: April 2, 2015

The Contractor shall submit a weekly report of Disadvantaged Business Enterprise (DBE) trucks hired by the Contractor or subcontractors (i.e. not owned by the Contractor or subcontractors) that are used for DBE goal credit.

The report shall be submitted to the Engineer on Department form "SBE 723" within ten business days following the reporting period. The reporting period shall be Monday through Sunday for each week reportable trucking activities occur.

Any costs associated with providing weekly DBE trucking reports shall be considered as included in the contract unit prices bid for the various items of work involved and no additional compensation will be allowed.

WORKING DAYS (BDE)

Effective: January 1, 2002

The Contractor shall complete the work within **140** working days.

INTERIM COMPLETION DATE FOR STRUCTURES OVER LYNCH RD.

To avoid traffic control conflicts with adjacent projects in Indiana during the 2021 construction season, an interim completion date is required for the structures over Lynch Rd. The Contractor shall complete all work shown in the plans and remove all traffic control & protection items including temporary traffic signals for Locations 3 & 4, S.N. 092-0025 & S.N. 092-0026 on or before **November 25, 2020**. If this work is not complete by the date specified, the Contractor shall be liable and shall pay to the Department the amount per calendar day shown in the table in Article 108.09, and based on the full awarded value of the contract, not as penalty but as liquidated damages, for each day of overrun beyond the date specified or such extended time as may have been allowed.
