- 1. Prevailing Wages. All wages paid by the Contractor and each subcontractor shall be in compliance with The Prevailing Wage Act (820 ILCS 130), as amended, except where a prevailing wage violates a federal law, order, or ruling, the rate conforming to the federal law, order, or ruling shall govern. The Contractor shall be responsible to notify each subcontractor of the wage rates set forth in this contract and any revisions thereto. If the Department of Labor revises the wage rates, the Contractor will not be allowed additional compensation on account of said revisions.
- 2. Payroll Records. The Contractor and each subcontractor shall make and keep, for a period of three years from the date of completion of this contract, records of the wages paid to his/her workers. The payroll records shall include each worker's name, address, telephone number, social security number, classification, rate of pay, number of hours worked each day, starting and ending times of work each day, total hours worked each week, itemized deductions made, and actual wages paid. Upon two business days' notice, these records shall be available, at all reasonable hours at a location within the State, for inspection by the Department or the Department of Labor.
- 3. Submission of Payroll Records. The Contractor and each subcontractor shall submit payroll records to the Engineer each week from the start to the completion of their respective work. The submittals shall be on the Department's form SBE 48, or an approved facsimile. When there has been no activity during a work week, a payroll record shall still be submitted with the appropriate box ("No Work", "Suspended", or "Complete") checked on the form.

Each submittal shall be accompanied by a statement signed by the Contractor or subcontractor which avers that: (i) such records are true and accurate; (ii) the hourly rate paid to each worker is not less than the general prevailing rate of hourly wages required by the Act; and (iii) the Contractor or subcontractor is aware that filing a payroll record that he/she knows to be false is a Class B misdemeanor.

4. Employee Interviews. The Contractor and each subcontractor shall permit his/her employees to be interviewed on the job, during working hours, by compliance investigators of the Department or the Department of Labor."

SPECIAL REQUIREMENTS FOR PLANTING BED AT LAFAYETTE AVENUE SOUTH OF 95TH ST.

The proposed location of the utility drop down pipe, near retaining wall #33, as shown on plan sheet #12, will be adjusted <u>prior</u> to construction by the Engineer, to clear and avoid conflict with the non-special waste area located along Lafayette Ave. between Sta. 1203+72 to Sta. 1204+82; 84 to 144 feet LT; 6 to 11.5 feet vertically. The Contractor must exercise caution not to disturb any soil below 6' while working in this area. The additional length and adjustments made to the irrigation system shall be included in the cost of the pay item IRRIGATION SYSTEM per SQ YD. Any adjustments made to the length of the utility drop down pipe will be paid for as: WATER SERVICE LINE, 2 1/2" per lineal foot.
