GENERAL NOTES

BEFORE STARTING ANY EXCAVATION IN THE CITY OF CHICAGO, THE CONTRACTOR SHALL CALL "C.U.A.N." AT (312) 744-7000 OR FOR FIELD LOCATIONS OF BURIED ELECTRIC, TELEPHONE AND GAS UTILITIES. 48 HOUR NOTIFICATION IS REQUIRED.

THE CONTRACTOR SHALL COORDINATE CONSTRUCTION ACTIVITIES WITH UTILITY COMPANIES AND THE CITY OF CHICAGO.

WHEN ARTIFICIAL LIGHTING IS UTILIZED IN NIGHT OPERATIONS, THE CONTRACTOR SHALL EXERCISE THE UTMOST PRECAUTIONS IN PREVENTING ADVERSE VISIBILITY TO THE MOTORING PUBLIC AND ADJOINING RESIDENTIAL AREAS.

IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO VERIFY ALL DIMENSIONS & CONDITIONS EXISTING IN THE FIELD PRIOR TO CONSTRUCTION & ORDERING OF MATERIALS.

THE CONTRACTOR WILL NOT BE ALLOWED TO SET UP A YARD OR FIELD OFFICE ON STATE PROPERTY WITHOUT WRITTEN PERMISSION FROM THE DEPARTMENT.

THE CONTRACTOR SHALL CONTACT THE DISTRICT ONE TRAFFIC CONTROL SUPERVISOR AT (847)705-4151 FOR EXPRESSWAYS A MINIMUM OF 72 HOURS IN ADVANCE OF BEGINNING WORK.

THE CONTRACTOR SHALL BE REQUIRED TO PROVIDE ACCESS TO ABUTTING PROPERTY AT ALL TIMES DURING THE CONSTRUCTION OF THIS PROJECT.

DO NOT SCALE PLANS FOR CONSTRUCTION DIMENSIONS.

IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO PROTECT AND PRESERVE THE EXISTING BRIDGE LIGHTING AT ANY LOCATIONS THAT LIGHTING IS ENCOUNTERED ADJACENT TO AN AREA TO BE CLEANED AND PAINTED.

THE CONTRACTOR SHALL BE RESPONSIBLE FOR THE NOTIFICATION OF ALL EMERGENCY SERVICES, SCHOOL DISTRICTS, I.D.O.T.'S COMMUNICATIONS CENTER, SPRINGFIELD TRUCK PERMIT SECTION AND OTHER AGENCIES AFFECTED BY THE CLOSURE. THE CONTRACTOR SHALL ALSO BE RESPONSIBLE FOR POSTING SIGNS THAT WILL INDICATE THE DATES THE CLOSURE WILL BE IN PLACE.

WORK ON THE STRUCTURE SHALL BE DONE IN SUCH A MANNER THAT THE CLOSURE OF THE BRIDGE TO RIVER TRAFFIC (PERIODS WHERE THE BRIDGE IS RESTRICTED IN THE DOWN POSITION) IS PROHIBITED. RIVER TRAFFIC IS TO BE MAINTAINED AT ALL TIMES. WORK THAT REQUIRES THE BRIDGE TO BE IMMOBILIZED SHALL BE DONE WITH THE BRIDGE RESTRICTED IN THE UP POSITION, SUBJECT TO COAST GUARD APPROVAL.

AFTER REMOVING THE ASBESTOS PANELS IF THE MACHINERY ROOM IS TO BE EXPOSED FOR MORE THAN ONE MONTH, THE CONTRACTOR SHALL INSTALL A TEMPORARY WALL AT NO ADDITIONAL COST TO THE DEPARTMENT.

THE CONTRACTOR SHALL PROTECT THE GEARS AND MACHINERY FROM DEBRIS, PAINT AND THE OUTSIDE ELEMENTS.

THE CONTRACTOR SHALL CONTACT DARYL ROUSE OF THE CITY OF CHICAGO AT (312)-617-0559 FOR ACCESS TO THE BRIDGE HOUSE.

THE CONTRACTOR SHALL OBTAIN COAST GUARD APPROVAL TO OCCUPY NAVIGABLE WATERS, IF REQUIRED, FOR THE PROPOSED WORK. A WORK PLAN SHALL BE PREPARED BY THE CONTRACTOR, REVIEWED AND APPROVED BY THE ENGINEER AND BE SUBMITTED BY THE ENGINEER TO THE COAST GUARD AT THE ADDRESS LISTED BELOW FOR APPROVAL.
