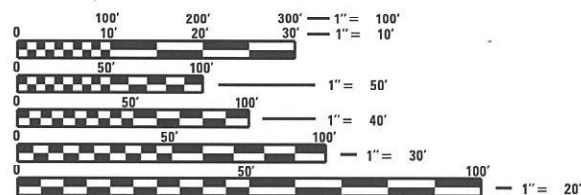
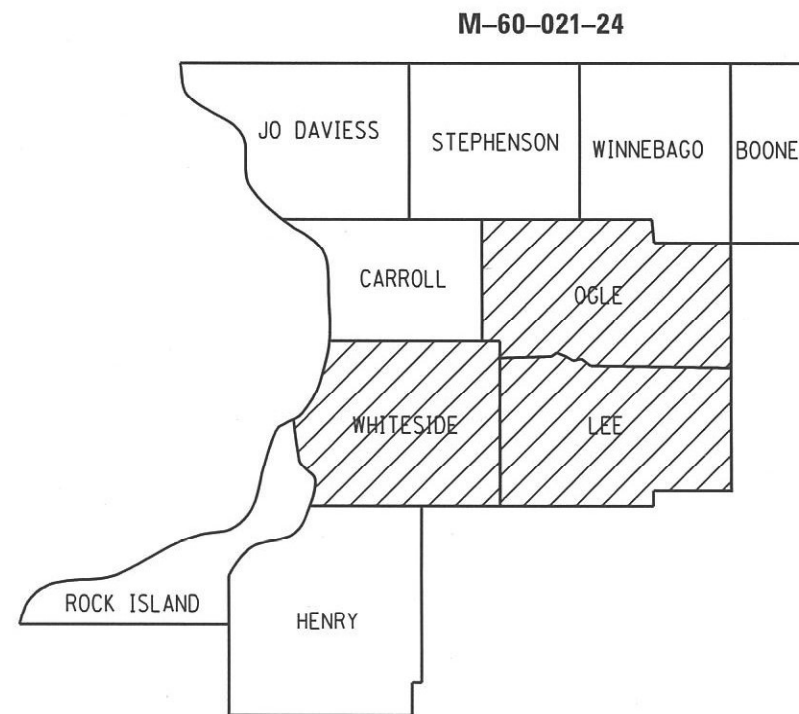
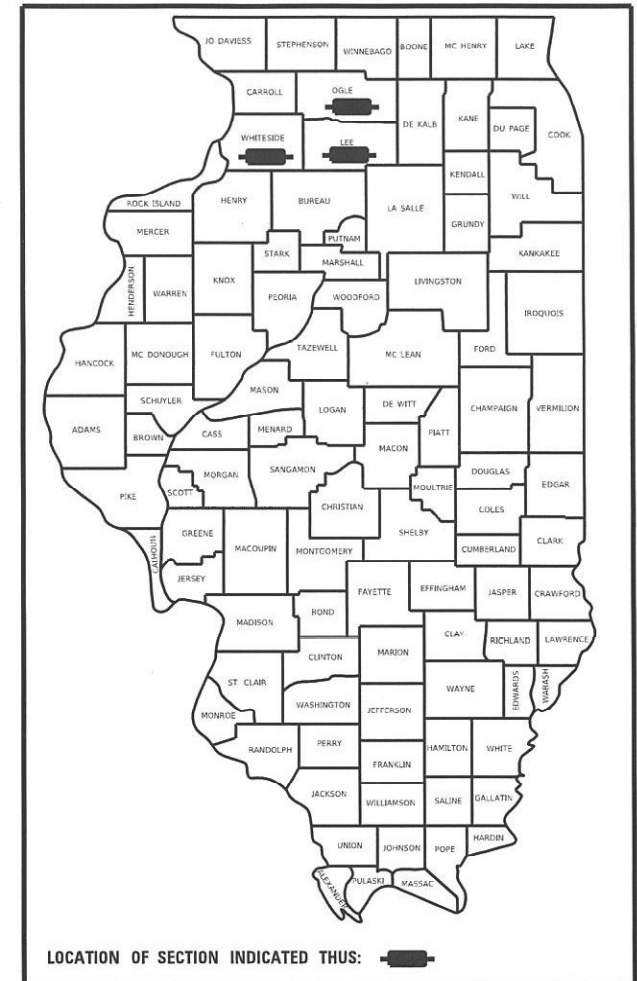

The Department may remove and not instal I markers in certain locations at the engineer's discretion.

The Department may instal I markers in certain locations that did not previously have markers at the engineer's discretion.

The locat ians of the repair areas sha II be determined by the engineer.

The work site shal I be left in a safe and orderly condition, filling any holes created by the end of the work day.

No material should be left on or near the roadway.
Remova I of damaged materia Is wiII include loading, hauling, and disposa I.

Any necessary traffic control wiII be provided by the contractor; appropriate standards are listed on Sheet No. 2.
Traff ic contro I shaII not be paid for as separate pay items, but shaII be considered a part of the contract .

The quantities specified in this contract are only an estimate to allow Contractors to establish unit prices and permit the Department to determine the low bidder. It shall be understood that the unit prices of this contract shall prevail throughout the contract regardless of the quantity.
