**BRIDGE APPROACH PAVEMENT (SPECIAL)**

Description. This work shall consist of constructing bridge approach pavements  $\frac{1}{4}$ " (6 mm) thicker than shown on Highway Standard 420401. The cover over the top layer of reinforcement shall be increased by  $\frac{1}{4}$ " (6 mm) to comply with the requirements of the special provision for **DIAMOND GRINDING AND SURFACE TESTING BRIDGE SECTIONS.**

Method of Measurement. Bridge Approach Pavement (Special) shall be measured in square yards (square meters). The length will be measured along the centerline of the surface of the approach pavement. The width will be the width of the pavement as shown on the plans. In computing the area for Bridge Approach Pavement (Special), a deduction will be made for the area displaced by the inlet.

Basis of Payment. Bridge Approach Pavement (Special) will be paid for at the contract unit price per square yard (square meter) for **BRIDGE APPROACH PAVEMENT (SPECIAL)**, and no other compensation shall be allowed.
