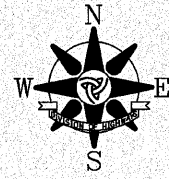


PART OF SECTION 24, T35N, R12E, OF THE 3RD PM, WILL COUNTY, ILLINOIS

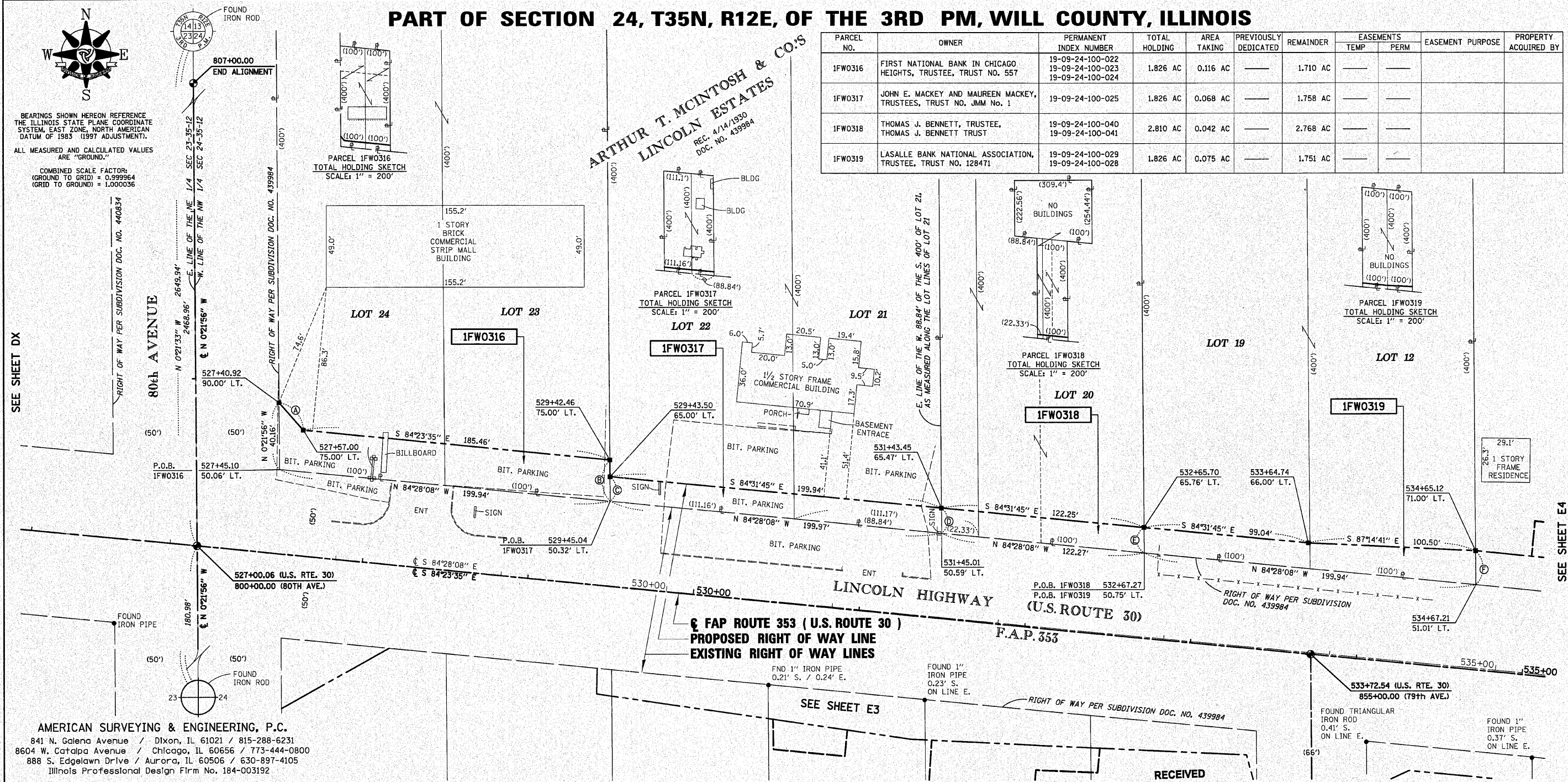

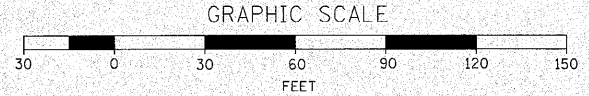
