### Special Provisions

**Basis of Payment:** This work will be paid for at the contract unit price per EACH for RECONSTRUCT ELECTRIC MANHOLE.

#### TOPSOIL

This work shall consist of placing topsoil. Topsoil shall be placed in accordance to Article 211.04 and 211.05. Topsoil shall be placed in all locations intended to establish ground cover. Topsoil shall be placed in areas of storm water detention, on top of embankment, in graded channels, between the sidewalk and back of curb, above the still water level in storm water retention basins, and in restored trench backfill that is outside of the proposed roadways. Topsoil shall not be placed in areas of proposed pavement and below the still water level in storm water retention basins. Topsoil shall be placed, a minimum of 4-inches thick or the thickness as indicated in the typical sections, in a settled but non-compacted state.

**Basis of Payment:** The placement of topsoil will be incidental to TOPSOIL EXCAVATION AND PLACEMENT.

#### CADD DATA

CADD data will be available to the awarded Contractor. This information will be provided upon request as MicroStation CADD files and GeoPak coordinate geometry files only. If data is required in other formats it will be your responsibility to make these conversions. If any discrepancy or inconsistency arises between the electronic data and the information on the hard copy, the information on the hard copy should be used. Contact the Local Agency to request these files.
