#### TREE AND BRUSH REMOVAL:

This work will include removal and offsite disposal of trees and brush that are located within the work area of the project. Removal and disposal will be considered incidental to EARTH EXCAVATION and no additional payment will be made. Final limits of tree and brush removal will be approved by the Engineer.

Clearing of all shrubs, brush, debris, etc. within the project limits between the existing and temporary right-of-way lines, which are not called out on the plans, shall be accomplished in accordance with Section 201 of the Standard Specifications.

Basis of Payment: Clearing shall not be measured for payment, but shall be considered incidental to the contract.

## SAW CUTTING PAVEMENT:

CH 19 shall be saw cut full depth at the ends of the improvements to provide a joint for the Hot-Mix Asphalt Pavement.

The work will not be paid for separately, but shall be considered as included in the contract unit price TON for HOT-MIX ASPHALT BINDER COURSE IL-19.0 N50" and no additional compensation will be allowed.

# BRIDGE SCUPPERS (9" X 9.5" GRATE):

The work will not be paid for separately, but shall be considered as included in the contract unit price CU. YD. for "CONCRETE BOX CULVERTS" and no additional compensation will be allowed.
