## WORKING RESTRICTIONS

IL Route 29 from the North end of the project to just North of Gail Street shall be milled and resurfaced under closure. The detour for this closure shall be as shown in the plans.

IL Route 29 shall be closed for one weekend, beginning at 6 p.m. on Friday night and opening at 6 am on Monday morning to allow for the milling and resurfacing of IL Route 29. The Contractor shall schedule their operations to have all lanes and shoulders of IL Route 29 open by 6 a.m. on Monday. Before the lanes are allowed to be reopened, the following work shall be completed: HMA surface removal, HMA binder course, HMA surface course, and short-term pavement marking.

Should the Contractor fail to have all lanes and shoulders of IL Route 29 open by 6 a.m. on **Monday**, or within such extended time allowed by the Department, the Contractor shall be subject to the provisions outlined in Article 108.09 of the Standard Specifications.

## RAILROAD PROTECTIVE LIABILITY INSURANCE (5 AND 10) (BDE)

Effective: January 1, 2006 Revised: August 1, 2019

<u>Description</u>. Railroad Protective Liability and Property Damage Liability Insurance shall be carried according to Article 107.11 of the Standard Specifications, except the limits shall be a minimum of \$5,000,000 combined single limit per occurrence for bodily injury liability and property damage liability with an aggregate limit of \$10,000,000 over the life of the policy. A separate policy is required for each railroad unless otherwise noted.
