The Contractor shall complete the work within 50 working days.

WORK RESTRICTION

The Contractor shall complete all contract items pertaining to patching, resurfacing and curb ramp construction east of Knight Avenue (Sta. 99+50) prior to beginning any work to the west. Resurfacing work shall be omitted from Sta. 107+03 to Sta. 107+80. This corresponds to the area of pavement replacement on concurrent IDOT project, Contract No. 62J27.
