JUSTIFCATION OF USE OF PROJECT LABOR AGREEMENT ON FAP RTE. 998 (RELOCATED I-70), CONTRACT NUMBER 76F39, ST. CLAIR COUNTY, WHICH INVOLVES THE LANDSCAPING OF THE INTERCHANGE OF RELOCATED I-70 AT RELOCATED IL 3. THIS INCLUDES APPROXIMATELY 120 TREES, 170 SHRUBS AND 76 ACRES OF SEEDING.

ITEM 2: This project is state funded.

**ITEM 3:** Estimated project cost is \$1,300,000. The project length is approximately 2.94 miles.

The overall scope of the project consists of:

- Seeding
- Landscape Plantings and Maintenance
- All incidental and collateral work necessary to complete the project as shown on the plans and special provisions.

This work must be coordinated with adjacent and overlapping active contracts and various contractors. Due to the ongoing work on other contracts, some areas may not be available for the landscaping work until that contract work is substantially completed. Scheduling of work on the various contacts cannot be determined in advance due to weather conditions, various other contractors' means and methods to complete their own work, and Standard Specification limitations on the weather/seasonal conditions under which certain plantings can be installed. This places the burden on the landscaping contractor to adapt their work to the work being done on adjacent contracts. The landscaping contractor must also schedule the plantings to ensure that they have a better chance of thriving, thereby reducing the number of replacement plantings required during the period of establishment.
