<u>Basis of Payment</u>. This work will be paid for at the contract unit price per foot for CONDUIT ATTACHED TO BRIDGE STRUCTURE, 4", FIBERGLASS REINFORCED EPOXY, SPECIAL, which shall include all material, labor, and equipment to complete this work. The PE inner ducts, and the two junction boxes at the Kishwaukee River bridge will not be paid for separately, but will be included in the cost of this item.

COMPLETION DATE

Effective November 21, 2006

The Contractor shall perform his work in such a manner that the project is completed on or prior to <u>November 19, 2007</u>. The project shall have all fiber optic installed before it is considered complete. If the Contractor fails to complete the project by the above completion date, the Contractor shall be charged liquidated damages by the Department of ONE THOUSAND TWO HUNDRED DOLLARS (\$1,200.00) a day for each day the project is not opened beyond the opening date. If in the event additional traffic control and protection is required to open the road or after the road is open to traffic, it shall be at no additional cost to the Department.

The Contractor will be allowed 15 working days, after the <u>November 19, 2007</u> completion date to complete landscaping.

- Page 60 Article 109.07(a). In the second line of the first paragraph change "amount" to "quantity".
