IDOT PROJECT LABOR AGREEMENT DETERMINATION

{Letting: March 10, 2023 Completion Date: October 31, 2024}

In accordance with the Project Labor Agreement Act (30 ILCS 571), it is recommended that a project labor agreement (PLA) be utilized for the above-captioned Project. This recommendation is based on the considerations indicated below.

- 1) The Project is being awarded and administered by IDOT (i.e., not by another governmental agency).
- 2) The Project is being constructed using state or local funds only (i.e., no federal funds).
- 3) The overall size, scope, sequencing, logistics or other aspects of the Project make it particularly challenging to manage, and use of a PLA is expected to help assure that the construction work is performed properly and efficiently under the circumstances. See attachment A below.
- 4) The duration of construction activity on the Project is expected to exceed one construction season (i.e., 110 or more working days), or the nature of the Project results in a heightened need for labor force continuity and stability over a substantial period of time.
- 5) There is a firm construction completion date established for the Project thereby increasing the adverse consequences of any work stoppage or other labor disruption. See attachment A below.
- 6) The time required to complete the Project is expected to extend beyond the expiration date of one or more existing collective bargaining agreements covering trades likely to be involved in the Project, thereby increasing the likelihood of work stoppage(s) or other labor disruption(s) during construction of the Project.
- 7) In the absence of a PLA, there is an increased likelihood of jurisdictional disputes among unions or of conflict between unionized and non-unionized workers on the Project that could have a potentially material adverse effect on the time, cost, or quality of work performed on the Project.

8) This project presents specific safety concerns to the traveling public and a PLA, will ensure labor force continuity and stability, decreasing the length of the safety concern.


9) Use of a PLA is expected to result in improved access to skilled labor, improved efficiency, or improved safety performance on the Project.


12) There are other material considerations favoring or disfavoring use of a PLA on this Project as follows:

The use of Project Labor Agreement (PLA) for Contract 60Y72 is consistent with all State and Local statutory and regulatory requirements.

Item 3: This project includes both State and Federal funding and the programmed cost for this project is estimated at \$36,023,000. The scope of work consists of reconstructing the roadway of Wood Street to a five-lane cross section from 161st Street to 143rd Street; and to a three-lane cross section from 143rd Street to Thornton Road; traffic signal modernization at the intersections of Wood St @ 158th St, 156th St, 155th St, 154th St, 150th St, and Thornton Road; drainage improvement; stormwater detention storage; construction of sidewalk and shared-use path; new roadway lighting; new signage; and aesthetic landscaping.


The project is located in the City of Harvey and Village of Dixmoor, Cook County, Illinois.
