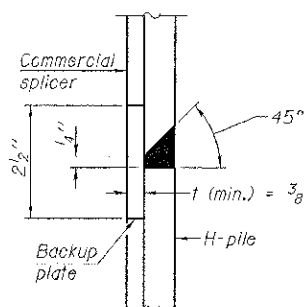


DETAIL A

H-PILE SHOE ATTACHMENT

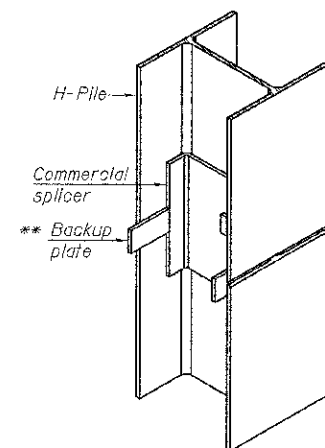

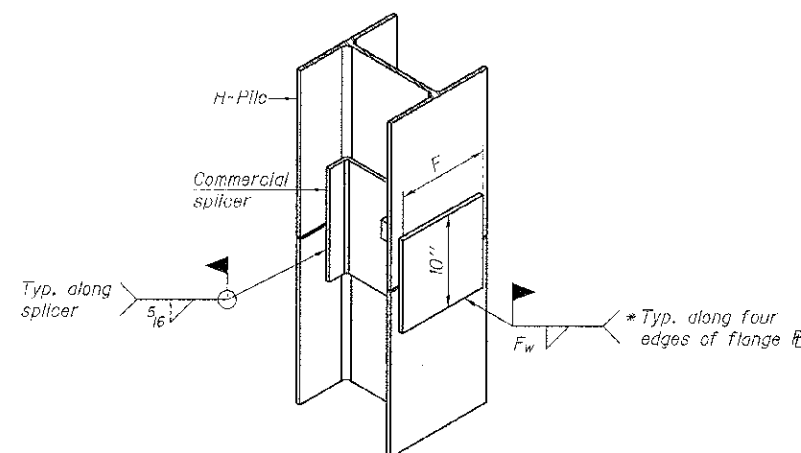


DETAIL "B"

WELDED COMMERCIAL SPLICE



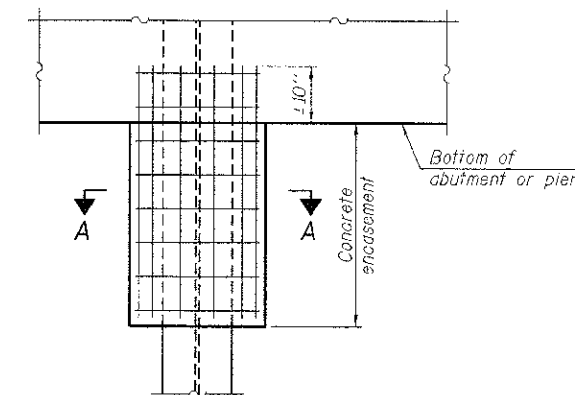
ISOMETRIC VIEW

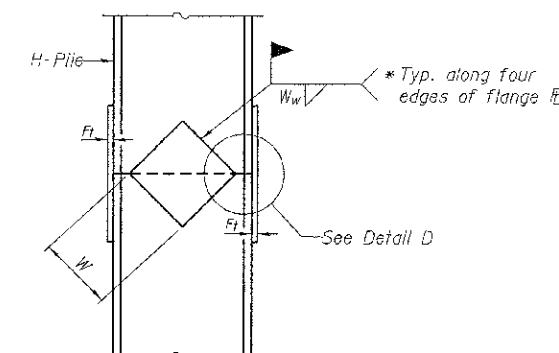
WELDED COMMERCIAL SPLICE ALTERNATE

- *** Weld size per pile shoe manufacturer (5/16" min.).

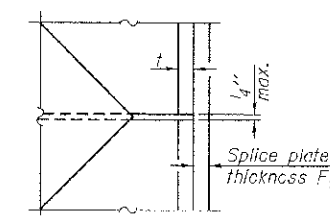


ELEVATION

PILE ENCASEMENT

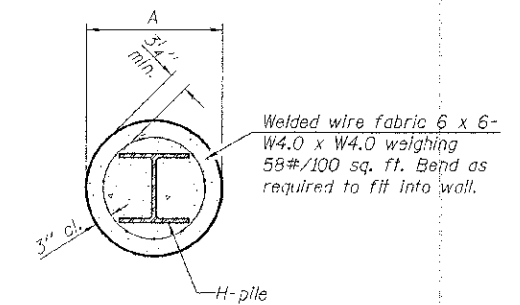

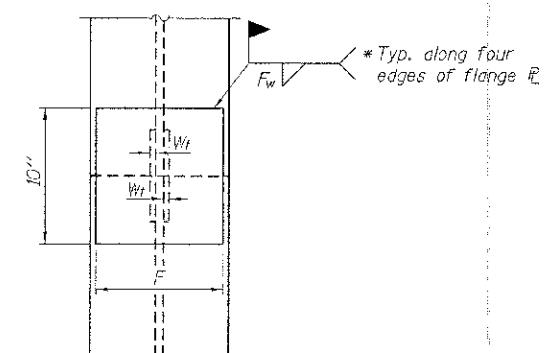
DETAIL D
