SPECIAL PROVISIONS

The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction," adopted April 1, 2016 the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways," and the "Manual of Test Procedures for Materials" in effect on the date of invitation for bids, and the Supplemental Specifications and Recurring Special Provisions indicated on the Check Sheet included herein which apply to and govern the construction of FAP Route 332 (IL 1), Project HSIP-0332(127), Section 2015-065I, Will County, Contract No. 62B44 and in case of conflict with any part or parts of said Specifications, the said Special Provisions shall take precedence and shall govern.

FAP Route 332 (IL 1) Project HSIP-0332(127) Section 2015-065I Will County Contract No. 62B44

LOCATION OF PROJECT

This improvement begins at a point on the centerline of IL Route 1 (FAP 332) approximately 2100 ft. north of County Line Road and extends in a northern direction for a distance of 31,000 feet (5.87 miles) to just south of Goodenow Road within the Village of Beecher and unincorporated Crete and Washington Townships in Will County. The net length of this improvement is 23,650 feet (4.48 miles).

DESCRIPTION OF PROJECT

This is a Highway Safety Improvement Program (HSIP) project and the work to be performed under this contract consists of paved shoulder removal, Hot-Mix Asphalt Shoulder Widening, milling shoulder and centerline rumble strips, grading and shaping of aggregate shoulder, placement of pavement markings and all incidental and collateral work necessary to complete the project as shown on the plans or described herein.

REMOVAL AND DISPOSAL OF REGULATED SUBSTANCES

This work shall be according to Article 669 of the Standard Specifications and the following:

<u>Qualifications</u>. The term environmental firm shall mean an environmental firm with at least five (5) documented leaking underground storage tank (LUST) cleanups or that is pre-qualified in hazardous waste by the Department. Documentation includes but not limited to verifying remediation and special waste operations for sites contaminated with gasoline, diesel, or waste oil in accordance with all Federal, State, or local regulatory requirements and shall be provided to the Engineer for approval. The environmental firm selected shall not be a former or current consultant or have any ties with any of the properties contained within and/or adjacent to this construction project.

<u>General.</u> This Special Provision will likely require the Contractor to subcontract for the execution of certain activities.

All contaminated materials shall be managed as either "uncontaminated soil" or non-special waste. <u>This work shall include monitoring and potential sampling, analytical testing, and management of a material contaminated by regulated substances.</u> The Environmental Firm shall continuously monitor all soil excavation for worker protection and soil contamination. **Phase I Preliminary Engineering information is available through the District's Environmental Studies Unit.** Soil samples or analysis without the approval of the Engineer will be at no additional cost to the Department. The lateral distance is measured from centerline and the farthest distance is the offset distance or construction limit whichever is less.
