**IDOT PROJECT LABOR AGREEMENT DETERMINATION**

In accordance with the Project Labor Agreement Act (30 ILCS 571), it is recommended that a project labor agreement (PLA) be utilized for the above-captioned Project. This recommendation is based on the considerations indicated below.

- 1) The Project is being awarded and administered by IDOT (i.e., not by another governmental agency).
- 2) The Project is being constructed using state or local funds only (i.e., no federal funds).
- 3) The overall size, scope, sequencing, logistics or other aspects of the Project make it particularly challenging to manage, and use of a PLA is expected to help assure that the construction work is performed properly and efficiently under the circumstances.
- 4) The duration of construction activity on the Project is expected to exceed one construction season (i.e., 110 or more working days), or the nature of the Project results in a heightened need for labor force continuity and stability over a substantial period of time.
- 5) There is a firm construction completion date established for the Project thereby increasing the adverse consequences of any work stoppage or other labor disruption.
- 6) The time required to complete the Project is expected to extend beyond the expiration date of one or more existing collective bargaining agreements covering trades likely to be involved in the Project, thereby increasing the likelihood of work stoppage(s) or other labor disruption(s) during construction of the Project.
- 7) In the absence of a PLA, there is an increased likelihood of jurisdictional disputes among unions or of conflict between unionized and non-unionized workers on the Project that could have a potentially material adverse effect on the time, cost, or quality of work performed on the Project.

9) Use of a PLA is expected to result in improved access to skilled labor, improved efficiency, or improved safety performance on the Project.


10) Use of a PLA on the Project is not expected to have a material adverse effect on the competitive bidding process.



12) There are other material considerations favoring or disfavoring use of a PLA on this Project as follows:



Justification for use of project Labor Agreement on Contract 70A89 Champaign County:

The use of a project Labor Agreement on this project is consistent with all State and Local statutory regulatory requirements.

**Project Description:** This project is for designed overlay of FAI 57 from two miles south of Thomasboro to US 136 at Rantoul in Champaign County. Other improvements associated with the project include milling, pavement patching, milled rumbles strips, guardrail removal and replacement, pavement marking, and raised reflective pavement markers.

**Item 3:** Estimated project cost is \$12,220,000. The use of a PLA will assure the project will be completed efficiently.

**Item 6:** Carpenters Local 243's contract expires 4/30/2022. Cement Masons Local 143's contract expires 04/30/2022. Teamsters Local 26's contract expires 04/30/2022.

**Item 8:** Any disruption to the contractor's schedule due to labor issues may result in an increase in duration of the project. This, in turn, would increase the length of time the traffic control on I-57 will be in place. The district desires to minimize the length of time traffic control is on I-57 to reduce the potential for crashes and improve safety.


