CONCRETE STEPS

<u>Description</u>. This work shall consist of constructing reinforced concrete steps as shown in the plans and shall be in accordance with Section 503 of the Standard Specifications.

Method of Measurement. This work will be measured for payment as follows:

Concrete steps will be measured for payment according to Article 503.21(a) or (b).

Protective coat will be measured for payment in place and the area computed in square yards.

Reinforcement bars and welded wire reinforcement will not be measured for payment.

<u>Basis of Payment.</u> This work will be paid for at the contract unit price per cubic yard for CONCRETE STEPS.

Protective coat will be paid for at the contract unit price per square yard for PROTECTIVE COAT.

CONCRETE STEP REMOVAL

<u>Description.</u> This work shall consist of removing the existing step in accordance with the applicable portions of Section 501 of the Standard Specifications and as specified herein. All concrete associated with the existing step shall be completely removed. The estimated volume of concrete to be removed is approximately less than one cubic yard.

<u>Method of Measurement.</u> Concrete Step Removal will be measured for payment in units of each removed.

<u>Basis of Payment.</u> The work will be paid for at the contract unit price per each for CONCRETE STEP REMOVAL.
