

## **INSTRUCTIONS**

**ABOUT IDOT PROPOSALS:** All proposals are potential bidding proposals. Each proposal contains all certifications and affidavits, a proposal signature sheet and a proposal bid bond.

### **PREQUALIFICATION**

Any contractor who desires to become pre-qualified to bid on work advertised by IDOT must submit the properly completed pre-qualification forms to the Bureau of Construction no later than 4:30 p.m. prevailing time twenty-one days prior to the letting of interest. This pre-qualification requirement applies to first time contractors, contractors renewing expired ratings, contractors maintaining continuous pre-qualification or contractors requesting revised ratings. To be eligible to bid, existing pre-qualification ratings must be effective through the date of the letting.

### **WHO CAN BID?**

Bids will be accepted from only those companies that request and receive written Authorization to Bid from IDOT's Central Bureau of Construction.

### **REQUESTS FOR AUTHORIZATION TO BID**

Contractors wanting to bid on items included in a particular letting must submit the properly completed "Request for Authorization to Bid/or Not For Bid Status" (BDE 124) and the ORIGINAL "Affidavit of Availability: (BC 57) to the proper office no later than 4:30 p.m. prevailing time, three (3) days prior to the letting date.

**WHAT CONSTITUTES WRITTEN AUTHORIZATION TO BID?:** When a prospective prime bidder submits a "Request for Authorization to Bid or Not for Bid Status" (BDE 124) he/she must indicate at that time which items are being requested For Bidding purposes. Only those items requested For Bidding will be analyzed. After the request has been analyzed, the bidder will be issued an **Authorization to Bid or Not for Bid Report**, approved by the Central Bureau of Construction and the Chief Procurement Officer that indicates which items have been approved For Bidding. If **Authorization to Bid** cannot be approved, the **Authorization to Bid or Not for Bid Report** will indicate the reason for denial.

**ABOUT AUTHORIZATION TO BID:** Firms that have not received an Authorization to Bid or Not For Bid Report within a reasonable time of complete and correct original document submittal should contact the department as to the status. Firms unsure as to authorization status should call the Prequalification Section of the Bureau of Construction at the number listed at the end of these instructions. These documents must be received three days before the letting date.

**ADDENDA AND REVISIONS:** It is the bidder's responsibility to determine which, if any, addenda or revisions pertain to any project they may be bidding. Failure to incorporate all relevant addenda or revisions may cause the bid to be declared unacceptable.

Each addendum or revision will be included with the Electronic Plans and Proposals. Addenda and revisions will also be placed on the Addendum/Revision Checklist and each subscription service subscriber will be notified by e-mail of each addendum and revision issued.

The Internet is the Department's primary way of doing business. The subscription server e-mails are an added courtesy the Department provides. It is suggested that bidders check IDOT's website at <http://www.dot.il.gov/desenv/delett.html> before submitting final bid information.

## **BID SUBMITTAL GUIDELINES AND CHECKLIST**

In an effort to eliminate confusion and standardize the bid submission process the Contracts Office has created the following guidelines and checklist for submitting bids.

This information has been compiled from questions received from contractors and from inconsistencies noted on submitted bids. If you have additional questions please refer to the contact information listed below.

**ABOUT SUBMITTING BIDS:** It is recommended that bidders deliver bid proposals in person to ensure they arrive at the proper location prior to the time specified for the receipt of bids. Any proposals received at the place of letting after the time specified will not be read.

### **STANDARD GUIDELINES FOR SUBMITTING BIDS**

- All pages should be single sided.
- Use the Cover Page that is provided in the Bid Proposal (posted on the IDOT Web Site) as the first page of your submitted bid. This page has the Item number in the upper left-hand corner and lines provided for your company name and address in the upper right-hand corner.
- Do not use report covers, presentation folders or special bindings and do not staple multiple times on left side like a book. Use only 1 staple in the upper left hand corner. Make sure all elements of your bid are stapled together including the bid bond or guaranty check (if required).
- Do not include any certificates of eligibility, your authorization to bid, Addendum Letters or affidavit of availability.
- Do not include the Subcontractor Documentation with your bid (pages 33-41). This documentation is required only after you are awarded the contract.
- Use the envelope cover sheet (provided with the proposal) as the cover for the proposal envelope.
- Do not rely on overnight services to deliver your proposal prior to 10 AM on letting day. It will not be read if it is delivered after 10 AM.
- Do not submit your Substance Abuse Prevention Program (SAPP) with your bid. If you are awarded the contract this form is to be submitted to the Division Construction Engineer at the pre-construction conference.

### **Use the following checklist to ensure completeness and the correct order in assembling your bid**

- Illinois Office Affidavit** (Not applicable to federally funded projects) Insert your affidavit after page 4 (if applicable).
- Cover page** (the sheet that has the item number on it) **followed by your bid (the Pay Items)**. If you are using special software or CBID to generate your schedule of prices, do not include the blank schedule of prices.
- Page 4 (Item 10)** - Check "YES" if you will use a subcontractor(s). Include the subcontractor(s) name, address, general type of work to be performed and the dollar amount (if over \$50,000). If you will use subcontractor(s) but are uncertain who or the dollar amount; check "YES" but leave the lines blank.
- Page 10 (Paragraph J)** - Check "YES" or "NO" whether your company has any business in Iran.
- Page 10 (Paragraph K)** – (Not applicable to federally funded projects) List the Union Local Name and number or certified training programs that you have in place. **Your bid will not be read if this is not completed.** Do not include certificates with your bid. Keep the certificates in your office in case they are requested by IDOT.
- Page 11 (Paragraph L)** - A copy of your State Board of Elections certificate of registration is no longer required with your bid.
- Page 11 (Paragraph M)** – Indicate if your company has hired a lobbyist in connection with the job for which you are submitting the bid proposal.
- Page 12 (Paragraph C)** - This is a work sheet to determine if a completed Form A is required. It is not part of the form and you do not need to make copies for each Form A that is filled out.

**Pages 14-17 (Form A)** - One Form A (4 pages) is required for each applicable person in your company. Copies of the Forms can be used and only need to be changed when the financial information changes. The certification signature and date must be original for each letting. Do not staple the forms together.

If you answered “NO” to all of the questions in Paragraph C (page 12), complete the first section (page 14) with your company information and then sign and date the Not Applicable statement on page 17.

**Page 18 (Form B)** - If you check “YES” to having other current or pending contracts it is acceptable to use the phrase, “See Affidavit of Availability on file”. **Ownership Certification** (at the bottom of the page) – Check N/A if the Form A you submitted accounts for 100 percent of the company ownership. Check YES if any percentage of ownership falls outside of the parameters that require reporting on the Form A. Checking NO indicates that the Form A you submitted is not correct and you will be required to submit a revised Form A.

**Pages 20-21 (Workforce Projection)** - Be sure to include the Duration of the Project. It is acceptable to use the phrase “Per Contract Specifications”.

**Bid Bond** - Submit your bid bond using the current Bid Bond Form provided in the proposal package. The Power of Attorney page should be stapled to the Bid Bond. If you are using an electronic bond, include your bid bond number on the form and attach the Proof of Insurance printed from the Surety 2000 Web Site.

**Disadvantaged Business Utilization Plan and/or Good Faith Effort** - The last item in your bid should be the DBE Utilization Plan (SBE 2026), followed by the DBE Participation Statement (SBE 2025) and supporting paperwork. If you have documentation for a Good Faith Effort, it should follow the SBE Forms.

**The Bid Letting is now available in streaming Audio/Video from the IDOT Web Site.** A link to the stream will be placed on the main page of the current letting on the day of the Letting. The stream will not begin until 10 AM. The actual reading of the bids does not begin until approximately 10:20 AM.

Following the Letting, the As-Read Tabulation of Bids will be posted by the end of the day. You will find the link on the main page of the current letting.

The undersigned bidder will furnish all labor, material and equipment to complete the above described project in a good workmanlike manner as provided in the contract documents provided by the Department of Transportation. This proposal will become part of the contract and the terms and conditions contained in the contract documents shall govern performance and payments.
3. **COMPLETION TIME/LIQUIDATED DAMAGES.** It being understood and agreed that the completion within the time limit is an essential part of the contract, the bidder agrees to complete the work within Base Bid: 89 calendar days; Additive Alternate 1: 13 additional calendar days; Additive Alternate 2: 17 additional calendar days, unless additional time is granted by the Engineer in accordance with the provisions of the specifications. In case of failure to complete the work on or before the time named herein, or within such extra time as may have been allowed by extensions, the bidder agrees that the Department of Transportation shall withhold from such sum as may be due him/her under the terms of this contract, the costs, as set forth below, which costs shall be considered and treated not as a penalty but as damages due to the State from the bidder by reason of the failure of the bidder to complete the work within the time specified in the contract.

### **STATE REQUIRED ETHICAL STANDARDS GOVERNING CONTRACT PROCUREMENT: ASSURANCES, CERTIFICATIONS AND DISCLOSURES**

#### **I. GENERAL**

**A.** Article 50 of the Code establishes the duty of all State CPOs, SPOs, and their designees to maximize the value of the expenditure of public moneys in procuring goods, services, and contracts for the State of Illinois and to act in a manner that maintains the integrity and public trust of State government. In discharging this duty, they are charged by law to use all available information, reasonable efforts, and reasonable actions to protect, safeguard, and maintain the procurement process of the State of Illinois.

**B.** In order to comply with the provisions of Article 50 and to carry out the duty established therein, all bidders are to adhere to ethical standards established for the procurement process, and to make such assurances, disclosures and certifications required by law. Except as otherwise required in subsection III, paragraphs J-M, by execution of the Proposal Signature Sheet, the bidder indicates that each of the mandated assurances has been read and understood, that each certification is made and understood, and that each disclosure requirement has been understood and completed.

**C.** In addition to all other remedies provided by law, failure to comply with any assurance, failure to make any disclosure or the making of a false certification shall be grounds for the CPO to void the contract, and may result in the suspension or debarment of the bidder or subcontractor. If a false certification is made by a subcontractor, the contractor's submitted bid and the executed contract may not be declared void unless the contractor refuses to terminate the subcontract upon the States' request after a finding that the subcontractor's certification was false.

#### **II. ASSURANCES**

The assurances hereinafter made by the bidder are each a material representation of fact upon which reliance is placed should the Department enter into the contract with the bidder.

##### **A. Conflicts of Interest**

1. The Code provides in pertinent part:

Section 50-13. Conflicts of Interest.

(a) Prohibition. It is unlawful for any person holding an elective office in this State, holding a seat in the General Assembly, or appointed to or employed in any of the offices or agencies of state government and who receives compensation for such employment in excess of 60% of the salary of the Governor of the State of Illinois, or who is an officer or employee of the Capital Development Board or the Illinois Toll Highway Authority, or who is the spouse or minor child of any such person to have or acquire any contract, or any direct pecuniary interest in any contract therein, whether for stationery, printing, paper, or any services, materials, or supplies, that will be wholly or partially satisfied by the payment of funds appropriated by the General Assembly of the State of Illinois or in any contract of the Capital Development Board or the Illinois Toll Highway Authority.

(b) Interests. It is unlawful for any firm, partnership, association or corporation, in which any person listed in subsection (a) is entitled to receive (i) more than 7 1/2% of the total distributable income or (ii) an amount in excess of the salary of the Governor, to have or acquire any such contract or direct pecuniary interest therein.

(c) Combined interests. It is unlawful for any firm, partnership, association, or corporation, in which any person listed in subsection (a) together with his or her spouse or minor children is entitled to receive (i) more than 15%, in the aggregate, of the total distributable income or (ii) an amount in excess of 2 times the salary of the Governor, to have or acquire any such contract or direct pecuniary interest therein.

(d) Securities. Nothing in this Section invalidates the provisions of any bond or other security previously offered or to be offered for sale or sold by or for the State of Illinois.

(e) Prior interests. This Section does not affect the validity of any contract made between the State and an officer or employee of the State or member of the General Assembly, his or her spouse, minor child or any combination of those persons if that contract was in existence before his or her election or employment as an officer, member, or employee. The contract is voidable, however, if it cannot be completed within 365 days after the officer, member, or employee takes office or is employed.

The current salary of the Governor is \$177,412.00. Sixty percent of the salary is \$106,447.20.

## RETURN WITH BID

2. The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-13, or that an effective exemption has been issued by the Board of Ethics to any individual subject to the Section 50-13 prohibitions pursuant to the provisions of Section 50-20 of the Code and Executive Order Number 3 (1998). Information concerning the exemption process is available from the Department upon request.

### **B. Negotiations**

1. The Code provides in pertinent part:

Section 50-15. Negotiations.

(a) It is unlawful for any person employed in or on a continual contractual relationship with any of the offices or agencies of State government to participate in contract negotiations on behalf of that office or agency with any firm, partnership, association, or corporation with whom that person has a contract for future employment or is negotiating concerning possible future employment.

2. The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-15, and that the bidder has no knowledge of any facts relevant to the kinds of acts prohibited therein.

### **C. Inducements**

1. The Code provides:

Section 50-25. Inducement. Any person who offers or pays any money or other valuable thing to any person to induce him or her not to bid for a State contract or as recompense for not having bid on a State contract is guilty of a Class 4 felony. Any person who accepts any money or other valuable thing for not bidding for a State contract or who withholds a bid in consideration of the promise for the payment of money or other valuable thing is guilty of a Class 4 felony.

2. The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-25, and that the bidder has no knowledge of any facts relevant to the kinds of acts prohibited therein.

### **D. Revolving Door Prohibition**

1. The Code provides:

Section 50-30. Revolving door prohibition. CPOs, SPOs, procurement compliance monitors, their designees whose principal duties are directly related to State procurement, and executive officers confirmed by the Senate are expressly prohibited for a period of 2 years after terminating an affected position from engaging in any procurement activity relating to the State agency most recently employing them in an affected position for a period of at least 6 months. The prohibition includes, but is not limited to: lobbying the procurement process; specifying; bidding; proposing bid, proposal, or contract documents; on their own behalf or on behalf of any firm, partnership, association, or corporation. This Section applies only to persons who terminate an affected position on or after January 15, 1999.

2. The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-30, and that the bidder has no knowledge of any facts relevant to the kinds of acts prohibited therein.

### **E. Reporting Anticompetitive Practices**

1. The Code provides:

Section 50-40. Reporting anticompetitive practices. When, for any reason, any vendor, bidder, contractor, CPO, SPO, designee, elected official, or State employee suspects collusion or other anticompetitive practice among any bidders, offers, contractors, proposers, or employees of the State, a notice of the relevant facts shall be transmitted to the Attorney General and the CPO.

2. The bidder assures the Department that it has not failed to report any relevant facts concerning the practices addressed in Section 50-40 which may involve the contract for which the bid is submitted.

### **F. Confidentiality**

1. The Code provides:

Section 50-45. Confidentiality. Any CPO, SPO, designee, or executive officer who willfully uses or allows the use of specifications, competitive bid documents, proprietary competitive information, proposals, contracts, or selection information to compromise the fairness or integrity of the procurement, bidding, or contract process shall be subject to immediate dismissal, regardless of the Personnel code, any contract, or any collective bargaining agreement, and may in addition be subject to criminal prosecution.

2. The bidder assures the Department that it has no knowledge of any fact relevant to the practices addressed in Section 50-45 which may involve the contract for which the bid is submitted.

## RETURN WITH BID

### **G. Insider Information**

1. The Code provides:

Section 50-50. Insider information. It is unlawful for any current or former elected or appointed State official or State employee to knowingly use confidential information available only by virtue of that office or employment for actual or anticipated gain for themselves or another person.

2. The bidder assures the Department that it has no knowledge of any facts relevant to the practices addressed in Section 50-50 which may involve the contract for which the bid is submitted.

### **III. CERTIFICATIONS**

The certifications hereinafter made by the bidder are each a material representation of fact upon which reliance is placed should the Department enter into the contract with the bidder. Section 50-2 of the Code provides that every person that has entered into a multi-year contract and every subcontractor with a multi-year subcontract shall certify, by July 1 of each fiscal year covered by the contract after the initial fiscal year, to the responsible CPO whether it continues to satisfy the requirements of Article 50 pertaining to the eligibility for a contract award. If a contractor or subcontractor is not able to truthfully certify that it continues to meet all requirements, it shall provide with its certification a detailed explanation of the circumstances leading to the change in certification status. A contractor or subcontractor that makes a false statement material to any given certification required under Article 50 is, in addition to any other penalties or consequences prescribed by law, subject to liability under the Whistleblower Reward and Protection Act for submission of a false claim.

#### **A. Bribery**

1. The Code provides:

Section 50-5. Bribery.

(a) Prohibition. No person or business shall be awarded a contract or subcontract under this Code who:

(1) has been convicted under the laws of Illinois or any other state of bribery or attempting to bribe an officer or employee of the State of Illinois or any other state in that officer's or employee's official capacity; or

(2) has made an admission of guilt of that conduct that is a matter of record but has not been prosecuted for that conduct.

(b) Businesses. No business shall be barred from contracting with any unit of State or local government, or subcontracting under such a contract, as a result of a conviction under this Section of any employee or agent of the business if the employee or agent is no longer employed by the business and:

(1) the business has been finally adjudicated not guilty; or

(2) the business demonstrates to the governmental entity with which it seeks to contract, or which is signatory to the contract which the subcontract relates, and that entity finds that the commission of the offense was not authorized, requested, commanded, or performed by a director, officer, or high managerial agent on behalf of the business as provided in paragraph (2) of subsection (a) of Section 5-4 of the Criminal Code of 1961.

(c) Conduct on behalf of business. For purposes of this Section, when an official, agent, or employee of a business committed the bribery or attempted bribery on behalf of the business and in accordance with the direction or authorization of a responsible official of the business, the business shall be chargeable with the conduct.

(d) Certification. Every bid submitted to and contract executed by the State, and every subcontract subject to Section 20-120 of the Code shall contain a certification by the contractor or the subcontractor, respectively, that the contractor or subcontractor is not barred from being awarded a contract or subcontract under this Section and acknowledges that the CPO may declare the related contract void if any certifications required by this Section are false. A contractor who makes a false statement, material to the certification, commits a Class 3 felony.

2. The contractor or subcontractor certifies that it is not barred from being awarded a contract under Section 50.5.

#### **B. Felons**

1. The Code provides:

Section 50-10. Felons. Unless otherwise provided, no person or business convicted of a felony shall do business with the State of Illinois or any State agency, or enter into a subcontract, from the date of conviction until 5 years after the date of completion of the sentence for that felony, unless no person held responsible by a prosecutorial office for the facts upon which the conviction was based continues to have any involvement with the business.

2. Certification. Every bid submitted to and contract executed by the State and every subcontract subject to Section 20-120 of the Code shall contain a certification by the bidder or contractor or subcontractor, respectively, that the bidder, contractor, or subcontractor is not barred from being awarded a contract or subcontract under this Section and acknowledges that the CPO may declare the related contract void if any of the certifications required by this Section are false.

## RETURN WITH BID

### **C. Debt Delinquency**

1. The Code provides:

Section 50-11 and 50-12. Debt Delinquency.

The contractor or bidder or subcontractor, respectively, certifies that it, or any affiliate, is not barred from being awarded a contract or subcontract under the Code. Section 50-11 prohibits a person from entering into a contract with a State agency, or entering into a subcontract, if it knows or should know that it, or any affiliate, is delinquent in the payment of any debt to the State as defined by the Debt Collection Board. Section 50-12 prohibits a person from entering into a contract with a State agency, or entering into a subcontract, if it, or any affiliate, has failed to collect and remit Illinois Use Tax on all sales of tangible personal property into the State of Illinois in accordance with the provisions of the Illinois Use Tax Act. The bidder or contractor or subcontractor, respectively, further acknowledges that the CPO may declare the related contract void if this certification is false or if the bidder, contractor, or subcontractor, or any affiliate, is determined to be delinquent in the payment of any debt to the State during the term of the contract.

### **D. Prohibited Bidders, Contractors and Subcontractors**

1. The Code provides:

Section 50-10.5 and 50-60(c). Prohibited bidders, contractors and subcontractors.

The bidder or contractor or subcontractor, respectively, certifies in accordance with 30 ILCS 500/50-10.5 that no officer, director, partner or other managerial agent of the contracting business has been convicted of a felony under the Sarbanes-Oxley Act of 2002 or a Class 3 or Class 2 felony under the Illinois Securities Law of 1953 or if in violation of Subsection (c) for a period of five years from the date of conviction. Every bid submitted to and contract executed by the State and every subcontract subject to Section 20-120 of the Code shall contain a certification by the bidder, contractor, or subcontractor, respectively, that the bidder, contractor, or subcontractor is not barred from being awarded a contract or subcontract under this Section and acknowledges that the CPO shall declare the related contract void if any of the certifications completed pursuant to this Section are false.

### **E. Section 42 of the Environmental Protection Act**

The bidder or contractor or subcontractor, respectively, certifies in accordance with 30 ILCS 500/50-14 that the bidder, contractor, or subcontractor, is not barred from being awarded a contract or entering into a subcontract under this Section which prohibits the bidding on or entering into contracts with the State of Illinois or a State agency, or entering into any subcontract, that is subject to the Code by a person or business found by a court or the Pollution Control Board to have committed a willful or knowing violation of Section 42 of the Environmental Protection Act for a period of five years from the date of the order. The bidder or contractor or subcontractor, respectively, acknowledges that the CPO may declare the contract void if this certification is false.

### **F. Educational Loan**

1. Section 3 of the Educational Loan Default Act provides:

§ 3. No State agency shall contract with an individual for goods or services if that individual is in default, as defined in Section 2 of this Act, on an educational loan. Any contract used by any State agency shall include a statement certifying that the individual is not in default on an educational loan as provided in this Section.

2. The bidder, if an individual as opposed to a corporation, partnership or other form of business organization, certifies that the bidder is not in default on an educational loan as provided in Section 3 of the Act.

### **G. Bid-Rigging/Bid Rotating**

1. Section 33E-11 of the Criminal Code of 1961 provides:

§ 33E-11. (a) Every bid submitted to and public contract executed pursuant to such bid by the State or a unit of local government shall contain a certification by the prime contractor that the prime contractor is not barred from contracting with any unit of State or local government as a result of a violation of either Section 33E-3 or 33E-4 of this Article. The State and units of local government shall provide the appropriate forms for such certification.

- (b) A contractor who makes a false statement, material to the certification, commits a Class 3 felony.

A violation of Section 33E-3 would be represented by a conviction of the crime of bid-rigging which, in addition to Class 3 felony sentencing, provides that any person convicted of this offense or any similar offense of any state or the United States which contains the same elements as this offense shall be barred for 5 years from the date of conviction from contracting with any unit of State or local government. No corporation shall be barred from contracting with any unit of State or local government as a result of a conviction under this Section of any employee or agent of such corporation if the employee so convicted is no longer employed by the corporation and: (1) it has been finally adjudicated not guilty or (2) if it demonstrates to the governmental entity with which it seeks to contract and that entity finds that the commission of the offense was neither authorized, requested, commanded, nor performed by a director, officer or a high managerial agent in behalf of the corporation.



## RETURN WITH BID

A violation of Section 33E-4 would be represented by a conviction of the crime of bid-rotating which, in addition to Class 2 felony sentencing, provides that any person convicted of this offense or any similar offense of any state or the United States which contains the same elements as this offense shall be permanently barred from contracting with any unit of State or local government. No corporation shall be barred from contracting with any unit of State or local government as a result of a conviction under this Section of any employee or agent of such corporation if the employee so convicted is no longer employed by the corporation and: (1) it has been finally adjudicated not guilty or (2) if it demonstrates to the governmental entity with which it seeks to contract and that entity finds that the commission of the offense was neither authorized, requested, commanded, nor performed by a director, officer or a high managerial agent in behalf of the corporation.

2. The bidder certifies that it is not barred from contracting with the Department by reason of a violation of either Section 33E-3 or Section 33E-4.

### **H. International Anti-Boycott**

1. Section 5 of the International Anti-Boycott Certification Act provides:

§ 5. State contracts. Every contract entered into by the State of Illinois for the manufacture, furnishing, or purchasing of supplies, material, or equipment or for the furnishing of work, labor, or services, in an amount exceeding the threshold for small purchases according to the purchasing laws of this State or \$10,000.00, whichever is less, shall contain certification, as a material condition of the contract, by which the contractor agrees that neither the contractor nor any substantially-owned affiliated company is participating or shall participate in an international boycott in violation of the provisions of the U.S. Export Administration Act of 1979 or the regulations of the U.S. Department of Commerce promulgated under that Act.

2. The bidder makes the certification set forth in Section 5 of the Act.

### **I. Drug Free Workplace**

1. The Illinois "Drug Free Workplace Act" applies to this contract and it is necessary to comply with the provisions of the "Act" if the contractor is a corporation, partnership, or other entity (including a sole proprietorship) which has 25 or more employees.

2. The bidder certifies that if awarded a contract in excess of \$5,000 it will provide a drug free workplace by:

(a) Publishing a statement notifying employees that the unlawful manufacture, distribution, dispensation, possession or use of a controlled substance, including cannabis, is prohibited in the contractor's workplace; specifying the actions that will be taken against employees for violations of such prohibition; and notifying the employee that, as a condition of employment on such contract, the employee shall abide by the terms of the statement, and notify the employer of any criminal drug statute conviction for a violation occurring in the workplace no later than five (5) days after such conviction.

(b) Establishing a drug free awareness program to inform employees about the dangers of drug abuse in the workplace; the contractor's policy of maintaining a drug free workplace; any available drug counseling, rehabilitation, and employee assistance programs; and the penalties that may be imposed upon employees for drug violations.

(c) Providing a copy of the statement required by subparagraph (1) to each employee engaged in the performance of the contract and to post the statement in a prominent place in the workplace.

(d) Notifying the Department within ten (10) days after receiving notice from an employee or otherwise receiving actual notice of the conviction of an employee for a violation of any criminal drug statute occurring in the workplace.

(e) Imposing or requiring, within 30 days after receiving notice from an employee of a conviction or actual notice of such a conviction, an appropriate personnel action, up to and including termination, or the satisfactory participation in a drug abuse assistance or rehabilitation program approved by a federal, state or local health, law enforcement or other appropriate agency.

(f) Assisting employees in selecting a course of action in the event drug counseling, treatment, and rehabilitation is required and indicating that a trained referral team is in place.

(g) Making a good faith effort to continue to maintain a drug free workplace through implementation of the actions and efforts stated in this certification.

**RETURN WITH BID**

**J. Disclosure of Business Operations in Iran**

Section 50-36 of the Code, 30ILCS 500/50-36 provides that each bid, offer, or proposal submitted for a State contract shall include a disclosure of whether or not the Company acting as the bidder, offeror, or proposing entity, or any of its corporate parents or subsidiaries, within the 24 months before submission of the bid, offer, or proposal had business operations that involved contracts with or provision of supplies or services to the Government of Iran, companies in which the Government of Iran has any direct or indirect equity share, consortiums or projects commissioned by the Government of Iran, or companies involved in consortiums or projects commissioned by the Government of Iran and either of the following conditions apply:

- (1) More than 10% of the Company's revenues produced in or assets located in Iran involve oil-related activities or mineral-extraction activities; less than 75% of the Company's revenues produced in or assets located in Iran involve contracts with or provision of oil-related or mineral-extraction products or services to the Government of Iran or a project or consortium created exclusively by that government; and the Company has failed to take substantial action.
- (2) The Company has, on or after August 5, 1996, made an investment of \$20 million or more, or any combination of investments of at least \$10 million each that in the aggregate equals or exceeds \$20 million in any 12-month period, which directly or significantly contributes to the enhancement of Iran's ability to develop petroleum resources of Iran.

The terms "Business operations", "Company", "Mineral-extraction activities", "Oil-related activities", "Petroleum resources", and "Substantial action" are all defined in the Code.

Failure to make the disclosure required by the Code shall cause the bid, offer or proposal to be considered not responsive. The disclosure will be considered when evaluating the bid, offer, or proposal or awarding the contract. The name of each Company disclosed as doing business or having done business in Iran will be provided to the State Comptroller.

**Check the appropriate statement:**

Company has no business operations in Iran to disclose.

Company has business operations in Iran as disclosed in the attached document.

**K. Apprenticeship and Training Certification (Does not apply to federal aid projects)**

In accordance with the provisions of Section 30-22 (6) of the Code, the bidder certifies that it is a participant, either as an individual or as part of a group program, in the approved apprenticeship and training programs applicable to each type of work or craft that the bidder will perform with its own forces. The bidder further certifies for work that will be performed by subcontract that each of its subcontractors submitted for approval either (a) is, at the time of such bid, participating in an approved, applicable apprenticeship and training program; or (b) will, prior to commencement of performance of work pursuant to this contract, begin participation in an approved apprenticeship and training program applicable to the work of the subcontract. The Department, at any time before or after award, may require the production of a copy of each applicable Certificate of Registration issued by the United States Department of Labor evidencing such participation by the contractor and any or all of its subcontractors. Applicable apprenticeship and training programs are those that have been approved and registered with the United States Department of Labor. The bidder shall list in the space below, the official name of the program sponsor holding the Certificate of Registration for all of the types of work or crafts in which the bidder is a participant and that will be performed with the bidder's forces. Types of work or craft work that will be subcontracted shall be included and listed as subcontracted work. The list shall also indicate any type of work or craft job category that does not have an applicable apprenticeship or training program. **The bidder is responsible for making a complete report and shall make certain that each type of work or craft job category that will be utilized on the project as reported on the Construction Employee Workforce Projection (Form BC-1256) and returned with the bid is accounted for and listed.**

The requirements of this certification and disclosure are a material part of the contract, and the contractor shall require this certification provision to be included in all approved subcontracts. In order to fulfill this requirement, it shall not be necessary that an applicable program sponsor be currently taking or that it will take applications for apprenticeship, training or employment during the performance of the work of this contract.

**RETURN WITH BID**

**L. Political Contributions and Registration with the State Board of Elections.**

Sections 20-160 and 50-37 of the Code regulate political contributions from business entities and any affiliated entities or affiliated persons bidding on or contracting with the state. Generally under Section 50-37, any business entity, and any affiliated entity or affiliated person of the business entity, whose current year contracts with all state agencies exceed an awarded value of \$50,000, are prohibited from making any contributions to any political committees established to promote the candidacy of the officeholder responsible for the awarding of the contracts or any other declared candidate for that office for the duration of the term of office of the incumbent officeholder or a period 2 years after the termination of the contract, whichever is longer. Any business entity and affiliated entities or affiliated persons whose state contracts in the current year do not exceed an awarded value of \$50,000, either alone or in combination with contracts not exceeding \$50,000, are prohibited from making any political contributions to any political committee established to promote the candidacy of the officeholder responsible for awarding the pending contract during the period beginning on the date the invitation for bids or request for proposals is issued and ending on the day after the date of award or selection if the entity was not awarded or selected. Section 20-160 requires certification of registration of affected business entities in accordance with procedures found in Section 9-35 of The Election Code

By submission of a bid, the contractor business entity acknowledges and agrees that it has read and understands Sections 20-160 and 50-37 of the Code, and that it makes the following certification:

**The undersigned business entity certifies that it has registered as a business with the State Board of Elections and acknowledges a continuing duty to update the registration in accordance with the above referenced statutes. If the business entity is required to register, the CPO shall verify that it is in compliance on the date the bid or proposal is due. The CPO shall not accept a bid or proposal if the business entity is not in compliance with the registration requirements.**

These requirements and compliance with the above referenced statutory sections are a material part of the contract, and any breach thereof shall be cause to void the contract under Section 50-60 of the Code. This provision does not apply to Federal-aid contracts.

**M. Lobbyist Disclosure**

Section 50-38 of the Code requires that any bidder or offeror on a State contract that hires a person required to register under the Lobbyist Registration Act to assist in obtaining a contract shall:

- (i) Disclose all costs, fees, compensation, reimbursements, and other remunerations paid or to be paid to the lobbyist related to the contract,
- (ii) Not bill or otherwise cause the State of Illinois to pay for any of the lobbyist's costs, fees, compensation, reimbursements, or other remuneration, and

### STATE ETHICAL STANDARDS GOVERNING SUBCONTRACTORS

Article 50 of the Code establishes the duty of all State CPOs, SPOs, and their designees to maximize the value of the expenditure of public moneys in procuring goods, services, and contracts for the State of Illinois and to act in a manner that maintains the integrity and public trust of State government. In discharging this duty, they are charged by law to use all available information, reasonable efforts, and reasonable actions to protect, safeguard, and maintain the procurement process of the State of Illinois.

#### **A. Bribery**

(a) Prohibition. No person or business shall be awarded a contract or subcontract under this Code who:

(1) has been convicted under the laws of Illinois or any other state of bribery or attempting to bribe an officer or employee of the State of Illinois or any other state in that officer's or employee's official capacity; or

(2) has made an admission of guilt of that conduct that is a matter of record but has not been prosecuted for that conduct.

(b) Businesses. No business shall be barred from contracting with any unit of State or local government, or subcontracting under such a contract, as a result of a conviction under this Section of any employee or agent of the business if the employee or agent is no longer employed by the business and:

(1) the business has been finally adjudicated not guilty; or

(2) the business demonstrates to the governmental entity with which it seeks to contract, or which is signatory to the contract to which the subcontract relates, and that entity finds that the commission of the offense was not authorized, requested, commanded, or performed by a director, officer, or high managerial agent on behalf of the business as provided in paragraph (2) of subsection (a) of Section 5-4 of the Criminal Code of 1961.

(c) Conduct on behalf of business. For purposes of this Section, when an official, agent, or employee of a business committed the bribery or attempted bribery on behalf of the business and in accordance with the direction or authorization of a responsible official of the business, the business shall be chargeable with the conduct.

(d) Certification. Every bid submitted to and contract executed by the State, and every subcontract subject to Section 20-120 of the Code shall contain a certification by the contractor or the subcontractor, respectively, that the contractor or subcontractor is not barred from being awarded a contract or subcontract under this Section and acknowledges that the CPO may declare the related contract void if any certifications required by this Section are false. A contractor who makes a false statement, material to the certification, commits a Class 3 felony.

2. The contractor or subcontractor certifies that it is not barred from being awarded a contract under Section 50.5.

#### **B. Felons**

1. The Code provides:

Section 50-10. Felons. Unless otherwise provided, no person or business convicted of a felony shall do business with the State of Illinois or any State agency, or enter into a subcontract, from the date of conviction until 5 years after the date of completion of the sentence for that felony, unless no person held responsible by a prosecutorial office for the facts upon which the conviction was based continues to have any involvement with the business.

2. Certification. Every bid submitted to and contract executed by the State and every subcontract subject to Section 20-120 of the Code shall contain a certification by the bidder or contractor or subcontractor, respectively, that the bidder, contractor, or subcontractor is not barred from being awarded a contract or subcontract under this Section and acknowledges that the CPO may declare the related contract void if any of the certifications required by this Section are false.

### **C. Debt Delinquency**

1. The Code provides:

Section 50-11 and 50-12. Debt Delinquency.

The contractor or bidder or subcontractor, respectively, certifies that it, or any affiliate, is not barred from being awarded a contract or subcontract under the Code. Section 50-11 prohibits a person from entering into a contract with a State agency, or entering into a subcontract, if it knows or should know that it, or any affiliate, is delinquent in the payment of any debt to the State as defined by the Debt Collection Board. Section 50-12 prohibits a person from entering into a contract with a State agency, or entering into a subcontract, if it, or any affiliate, has failed to collect and remit Illinois Use Tax on all sales of tangible personal property into the State of Illinois in accordance with the provisions of the Illinois Use Tax Act. Every bid submitted to and contract executed by the State and every subcontract subject to Section 20-120 of the Code shall contain a certification by the bidder, contractor, or subcontractor, respectively, that the bidder, contractor, or subcontractor is not barred from being awarded a contract or subcontract under this Section and acknowledges that the CPO shall declare the related contract void if any of the certifications completed pursuant to this Section are false.

### **E. Section 42 of the Environmental Protection Act**

CONTRACTS**

The work in this contract is included in the federal FAA Airport Improvement Program and is being undertaken and accomplished by the Illinois Department of Transportation, Division of Aeronautics and the Municipality, hereinafter called the Co-Sponsors, in accordance with the terms and conditions of a Grant Agreement between the Co-Sponsors and the United States, under the Airport and Airway Improvement Act of 1982 (Public Law 97-248; Title V, Section 501 et seq., September 3, 1982; 96 Stat. 671; codified at 49 U.S.C Section 2201 et seq.) and Part 152 of the Federal Aviation Regulations (14 CFR Part 152), pursuant to which the United States has agreed to pay a certain percentage of the costs of the Project that are determined to be allowable Project costs under the Act. The United States is not a party to this contract and no reference in this contract to FAA or representative thereof, or to any rights granted to the FAA or any representative thereof, or the United States, by the contract, makes the United States a party to this contract.

Consent of Assignment. The Contractor shall obtain the prior written consent of the Co-Sponsors to any proposed assignment of any interest in or part of this contract.

**Provisions for all Construction Contracts**

**BUY AMERICAN PREFERENCE (Title 49 U.S.C., Chapter 501)**

- (a) The Aviation Safety and Capacity Expansion Act of 1990 provides that preference be given to steel and manufactured products produced in the United States when funds are expended pursuant to a grant issued under the Airport Improvement Program (AIP).
- (b) Any and all steel products used in the performance of this contract by the Contractor, subcontractors, producers, and suppliers are required to adhere to the Illinois Steel Products Procurement Act, which requires that all steel items be of 100 percent domestic origin and manufacture. Any products listed under the Federal Aviation Administration's (FAA) nationwide approved list of "Equipment Meeting Buy American Requirements" shall be deemed as meeting the requirements of the Illinois Steel Products Procurement Act.
- (c) The successful bidder will be required to assure that only domestic steel and domestically manufactured products will be used by the Contractor, subcontractors, producers, and suppliers in the performance of this contract. The North American Free Trade Agreement (NAFTA) specifically excluded federal grant programs such as the AIP. Therefore, NAFTA does not change the requirement to comply with the Buy American requirement in the Act. Exceptions to this are for products, other than steel, that:
  - (1) the FAA has determined, under the Aviation Safety and Capacity Expansion Act of 1990, are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality;
  - (2) the FAA has determined, under the Aviation Safety and Capacity Expansion Act of 1990, that domestic preference would be inconsistent with the public interest;
  - (3) the FAA has determined that inclusion of domestic material will increase the cost of the overall project contract by more than 25 percent; or
  - (4) the FAA has determined, under the Aviation Safety and Capacity Expansion Act of 1990,
    - (i) the cost of components and subcomponents produced in the United States is more than 60 percent of the cost of all components of the facility or equipment, and
    - (ii) final assembly of the facility or equipment has occurred in the United States.

During the performance of this contract, the contractor, for itself, its assignees and successors in interest (hereinafter referred to as the "contractor") agrees as follows:

1.1 Compliance with Regulations. 1.4 Information and Reports. The contractor shall provide all information and reports required by the Regulations or directives issued pursuant thereto and shall permit access to its books, records, accounts, other sources of information, and its facilities as may be determined by the Co-Sponsors or the Federal Aviation Administration (FAA) to be pertinent to ascertain compliance with such Regulations, orders, and instructions. Where any information required of a contractor is in the exclusive possession of another who fails or refuses to furnish this information, the contractor shall so certify to the Co-Sponsors or the FAA, as appropriate, and shall set forth what efforts it has made to obtain the information.

1.5 Sanctions for Noncompliance. In the event of the contractor's noncompliance with the nondiscrimination provisions of this contract, the Co-Sponsor shall impose such contract sanctions as it or the FAA may determine to be appropriate, including, but not limited to:

- a. Withholding of payments to the contractor under the contract until the contractor complies, and/or
- b. Cancellation, termination, or suspension of the contract, in whole or in part.

1.6 Incorporation of Provisions. - a. is not owned or controlled by one or more citizens or nationals of a foreign country included in the list of countries that discriminate against U.S. firms published by the Office of the United States Trade Representative (USTR);
- b. has not knowingly entered into any contract or subcontract for this project with a Contractor that is a citizen or national of a foreign country on said list, or is owned or controlled directly or indirectly by one or more citizens or nationals of a foreign country on said list.

- c. has not procured any product nor subcontracted for the supply of any product for use on the project that is produced in a foreign country on said list.

Unless the restrictions of this clause are waived by the Secretary of Transportation in accordance with 49 CFR 30.17, no contract shall be awarded to a Contractor or subcontractor who is unable to certify to the above. If the Contractor knowingly procures or subcontracts for the supply of any product or service of a foreign country on the said list for use on the project, the Federal Aviation Administration may direct, through the Co-Sponsors, cancellation of the contract at no cost to the Government.

Further, the Contractor agrees that, if awarded a contract resulting from this solicitation, it will incorporate this provision for certification without modification in each contract and in all lower tier subcontracts. The Contractor may rely upon the certification of a prospective subcontractor unless it has knowledge that the certification is erroneous.

The Contractor shall provide immediate written notice to the Co-Sponsors if the Contractor learns that its certification or that of a subcontractor was erroneous when submitted or has become erroneous by reason of changed circumstances. The subcontractor agrees to provide immediate written notice to the Contractor, if at any time it learns that its certification was erroneous by reason of changed circumstances.

This certification is a material representation of fact upon which reliance was placed when making the award. If it is later determined that the Contractor or subcontractor knowingly rendered an erroneous certification, the Federal Aviation Administration may direct, through this Co-Sponsor, cancellation of the contract or subcontract for default at no cost to the Government.

Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render, in good faith, the certification required by this provision. The knowledge and information of a Contractor is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.

This certification concerns a matter within the jurisdiction of an agency of the United States of America and the making of false, fictitious, or fraudulent certification may render the maker subject to prosecution under Title 18, United States Code, Section 1001.

#### **VETERAN'S PREFERENCE (Title 49 U.S.C. 47112)**

In the employment of labor (except in executive, administrative, and supervisory positions), preference shall be given to Veterans of the Vietnam era and disabled veterans as defined in Section 515(c)(1) and (2) of the Airport and Airway Improvement Act of 1982. However, this preference shall apply only where the individuals are available and qualified to perform the work to which the employment relates.

#### **Additional Provisions for Construction Contracts Exceeding \$2,000**

##### **DAVIS BACON LABOR PROVISIONS (Title 29 Part 5)**

###### **(1) Minimum Wages.**

(i) All laborers and mechanics employed or working upon the site of the work will be paid unconditionally and not less often than once a week, and without subsequent deduction or rebate on any account (except such payroll deductions as are permitted by regulations issued by the Secretary of Labor under the Copeland Act (29 CFR Part 3)), the full amount of wages and bona fide fringe benefits (or cash equivalents thereof) due at time of payment computed at rates not less than those contained in the wage determination of the Secretary of Labor.

Contributions made or costs reasonably anticipated for bona fide fringe benefits under section 1(b)(2) of the Davis-Bacon Act on behalf of laborers or mechanics are considered wages paid to such laborers or mechanics, subject to the provision of paragraph (a)(1)(iv) of this section; also, regular contributions made or costs incurred for more than a weekly period (but not less often than quarterly) under plans, funds, or programs which cover the particular weekly period, are deemed to be constructively made or incurred during such weekly period. Such laborers and mechanics shall be paid the appropriate wage rate and fringe benefits on the wage determination for the classification of work actually performed, without regard to skill, except as provided in paragraph 5.5(a)(4). Laborers or mechanics performing work in more than one classification may be compensated at the rate specified for each classification for the time actually worked therein: *Provided*, That the employer's payroll records accurately set forth the time spent in each classification in which work is performed. The wage determination (including any additional classification and wage rates conformed under paragraph (a)(1)(ii) of this section) and the Davis-Bacon poster (WH-1321) shall be posted at all times by the Contractor and its subcontractors at the site of the work in a prominent and accessible place where it can be easily seen by the workers.

(ii)(A) The contracting officer shall require that any class of laborers or mechanics which is not listed in the wage determination and which is to be employed under the contract shall be classified in conformance with the wage determination. The contracting officer shall approve an additional classification and wage rate and fringe benefits therefore only when the following criteria have been met:

- (1)The work to be performed by the classification requested is not performed by a classification in the wage determination;
- and

(2) The classification is utilized in the area by the construction industry; and

(3) The proposed wage rate, including any bona fide fringe benefits, bears a reasonable relationship to the wage rates contained in the wage determination.

(B) If the Contractor and the laborers and mechanics to be employed in the classification (if known), or their representatives, and the contracting officer agree on the classification and wage rate (including the amount designated for fringe benefits where appropriate), a report of the action taken shall be sent by the contracting officer to the Administrator of the Wage and Hour Division, Employment Standards Administration, U.S. Department of Labor, Washington, D.C. 20210. The Administrator, or an authorized representative, will approve, modify, or disapprove every additional classification action within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30-day period that additional time is necessary.

(C) In the event the Contractor, the laborers or mechanics to be employed in the classification or their representatives, and the contracting officer do not agree on the proposed classification and wage rate (including the amount designated for fringe benefits, where appropriate), the contracting officer shall refer the questions, including the views of all interested parties and the recommendation of the contracting officer, to the Administrator for determination. The Administrator, or an authorized representative, will issue a determination within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30-day period that additional time is necessary.

(D) The wage rate (including fringe benefits where appropriate) determined pursuant to subparagraphs (1)(ii) (B) or (C) of this paragraph, shall be paid to all workers performing work in the classification under this contract from the first day on which work is performed in the classification.

(iii) Whenever the minimum wage rate prescribed in the contract for a class of laborers or mechanics includes a fringe benefit which is not expressed as an hourly rate, the Contractor shall either pay the benefit as stated in the wage determination or shall pay another bona fide fringe benefit or an hourly cash equivalent thereof.

(iv) If the Contractor does not make payments to a trustee or other third person, the Contractor may consider as part of the wages of any laborer or mechanic the amount of any costs reasonably anticipated in providing bona fide fringe benefits under a plan or program, *Provided*, That the Secretary of Labor has found, upon the written request of the Contractor, that the applicable standards of the Davis-Bacon Act have been met. The Secretary of Labor may require the Contractor to set aside in a separate account assets for the meeting of obligations under the plan or program.

(2) Withholding.

The Federal Aviation Administration shall upon its own action or written request of an authorized representative of the Department of Labor withhold or cause to be withheld from the Contractor under this contract or any other Federal contract with the same prime Contractor, or any other Federally-assisted contract subject to Davis-Bacon prevailing wage requirements, which is held by the same prime Contractor, so much of the accrued payments or advances as may be considered necessary to pay laborers and mechanics, including apprentices, trainees, and helpers, employed by the Contractor or any subcontractor the full amount of wages required by the contract. In the event of failure to pay any laborer or mechanic, including any apprentice, trainee, or helper, employed or working on the site of the work, all or part of the wages required by the contract, the (Agency) may, after written notice to the Contractor, sponsor, applicant, or owner, take such action as may be necessary to cause the suspension of any further payment, advance, or guarantee of funds until such violations have ceased.

(3) Payrolls and basic records.

(i) Payrolls and basic records relating thereto shall be maintained by the Contractor during the course of the work and preserved for a period of three years thereafter for all laborers and mechanics working at the site of the work. Such records shall contain the name, address, and social security number of each such work, his or her correct classification, hourly rates of wages paid (including rates of contributions or costs anticipated for bona fide fringe benefits or cash equivalents thereof of the types described in section 1(b)(2)(B) of the Davis-Bacon Act), daily and weekly number of hours worked, deductions made and actual wages paid. Whenever the Secretary of Labor has found under 29 CFR 5.5(a)(1)(iv) that the wages of any laborer or mechanic include the amount of any costs reasonably anticipated in providing benefits under a plan or program described in section 1(b)(2)(B) of the Davis-Bacon Act, the Contractor shall maintain records which show that the commitment to provide such benefits is enforceable, that the plan or program is financially responsible, and that the plan or program has been communicated in writing to the laborers or mechanics affected, and records which show the costs anticipated or the actual cost incurred in providing such benefits. Contractors employing apprentices or trainees under approved programs shall maintain written evidence of the registration of apprenticeship programs and certification of trainee programs, the registration of the apprentices and trainees, and the ratios and wage rates prescribed in the applicable programs.

(ii)(A) The Contractor shall submit weekly for each week in which any contract work is performed a copy of all payrolls to the Federal Aviation Administration if the agency is a party to the contract, but if the agency is not such a party, the Contractor will submit the payrolls to the applicant, sponsor, or owner, as the case may be, for transmission to the Federal Aviation Administration. The payrolls submitted shall set out accurately and completely all of the information required to be maintained under paragraph 5.5(a)(3)(i) of Regulations, 29 CFR Part 5. This information may be submitted in any form desired. Optional Form WH-347 is available for this purpose and may be purchased from the Superintendent of Documents (Federal Stock Number 029-005-00014-

1), U.S. Government Printing Office, Washington, D.C. 20402. The prime Contractor is responsible for the submission of copies of payrolls by all subcontractors.

(B) Each payroll submitted shall be accompanied by a "Statement of Compliance," signed by the Contractor, or subcontractor or his or her agent who pays or supervises the payment of the persons employed under the contract and shall certify the following:

(1) That the payroll for the payroll period contains the information required to be maintained under paragraph (3)(i) above and that such information is correct and complete;

(2) That each laborer or mechanic (including each helper, apprentice, and trainee) employed on the contract during the payroll period has been paid the full weekly wages earned, without rebate, either directly or indirectly, and that no deductions have been made either directly or indirectly from the full wages earned, other than permissible deductions as set forth in Regulations, 29 CFR Part 3;

(3) That each laborer or mechanic has been paid not less than the applicable wage rates and fringe benefits or cash equivalents for the classification of work performed as specified in the applicable wage determination incorporated into the contract.

(C) The weekly submission of a properly executed certification set forth on the reverse side of Optional Form WH-347 shall satisfy the requirement for submission of the "Statement of Compliance" required by paragraph (3)(ii)(B) of this section.

(D) The falsification of any of the above certifications may subject the Contractor or subcontractor to civil or criminal prosecution under Section 1001 of Title 18 and Section 231 of Title 31 of the United States Code.

(iii) The Contractor or subcontractor shall make the records required under paragraph (3)(i) of this section available for inspection, copying, or transcription by authorized representatives of the (write the name of the agency) or the Department of Labor, and shall permit such representatives to interview employees during working hours on the job. If the Contractor or subcontractor fails to submit the required records or to make them available, the Federal agency may, after written notice to the Contractor, sponsor, applicant, or owner, take such action as may be necessary to cause the suspension of any further payment, advance, or guarantee of funds. Furthermore, failure to submit the required records upon request or to make such records available may be grounds for debarment action pursuant to 29 CFR 5.12.

#### (4) Apprentices and Trainees

(i) Apprentices. Apprentices will be permitted to work at less than the predetermined rate for the work they performed when they are employed pursuant to and individually registered in a bona fide apprenticeship program registered with the U.S. Department of Labor, Employment and Training Administration, Bureau of Apprenticeship and Training, or with a State Apprenticeship Agency recognized by the Bureau, or if a person is employed in his or her first 90 days of probationary employment as an apprentice in such an apprenticeship program, who is not individually registered in the program, but who has been certified by the Bureau of Apprenticeship and Training or a State Apprenticeship Agency (where appropriate) to be eligible for probationary employment as an apprentice. The allowable ratio of apprentices to journeymen on the job site in any craft classification shall not be greater than the ratio permitted to the Contractor as to the entire work force under the registered program. Any worker listed on a payroll at an apprentice wage rate, who is not registered or otherwise employed as stated above, shall be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed. In addition, any apprentice performing work on the job site in excess of the ratio permitted under the registered program shall be paid not less than the applicable wage rate on the wage determination for the work actually performed. Where a Contractor is performing construction on a project in a locality other than that in which its program is registered, the ratios and wage rates (expressed in percentages of the journeyman's hourly rate) specified in the Contractor's or subcontractor's registered program shall be observed. Every apprentice must be paid at not less than the rate specified in the registered program for the apprentice's level of progress, expressed as a percentage of the journeymen hourly rate specified in the applicable wage determination. Apprentices shall be paid fringe benefits in accordance with the provisions of the apprenticeship program. If the apprenticeship program does not specify fringe benefits, apprentices must be paid the full amount of fringe benefits listed on the wage determination for the applicable classification. If the Administrator determines that a different practice prevails for the applicable apprentice classification, fringes shall be paid in accordance with that determination. In the event the Bureau of Apprenticeship and Training, or a State Apprenticeship Agency recognized by the Bureau, withdraws approval of an apprenticeship program, the Contractor will no longer be permitted to utilize apprentices at less than the applicable predetermined rate for the work performed until an acceptable program is approved.

(ii) Trainees. Except as provided in 29 CFR 5.16, trainees will not be permitted to work at less than the predetermined rate for the work performed unless they are employed pursuant to and individually registered in a program which has received prior approval, evidenced by formal certification by the U.S. Department of Labor, Employment and Training Administration. The ratio of trainees to journeymen on the job site shall not be greater than permitted under the plan approved by the Employment and Training Administration. Every trainee must be paid at not less than the rate specified in the approved program for the trainee's level of progress, expressed as a percentage of the journeyman hourly rate specified in the applicable wage determination. Trainees shall be paid fringe benefits in accordance with the provisions of the trainee program. If the trainee program does not mention fringe benefits, trainees shall be paid the full amount of fringe benefits listed on the wage determination unless the Administrator of the Wage and Hour Division determines that there is an apprenticeship program associated with the corresponding journeyman wage rate on the wage determination which provides for less than full fringe benefits for apprentices. Any employee listed on the payroll at a trainee rate who is not registered and participating in a training plan approved by the Employment and Training Administration

shall be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed. In addition, any trainee performing work on the job site in excess of the ration permitted under the registered program shall be paid not less than the applicable wage rate on the wage determination for the work actually performed. In the event the Employment and Training Administration withdraws approval of a training program, the contract will no longer be permitted to utilize trainees at less than the applicable predetermined rate for the work performed until an acceptable program is approved.

(iii) Equal employment opportunity. The utilization of apprentices, trainees and journeymen under this part shall be in conformity with the equal employment opportunity requirements of Executive Order 11246, as amended, and 29 CFR Part 30.

(5) Compliance with Copeland Act Requirements.

The Contractor shall comply with the requirements of 29 CFR Part 3, which are incorporated by reference in this contract.

(6) Subcontracts.

The Contractor or subcontractor shall insert in any subcontracts the clauses contained in 29 CFR Part 5.5(a)(1) through (10) and such other clauses as the Federal Aviation Administration may by appropriate instructions require, and also a clause requiring the subcontractors to include these clauses in any lower tier subcontracts. The prime Contractor shall be responsible for the compliance by an subcontractor or lower tier subcontractor with all the contract clauses in 29 CFR Part 5.5.

(7) Contract Termination: Debarment.

A breach of these contract clauses paragraphs (1) through (10) of this section may be grounds for termination of the contract and for debarment as a Contractor and a subcontractor as provided in 29 CFR Part 5.12.

(8) Compliance with Davis-Bacon and Related Act Requirements.

All rulings and interpretations of the Davis-Bacon and Related Acts contained in 29 CFR Parts 1, 3, and 5 are herein incorporated by referenced in this contract.

(9) Disputes Concerning Labor Standards.

Disputes arising out of the labor standards provisions of this contract shall not be subject to the general disputes clause of this contract. Such disputes shall be resolved in accordance with the procedures of the Department of Labor set forth in 29 CFR Parts 5, 6, and 7. Disputes within the meaning of this clause include disputes between the Contractor (or any of its subcontractors ) and the contracting agency, the U.S. Department of Labor, or the employees or their representatives.

(10) Certification of Eligibility.

(i) By entering into this contract, the Contractor certifies that neither it (nor he or she) nor any person or firm who has an interest in the Contractor's firm is a person or firm ineligible to be awarded Government contracts by virtue of section 3(a) of the Davis-Bacon Act or 29 CFR 5.12(a)(1).

(ii) No part of this contract shall be subcontracted to any person or firm ineligible for award of a Government contract by virtue of section 3(a) of the Davis-Bacon Act or 29 CFR 5.12(a)(1).

(iii) The penalty for making false statements is prescribed in the U.S. Criminal Code, 18 U.S.C. 1001.

## **MINIMUM WAGES FOR FEDERAL AND FEDERALLY ASSISTED CONSTRUCTION CONTRACTS**

This project is funded, in part, with Federal-aid funds and, as such, is subject to the provisions of the Davis-Bacon Act of March 3, 1931, as amended (46 Sta. 1494, as amended, 40 U.S.C. 276a) and of other Federal statutes referred to in a 29 CFR Part 1, Appendix A, as well as such additional statutes as may from time to time be enacted containing provisions for the payment of wages determined to be prevailing by the Secretary of Labor in accordance with the Davis-Bacon Act and pursuant to the provisions of 29 CFR Part 1. The prevailing rates and fringe benefits shown in the General Wage Determination Decisions issued by the U.S. Department of Labor shall, in accordance with the provisions of the foregoing statutes, constitute the minimum wages payable on Federal and federally assisted construction projects to laborers and mechanics of the specified classes engaged on contract work of the character and in the localities described therein.

General Wage Determination Decisions, modifications and supersedes decisions thereto are to be used in accordance with the provisions of 29 CFR Parts 1 and 5. Accordingly, the applicable decision, together with any modifications issued, must be made a part of every contract for performance of the described work within the geographic area indicated as required by an applicable DBRA Federal prevailing wage law and 29 CFR Part 5. The wage rates and fringe benefits contained in the General Wage Determination Decision shall be the minimum paid by contractors and subcontractors to laborers and mechanics.

### **Additional Provisions for Construction Contracts Exceeding \$10,000**

#### **EQUAL EMPLOYMENT OPPORTUNITY - 41 CFR PART 60-1.4(b)**

During the performance of this contract, the contractor agrees as follows:

1. The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin. The contractor will take affirmative action to ensure that applicants are employed, and that employees are treated during employment without regard to their race, color, religion, sex, or national origin. Such action shall include, but not be limited to the following: Employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided setting forth the provisions of this nondiscrimination clause.
2. The contractor will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive considerations for employment without regard to race, color, religion, sex, or national origin.
3. The contractor will send to each labor union or representative of workers with which s/he has a collective bargaining agreement or other contract or understanding, a notice to be provided advising the said labor union or workers' representatives of the contractor's commitments under this section, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
4. The contractor will comply with all provisions of Executive Order 11246 of September 24, 1965, as amended, and of the rules, regulations, and relevant orders of the Secretary of Labor.
5. The contractor will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to his books, records, and accounts by the administering agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
6. In the event of the contractor's noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations, or orders, this contract may be canceled, terminated or suspended in whole or in part and the contractor may be declared ineligible for further Government contracts or federally assisted construction contracts in accordance with procedure authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
7. The contractor will include the portion of the sentence immediately preceding paragraph (1) and the provisions of paragraphs (1) through (7) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. The contractor will take such action with respect to any subcontract or purchase order as the administering agency may direct as a means of enforcing such provision, including sanctions for noncompliance: *Provided, however*, that in the event a contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction by the administering agency the contractor may request the United States to enter into such litigation to protect the interests of the United States.

#### **CERTIFICATION OF NONSEGREGATED FACILITIES (41 CFR PART 60-1.8)**

The federally-assisted construction contractor certifies that she or he does not maintain or provide, for his employees, any segregated facilities at any of his establishments and that she or he does not permit his employees to perform their services at any location, under his control, where segregated facilities are maintained. The federally-assisted construction contractor certifies that she or he will not



maintain or provide, for his employees, segregated facilities at any of his establishments and that she or he will not permit his employees to perform their services at any location under his control where segregated facilities are maintained. The federally-assisted construction contractor agrees that a breach of this certification is a violation of the Equal Opportunity Clause in this contract.

As used in this certification, the term "segregated facilities" means any waiting rooms, work areas, restrooms, and washrooms, restaurants and other eating areas, timeclocks, locker rooms and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing facilities provided for employees which are segregated by explicit directives or are, in fact, segregated on the basis of race, color, religion, or national origin because of habit, local custom, or any other reason. The federally-assisted construction contractor agrees that (except where she or he has obtained identical certifications from proposed subcontractors for specific time periods) she or he will obtain identical certifications from proposed subcontractors prior to the award of subcontracts exceeding \$10,000 which are not exempt from the provisions of the Equal Opportunity Clause and that she or he will retain such certifications in his files.

**NOTICE OF REQUIREMENT FOR AFFIRMATIVE ACTION (Title 41 CFR Part 60-4.2)**

1. The Offeror's or Bidder's attention is called to the "Equal Opportunity Clause" and the "Standard Federal Equal Employment Opportunity Construction Contract Specifications" set forth herein.

These goals are applicable to all the Contractor's construction work (whether or not it is Federal or federally assisted) performed in the covered area. If the Contractor performs construction work in a geographical area located outside of the covered area, it shall apply the goals established for such geographical area where the work is actually performed. With regard to this second area, the Contractor also is subject to the goals for both its federally involved and nonfederally involved construction.

The Contractor's compliance with Executive Order and the regulations in 41 CFR Part 60-4 shall be based on its implementation of the Equal Opportunity Clause, specific affirmative action obligations required by the provisions and specifications set forth in its federally assisted contracts, and its efforts to meet the goals established for the geographical area where the contract resulting from this solicitation is to be performed. The hours of minority and female employment and training must be substantially uniform throughout the length of the contract, and in each trade, and the Contractor shall make a good faith effort to employ minorities and women evenly on each of its projects. The transfer of minority or female employees or trainees from Contractor to Contractor or from project to project for the sole purpose of meeting the Contractor's goals shall be a violation of the contract, the Executive Order and the regulations in 41 CFR Part 60-4. Compliance with the goals will be measured against the total work hours performed.

3. The Illinois Division of Aeronautics will provide written notification to the Director of the Office of Federal Contract Compliance Programs within 10 working days of award of any construction contract and/or subcontract in excess of \$10,000 at any tier for construction work under the contract resulting from this solicitation. This notification will list the name, address and telephone number of the subcontractor; employer identification number; estimated dollar amount of the subcontract; estimated starting and completion dates of the subcontract; and the geographical area in which the contract is to be performed.

4. As used in this Notice, and in the contract resulting from this solicitation, the "covered area" is the entire State of Illinois for the goal set forth in APPENDIX A and the county or counties in which the work is located for the goals set forth in APPENDIX B.

**EQUAL EMPLOYMENT OPPORTUNITY SPECIFICATION (Title 41 CFR Part 60-4.3)**

1. As used in these specifications:
  - a) "Covered area" means the geographical area described in the solicitation from which this contract resulted;
  - b) "Director" means Director, Office of Federal Contract Compliance Programs, United States Department of Labor, or any person to whom the Director delegates authority;
  - c) "Employer identification number" means the Federal Social Security number used on the Employer's Quarterly Federal Tax Return, U.S. Treasury Department Form 941;
  - d) "Minority" includes:
    - (i) Black (all persons having origins in any of the Black African racial groups not of Hispanic origin);
    - (ii) Hispanic (all persons of Mexican, Puerto Rican, Cuban, Central or South American or other Spanish Culture or origin, regardless of race);
    - (iii) Asian and Pacific Islander (all persons having origins in any of the original peoples of the Far East, Southeast Asia, the Indian Subcontinent, or the Pacific Islands); and
    - (iv) American Indian or Alaskan Native (all persons having origins in any of the original peoples of North America and maintaining identifiable tribal affiliations through membership and participation or community identification).

2. Whenever the Contractor, or any Subcontractor at any tier, subcontracts a portion of the work involving any construction trade, it shall physically include in each subcontract in excess of \$10,000. the provisions of these specifications and the Notice which contains the applicable goals for minority and female participation and which is set forth in the solicitations from which this contract resulted.
3. If the Contractor is participating (pursuant to 41 CFR 60-4.5) in a Hometown Plan approved by the U.S. Department of Labor in the covered area either individually or through an association, its affirmative action obligations on all work in the plan area (including goals and timetables) shall be in accordance with that Plan for those trades which have unions participating in the Plan. Contractors must be able to demonstrate their participation in and compliance with the provisions of any such Hometown Plan. Each Contractor or Subcontractor participating in an approved Plan is individually required to comply with its obligations under the EEO clause, and to make a good faith effort to achieve each goal under the Plan in each trade in which it has employees. The overall good faith performance by other Contractors or Subcontractors toward a goal in an approved Plan does not excuse any covered Contractor's or Subcontractor's failure to take good faith efforts to achieve the Plan goals and timetables.
4. The Contractor shall implement the specific affirmative action standards provided in paragraphs 7a through p of these specifications. The goals set forth in the solicitation from which this contract resulted are expressed as percentages of the total hours of employment and training of minority and female utilization the Contractor should reasonably be able to achieve in each construction trade in which it has employees in the covered area. Covered Construction Contractors performing construction work in geographical areas where they do not have a Federal or federally assisted construction contract shall apply the minority and female goals established for the geographical area where the work is being performed. Goals are published periodically in the Federal Register in notice form, and such notices may be obtained from any Office of Federal Contract Compliance Programs office or from Federal procurement contracting officers. The Contractor is expected to make substantially uniform progress toward its goals in each craft during the period specified.
5. Neither the provisions of any collective bargaining agreement, nor the failure by a union with whom the Contractor has a collective bargaining agreement, to refer either minorities or women shall excuse the Contractor's obligations under these specifications, Executive Order 11246, or the regulations promulgated pursuant thereto.
6. In order for the nonworking training hours of apprentices and trainees to be counted in meeting the goals, such apprentices and trainees must be employed by the Contractor during the training period, and the Contractor must have made a commitment to employ the apprentices and trainees at the completion of their training, subject to the availability of employment opportunities. Trainees must be trained pursuant to training programs approved by the U.S. Department of Labor.
7. The Contractor shall take specific affirmative actions to ensure equal employment opportunity. The evaluation of the Contractor's compliance with these specifications shall be based upon its effort to achieve maximum results from its actions. The Contractor shall document these efforts fully, and shall implement affirmative action steps at least as extensive as the following:
  - a) Ensure and maintain a working environment free of harassment, intimidation, and coercion at all sites, and in all facilities at which the Contractor's employees are assigned to work. The Contractor, where possible, will assign two or more women to each construction project. The Contractor shall specifically ensure that all foremen, superintendents, and other on-site supervisory personnel are aware of and carry out the Contractor's obligation to maintain such a working environment, with specific attention to minority or female individuals working as such sites or in such facilities.
  - b) Establish and maintain a current list of minority and female recruitment sources, provide written notification to minority and female recruitment sources and to community organizations when the Contractor or its unions have employment opportunities available, and maintain a record of the organizations' responses.
  - c) Maintain a current file of the names, addresses and telephone numbers of each minority and female off-the-street applicant and minority or female referral from a union, a recruitment source or community organization and of what action was taken with respect to each such individual. If such individual was sent to the union hiring hall for referral and was not referred back to the Contractor by the union or, if referred, not employed by the Contractor, this shall be documented in the file with the reason therefor, along with whatever additional actions the Contractors may have taken.
  - d) Provide immediate written notification to the Director when the union or unions with which the Contractor has a collective bargaining agreement has not referred to the Contractor a minority person or woman sent by the Contractor, or when the Contractor has other information that the union referral process has impeded the Contractor's efforts to meet its obligations.
  - e) Develop on-the-job training opportunities and/or participate in training programs for the area which expressly include minorities and women, including upgrading programs and apprenticeship and trainee programs relevant to the Contractor's employment needs, especially those programs funded or approved by the Department of Labor. The Contractor shall provide notice of these programs to the sources compiled under 7b above.

  - h) Disseminate the Contractor's EEO policy externally by including it in any advertising in the news media, specifically including minority and female news media, and providing written notification to and discussing the Contractor's EEO policy with other Contractors and Subcontractors with whom the Contractor does or anticipates doing business.
  - i) Direct its recruitment efforts, both oral and written, to minority, female and community organizations, to schools with minority and female students and to minority and female recruitment and training organizations serving the Contractor's recruitment area and employment needs. Not later than one month prior to the date for the acceptance of applications for apprenticeship or other training by any recruitment source, the Contractor shall send written notification to organizations such as the above, describing the openings, screening procedures, and tests to be used in the selection process.
  - j) Encourage present minority and female employees to recruit other minority persons and women and, where reasonable, provide after school, summer and vacation employment to minority and female youth both on the site and in other areas of a Contractor's workforce.
  - k) Validate all tests and other selection requirements where there is an obligation to do so under 41 CFR Part 60-3.
  - l) Conduct, at least annually, an inventory and evaluation at least of all minority and female personnel for promotional opportunities and encourage these employees to seek or to prepare for, through appropriate training, etc., such opportunities.
  - m) Ensure that seniority practices, job classifications, work assignments and other personnel practices, do not have a discriminatory effect by continually monitoring all personnel and employment related activities to ensure that the EEO policy and the Contractor's obligations under these specifications are being carried out.
  - n) Ensure that all facilities and company activities are nonsegregated except that separate or single-user toilet and necessary changing facilities shall be provided to assure privacy between the sexes.
  - o) Document and maintain a record of all solicitations of offers for subcontracts from minority and female construction Contractors and suppliers, including circulation of solicitations to minority and female Contractor associations and other business associations.
  - p) Conduct a review, at least annually, of all supervisors' adherence to and performance under the Contractor's EEO policies and affirmative action obligations.
8. Contractors are encouraged to participate in voluntary associations which assist in fulfilling one or more of their affirmative action obligations (7a through p). The efforts of a Contractor association, joint Contractor-union, Contractor-community, or other similar group of which the Contractor is a member and participant, may be asserted as fulfilling any one or more of its obligations under 7a through p of these Specifications provided that the Contractor actively participates in the group, makes every effort to assure that the group has a positive impact on the employment of minorities and women in the industry, ensures that the concrete benefits of the program are reflected in the Contractor's minority and female workforce participation makes a good faith effort to meet its individual goals and timetables, and can provide access to documentation which demonstrates the effectiveness of actions taken on behalf of the Contractor. 9. A single goal for minorities and a separate single goal for women have been established. The Contractor, however, is required to provide equal employment opportunity and to take affirmative action for all minority groups, both male and female, and all women, both minority and non-minority. Consequently, the Contractor may be in violation of the Executive Order if a particular group is employed in a substantially disparate manner (for example, even though the Contractor has achieved its goals for women generally, the Contractor may be in violation of the Executive Order if a specified minority group of women is underutilized).

10. The Contractor shall not use the goals and timetables or affirmative action standards to discriminate against any person because of race, color, religion, sex, or national origin.

12. The Contractor shall carry out such sanctions and penalties for violation of these specifications and of the Equal Opportunity Clause, including suspension, termination and cancellation of existing subcontracts as may be imposed or ordered pursuant to Executive Order 11246, as amended, and its implementing regulations, by the Office of Federal Contract Compliance Programs. Any Contractor who fails to carry out such sanctions and penalties shall be in violation of these specifications and Executive Order 11246, as amended.
13. The Contractor, in fulfilling its obligations under these specifications, shall implement specific affirmative action steps, at least as extensive as those standards prescribed in paragraph 7 of these specifications, so as to achieve maximum results from its efforts to ensure equal opportunity. If the Contractor fails to comply with the requirements of the Executive Order, the implementing regulations, or these specifications, the Director shall proceed in accordance with 41 CFR 60-4.8.
14. The Contractor shall designate a responsible official to monitor all employment related activity to ensure that the company EEO policy is being carried out, to submit reports relating to the provisions hereof as may be required by the Government and to keep records. Records shall at least include for each employee the name, address, telephone numbers, construction trade, union affiliation if any, employee identification number when assigned, social security number, race, sex, status (e.g., mechanic, apprentice, trainee, helper, or laborer), dates of changes in status, hours worked per week in the indicated trade, rate of pay, and locations at which the work was performed. Records shall be maintained in an easily understandable and retrievable form; however, to the degree that existing records satisfy his requirement, Contractors shall not be required to maintain separate records.
15. Nothing herein provided shall be construed as a limitation upon the application of other laws which establish different standards of compliance or upon the application of requirements for the hiring of local or other area residents (e.g., those under the Public Works Employment Act of 1977 and the Community Development Block Grant Program).

#### **TERMINATION OF CONTRACT (Title 49 CFR Part 18.36)**

1. The Co-Sponsor may, by written notice, terminate this contract in whole or in part at any time, either for the Co-Sponsor's convenience or because of failure to fulfill the contract obligations. Upon receipt of such notice services shall be immediately discontinued (unless the notice directs otherwise) and all materials as may have been accumulated in performing this contract, whether completed or in progress, delivered to the Co-Sponsor.
2. If the termination is for the convenience of the Co-Sponsor, an equitable adjustment in the contract price shall be made, but no amount shall be allowed for anticipated profit on unperformed services.
3. If the termination is due to failure to fulfill the Contractor's obligations, the Co-Sponsor may take over the work and prosecute the same to completion by contract or otherwise. In such case, the Contractor shall be liable to the Co-Sponsor for any additional cost occasioned to the Co-Sponsor thereby.
4. If, after notice of termination for failure to fulfill contract obligations, it is determined that the Contractor had not so failed, the termination shall be deemed to have been effected for the convenience of the Co-Sponsor. In such event, adjustment in the contract price shall be made as provided in paragraph 2 of this clause.
5. The rights and remedies of the Co-Sponsor provided in this clause are in addition to any other rights and remedies provided by law or under this contract.

#### **Additional Provisions for Construction Contracts Exceeding \$25,000**

#### **CERTIFICATION REGARDING DEBARMENT, SUSPENSION, INELIGIBILITY AND VOLUNTARY EXCLUSION (Title 49 CFR Part 29)**

##### Instructions for Certification

1. By signing and submitting this proposal, the prospective primary participant is providing the certification set out below.
2. The inability of a person to provide the certification required below will not necessarily result in denial of participation in this covered transaction. The prospective participant shall submit an explanation of why it cannot provide the certification set out below. The certification or explanation will be considered in connection with the department or agency's determination whether to enter into this transaction. However, failure of the prospective primary participant to furnish a certification or an explanation shall disqualify such person from participation in this transaction.

3. The certification in this clause is a material representation of fact upon which reliance was placed when the department or agency determined to enter into this transaction. If it is later determined that the prospective primary participant knowingly rendered an erroneous certification in addition to other remedies available to the Federal Government, the department or agency may terminate this transaction for cause of default.
4. The prospective primary participant shall provide immediate written notice to the department or agency to whom this proposal is submitted if at any time the prospective primary participant learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
5. The terms "covered transaction" "debarred" "suspended" "ineligible" "lower tier covered transaction" "participant" "person" "primary covered transaction" "principal" "proposal" and "voluntarily excluded" as used in this clause have the meaning set out in the Definitions and Coverage sections of the rules implementing Executive Order 12540. You may contact the department or agency to which this proposal is being submitted for assistance in obtaining a copy of those regulations.
6. The prospective primary participant agrees by submitting this proposal that should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction unless authorized by the department or agency entering into this transaction.
7. The prospective primary participant further agrees by submitting this proposal that it will include the clause titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion - Lower Tier Transaction", provided by the department or agency entering into this covered transaction without modification in all lower covered transactions and in all solicitations for lower covered transactions.
8. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that it is not debarred, suspended, ineligible, or voluntarily excluded from the covered transaction unless it knows that the certification is erroneous. A participant may decide the method and frequency by which it determines the eligibility of its principals. Each participant may, but is not required to check the Nonprocurement List (Tel. #).
9. Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render in good faith the certification required by this clause. The knowledge and information of a participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.
10. Except for transactions authorized under paragraph 8 of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible, or voluntarily excluded from participation in this transaction, in addition to other remedies available to the Federal Government, the department or agency may terminate this transaction for cause or default.

**Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion**  
**Primary Covered Transactions**

1. The prospective primary participant certifies to the best of its knowledge and belief that it and its principals:

The terms "covered transaction," "debarred," "suspended," "ineligible," "lower tier covered transaction," "participant," "person," "primary covered transaction," "principal," "proposal," and "voluntarily excluded," as used in this clause sections of rules implementing Executive Order 12549. You may contact the person to which this proposal is submitted for assistance in obtaining a copy of those regulations.
5. The prospective lower tier participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized by the department or agency with which this transaction originated.
6. The prospective lower tier participant further agrees by submitting this proposal that it will include this clause titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion--Lower Tier Covered Transaction," without modification, in all lower tier covered transactions and in all solicitations for lower tier covered transactions.
7. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that it is not debarred, suspended, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is erroneous. Except for transactions authorized under paragraph 5 of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible, or voluntarily excluded from participation in this transaction, in addition to other remedies available to the Federal Government, the department or agency with which this transaction originated may pursue available remedies, including suspension and/or debarment.

#### **Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion** **Lower Tier Covered Transactions**

1. The prospective lower tier participant certifies, by submission of this proposal, that neither it nor its principals is presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this transaction by any Federal department or agency.
2. Where the prospective lower tier participant is unable to certify to any of the statements in this certification, such prospective participant shall attach an explanation to this proposal.

#### **Additional Provisions for Construction Contracts Exceeding \$100,000**

#### **CONTRACT WORKHOURS AND SAFETY STANDARDS ACT REQUIREMENTS (Title 29 CFR Part 5)**

##### (1) Overtime requirements:

No Contractor or subcontractor contracting for any part of the contract work which may require or involve the employment of laborers, mechanics, watchmen or guards (including apprentices and trainees described in paragraphs 5 and 6 above) shall require or permit any laborer, mechanic, watchman or guard in any workweek in which he/she is employed on such work, to work



in excess of 40 hours in such workweek unless such laborer, mechanic, watchman or guard receives compensation at a rate not less than one and one-half times his/her basic rate of pay for all hours worked in excess of 40 hours in such workweek.

(2) Violations: Liability for Unpaid Wages; Liquidated Damages:

In the event of any violation of the clause set forth in paragraph (1) above, the Contractor and any subcontractor responsible therefore shall be liable for the unpaid wages. In addition, such Contractor and subcontractor shall be liable to the United States (in case of work done under contract for the District of Columbia or a territory, to such District or to such territory), for liquidated damages. Such liquidated damages shall be computed with respect to each individual laborer, mechanic, including watchmen and guards, employed in violation of the clause set forth in paragraph (1) above, in the sum of \$10.00 for each calendar day on which such employee was required or permitted to work in excess of the standard workweek of 40 hours without payment of the overtime wages required by the clause set forth in paragraph (1) above.

(3) Withholding for Unpaid Wages and Liquidated Damages.

The Federal Aviation Administration or the Co-Sponsor shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the Contractor or subcontractor under any such contract or any other Federal contract with the same prime Contractor, or any other Federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime Contractor, such sums as may be determined to be necessary to satisfy any liabilities of such Contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph (2) above.

(4) Subcontracts.

The Contractor or subcontractor shall insert in any subcontracts the clauses set forth in paragraph (1) through (4) and also a clause requiring the subcontractors to include these clauses in any lower tier subcontracts. The prime Contractor shall be responsible for compliance by any subcontractor or lower tier subcontractor with the clauses set forth in paragraphs (1) through (4) of this section.

(5) Working Conditions.

No Contractor or subcontractor may require any laborer or mechanic employed in the performance of any contract to work in surroundings or under working conditions that are unsanitary, hazardous, or dangerous to his health or safety as determined under construction safety and health standards (29 CFR 1926) issued by Department of Labor.

**CLEAN AIR AND WATER POLLUTION CONTROL (Title 49 CFR Part 18.36(i)(12))**

In connection with the administration of the Clean Air Act and the Water Pollution Control Act with respect to Federal Grants, specific requirements have been imposed of any contract which is not exempt under the provisions of 40 CFR 15.5.

(1) Any facility listed on the EPA List of Violating Facilities pursuant to Paragraph 15.20 of 40 CFR as of the date of the contract award will not be utilized in the performance of any non-exempt contract or subcontract.

(2) The Contractor shall comply with all the requirements of Section 114 of the Clean Air Act, as amended, 42 USC 1857 et seq. and Section 308 of the Federal Water Pollution Control Act, as amended, 33 USC 1251 et seq. relating to inspection, monitoring, entry, reports and information, as well as all other requirements specified in Section 114 and Section 308 of the Air Act and Water Act, respectively, and all regulations and guidelines issued thereunder after the award of the contract.

(3) Prompt notification shall be required prior to contract award to the awarding official by the Contractor who will receive the award of the receipt of any communication from the Director, Office of Federal Activities, U.S. Environmental Protection Agency, indicating that a facility to be utilized for the contract is under consideration to be listed on the EPA List of Violating Facilities.

(4) The Contractor shall include or cause to be included the criteria and requirements in paragraphs 1 through 4 in any non-exempt subcontract and will take such action as the Government may direct as a means of enforcing such provisions.

The following provisions are State of Illinois requirements and are in addition to the REQUIRED CONTRACT PROVISIONS FOR FEDERALLY FUNDED AIRPORT CONSTRUCTION CONTRACTS

**DISADVANTAGED BUSINESS POLICY**

NOTICE: This proposal contains the special provision entitled "Disadvantaged Business Participation." Inclusion of this Special Provision in this contract satisfies the obligations of the Department of Transportation under federal law as implemented by 49 CFR 23 and under the Illinois "Minority and Female Business Enterprise Act."

POLICY: It is public policy that the businesses defined in 49 CFR Part 23 shall have the maximum opportunity to participate in the performance of contracts financed in whole or in part with State or Federal funds. Consequently, the requirements of 49 CFR Part 23 apply to this contract.

OBLIGATION: The Contractor agrees to ensure that the businesses defined in 49 CFR Part 23 have the maximum opportunity to participate in the performance of this contract. In this regard, the Contractor shall take all necessary and reasonable steps, in accordance with 49 CFR Part 23, to ensure that the said businesses have the maximum opportunity to compete for and perform portions of this contract. The Contractor shall not discriminate on the basis of race, color, national origin, or sex in the selection and retention of subcontractors, including procurement of materials and leases of equipment.

The Contractor shall include the above Policy and Obligation statements of this Special Provision in every subcontract, including procurement of materials and leases of equipment.

DBE/WBE CONTRACTOR FINANCE PROGRAM: On contracts where a loan has been obtained through the DBE/WBE Contractor Finance Program, the Contractor shall cooperate with the Department by making all payments due to the DBE/WBE Contractor by means of a two-payee check payable to the Lender (Bank) and the Borrower (DBE/WBE Contractor).

BREACH OF CONTRACT: Failure to carry out the requirements set forth above and in the Special Provision shall constitute a breach of contract and may result in termination of the contract or liquidated damages as provided in the special provision.

**SPECIAL PROVISION FOR DISADVANTAGED BUSINESS ENTERPRISE PARTICIPATION**  
**Revised: August 2, 2011**

FEDERAL OBLIGATION: The Department of Transportation, as a recipient of federal financial assistance, is required to take all necessary and reasonable steps to ensure nondiscrimination in the award and administration of contracts. Consequently, the federal regulatory provisions of 49 CFR part 26 apply to this contract concerning the utilization of disadvantaged business enterprises. For the purposes of this Special Provision, a disadvantaged business enterprise (DBE) means a business certified by the Department in accordance with the requirements of 49 CFR part 26 and listed in the Illinois Unified Certification Program (IL UCP) DBE Directory

STATE OBLIGATION. This Special Provision will also be used by the Department to satisfy the requirements of the Business Enterprise for Minorities, Females, and Persons with Disabilities Act, 30 ILCS 575. When this Special Provision is used to satisfy state law requirements on 100 percent state-funded contracts, the federal government has no involvement in such contracts (not a federal-aid contract) and no responsibility to oversee the implementation of this Special Provision by the Department on those contracts. DBE participation on 100 percent state-funded contracts will not be credited toward fulfilling the Department's annual overall DBE goal required by the US Department of Transportation to comply with the federal DBE program requirements.

CONTRACTOR ASSURANCE: The Contractor makes the following assurance and agrees to include the assurance in each subcontract that the Contractor signs with a subcontractor:

The Contractor, subrecipient or subcontractor shall not discriminate on the basis of race, color, national origin, or sex in the performance of this contract. The Contractor shall carry out applicable requirements of 49 CFR part 26 in the award and administration of contracts funded in whole or in part with federal or state funds. Failure by the contractor to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy as the recipient deems appropriate.

OVERALL GOAL SET FOR THE DEPARTMENT: As a requirement of compliance with 49 CFR part 26, the Department has set an overall goal for DBE participation in its federally assisted contracts. That goal applies to all federal-aid funds the Department will expend in its federally assisted contracts for the subject reporting fiscal year. The Department is required to make a good faith effort to

achieve the overall goal. The dollar amount paid to all approved DBE companies performing work called for in this contract is eligible to be credited toward fulfillment of the Department's overall goal.

**CONTRACT GOAL TO BE ACHIEVED BY THE CONTRACTOR:** This contract includes a specific DBE utilization goal established by the Department. The goal has been included because the Department has determined that the work of this contract has subcontracting opportunities that may be suitable for performance by DBE companies. This determination is based on an assessment of the type of work, the location of the work, and the availability of DBE companies to do a part of the work. The assessment indicates that, in the absence of unlawful discrimination, and in an arena of fair and open competition, DBE companies can be expected to perform **0.0%** of the work. This percentage is set as the DBE participation goal for this contract. Consequently, in addition to the other award criteria established for this contract, the Department will only award this contract to a bidder who makes a good faith effort to meet this goal of DBE participation in the performance of the work. A bidder makes a good faith effort for award consideration if either of the following is done in accordance with the procedures set forth in this Special Provision:

- (a) The bidder documents that enough DBE participation has been obtained to meet the goal; or
- (b) The bidder documents that a good faith effort has been made to meet the goal, even though the effort did not succeed in obtaining enough DBE participation to meet the goal.

**DBE LOCATOR REFERENCES:** Bidders shall consult the IL UCP DBE Directory as a reference source for DBE-certified companies. In addition, the Department maintains a letting and item specific DBE locator information system whereby DBE companies can register their interest in providing quotes on particular bid items advertised for letting. Information concerning DBE companies willing to quote work for particular contracts may be obtained by contacting the Department's Bureau of Small Business Enterprises at telephone number (217)785-4611, or by visiting the Department's web site at [www.dot.il.gov](http://www.dot.il.gov).

**BIDDING PROCEDURES:** Compliance with this Special Provision is a material bidding requirement. The failure of the bidder to comply will render the bid not responsive.

- (a) The bidder shall submit a Disadvantaged Business Utilization Plan on Department forms SBE 2025 and 2026 with the bid.
- (b) The Utilization Plan shall indicate that the bidder either has obtained sufficient DBE participation commitments to meet the contract goal or has not obtained enough DBE participation commitments in spite of a good faith effort to meet the goal. The Utilization Plan shall further provide the name, telephone number and telefax number of a responsible official of the bidder designated for purposes of notification of plan approval or disapproval under the procedures of this Special Provision.
- (c) The Utilization Plan shall include a DBE Participation Commitment Statement, Department form SBE 2025, for each DBE proposed for the performance of work to achieve the contract goal. For bidding purposes, submission of the completed SBE 2025 forms, signed by the DBEs and faxed to the bidder will be acceptable as long as the original is available and provided upon request. All elements of information indicated on the said form shall be provided, including but not limited to the following:
  - (1) The name and address of DBE firms that will participate in the contract;
  - (2) A description, including pay item numbers, of the work each DBE will perform;
  - (3) The dollar amount of the participation of each DBE firm participating. The dollar amount of participation for identified work shall specifically state the quantity, unit price and total subcontract price for the work to be completed by the DBE. If partial pay items are to be performed by the DBE, indicate the portion of each item, a unit price where appropriate and the subcontract price amount;
  - (4) DBE Participation Commitment Statements, form SBE 2025, signed by the bidder and each participating DBE firm documenting the commitment to use the DBE subcontractors whose participation is submitted to meet the contract goal;
  - (5) If the bidder is a joint venture comprised of DBE companies and non-DBE companies, the plan must also include a clear identification of the portion of the work to be performed by the DBE partner(s); and,
  - (6) If the contract goal is not met, evidence of good faith efforts.

**GOOD FAITH EFFORT PROCEDURE:** The contract will not be awarded until the Utilization Plan submitted by the apparent successful bidder is approved. All information submitted by the bidder must be complete, accurate and adequately document that enough DBE participation has been obtained or document the good faith efforts of the bidder, in the event enough DBE participation has not been obtained, before the Department will commit to the performance of the contract by the bidder. The Utilization Plan will be approved by the Department if the Utilization Plan commits sufficient commercially useful DBE work performance to meet the contract goal or the bidder submits sufficient documentation of a good faith effort to meet the contract goal pursuant to 49 CFR part 26, Appendix A.

The Utilization Plan will not be approved by the Department if the Utilization Plan does not commit sufficient DBE participation to meet the contract goal unless the apparent successful bidder documented in the Utilization Plan that it made a good faith effort to meet the goal. This means that the bidder must show that all necessary and reasonable steps were taken to achieve the contract goal. Necessary and reasonable steps are those which, by their scope, intensity and appropriateness to the objective, could reasonably be

expected to obtain sufficient DBE participation, even if they were not successful. The Department will consider the quality, quantity, and intensity of the kinds of efforts that the bidder has made. Mere *pro forma* efforts, in other words, efforts done as a matter of form, are not good faith efforts; rather, the bidder is expected to have taken genuine efforts that would be reasonably expected of a bidder actively and aggressively trying to obtain DBE participation sufficient to meet the contract goal.

- (a) The following is a list of types of action that the Department will consider as part of the evaluation of the bidder's good faith efforts to obtain participation. These listed factors are not intended to be a mandatory checklist and are not intended to be exhaustive. Other factors or efforts brought to the attention of the Department may be relevant in appropriate cases, and will be considered by the Department.
- (1) Soliciting through all reasonable and available means (e.g. attendance at pre-bid meetings, advertising and/or written notices) the interest of all certified DBE companies that have the capability to perform the work of the contract. The bidder must solicit this interest within sufficient time to allow the DBE companies to respond to the solicitation. The bidder must determine with certainty if the DBE companies are interested by taking appropriate steps to follow up initial solicitations.
  - (2) Selecting portions of the work to be performed by DBE companies in order to increase the likelihood that the DBE goals will be achieved. This includes, where appropriate, breaking out contract work items into economically feasible units to facilitate DBE participation, even when the prime Contractor might otherwise prefer to perform these work items with its own forces.
  - (3) Providing interested DBE companies with adequate information about the plans, specifications, and requirements of the contract in a timely manner to assist them in responding to a solicitation.
  - (4) a. Negotiating in good faith with interested DBE companies. It is the bidder's responsibility to make a portion of the work available to DBE subcontractors and suppliers and to select those portions of the work or material needs consistent with the available DBE subcontractors and suppliers, so as to facilitate DBE participation. Evidence of such negotiation includes the names, addresses, and telephone numbers of DBE companies that were considered; a description of the information provided regarding the plans and specifications for the work selected for subcontracting; and evidence as to why additional agreements could not be reached for DBE companies to perform the work.  
  
b. A bidder using good business judgment would consider a number of factors in negotiating with subcontractors, including DBE subcontractors, and would take a firm's price and capabilities as well as contract goals into consideration. However, the fact that there may be some additional costs involved in finding and using DBE companies is not in itself sufficient reason for a bidder's failure to meet the contract DBE goal, as long as such costs are reasonable.  
  
Also, the ability or desire of a bidder to perform the work of a contract with its own organization does not relieve the bidder of the responsibility to make good faith efforts. Bidders are not, however, required to accept higher quotes from DBE companies if the price difference is excessive or unreasonable.
  - (5) Not rejecting DBE companies as being unqualified without sound reasons based on a thorough investigation of their capabilities. The bidder's standing within its industry, membership in specific groups, organizations, or associations and political or social affiliations (for example union vs. non-union employee status) are not legitimate causes for the rejection or non-solicitation of bids in the bidder's efforts to meet the project goal.
  - (6) Making efforts to assist interested DBE companies in obtaining bonding, lines of credit, or insurance as required by the recipient or Contractor.
  - (7) Making efforts to assist interested DBE companies in obtaining necessary equipment, supplies, materials, or related assistance or services.
  - (8) Effectively using the services of available minority/women community organizations; minority/women contractors' groups; local, state, and federal minority/women business assistance offices; and other organizations as allowed on a case-by-case basis to provide assistance in the recruitment and placement of DBE companies.
- (b) If the Department determines that the apparent successful bidder has made a good faith effort to secure the work commitment of DBE companies to meet the contract goal, the Department will award the contract provided that it is otherwise eligible for award. If the Department determines that the bidder has failed to meet the requirements of this Special Provision and that a good faith effort has not been made, the Department will notify the responsible company official designated in the Utilization Plan that the bid is not responsive. The notification shall include a statement of reasons why good faith efforts have not been found.
- (c) The bidder may request administrative reconsideration of a determination adverse to the bidder within the five working days after receipt of the notification date of the determination by delivering the request to the Department of Transportation, Bureau of Small Business Enterprises, Contract Compliance Section, 2300 South Dirksen Parkway, Room 319, Springfield, Illinois 62764 (Telefax: (217)785-1524). Deposit of the request in the United States mail on or before the fifth business day shall not be deemed delivery. The determination shall become final if a request is not made and delivered. A request may provide additional written documentation and/or argument concerning the issues raised in the determination statement of reasons, provided the documentation and arguments address efforts made prior to submitting the bid. The request will be forwarded to

the Department's Reconsideration Officer. The Reconsideration Officer will extend an opportunity to the bidder to meet in person in order to consider all issues of whether the bidder made a good faith effort to meet the goal. After the review by the Reconsideration Officer, the bidder will be sent a written decision within ten working days after receipt of the request for reconsideration, explaining the basis for finding that the bidder did or did not meet the goal or make adequate good faith efforts to do so. A final decision by the Reconsideration Officer that a good faith effort was made shall approve the Utilization Plan submitted by the bidder and shall clear the contract for award. A final decision that a good faith effort was not made shall render the bid not responsive.

**CALCULATING DBE PARTICIPATION.** The Utilization Plan values represent work anticipated to be performed and paid for upon satisfactory completion. The Department is only able to count toward the achievement of the overall goal and the contract goal the value of payments made for the work actually performed by DBE companies. In addition, a DBE must perform a commercially useful function on the contract to be counted. A commercially useful function is generally performed when the DBE is responsible for the work and is carrying out its responsibilities by actually performing, managing, and supervising the work involved. The Department and Contractor are governed by the provisions of 49 CFR part 26.55(c) on questions of commercially useful functions as it affects the work. Specific counting guidelines are provided in 49 CFR part 26.55, the provisions of which govern over the summary contained herein.

- (a) DBE as the Contractor: 100 percent goal credit for that portion of the work performed by the DBE's own forces, including the cost of materials and supplies. Work that a DBE subcontracts to a non-DBE does not count toward the DBE goals.
- (b) DBE as a joint venture Contractor: 100 percent goal credit for that portion of the total dollar value of the contract equal to the distinct, clearly defined portion of the work performed by the DBE's own forces.
- (c) DBE as a subcontractor: 100 percent goal credit for the work of the subcontract performed by the DBE's own forces, including the cost of materials and supplies, excluding the purchase of materials and supplies or the lease of equipment by the DBE subcontractor from the prime Contractor or its affiliates. Work that a DBE subcontractor in turn subcontracts to a non-DBE does not count toward the DBE goal.
- (d) DBE as a trucker: 100 percent goal credit for trucking participation provided the DBE is responsible for the management and supervision of the entire trucking operation for which it is responsible. At least one truck owned, operated, licensed, and insured by the DBE must be used on the contract. Credit will be given for the following:
  - (1) The DBE may lease trucks from another DBE firm, including an owner-operator who is certified as a DBE. The DBE who leases trucks from another DBE receives credit for the total value of the transportation services the lessee DBE provides on the contract.
  - (2) The DBE may also lease trucks from a non-DBE firm, including from an owner-operator. The DBE who leases trucks from a non-DBE is entitled to credit only for the fee or commission it receives as a result of the lease arrangement.
- (e) DBE as a material supplier:
  - (1) 60 percent goal credit for the cost of the materials or supplies purchased from a DBE regular dealer.
  - (2) 100 percent goal credit for the cost of materials or supplies obtained from a DBE manufacturer.
  - (3) 100 percent credit for the value of reasonable fees and commissions for the procurement of materials and supplies if not a regular dealer or manufacturer.

**CONTRACT COMPLIANCE.** Compliance with this Special Provision is an essential part of the contract. The Department is prohibited by federal regulations from crediting the participation of a DBE included in the Utilization Plan toward either the contract goal or the Department's overall goal until the amount to be applied toward the goals has been paid to the DBE. The following administrative procedures and remedies govern the compliance by the Contractor with the contractual obligations established by the Utilization Plan. After approval of the Utilization Plan and award of the contract, the Utilization Plan and individual DBE Participation Statements become part of the contract. If the Contractor did not succeed in obtaining enough DBE participation to achieve the advertised contract goal, and the Utilization Plan was approved and contract awarded based upon a determination of good faith, the total dollar value of DBE work calculated in the approved Utilization Plan as a percentage of the awarded contract value shall become the amended contract goal. All work indicated for performance by an approved DBE shall be performed, managed, and supervised by the DBE executing the Participation Statement.

- (a) **NO AMENDMENT.** No amendment to the Utilization Plan may be made without prior written approval from the Department's Bureau of Small Business Enterprises. All requests for amendment to the Utilization Plan shall be submitted to the Department of Transportation, Bureau of Small Business Enterprises, Contract Compliance Section, 2300 South Dirksen Parkway, Room 319, Springfield, Illinois 62764. Telephone number (217) 785-4611. Telefax number (217) 785-1524.
- (b) **TERMINATION OR REPLACEMENT.** The Contractor shall not terminate or replace a DBE listed on the approved Utilization Plan, or perform with other forces work designated for a listed DBE except as provided in the Special Provision.
- (c) **CHANGES TO WORK.** Any deviation from the DBE condition-of-award or contract plans, specifications, or special provisions must be approved, in writing, by the Department as provided elsewhere in the Contract. The Contractor shall notify affected

DBEs in writing of any changes in the scope of work which result in a reduction in the dollar amount condition-of-award to the contract. Where the revision includes work committed to a new DBE subcontractor, not previously involved in the project, then a Request for Approval of Subcontractor, Department form BC 260A, must be signed and submitted. If the commitment of work is in the form of additional tasks assigned to an existing subcontract, then a new Request for Approval of Subcontractor shall not be required. However, the Contractor must document efforts to assure that the existing DBE subcontractor is capable of performing the additional work and has agreed in writing to the change.

- (d) ALTERNATIVE WORK METHODS. In addition to the above requirements for reductions in the condition of award, additional requirements apply to the two cases of Contractor-initiated work substitution proposals. Where the contract allows alternate work methods which serve to delete or create underruns in condition of award DBE work, and the Contractor selects that alternate method or, where the Contractor proposes a substitute work method or material that serves to diminish or delete work committed to a DBE and replace it with other work, then the Contractor must demonstrate one of the following:
- (1) That the replacement work will be performed by the same DBE (as long as the DBE is certified in the respective item of work) in a modification of the condition of award; or
  - (2) That the DBE is aware that its work will be deleted or will experience underruns and has agreed in writing to the change. If this occurs, the Contractor shall substitute other work of equivalent value to a certified DBE or provide documentation of good faith efforts to do so; or
  - (3) That the DBE is not capable of performing the replacement work or has declined to perform the work at a reasonably competitive price. If this occurs, the Contractor shall substitute other work of equivalent value to a certified DBE or provide documentation of good faith efforts to do so.
- (e) TERMINATION AND REPLACEMENT PROCEDURES. The Contractor shall not terminate or replace a DBE subcontractor listed in the approved Utilization Plan without prior written consent. This includes, but is not limited to, instances in which the Contractor seeks to perform work originally designated for a DBE subcontractor with its own forces or those of an affiliate, a non-DBE firm, or with another DBE firm. Written consent will be granted only if the Bureau of Small Business Enterprises agrees, for reasons stated in its concurrence document, that the Contractor has good cause to terminate or replace the DBE firm. Before transmitting to the Bureau of Small Business Enterprises any request to terminate and/or substitute a DBE subcontractor, the Contractor shall give notice in writing to the DBE subcontractor, with a copy to the Bureau, of its intent to request to terminate and/or substitute, and the reason for the request. The Contractor shall give the DBE five days to respond to the Contractor's notice. The DBE so notified shall advise the Bureau and the Contractor of the reasons, if any, why it objects to the proposed termination of its subcontract and why the Bureau should not approve the Contractor's action. If required in a particular case as a matter of public necessity, the Bureau may provide a response period shorter than five days.

For purposes of this paragraph, good cause includes the following circumstances:

- (1) The listed DBE subcontractor fails or refuses to execute a written contract;
- (2) The listed DBE subcontractor fails or refuses to perform the work of its subcontract in a way consistent with normal industry standards. Provided, however, that good cause does not exist if the failure or refusal of the DBE subcontractor to perform its work on the subcontract results from the bad faith or discriminatory action of the prime contractor;
- (3) The listed DBE subcontractor fails or refuses to meet the prime Contractor's reasonable, nondiscriminatory bond requirements;
- (4) The listed DBE subcontractor becomes bankrupt, insolvent, or exhibits credit unworthiness;
- (5) The listed DBE subcontractor is ineligible to work on public works projects because of suspension and debarment proceedings pursuant to CFR Parts 180, 215 and 1200 or applicable state law;
- (6) You have determined that the listed DBE subcontractor is not a responsible contractor;
- (7) The listed DBE subcontractor voluntarily withdraws from the projects and provides to you written notice of its withdrawal;
- (8) The listed DBE is ineligible to receive DBE credit for the type of work required;
- (9) A DBE owner dies or becomes disabled with the result that the listed DBE contractor is unable to complete its work on the contract;
- (10) Other documented good cause that compels the termination of the DBE subcontractor. Provided, that good cause does not exist if the prime Contractor seeks to terminate a DBE it relied upon to obtain the contract so that the prime Contractor can self-perform the work for which the DBE contractor was engaged or so that the prime Contractor can substitute another DBE or non-DBE contractor after contract award.

When a DBE is terminated, or fails to complete its work on the contract for any reason the Contractor shall make a good faith effort to find another DBE to substitute for the original DBE to perform at least the same amount of work under the contract as the terminated DBE to the extent needed to meet the established contract goal.

- (f) **PAYMENT RECORDS.** The Contractor shall maintain a record of payments for work performed to the DBE participants. The records shall be made available to the Department for inspection upon request. After the performance of the final item of work or delivery of material by a DBE and final payment therefore to the DBE by the Contractor, but not later than thirty calendar days after payment has been made by the Department to the Contractor for such work or material, the Contractor shall submit a DBE Payment Agreement on Department form SBE 2115 to the Regional Engineer. If full and final payment has not been made to the DBE, the DBE Payment Agreement shall indicate whether a disagreement as to the payment required exists between the Contractor and the DBE or if the Contractor believes that the work has not been satisfactorily completed. If the Contractor does not have the full amount of work indicated in the Utilization Plan performed by the DBE companies indicated in the Utilization Plan and after good faith efforts are reviewed, the Department may deduct from contract payments to the Contractor the amount of the goal not achieved as liquidated and ascertained damages. The Contractor may request an administrative reconsideration of any amount deducted as damages pursuant to subsection (h) of this part.
- (g) **ENFORCEMENT.** The Department reserves the right to withhold payment to the Contractor to enforce the provisions of this Special Provision. Final payment shall not be made on the contract until such time as the Contractor submits sufficient documentation demonstrating achievement of the goal in accordance with this Special Provision or after liquidated damages have been determined and collected.
- (h) **RECONSIDERATION.** Notwithstanding any other provision of the contract, including but not limited to Article 50-17 of the Standard Specifications, the Contractor may request administrative reconsideration of a decision to deduct the amount of the goal not achieved as liquidated damages. A request to reconsider shall be delivered to the Contract Compliance Section and shall be handled and considered in the same manner as set forth in paragraph (c) of "Good Faith Effort Procedures" of this Special Provision, except a final decision that a good faith effort was not made during contract performance to achieve the goal agreed to in the Utilization Plan shall be the final administrative decision of the Department.

## **SPECIAL PROVISION FOR SUBCONTRACTOR MOBILIZATION PAYMENTS**

**Revised: April 1, 2011**

To account for the preparatory work and the operations necessary for the movement of subcontractor personnel, equipment, supplies, and incidentals to the project site and for all other work or operations that must be performed or costs incurred when beginning work approved for subcontracting according to Section 80-01 of the Standard Specifications, the Contractor shall make a mobilization payment to each subcontractor.

This mobilization payment shall be made at least 14 days prior to the subcontractor starting work. The amount paid shall be equal to 3 percent of the amount of the subcontract reported on form AER 260A submitted for the approval of the subcontractor's work.

The mobilization payment to the subcontractor is an advance payment of the reported amount of the subcontract and is not a payment in addition to the amount of the subcontract; therefore, the amount of the advance payment will be deducted from future progress payments.

This provision shall be incorporated directly or by reference into each subcontract approved by the Department

## **SPECIAL PROVISION FOR PAYMENTS TO SUBCONTRACTORS**

**Revised: January 1, 2006**

Federal regulations found at 49 CFR §26.29 mandate the Department to establish a contract clause to require Contractors to pay subcontractors for satisfactory performance of their subcontracts and to set the time for such payments.

State law also addresses the timing of payments to be made to subcontractors and material suppliers. Section 7 of the Prompt Payment Act, 30 ILCS 540/7, requires that when a Contractor receives any payment from the Department, the Contractor shall make corresponding, proportional payments to each subcontractor and material supplier performing work or supplying material within 15 calendar days after receipt of the Department payment. Section 7 of the Act further provides that interest in the amount of two percent per month, in addition to the payment due, shall be paid to any subcontractor or material supplier by the Contractor if the payment required by the Act is withheld or delayed without reasonable cause. The Act also provides that the time for payment required and the calculation of any interest due applies to transactions between subcontractors and lower-tier subcontractors and material suppliers throughout the contracting chain.

This Special Provision establishes the required federal contract clause, and adopts the 15 calendar day requirement of the State Prompt Payment Act for purposes of compliance with the federal regulation regarding payments to subcontractors. This contract is subject to the following payment obligations.

When progress payments are made to the Contractor according to Article 90-07 of the Standard Specifications, the Contractor shall make a corresponding payment to each subcontractor and material supplier in proportion to the work satisfactorily completed by each subcontractor and for the material supplied to perform any work of the contract. The proportionate amount of partial payment due to

each subcontractor and material supplier throughout the contracting chain shall be determined by the quantities measured or otherwise determined as eligible for payment by the Department and included in the progress payment to the Contractor. Subcontractors and material suppliers shall be paid by the Contractor within 15 calendar days after the receipt of payment from the Department. The Contractor shall not hold retainage from the subcontractors. These obligations shall also apply to any payments made by subcontractors and material suppliers to their subcontractors and material suppliers; and to all payments made to lower tier subcontractors and material suppliers throughout the contracting chain. Any payment or portion of a payment subject to this provision may only be withheld from the subcontractor or material supplier to whom it is due for reasonable cause.

This Special Provision does not create any rights in favor of any subcontractor or material supplier against the State or authorize any cause of action against the State on account of any payment, nonpayment, delayed payment, or interest claimed by application of the State Prompt Payment Act. The Department will not approve any delay or postponement of the 15 day requirement except for reasonable cause shown after notice and hearing pursuant to Section 7(b) of the State Prompt Payment Act. State law creates other and additional remedies available to any subcontractor or material supplier, regardless of tier, who has not been paid for work properly performed or material furnished. These remedies are a lien against public funds set forth in Section 23(c) of the Mechanics Lien Act, 770 ILCS 60/23(c), and a recovery on the Contractor's payment bond according to the Public Construction Bond Act, 30 ILCS 550.

## **SPECIAL PROVISION FOR ADDITIONAL STATE REQUIREMENTS FOR FEDERAL-AID CONSTRUCTION CONTRACTS**

**Effective: February 1, 1969**

**Revised: January 1, 2010**

### **EQUAL EMPLOYMENT OPPORTUNITY**

In the event of the Contractor's noncompliance with any provisions of this Equal Employment Opportunity Clause, the Illinois Fair Employment Practices Act or the Fair Employment Practices Commission's Rules and Regulations for Public Contracts, the Contractor may be declared nonresponsible and therefore ineligible for future contracts or subcontracts with the State of Illinois or any of its political subdivisions or municipal corporations, and the contract may be canceled or avoided in whole or in part, and such other sanctions or penalties may be imposed or remedies invoked as provided by statute or regulation.

During the performance of this contract, the Contractor agrees as follows:

- (1) That it will not discriminate against any employee or applicant for employment because of race, color, religion, sex, national origin or ancestry; and further that it will examine all job classifications to determine if minority persons or women are underutilized and will take appropriate affirmative action to rectify any such underutilization.
- (2) That, if it hires additional employees in order to perform this contract or any portion hereof, it will determine the availability (in accordance with the Commission's Rules and Regulations for Public Contracts) of minorities and women in the area(s) from which it may reasonably recruit and it will hire for each job classification for which employees are hired in such a way that minorities and women are not underutilized.
- (3) That, in all solicitations or advertisements for employees placed by it or on its behalf, it will state that all applicants will be afforded equal opportunity without discrimination because of race, color, religion, sex, national origin or ancestry.
- (4) That it will send to each labor organization or representative of workers with which it has or is bound by a collective bargaining or other agreement or understanding, a notice advising such labor organization or representative of the Contractor's obligations under the Illinois Fair Employment Practices Act and the Commission's Rules and Regulations for Public Contracts. If any such labor organization or representative fails or refuses to cooperate with the Contractor in its efforts to comply with such Act and Rules and Regulations, the Contractor will promptly so notify the Illinois Fair Employment Practices Commission and the contracting agency and will recruit employees from other sources when necessary to fulfill its obligations thereunder.
- (5) That it will submit reports as required by the Illinois Fair Employment Practices Commission's Rules and Regulations for Public Contracts, furnish all relevant information as may from time to time be requested by the Commission or the contracting agency, and in all respects comply with the Illinois Fair Employment Practices Act and the Commission's Rules and Regulations for Public Contracts.
- (6) That it will permit access to all relevant books, records, accounts and work sites by personnel of the contracting agency and the Illinois Fair Employment Practices Commission for purposes of investigation to ascertain compliance with the Illinois Fair Employment Practices Act and the Commission's Rules and Regulations for Public Contracts.
- (7) That it will include verbatim or by reference the provisions of paragraphs 1 through 7 of this clause in every performance subcontract as defined in Section 2.10(b) of the Commission's Rules and Regulations for Public Contracts so that such provisions will be binding upon every subcontractor; and that it will also so include the provisions of paragraphs 1, 5, 6 and 7 in every supply subcontract as defined in Section 2.10(a) of the Commission's Rules and Regulations for Public Contracts so that such provisions will be binding upon every such subcontractor. In the same manner as with other provisions of this contract, the Contractor will be liable for compliance with applicable provisions of this clause by all its subcontractors; and further it will promptly notify the contracting agency and the Illinois Fair Employment Practices Commission in the event any subcontractor fails or refuses to comply therewith. In addition, no Contractor will utilize any subcontractor declared by the Commission to be nonresponsible and therefore ineligible for contracts or subcontracts with the State of Illinois or any of its political subdivisions or municipal corporations.



## **SPECIAL PROVISION FOR NPDES CERTIFICATION**

In accordance with the provisions of the Illinois Environmental Protection Act, the Illinois Pollution Control Board Rules and Regulations (35 Ill. Adm. Code, Subtitle C, Chapter I), and the Clean Water Act, and the regulations thereunder, this certification is required for all construction contracts that will result in the disturbance of one or more acres total land area.

The bidder certifies under penalty of law that he/she understands the terms and conditions of the general National Pollutant Discharge Elimination System (NPDES) permit (ILR100000) that authorizes the storm water discharges associated with industrial activity from the construction site identified as part of this certification.

The Airport Owner or its Agent will:

- 1) prepare, sign and submit the Notice of Intent (NOI)
- 2) conduct site inspections and complete and file the inspection reports
- 3) submit Incidence of Non-Compliance (ION) forms
- 4) submit Notice of Termination (NOT) form

Prior to the issuance of the Notice-to-Proceed, for each erosion control measure identified in the Storm Water Pollution Prevention Plan, the contractor or subcontractor responsible for the control measure(s) must sign the above certification (forms to be provided by the Department).

SECTION 90 MEASUREMENT AND PAYMENT

This Special Provision amends the provisions of the Standard Specifications for Construction of Airports, adopted April 1, 2012 and shall be construed to be a part thereof, superseding any conflicting provisions thereof applicable to the work under the contract.

90-07 PARTIAL PAYMENTS.

DELETE: The entire section.

ADD: Partial payments will be made to the Contractor at least once each month as the work progresses. The payments will be based upon estimates, prepared by the Resident Engineer, of the value of the work performed and materials complete and in place in accordance with the contract, plans, and specifications. Such partial payments may also include the delivered actual cost of those materials stockpiled and stored in accordance with the Section 90-08 PAYMENT FOR MATERIALS ON HAND. From the amount of partial payment so determined, there shall be deducted an amount up to ten percent of the cost of the completed work which shall be retained until all conditions necessary for financial closeout of the project are satisfied. The amount of the estimate approved as due for payment will be vouchered by the Department and presented to the State Comptroller for payment. No amount less than \$1,000.00 will be approved for payment other than the final payment.

It is understood and agreed that the Contractor shall not be entitled to demand or receive partial payment based on quantities of work in excess of those provided in the proposal or covered by approved change orders, except when such excess quantities have been determined by the Engineer to be a part of the final quantity for the item of work in question.

No partial payment shall bind the Department to the acceptance of any materials or work in place as to quality or quantity. All partial payments are subject to correction at the time of final payment as provided in Section 90-09 ACCEPTANCE AND FINAL PAYMENT.

The failure to perform any requirement, obligation, or term of the contract by the Contractor shall be reason for withholding any progress payments until the Department determines that compliance has been achieved. Furthermore, progress payments may be reduced by liens filed pursuant to Section 23(c) of the Mechanics Lien Act, 770 ILCS 60/23(c).

In accordance with 49 USC § 47111, the Department will not make payments totaling more than 90 percent of the contract until all conditions necessary for financial closeout of the project are satisfied.

**GOVERNING SPECIFICATIONS AND RULES AND REGULATIONS**

The "Standard Specifications for Construction of Airports," adopted April 1, 2012, State of Illinois, Department of Transportation, Division of Aeronautics, shall govern the project except as otherwise noted in these Special Provisions. In cases of conflict with any part or parts of said specifications, the said Special Provisions shall take precedence and shall govern. When noted within the Special Provisions, the Illinois Department of Transportation "Standard Specifications for Road and Bridge Construction", Adopted January 1, 2012, shall also apply.

## **DIVISION I – GENERAL PROVISIONS**

### **SECTION 40 – SCOPE OF WORK**

#### **20-05 MAINTENANCE OF TRAFFIC**

ADD:

The Contractor shall be responsible for cleaning and maintaining all haul roads and use a pick-up type sweeper on all pavements and adjacent roadways utilized in hauling operations when material is tracked onto said pavement. **The Contractor shall have a sweeper on site and maintain all pavements clear of dirt and debris at all times or as requested by the Resident Engineer.** If the Contractor fails to comply with the Standard Specifications, Contract Plans or these Special Provisions concerning traffic control, the Resident Engineer shall execute such work as may be deemed necessary to correct deficiencies and the cost thereof shall be deducted from compensation due or which may become due the Contractor under the contract. The Contractor shall be responsible for supplying, maintaining and moving all barricades required for construction. The cost thereof shall not be paid for separately, but shall be considered incidental to the contract unit prices.

The Airport, following consultation with the Resident Engineer, will give proper notice to the nearest Flight Service Station and the Airways Facilities Chief of the Federal Aviation Administration prior to the beginning of construction. The Contractor shall furnish a flagger in radio control with the Air Traffic at any time the active taxiways or airfield pavement are crossed or used for a haul road. The Contractor shall supply his own radios. The cost thereof shall not be paid for separately, but shall be considered incidental to the contract unit prices.

#### **40-09 AIRPORT OPERATIONS DURING CONSTRUCTION**

ADD:

a. Construction Activity and Aircraft Movements

For construction activity to be performed in other areas than active operational areas, the storage and parking of equipment and materials, when not in use or about to be installed, shall not encroach upon active operational areas. In protecting operational areas, the minimum clearances maintained for runways shall be in conformance with Part 77 of the Federal Aviation Regulations.

All construction operations shall conform to the plans and in accordance with AC 150/5370-2 (Latest Edition) Operational Safety on Airports During Construction.

b. Limitations on Construction

- (1) Open flame welding or torch cutting operations shall be prohibited, unless adequate fire and safety precautions are provided.
- (2) Open trenches, excavations and stockpiled material near any pavements shall be prominently marked with red flags and lighted by light units during hours of restricted visibility and/or darkness.
- (3) Stockpiled material shall be constrained in a manner to prevent movement resulting from aircraft blast or wind conditions.

- (4) The use of explosives shall be prohibited.
- (5) Burning shall not be allowed.
- c. Debris

Waste and loose material capable of causing damage to aircraft landing gears, propellers, or being ingested in jet engines shall not be placed on active aircraft movement areas. Material tracked on these areas shall be removed continuously during the work project. The Contractor shall provide garbage cans in employee parking areas and storage areas for debris.

## **SECTION 50 – CONTROL OF WORK**

### **50-10 INSPECTION OF WORK**

ADD:

The Contractor shall provide portable flood lighting for nighttime construction. Sufficient units shall be provided so that work areas are illuminated to a level of five horizontal foot candles. The lighting levels shall be calculated and measured in accordance with the current standards of the Illumination Engineering Society. Lights shall be positioned so as not to interfere with Airport operations.

### **50-12 LOAD RESTRICTIONS**

ADD:

The Contractor shall obtain written permission from the Airport Owner to use any airfield pavements.

### **50-18 PLANS AND WORK DRAWINGS**

REVISE the fifth paragraph to read:

Shop drawings submitted by the Contractor for materials and/or equipment to be provided as a part of the contract shall be reviewed by the Project Engineer for substantial conformance of said materials and/or equipment, to contract requirements. Shop drawings shall be fully descriptive, complete and of sufficient detail for ready determination of compliance.

REVISE the last paragraph to read:

The following information shall be clearly marked on each shop, working, and layout drawing, catalog cut, pamphlet specifications sheet, etc., submitted.

## **SECTION 60 – CONTROL OF MATERIALS**

### **60-01 SOURCE OF SUPPLY AND QUALITY REQUIREMENTS**

ADD: After the last paragraph

The Contractor shall certify all materials contained in the contract. Certification documentation shall be submitted to the Engineer. It shall be the sole responsibility of the Contractor to ensure the delivery of adequate and accurate documentation prior to the delivery of the materials.

**If, upon delivery and incorporation of any materials, the Contractor has failed to provide the necessary submittals as required by Sections 50-18, 60-01, 60-03 and 60-12 of the Standard and Special Provisions, the pay item shall not be included on the Construction Progress Payment report until such submittals have been furnished.**

### **60-03 CERTIFICATION OF COMPLIANCE**

ADD:

Additional requirements are specified in Section 60-12 Certification of Materials.

### **60-11 REQUIRED CONTRACTOR TESTING**

ADD:

The Contractor shall be required to provide all material testing and associated certification of materials as outlined in Section 60-12 of these Special Provisions and in accordance with the Section 400.02 of the latest edition of the Illinois Department of Transportation, Division of Aeronautics "Manual for Documentation of Airport Materials", or as specified herein. Note any reference to testing and/or documentation being the responsibility of the Resident Engineer, Professional Engineer or Consultant shall be changed to the Contractor.

### **60-12 CERTIFICATION OF MATERIALS**

ADD:

The Contractor shall certify all materials incorporated into the contract. Certification documentation shall be submitted to the Resident Engineer. It shall be the **sole** responsibility of the Contractor to ensure the submittal of adequate and accurate documentation in order to satisfy the contract material certification requirements **prior** to the delivery of the materials. Materials without certification or those with certification that demonstrates the materials do not meet the requirements of the plans and specifications shall be considered nonconforming and subject to the provisions of Section 30-02.

As a guide to the certification process and requirements, the Contractor shall use the Illinois Department of Transportation/Division of Aeronautics MANUAL FOR DOCUMENTATION OF AIRPORT MATERIALS dated April 1, 2010 or latest edition including any addendums. Copies of this manual are available by contacting Mr. Mike Wilhelm-Division of Aeronautics at (217) 785-4282 or from their website at:

The cost of providing the required material documentation and certifications shall not be paid for separately, but shall be considered incidental to the associated item.

## **SECTION 70 – LEGAL RELATIONS AND RESPONSIBILITY TO PUBLIC**

### **70-17 CONTRACTOR'S RESPONSIBILITY FOR UTILITY SERVICE AND FACILITIES OF OTHERS**

ADD:

Special care shall be taken on all operations and particularly near pavement edges to avoid damage to edge lights and all underground electrical cable on the airport. The approximate location of known existing underground cable is shown on drawings. Any airfield lights or cable that are broken and require replacement because of the Contractor's operations will be replaced by the contractor at his own expense.

Any airfield cable repairs or replacement to any part of the electrical system made necessary by the Contractor's operations will be made by him in the manner specified in Sections 108 and 125 at no cost to the airport. Cost of replacement to be borne by the Contractor shall include any expense incurred in locating as well as repairing or replacing damaged parts of the system by the owning agency. Should the Contractor fail to respond to notification received from the Resident Engineer or his authorized representative to repair or replace damaged facilities within two hours, the Resident Engineer shall execute such work as may be deemed necessary to repair the damage, and the cost thereof shall be deducted from the compensation due or which may become due the Contractor under the contract.

**It shall be the Contractor's responsibility to locate and protect all airport-owned utilities within the construction limits.** This includes all electrical cables, storm sewer, drain tile, sanitary sewer and water main. **The contractor shall coordinate with Airport personnel prior to locating any Airport owned facilities.**

Special attention is necessary when working near FAA power and control cables. Any FAA utility that is damaged or cut during construction shall be repaired immediately. FAA requires that any damaged cable be replaced in its entirety, no splices will be permitted. No additional compensation will be made for replacement or repair of FAA facilities or cables but, shall be incidental to the contract. **The contractor shall coordinate with the FAA personnel listed in the table below prior to locating any FAA owned facilities.**

**SECTION 80 – PROSECUTION AND PROGRESS**

**80-03 NOTICE TO PROCEED**

ADD:

The Notice to Proceed will not be given until all materials are certified by the Contractor to be available and on hand and that the proposed materials meet the Buy American clauses of the Contract.

**80-05 LIMITATION OF OPERATIONS**

ADD:

The Contractor shall not have access to any part of the active airfield (runways or taxiways) for any equipment or personnel without approval of the Deputy Director of Operations and Maintenance. All operations shall conform to the approved construction activity plan and general notes.

**80-07 TEMPORARY SUSPENSION OF THE WORK**

REVISE the second paragraph to read:

In the event that the Contractor is ordered by the Engineer to suspend work for some unforeseen cause not otherwise provided for in the contract and over which the Contractor has no control, the Contractor may be reimbursed for actual money expended on the work during the period of shutdown. No allowance will be made for anticipated profits. The period of shutdown shall be computed from the effective date of the Engineer's order to suspend work to the effective date of the

Engineer's order to resume the work. Claims for such compensation shall be filed with the Resident Engineer within the time period stated in the Engineer's order to resume work. The Contractor shall submit with his/her claim information substantiating the amount shown on the claim. The Resident Engineer will forward the Contractor's claim to the Division for their consideration in accordance with local laws or ordinances. No provision of this article shall be construed as entitling the Contractor to compensation for delays due to inclement weather, for suspension made at the request of the Engineer, or for any other delay provided for in the contract, plans, or specifications.

#### **80-13 CONTRACTOR'S ACCESS TO AIRFIELD**

ADD:

The Contractor shall not have access to any part of the active airfield pavements (runways, aprons, or taxiways, and associated safety areas) for any equipment or personnel without the approval of the Airport. All access to active runway and taxiway pavements shall be coordinated with the Air Traffic Control Tower (ATCT). ***Access to the referenced pavements without ATCT approval may result in a determination of an airfield incursion with associated fines.***

Unattended construction access and unauthorized access to the airfield shall be fined in accordance with the fines noted in the plans in the construction phasing notes. Gate guards shall have mobile telephone communications at all times, and shall be required to provide a daily visitor log to the airport at the weekly coordination meetings.

***Gates used for Contractor access shall be padlocked using airport supplied locks. All padlocks and keys shall be issued by the airport after a \$50.00 deposit is made. Two (2) keys will be issued initially, with additional keys provided at \$3.00 / Each. Lost keys will result in fine of \$85.00, with additional costs to provide a new lock and keys.***

### **SECTION 90 – MEASUREMENT AND PAYMENT**

#### **90-05 PAYMENT FOR EXTRA AND FORCE ACCOUNT WORK**

ADD the following to subsection B.7. Statements:

All statements of the cost of force account work shall be furnished to the Engineer not later than 60 days after completion of the force account work. If the statement is not received within the specified time frame, all demands for payment for the extra work are waived and the Division, Airport Owner and Local Sponsor are released from any and all such demands. It is the responsibility of the Contractor to ensure that all statements are received within the specified time regardless of the manner or method of delivery.

## **DIVISION II – PAVING CONSTRUCTION DETAILS**

### **ITEM 151 – CLEARING AND GRUBBING**

#### **DESCRIPTION**

##### **151-1.1**

ADD:

Limits of clearing and grubbing shall be established by the Contractor as required for the construction and erection of the new 10-foot Class E Fence and gates in the alignment delineated in the Plans. Limits shall not exceed 10-feet either side of the new fence alignment. Limits shall be approved by the Resident Engineer prior to beginning work. Trees cleared under this item shall be removed from the site by the Contractor. No burning shall be allowed on Airport property.

#### **CONSTRUCTION METHODS**

##### **151-2.1 GENERAL**

REVISE 1<sup>st</sup> Sentence of Paragraph 1 to read:

The areas to be cleared and grubbed under this item shall be staked on the ground by the Contractor and approved by the Resident Engineer prior to beginning work.

ADD:

Burning of cleared trees and other materials shall not be allowed on Airport property.

##### **151-2.3 CLEARING AND GRUBBING**

REVISE 1<sup>st</sup> Sentence of Paragraph 1 to read:

In areas proposed by the Contractor and approved by the Resident Engineer to be cleared and grubbed, all stumps, roots, buried logs, brush and other unsatisfactory materials shall be removed.

ADD:

Subgrade materials required to fill holes and level areas at the completion of clearing and grubbing shall be provided by the Contractor at no additional cost to the contract. These materials shall be compacted in a manner acceptable to the Resident Engineer.

#### **METHOD OF MEASUREMENT**

##### **151-3.1**

DELETE: This Section.

ADD:

The quantities of clearing and grubbing as approved by the Resident Engineer shall be cited in terms of the number of acres or fractions thereof, of land specifically cleared and grubbed.

**BASIS OF PAYMENT**

**151-4.3**

ADD:

Payment will be made under:

**ITEM AR151450 CLEARING AND GRUBBING – PER ACRE.**

## **ITEM 152 – EXCAVATION AND EMBANKMENT**

### **DESCRIPTION**

#### **152-1.1**

ADD:

Excavation required for fence and gate post foundations, gate operator foundations, electrical conduit installation, wildlife deterrent barrier installation, construction of the concrete entrance pad or for any other excavation required during this project shall be considered incidental to the contract.

### **METHOD OF MEASUREMENT**

#### **152-3.1, 3.2 and 3.3**

DELETE: These Sections.

ADD:

Excavation required for fence and gate post foundations, gate operator foundations, electrical conduit installation, wildlife deterrent barrier installation, construction of the concrete entrance pad or for any other excavation required during this project shall be considered incidental to the contract.

### **BASIS OF PAYMENT**

#### **151-4.1, 4.2, 4.3 and 4.4**

DELETE: These Sections.

ADD:

Excavation required for fence and gate post foundations, gate operator foundations, electrical conduit installation, wildlife deterrent barrier installation, construction of the concrete entrance pad or for any other excavation required during this project shall be considered incidental to the contract.

## **ITEM 610 – STRUCTURAL PORTLAND CEMENT CONCRETE**

### **DESCRIPTION**

#### **610-1.1**

ADD:

This item shall consist of furnishing and installing structural concrete for fence and gate post foundations, gate operator foundations, concrete encased duct installation, and for the installation of an 8-inch thick concrete entrance pad of the dimensions shown in the plans.

### **MATERIALS**

#### **610-2.9 STEEL REINFORCEMENT**

REVISE:

Welded wire fabric shall be provided for the 8-inch thick concrete entrance pad in accordance with the plan details. The welded wire fabric shall provide a minimum of 0.05% area of steel in both directions and meet the requirements of AASHTO M 55, ASTM A 82 or ASTM A 185, plain type, flat stock only.

Steel reinforcement shall not be required for fence footings.

### **CONSTRUCTION METHODS**

#### **610-3.11 PLACING CONCRETE**

ADD:

Holes dug for fence and gate post foundations shall be to the depth and sizes indicated on the plans or as required by the manufacturer. The Resident Engineer shall be given the opportunity to inspect fence footings prior to concrete placement. Footings found to be insufficient in either depth or diameter shall be corrected prior to concrete placement.

Subgrade prepared for the 8-inch thick concrete entrance pad shall be compacted to the satisfaction of the Resident Engineer and shall not be soft or yielding. A 4-inch layer of asphalt millings shall be spread and compacted to the satisfaction of the Resident Engineer prior to concrete placement. Acceptable methods of compaction shall include tamping with a walk behind compactor. The millings will be provided by the Airport from a stockpile on Airport property, and hauled to the work site by the Contractor. At the discretion of the Resident Engineer, base course materials comprising the in-place aggregate roadway may be used as subbase materials.

#### **610-3.19 FILLING JOINTS**

ADD:

Joints shall be cut to the dimensions indicated on the plan drawings. After the joints have been cleaned and dried in accordance with the joint filler manufacturer's requirements, the joints shall be filled and sealed with materials meeting the requirements of Section 605-2.2, 605-2.3 and 605-2.4.



## METHOD OF MEASUREMENT

### 610-4.3

ADD:

The quantities of structural Portland Cement Concrete used for fence and gate post foundations, gate operator foundations, concrete encasement for in-ground duct or for any other incidental concrete work shall not be measured for payment but shall be considered incidental to the associated pay items.

### 610-4.4

ADD:

The quantities of structural Portland Cement Concrete used for construction of the 8-inch concrete entrance pad shall be measured by the cubic yard or portion thereof actually placed, except for that portion that exceeds the plan dimensions shown in the plans unless so ordered by the Resident Engineer.

Welded wire fabric steel reinforcement shall not be measured for payment but shall be considered incidental to the concrete entrance pad.

Joint sawing and sealing shall not be measured for payment, but shall be considered incidental to the concrete entrance pad.

### 610-4.5

ADD:

Excavation required for the installation of the fence and gate post foundations, gate operator foundations, concrete entrance pad or any other incidental concrete construction shall not be measured for payment, but shall be considered incidental to the associated pay items. Excess materials shall be hauled off site or stockpiled on Airport property at a location to be designated by the Airport at no additional cost to the contract. Backfilling along edges of exposed concrete shall be considered incidental.

## BASIS OF PAYMENT

### 610-5.2

ADD:

Payment shall be made at the contract unit price per cubic yard for Structural PC Concrete placed to construct the concrete entrance pad. These prices shall be full compensation for furnishing all materials and for all excavation, subgrade preparation and subbase preparation using Airport furnished subbase materials, steel reinforcement and joint sawing and sealing, hauling and placement of the materials, and for all labor, equipment, tools, and incidentals necessary to complete the item.

No direct payment shall be made for excavation required for the placement of any Structural PC Concrete, be it excavation for fence and gate post foundations, gate operator foundations, direct bury or concrete encased duct installation, concrete entrance pad construction, or any other incidental concrete installation. Excavation and subgrade preparation shall be considered incidental to the contract unit prices for the respective pay items requiring excavation.

Subbase preparation using asphalt millings furnished from a stockpile on Airport property shall not be paid for directly, but shall be considered incidental to the construction of the concrete entrance pad.

No direct payment shall be made for steel reinforcement or for joint sawing and sealing. Steel reinforcement and joint sawing and sealing shall be considered incidental to the construction of the concrete entrance pad.

Structural PC concrete used for any other purpose on this project shall not be paid for, but shall be considered incidental to the associated pay items.

## DIVISION III – FENCING

### ITEM 162 – CHAIN-LINK FENCES

#### DESCRIPTION

##### 162-1.1

ADD:

Existing fencing materials may be used at the Contractor's discretion as temporary fencing to provide a fully secured perimeter to the Airport. Existing 6-foot and 8-foot fencing materials shall **not** be incorporated into the new installation but may be used when connecting existing fence to the new fence. Temporary fence panels, with pre-approval of the Resident Engineer, may be used to provide a secured perimeter where it is not feasible to use the existing fence materials.

A portion of fence shall be relocated by the Contractor. Fence to be relocated shall be installed at locations directed by the Resident Engineer. Ten percent of the length of fencing to be reused has been added to the length of new materials to be furnished by the Contractor in the event the fencing is damaged or unsalvageable. The Contractor shall inspect the materials to be reused prior to ordering new materials to ensure the proper length of new fencing is appropriated for this project.

Vinyl coated fence shall be installed from the UPS Generator Building to the Kaney Jet Center along Airport Drive, as denoted in the plans. Gates within the limits of the vinyl coated fence shall be vinyl coated.

Additive Alternate 1 is the removal and replacement of 6-foot Class E chain link fence with top rail and three strands barbed wire and gates of various types and sizes with new 10-foot Class E chain link fence with top rail and three strands barbed wire and 10-foot high gates of various types and sizes from the UPS main entrance gate to UPS Generator building and the area surrounding the City of Rockford Well and Pump House located off of Old Cessna Drive and South Cargo Road. In addition, wildlife deterrent barrier shall be installed at the locations noted in the plans. The barrier shall be installed in a manner such that no part of the barrier extends off of Airport property or encroaches on the Right-of-Way limits of adjoining roadways.

Additive Alternate 2 is the removal and replacement of 6-foot Class E chain link fence with top rail and three strands barbed wire and gates of various types and sizes with new 10-foot Class E chain link fence with top rail and three strands barbed wire and 10-foot high gates of various types and sizes along Falcon Road from the east side of the Kaney Jet Center to just south of Avionics Place.

Electrical gate installation shall be as detailed in the plans for each specific gate location. Electrical Gate installation shall include new gate operator, new disconnect, loop detectors, dual height gooseneck stands with two card readers per stand, power cable/conduit and all the required materials to install the electric gate as detailed in the plans. Access control system upgrades shall be as detailed in item AR800849.

#### MATERIALS

##### 162-2.1 FABRIC

ADD:

Vinyl coated fence fabric shall be installed at select locations. The color of the vinyl coating shall be selected by the Airport. The Contractor shall provide to the Airport the set of color choices available.

Fabric for wildlife deterrent barrier shall match the fabric of the adjoining fence except that it shall not be required to be vinyl coated.

### **162-2.3 FENCE POSTS, POST TOPS AND EXTENSIONS, RAILS, GATES, BRACES, STRETCHER BARS AND CLIPS**

ADD:

Posts for 10-foot chain link fence shall conform to the minimum dimensions and weights given in Federal Specification RR-F-191/3, Latest Edition. The Contractor shall supply a table listing the minimum requirements for posts in comparison to the sizes and weights of posts he proposes to use for verification purposes during shop drawing and material certification reviews. The table shall include information for all line posts, pull/terminal posts and gate posts.

ADD to Section C, Subsection 1, Slide Gates:

Gates shall be sliding type, complete with latches, stops, keepers, hinges, rollers and roller tracks, and three strands of barbed wire above the fabric. Gate posts shall consist of galvanized steel pipe of the size recommended by the gate manufacturer. The fabric shall be of the same type material as used in the fence. Gates with vinyl coated fence fabric shall use vinyl coated gate posts and the color of the gate frame shall match the color of the vinyl coated fence fabric. The gates shall be to the dimensions as shown on the plans.

Cantilever slide gates shall be constructed so as to extend across the opening specified. The height of the gates shall be identical to the fence adjacent to the gate. Gates shall be "Fortress" gates, as manufactured by Tymetal Corporation, or equivalent. The sag and deflection of the slide gates shall not exceed the values presented in ASTM F 1184, Type II, Class 2.

The gate shall be fabricated from aluminum alloy extrusions. The gate frame shall be reinforced or post-tensioned with galvanized tubular steel running through the full length of the top and bottom primary members. The primary members shall be oversized rectangular members, top member nominally 3" by 5", bottom member nominally 2" by 5". Vertical members at the ends of the frame and at 2' centers, end to end, shall be square, not less than 1" by 1". Spacing of vertical members shall be no greater than half the height of the gate frame. Diagonal bracing shall be installed to further stabilize the gate frame. Gate frames shall be modular sections.

The gate frame shall have a separate semi-enclosed top track of extruded aluminum alloy, which becomes an integral part of, and forms a composite structure with, the top of the gate frame. This gate frame shall be supported by two self-aligning, 4-wheel, sealed lubricant, ball bearing truck assemblies riding in the semi-enclosed track. The bottom of the support posts shall be equipped with two pairs of rubber guide wheels.

The slide gates shall be equipped with a standard latch assembly consisting of post mount catcher and a frame-mounted yoke. A mating eyelet on the catcher yoke and the frame yoke intended for a padlock to secure the gate shall be included.

The rear of the gate shall be supported in the open position.

### **162-2.6 MISCELLANEOUS FITTINGS AND HARDWARE**

ADD:

Barbed wire support arms shall withstand a minimum load of 250 pounds applied vertically to the outermost end of the arm.

### **162-2.10 SIGNS**

ADD:

The Airport shall supply the Contractor with the gate identification number to be used in the manufacture of the gate identification signs.

Signs attached to the existing fence shall be removed and reinstalled, except gate identification, warning signs and Restricted Area signage, which shall be furnished new per the plan details.

### **162-2.11 ELECTRIC GATE DRIVE**

ADD:

The Electrical Gate Drive System shall consist of the following:

- Sliding gate, size as shown on the plans
- One hydraulic gate operator
- One time delay
- Inherent and external obstruction sensing equipment
- Four (4) card readers per gate
- Two double gooseneck stands per gate
- Weatherproof GFCI 120V receptacle
- NEMA 3R Disconnect, voltage and size to match existing power requirements
- Concrete foundation for gate driver
- Concrete foundation for gooseneck stands
- Vehicular Barriers
- Two detector loops (Inside & Outside Safety Loops)
- Radio controller with transmitters

### **GATE DRIVER**

The new gate operator shall be designed for continuous operation and shall be capable of actuating roller type gates. Primary power for the operator shall be to match with existing power at each location. Contractor shall field verify the voltage. Motor shall be rated 1 HP. The control circuit shall be 24VDC with pre-wired terminal strip for field connection of control devices. All electrical components shall be U.L. or C.S.A. listed. The hydraulic system shall be self-contained and shall consist of electric motor, pump, reservoir, Heater, hydraulic motors and 4-way control valve. The motor shall be totally enclosed and of the high-starting torque, continuous-duty, industrial type, protected against overload by either a thermal or current sensing overload device. Motor control shall be by means of an across-the-line, mechanically interlocked reversing contactor. Unit shall also have an enclosed on/off power switch for convenience in servicing. The gate shall have an aluminum drive rail rigidly attached its entire length. The rail shall be friction fed through spring loaded drive wheels. The gate travel shall be limited by drive rail mounted switches and come which read the time position of the gate. The use of chains, belts, sprockets or pulleys and clutches shall not be allowed. The new gate drive shall provide for instant reversal of the gate travel direction without reversal of the electric motor rotation. Driver shall also be capable of driving the gate regardless of snow, ice or moisture on drive rail. Driver shall have a built in manual release that shall disengage the drive wheels to allow manual sliding of the gate in case of power or mechanical failure. The operator housing shall be constructed of high quality steel. It shall be weather resistant and durable and shall be finished with corrosion resistant primer and two enamel top coats for maximum protection. Gate driver shall have internal 208V or 480V - 120V transformer for 120V feed to GFCI receptacle. Transformer shall be 500VA minimum. The operator shall be controlled by

radio transmitter, detector loops and any other items and detailed on the plans or specified herein.

It shall be the contractor's responsibility to verify compatibility of all equipment with the gate driver.

The new gate driver shall be Model #222-EX with a travel speed of 2 feet/second as manufactured by Hy-Security or equal.

Mounting - unit shall be mounted on a concrete footing.

The operator shall be controlled by access control system card readers, external obstruction sensing equipment, detector loops, ten (10) remote openers and any other items and detailed on the plans or specified herein. It shall be the Contractor's responsibility to verify compatibility of all equipment with the gate driver.

#### **LOCAL MANUAL DISCONNECT**

The manual disconnect shall be mounted on unistrut or to the gate operator enclosure as shown on the plans. Disconnect shall be Model DU321RB rated 30A, 3 Pole at 240VAC or as to match with existing system voltage. Disconnect shall be as manufactured by Square D or equal.

#### **CONVENIENCE RECEPTACLE**

Contractor shall mount duplex, waterproof, GFCI receptacle on electric gate operator as directed by Engineer. Install a 208V or 480V – 120V transformer as required. All necessary hardware shall be incidental.

#### **CARD READER**

New card readers shall be Indala Keypad Card Readers Model number FP5071B by Assa Alboj or equal. Two card readers shall be installed on the double gooseneck stand as detailed on the plans or as recommended by the manufacturer. The new gooseneck stand shall be installed with weather housing for the card readers.

#### **Detector Loops.**

Two detector loops shall be installed in the pavement as shown on the plans. One detector loop shall be installed in the pavement inside of the gate as detailed in the plans and the safety of the vehicles entering the airport. The other detector loop shall be installed in the pavement outside the gate and shall be used as a safety loop that stops the gate from closing while a vehicle is still in its path.

#### **ELECTRICAL WIRING**

Electrical wiring shall consist of all wiring necessary to properly operate the motorized gate as recommended by the manufacturer or as directed by and to the satisfaction of the Engineer. Conductors and conduits required for power to the gate operators as shown on the plans are included in this item.

## CONSTRUCTION METHODS

### 162-3.1 CLEARING FENCE LINE

ADD:

The area to be cleared and grubbed shall be delineated by the Contractor and approved by the Resident Engineer prior to commencing the work, in accordance with Item 151, Clearing and Grubbing.

### 162-3.5 INSTALLING FABRIC

REVISE: Subsection C, second sentence, to read: The fastenings shall **not** be spaced more than 14 inches on centers for line posts.

ADD:

At locations of small natural swales or drainage ditches and where it is not practical to have the fence conform to the general contour of the ground surface, longer posts may be used and multiple strands of barbed wire stretched thereon to span the opening below the fence. The vertical clearance between strands of barbed wire shall be 12 inches or less.

Where new fence is installed within 10-feet of the existing fence line, the existing fence fabric shall be removed the same day the new fabric is installed.

### 162-3.8 INSTALLING GATES

ADD:

The Contractor shall install the proposed gates at the locations shown in the plans or as required by the Airport. Gates shall be installed to conform to manufacturer's recommendations and the details shown in the plans.

Gate installation shall include erection of the posts, fence, gate and warning and identifications signs required to provide a complete operating installation satisfactory to the owner. Signs on the existing gates other than gate identification and warning signs shall be removed from the existing gate and reinstalled on the new gate.

### 162-3.9 EXISTING FENCE CONNECTIONS

ADD:

Where new fence and existing fence meet, a new terminal or end post shall be installed and the new and existing fence shall be connected to the new corner post. A brace shall be required in both the new and existing fence. Connections between new and existing fence shall be considered incidental to the contract.

### 162-3.11 FENCE AND GATE REMOVAL

ADD:

This work shall consist of the removal and disposal of the existing 6-foot, 8-foot and 6-foot to 10-foot transition, Class E airport security perimeter fence. The fence shall be completely removed including fabric, posts, top rail, miscellaneous fittings and hardware, barbed wire, tension wire and concrete foundations. At the discretion of the Airport, the removed material shall become the property of the Airport and be delivered by the Contractor to a location specified by the Airport Maintenance and

Operations staff. Should the Airport decline ownership of the removed materials, the Contractor shall dispose of the material off Airport property.

The fence posts in turf shall be pulled, including foundations, and not cut off.

All holes shall be filled and compacted with material generated as a part of the holes for the new fence post excavation. At the Contractor's option, offsite borrow material may be supplied at no additional cost to the contract.

Existing posts located in concrete or asphalt shall be removed in accordance with the details in the plans.

The fence removal shall include removal of all gates present in the fence line. Payment for removal of the gates shall be measured by the unit removed for each gate.

All gates shall be removed and turned over to the Airport at a location on Airport property unless the Airport declines ownership of the removed materials, in which case they shall become the property of the Contractor and disposed of off site.

Removal of the existing chain link fence includes removal of all fence posts. No distinction of post diameter will be made for payment purposes. The Contractor shall examine the site prior to submitting a proposal.

#### **162-3.12 FENCE AND GATE RELOCATION**

REPLACE this section with the following:

At the locations shown in the plans, the existing 10-foot fence shall be removed and reused. Portions of this fence may be removed by the Airport, either prior to or during construction. Those portions of fence removed by the Airport will be made available to the Contractor at a storage location on Airport property. No additional payment shall be made for relocating fence previously removed by the Airport, i.e., the payment to relocate fence from storage or from the site shall be the same.

The existing 10-foot fence to be removed and reused was installed without concrete foundations.

At a minimum, the Contractor shall salvage all line posts, post caps, chain link fence fabric, top rail, tension wire, barbed wire and barb arms, and braces. When possible, existing nuts and bolts shall be reused. Tie wire or clips required to fasten the chain link fence fabric to the top rail, posts and tension wire shall not be reused and shall be furnished new. End/pull posts shall be furnished new, incidental to the fence relocation.

The Resident Engineer shall determine where the relocated fence will be installed in the proposed fenceline.

#### **162-3.13 BARBED WIRE**

Three strands of barbed wire shall be installed above all fence and gates, except Type A fence and gates, and be secured to the posts.

#### **162-3.14 SECURITY AND MAINTAINING THE EXISTING AIRPORT PERIMETER FENCE LINE**

The Contractor shall maintain a continuous perimeter fence throughout the length of his work area in any manner he sees fit. In areas where new fence will replace existing security fence at the same location, temporary fence or guards shall be used to prevent unauthorized persons from entering the airfield. Existing fencing materials removed as part of the contract may be used as temporary fence.



In locations where it is not feasible to use the existing fencing materials as temporary fencing, the Contractor shall provide temporary fence panels, 8-foot high minimum. The fence panels shall be supported on moveable bases that shall be weighted and the panels tied together to prevent dislocation by wind or persons attempting unauthorized access to the airfield. The Resident Engineer shall approve the use of temporary fencing materials provided by the Contractor prior to the delivery and erection of the materials.

In areas where the new fence will be installed with 10-feet of the existing fence, at a minimum, the existing fence fabric shall be removed within eight (8) hours of the new fabric being installed. This requirement is to assist in ensuring unauthorized personnel cannot take advantage of the double fenceline by sliding boards through the fence fabric to assist in scaling the fence.

### **162-3.15 CONTRACTOR'S RESPONSIBILITY FOR UTILITY LOCATING**

The location of known underground utilities is presented on the plans.

It shall be the Contractor's responsibility to determine the actual location of all utilities, including service connections to underground utilities. Prior to construction, the Contractor shall contact JULIE, FAA and Airport Maintenance. Prior to construction, the Contractor shall notify all utility companies of his operational plans. The Contractor shall make arrangements for detailed information and assistance in locating utilities. In the event an unexpected utility interference is encountered during construction, the Contractor shall immediately notify the utility company, the Owner and the Resident Engineer. Any such mains and/or services disturbed by the Contractor's operations shall be restored immediately at his expense to the satisfaction of the Owner and the Engineer.

The Contractor shall be responsible for keeping the owner advised of this plan of operations. Prior to commencing work in the general vicinity of an existing utility service or facility, the Contractor shall notify the owner of his plan of operation.

### **METHOD OF MEASUREMENT**

#### **162-4.5**

ADD:

Class E Gate Removals shall be counted per each gate removed, regardless of type, width or height of gate removed. For the purpose of this project, a gate shall be counted as one removal, regardless of the number of leaves or sliding gates used to secure the opening. For instance, a double swing or double slide gate shall be counted as a single gate removal.

Electric Gate Removals shall be counted per the number of electrically operated gates removed. In instances where more than one gate is used to span the gate opening, the number of electric gate removals counted shall be per the number of gate operators removed. For instance, in a double slide gate installation with only one gate being operated, both gates and the operator shall be removed and measured as a single electric gate removal. If both gates are operated by independent gate operators, both gates and operators shall be removed and counted. Card readers, conduit and cabling and other incidental removals at each gate location shall be as detailed in the plans and shall not be measured separately.

#### ADD: **162-4.6**

Wildlife Deterrent Barrier shall be measured by the linear foot, in-place and accepted by the Engineer.

ADD: 162-4.7

The labor and materials used to erect temporary fence using the existing fencing materials in order to maintain a secured perimeter shall not be measured for payment, but shall be considered incidental to the fencing items.

The use of security forces to guard gaps in the perimeter fence to prevent unauthorized access to the airfield shall not be measured for payment, but shall be considered incidental to the fencing items.

The use of temporary fence panels used to provide a continuous perimeter fence shall be pre-approved by the Resident Engineer and shall be measured by the linear foot from outside of post to outside of post.

### BASIS OF PAYMENT

162-5.1

DELETE entire Section and REPLACE with:

Payment will be made at the contract unit price per linear foot for Class E Fence 10' with three strands of barbed wire. This price shall be full compensation for furnishing all materials and for all preparation, erection, and installation of these materials, and for all labor, equipment, tools, and incidentals necessary to complete the item.

Payment will be made at the contract unit price per linear foot for Class E Fence, Vinyl-10' with three strands of barbed wire. This price shall be full compensation for furnishing all materials and for all preparation, erection, and installation of these materials, and for all labor, equipment, tools, and incidentals necessary to complete the item.

Connections between the existing fence to remain and the new fence shall be considered incidental to the new fencing items and shall not be included for payment.

Payment will be made at the contract unit price per each for Class E Gate. This price shall be full compensation for furnishing all materials and for all preparation, erection, and installation of these materials, and for all labor, equipment, tools, and incidentals necessary to complete the item. No distinction shall be made for payment purposes for gates using multiple leaves to secure the gate opening.

Payment will be made at the contract unit price per each for Electric Gate. This price shall be full compensation for furnishing all materials and for all preparation, erection, and installation of these materials, and for all labor, equipment, tools, and incidentals necessary to complete the item. No distinction shall be made for payment purposes for gates using multiple leaves to secure the gate opening. Coating for electric gates to be vinyl coated as delineated in the plans shall be incidental to the electric gate installation and no separate payment shall be made. The requirements and incidentals for each electric gate installation shall be per the plan details. This price will include furnishing and installation of new electric gate operator, new disconnect, new gooseneck stand, detector loops, circuit breakers in MCC and power panels, cable/conduit for power at each and all components of the electric gate as detailed on the plans. ALL power conduits and conductors as shown on the plans are incidental to the pay item for each gate.

162-5.2

DELETE: This Section and REPLACE with:

Payment will be made at the contract unit price for Relocate Class E Fence. This price shall be full compensation for the removal and salvage of the existing fence, hauling the salvaged material to the proposed installation site, furnishing new end/pull posts as required, wire ties and clips and other miscellaneous fittings and hardware required for a complete fence installation that cannot be salvaged from the existing fenceline and for all preparation, erection, and installation of these and the salvaged materials and for all labor, equipment, tools, and incidentals necessary to complete the item.

Fence to be relocated that is damaged due to Contractor negligence shall be replaced with new 10-foot Class E Fence meeting the requirements of these Specifications and shall not be included for payment.

**162-5.3**

ADD:

No distinction will be made between heights of removed fence for payment purposes.

**162-5.5**

DELETE: Entire Section.

ADD:

Payment shall be made at the contract unit price per each for Remove Class E Gate, regardless of type, width or height of gate or number of leaves removed at each gate opening. This price shall be full compensation for all removals, restoration, including grading, backfilling, seeding and mulching, and disposal, and for all labor, equipment, tools, and incidentals necessary to complete this item.

Payment shall be made at the contract unit price per each for Remove Electric Gate. This price shall be full compensation for all removals as detailed in the plans, restoration, including grading, backfilling, seeding and mulching, and disposal, and for all labor, equipment, tools, and incidentals necessary to complete this item.

ADD: **162-5.6**

Payment shall be made at the contract unit price per linear foot for Wildlife Deterrent Barrier. This price shall be full compensation for furnishing all materials and for all preparation, excavation and backfill, erection, and installation of these materials, and for all labor, equipment, tools, and incidentals necessary to complete the item. Seeding and mulching of the disturbed area shall be paid under Items 901 Seeding and 908 Mulching.

ADD: **162-5.7**

Payment will be made at the contract unit price per linear foot for Temporary Construction Fence when the use of temporary fence panels is approved by the Resident Engineer. This price shall be full compensation for furnishing all materials and for all preparation and erection of these materials, and for all labor, equipment, tools and incidentals necessary to complete the item. Payment shall also include the removal of the temporary fencing materials when the new fenceline has been established.

The use of security forces in order to maintain a secured perimeter shall not be paid for directly, but shall be considered incidental to the fencing items. The use of existing fence materials as temporary fencing shall not be paid for directly but shall be considered incidental to the fencing items.

#### CONSTRUCTION METHODS

##### 901-3.2 DRY APPLICATION METHOD

(a) Description: This work shall consist of furnishing, transporting and installing all seeds, plant or other materials required for:

1. Any remedial operations in conformance with the plans as specified in these Special Provisions or as directed by the Engineer.

(b) General Requirements: The site will be in the following condition:

1. The grade will be shaped to the elevation shown in the plans or to drain when no grades are given.
2. The topsoil will be free of clods, stones, roots, sticks, rivulets, gullies, crusting, caking and have a soil particle size of no larger than 1".

- (c) Seeding Equipment: Seeding equipment shall meet the following requirements. Any other equipment deemed necessary shall be subject to the approval of the Engineer.
1. Disc: Any disc new for the use shall be in a good state of repair with sound, unbroken blades. The disc shall be weighted if necessary to achieve the required tillage depth.
  2. No-Till Planters and Drills: Rangeland type drills and no-till planters shall be designed specifically for the seeding of native grasses and forbs with depth control bands set at 1/4" to 1/8".
  3. Seedbed Preparation: Seedbed preparation methods shall be approved by the Engineer. Cultivation shall be accomplished at such a time that seeding may occur immediately and without delay. No seeds shall be sown until the seedbed has been approved by the Engineer.
- (d) Seeding Methods: The Contractor shall submit for approval by the Engineer a schedule for seeding and/or planting at least two weeks prior to the scheduled commencement of work. Broadcast seeders will not be allowed. Seeder will be a drill type planter. The Engineer shall examine and then approve any equipment to be used. Prior to starting work, all seeding equipment shall be calibrated and adjusted to sow seeds at the proper seeding rate. Equipment shall be operated in a manner to ensure complete coverage of the entire area to be seeded. The Engineer shall be notified forty-eight (48) hours prior to beginning the seeding operations. Any gaps between areas of growth greater than eight square feet shall be resown or replanted.
1. No-Till or Drill Method: Rolling of the seedbed will not be required with the use of rangeland type grass drills or no-till planters.

### **901-3.3 WET APPLICATION METHOD**

#### DESCRIPTION

##### 800-1.1 GENERAL

- A. This item includes Access Control System (ACS) for five (5) electric vehicular gates added to the existing ACS at the Airport. Existing ACS at Rockford Airport was installed by:

New ACS, ACS components and system upgrades must be compatible with existing system.

- B. All labor and materials including ACS controller, card readers, fiber optic converters, fiber optic cable/conduit, communication cable/conduits, LAN, wireless network for gates W51 and W52, software upgrades, programming, commissioning and training and other equipment that are required to form a fully functional ACS as shown on the Drawings and specified herein are part of this item.
- C. The initial programming of the ACS, testing of LAN, testing of wireless network as well as the testing of ACS, owner training and documentation of the installed ACS as shown on the Drawings and specified herein are also part of this item. All costs associated with programming, testing, training and documentation of the system shall be included in the item.
- D. Fiber optic LAN for gates E33 and N6 shall be provided as shown on the plans and as specified herein.
- E. Wireless LAN/Ethernet for gates W51 and W52 shall be provided as shown on the plans and as specified herein.
- F. Existing wireless LAN shall be utilized for gate E18 as shown on the plans and as specified herein.
- G. All communication, fiber optic, antenna and controls cabling required for the system and also shown on the Drawings shall be furnished and installed as required for the complete and functional ACS.
- H. Integration with the existing ACS is part of this item: Include all costs required to cover the integration as contained in these Specifications.

##### 800-1.2 QUALITY ASSURANCE

- A. Manufacturer's Qualifications: Firms regularly engaged in manufacture of ACS components and accessories, of types, capacities and characteristics required, whose products have been in satisfactory use in similar service for not less than five (5) years.
- B. Installer's Qualifications: Firms with at least three (3) years of successful installation experience with projects utilizing ACS work similar to that required for this project.
- C. Equipment Qualifications: Underwriters Laboratory (UL) approval labeling or International Organizations for Standardization (ISO) compliance labeling.



### **800-1.3 SUBMITTALS**

- A. General: Partial submittals are not acceptable. Submit all documentation in accordance with Conditions of Contract Documents as well as this section.
- B. Informational Data: The successful bidder shall submit the following documents a minimum of ten (10) Days prior to the Pre-Construction Conference:
  - 1. Proposed Construction Schedule.
  - 2. Contractor Qualification Data demonstrating capabilities and experience of the firm. Include lists of completed projects with information on project name and address, name and addresses of architects, consultants or Owners involved in these projects.
  - 3. Installer Certifications on manufacturer's letterhead indicating that installer complies with the manufacturer's requirements necessary to install the equipment specific to this project.
- C. Installation Work Plan: At the Pre-Construction Conference, the successful bidder shall submit a work plan for approval by the Engineer. The work plan shall describe normal and special work hour schedules. The plan shall detail methods for protection of existing equipment, daily cleanup, restoration of exposed ceilings and any other activity that assures continuing operation with minimal impact on operations and passenger activities.
- D. Product Data: At the Pre-Construction Conference the successful bidder shall submit manufacturer's data on ACS components as follows:
  - 1. Electrical Specifications.
  - 2. Mechanical Specifications.
  - 3. Instructions for installation and operation.
  - 4. On data sheets that illustrate multiple models, the particular model proposed for the application shall be encircled or underlined. Individual copies shall be included for each proposed model number indicating areas of application.
  - 5. Deviations from Specifications shall be encircled or underlined on the documents and be marked as deviations.
- E. Shop Drawings: The successful bidder shall provide Shop Drawings showing equipment quantities, locations, types and arrangements including but not limited to:
  - 1. Dimensions.
  - 2. Product identification.
  - 3. Fabrication and installation Drawings.
  - 4. Rough-in diagrams.
  - 5. Wiring diagrams showing field-installed wiring.
  - 6. Schedules and Tables.
  - 7. Design calculations and methods.
  - 8. Compliance with specified standards.
  - 9. If rack mounted equipment is used, provide an assembly drawing of every equipment rack with locations, quantities, model numbers of individual components contained in the rack, and dimensions shown on the Drawing.

- F. The successful bidder shall submit for review and approval, by the Engineer or designated representative a test plan a minimum of fourteen (14) days prior to substantial completion. The test plan shall detail test procedures and test reports that indicate testing methods, testing device calibration, and interpretations of test results for Field Acceptance Tests. The test plan shall detail the objectives of all tests. The tests shall clearly demonstrate that the ACS and its components fully comply with the requirements specified herein.
- G. Training: Provide training schedule for approval by the owner seven (7) days prior to substantial completion. Include course outline and training material planning to be used in the training for approval by the consultant. Plan on holding two (2) sessions focused on administration and maintenance of the system and a minimum of four (2) sessions focused on user training. Some of the training sessions will be conducted after normal business hours to accommodate those on evening, weekend and night shifts.

#### **800-1.4 QUALITY ASSURANCE**

- A. Manufacturer's Qualifications: Firms regularly engaged in manufacture of ACS, components and accessories, of types, capacities and characteristics required for this job, whose products have been in satisfactory use in similar installations for not less than five (5) years.
- B. Installer's Qualifications: Firms with at least three (3) years of successful installation experience with projects of similar size and environments utilizing the brand of ACS equipment proposed for this project.
- C. Code compliance: comply with national and municipal codes as applicable to construction and installation of ACS equipment and signal distributions systems. When there is a conflict between codes, the more stringent will apply.

#### **800-1.5 INTELLECTUAL PROPERTY**

- A. Should patented articles, methods, materials apparatus, etc., be used in this work, the Contractor shall acquire the right to use it. The Contractor shall hold the Airport and its agents harmless for any delay, action, suit, or cost growing out of the patent rights for any device on this project.
- B. Should copyrighted software be used in this work, the Contractor shall acquire the right to use it. The Contractor shall hold the Airport and its agents harmless for any delay, action, suit, or cost growing out of copyrights for any software on this project.
- C. All software required for the complete operation of the system as specified herein shall be delivered with either full Ownership transferred to the Airport or a License to use at this site, including the right to make back up copies.

#### **800-1.6 WARRANTY**

- A. Period: The Contractor shall guarantee all labor, workmanship, and materials for a period of two (2) years from the date of final acceptance. Should a failure occur within the first two (2) years to the system, the Contractor shall provide all labor and materials necessary to restore the system to the condition required for the final test and acceptance for this contract, at no cost to the Airport.
- B. Software Maintenance: The contractor shall maintain the operating system and ACS software to the most current version available from the manufacturer during the warranty period at no additional cost to the Airport.

- C. During the warranty period, all periodic and routine maintenance of the installed components to maintain the factory warranty shall be provided at no additional cost under this contract.
- D. Tie-ins: During the warranty period, components may be connected/disconnected from the system as applicable. New devices will be connected in a similar manner as shown on the drawings for this contract by a qualified company and the existence of the new connections or deletion of existing connections shall not void the system warranty on the original system.
- E. Response Times: For the Warranty Period, the following response times shall be maintained:
  - 1. The initial call to the contractor shall require the type of call to be classified as critical or non-critical by the owner. The nature of the problem and the effect on operations will be the deciding factor in classifying the problem. For the purpose of defining the priority of the call, the contractor shall have personnel accessible to Airport personnel via phone callback within one (1) hour of initial call.
    - a. Non-critical Items: For purposes of this section, these are defined as failures or problems, which do not affect the overall safety, security, or operation of the Airport. For example, the loss of operation on a single card reader would usually be considered non-critical.
    - b. Critical Items: For purposes of this section, these are defined as failures or problems, which do affect the overall safety, security, or operation of the Airport. A failure of the main software resulting in the loss of access from the gates would be an example of a critical item requiring immediate remedy.
- F. Non-critical items: The contractor shall diagnose and remedy the problem during normal working hours of the next working day. The initial response shall be the morning of the next day if received before noon or by the noon the next day if received before close of business. Normal business hours are defined as 8 AM to 5 PM Monday through Friday.
- G. Critical Items: Critical Items require the contractor to respond with all due speed. These will possibly need to be responded to outside of normal business hours.
- H. The contractor must respond on-site to all critical item calls within four (4) hours of the initial call.

#### **800-1.7 RADIO/TELEVISION INTERFERENCE**

A. FCC Compliance: All equipment that uses radio frequency energy shall be certified to comply with Subpart J of Part 15 of Federal Communication Commission rules CFR 47 as those rules define a class "A" computing device.

B. This ACS and wireless network is to be installed in a major airport and is subject to background RF levels expected in such an area. It is the Contractor's responsibility to protect the specified systems from interference of other systems, and through FCC compliance listed above, to prevent interference with other systems.

## **EQUIPMENT AND MATERIALS**

### **800-2.1 ACS CONTROLLER**

ACS controller shall be Intelligent Controller, model PW6000 by Honeywell or approved equal. ACS controller shall be mounted in a NEMA 3R enclosure at each gate location on a unitstrut frame next to the gate operator. ACS controller shall be capable of communication with Ethernet (TCP/IP). ACS controller shall be furnished with integral power supply to operate at 120VAC. Contractor shall be responsible for step down transformer as required at each location to provide 120VAC power supply to all ACS components. ACS controller shall be capable of interfacing with card readers and existing ACS.

### **800-2.2 FIBER CONVERTER**

Fiber optic converter and termination shall be required at all gate locations. Fiber converter shall be capable of converting Ethernet/LAN fiber optic network and interface with ACS controller. Fiber converter shall installed inside NEMA 3R enclosure with ACS controller. Fiber converter shall be furnished with integral power supply to operate at 120VAC. Contractor shall be responsible for step down transformer as required at each location to provide 120VAC power supply to all ACS components.

### **800-2.3 WIRELESS NETWORK**

#### A. GENERAL

1. New wireless LAN/Ethernet network shall be installed to connect new gates W51 and W52 to the existing ACS at the Terminal Building. There is no clear line of sight from the existing Glycol pump building to the Terminal Building, therefore wireless signal bridge shall be established via Professional Building.
2. Unless otherwise specified, radio networking equipment shall utilize unlicensed 900 MHz (902-928 ISM Band) Spread Spectrum hardware.
3. As part of this Section, Contractor shall be responsible for providing reliable radio communications to all sites indicated. All necessary costs to meet this requirement (including data store-and-forward and/or repeater sites) shall be included with Contractor's base-bid cost. No additional compensation will be made for meeting this requirement.
4. To comply with non-licensed operation under FCC 47CFR15.247.b.3, verify the Effective Isotropic Radiated Power (EIRP) of each transmitter path does not exceed +36dBm (4 Watts). Decrease transmitter output as required. Include documentation that this requirement has been met for each transmitter path in commissioning report.

#### B. RADIO PROPAGATION PATH STUDY (RPPS)/SITE SURVEY

1. A Radio Propagation Path Study (RPPS) shall be furnished by the Contractor and included in cost for this item. All costs for this work shall be included in the base-bid cost and are considered incidental to this item.
2. The RPPS shall be furnished to the Owner/Engineer for review prior to procurement or installation of any telemetry equipment.
3. RPPS shall include allowances for all R.F. down-lead, lightning arrestor and connectors in signal loss calculations.
4. Calculations shall identify the type and approximate length of R.F. cable used. Furnish cable manufacturer's published signal-loss data with RPPS for review.
5. Unless otherwise specified, "Fade Margin" to any site shall be 15dB or better above published minimum acceptable sensitivity for proposed radio hardware.
6. RPPS results shall include calculated R.F signal levels (in dBm and  $\mu$ Volt).
7. RPPS shall include scaled terrain profile between locations radio sites based upon

actual ground terrain data from USGS, or equivalent database.

7. RPPS results shall be furnished for each radio path (i.e. both Master-to-Remote and Remote-to-Master).
8. A minimum of 60% of the First Fresnel zone shall be clear of terrain along the radio path. Adjust antenna mounting elevations, as required. RPPS shall include Fresnel calculations along each radio path using actual ground terrain data. RPPS reports utilizing "flat" terrain are not acceptable and will be rejected.
9. RPPS shall include proposed antenna mounting height, type, polarization and tilt (where applicable) along with proposed method of installation (pole, mast, etc.).

#### C. RADIO MODEMS

1. Radio Modem shall be both serial and Ethernet compatible. Units shall be iNET-II 900 as manufactured by GE/Microwave Data Systems (MDS).
2. Radio Modems shall have FCC Part 15 Approval.
3. Radio Modem shall include capabilities for either DTS (Direct Transmission System) or FHSS (Frequency Hopping Spread Spectrum) modes.
4. Transmit power must be adjustable from 0.1 watt to the FCC maximum of 1.0 watt.
5. Radio Modems shall include integral RSSI (Receive Signal Strength Indication).
6. Radio Modem shall be capable of user-configured data rates of either 512kbps or 1Mbps.
7. Radio Modem shall have minimum receiver sensitivity of -97 dBm@512Kbps with  $10^{-6}$  BER (Bit Error Rate) and -92 dBm@1Mbps with  $10^{-6}$  BER.
8. Radio Modems shall utilize CPFSK modulation (Continuous phase FSK)
9. Radio Modems shall be configurable as follows:
  - a. Access Point/Remote Dual Gateway – Serial and Ethernet
  - b. Remote Serial Gateway – Serial Only
  - c. Remote Ethernet Bridge – Ethernet Only
10. Radio Modems shall utilize TNC female connectors for R.F. termination. R.F. Output impedance: 50 Ohms.
11. Radio Modems shall include capabilities for the following protocols:
  - a. Allen-Bradley EtherNet/IP – Modbus/TCP
  - b. Wireless: CSMA/CA (collision avoidance)
  - c. Ethernet: IEEE 802.3, Ethernet II, IEEE 802.1Q (trunk, access and native, STP, IGMP.
  - d. TCP/IP, GHCP, ICMP, UDP, TCP, ARP, Multicast, SNMP, TFTP
  - e. Serial: PPP, encapsulation over IP (tunneling) for serial async, multidrop protocols including Modbus, DNP3, DF1, BSAP
12. Radio Modem Encryption Capabilities shall include:
  - a. Encryption: AES-128 with automatic key rotation
  - b. Authentication: 802.1x, RADIUS, EAP/TLS, PKI, PAP, CHAP
  - c. Traffic segregation: 802.1Q VLAN
  - d. Management: SSL, SSH, HTTPS
13. Radio Modems shall be suitable for operation in temperature range of no less than -30°C to +60°C (-22°F to +140°F).

#### D. ANTENNA

1. Contractor shall propose antenna type and model at each site. Include and identify allowances for elevation, environmental and seasonal signal losses in Radio Propagation Path Study (RPPS).
2. In general, Master Site locations will typically utilize omni-directional antenna design (e.g. whip type with gain) and Remote Site locations will utilize directional antenna

- design with gain (e.g. yagi).
3. Unless otherwise noted, all antenna installations shall utilize vertical polarization.
  4. All antennas installations, including mounting masts or towers, brackets, guys, lightning arresters and other ancillary equipment shall be furnished in order to provide a complete and operational radio network system to all specified sites. Contractor and suppliers shall acquaint themselves with the various site locations.
  5. All antenna/tower/mast installations shall be designed for a minimum of 80 mph continuous winds with ½" radial ice.
  6. Triangular tower installations shall include an anti-climbing option on the bottom 10 foot section. Concrete foundations and support shall be as recommended by tower manufacturer.
  7. Antennas shall be installed on the roof of existing Glycol Building, Professional Building and Terminal Building.

#### **2.04 R.F. CABLE**

1. All R.F. cable shall be low-loss type such as Times Microwave LMR-400 or Andrew Heliac. Contractor shall select an R.F. cable type compatible with requirements at each site, including consideration of RF cable length, overall system gain and propagation path loss.
2. Unless specifically approved, high-loss cables such as RG-188, RG-58 will not be considered as meeting this requirement and will be rejected.
3. Include and identify allowances for elevation, environmental and seasonal signal losses in Radio Propagation Path Study (RPPS).
4. Furnish all required weatherproof boxes, heaters, etc as necessary for the proposed equipment. All exterior couplings in cables shall be made weatherproof and watertight.
5. Where subjected to physical abuse or vandalism, install R.F. cable in protective conduit.

#### **2.05 LIGHTNING ARRESTORS**

1. Lightning Arresters shall be furnished for all radio sites. Arresters shall be PolyPhasor DSX, or equivalent. Units shall be compatible with proposed radio hardware and R.F. cable.
2. Where not in place at existing sites, furnish suitable site grounding electrodes for R.F. lightning arrestors and TVSS applied on 120 VAC powered equipment.

### **CONSTRUCTION METHODS**

#### **800-3.1 INSTALLATION OF ACCESS CONTROL SYSTEM (ACS)**

- A. General: The Contractor shall investigate the site and become thoroughly familiar with the facility. The existing ACS must remain functional during the construction of this project. Any impairment or malfunction of the existing systems directly related to the installation of the new system shall be immediately repaired at the Contractor's expense.
- B. The ACS shall also be coordinated with the existing CCTV system.
- C. Raceways: Contractor shall coordinate with the Engineer for exact location of all exterior building penetrations for ACS conduit before proceeding. All conduits shall be concealed within the building structure where possible. Contractor shall obtain Engineer approval of any exposed conduit routing before installation. All wall penetrations by conduit or cable tray shall be sealed and fireproofed to retain original fire rating. Conduit size shall be 3/4-inch minimum to all ACS devices, and shall be used for no other purpose. Any cutting of finished interior surfaces, to facilitate conduit running, shall be patched and repaired to the conditions that existed before the cutting.

- D. Facilities: The facility where this system is being installed is fully occupied and conducting the business of processing aircraft passengers and baggage, and hosting airport guests as well as retail businesses. The Contractor shall make provisions to coordinate with the Airport to minimize disruption of all airport operations. This may require parts of the installation being done in off-peak hours. All debris from the installation process shall be removed from the worksite immediately to minimize the potential for Foreign Objects of Destruction (FOD) being introduced into the Air Operations Area (AOA). Care shall be exercised at all times to protect the occupants and the facility from any damage. The area where the ACS is to be installed is a Security Identification Display Area (SIDA). The Contractor shall be required to obtain badges for all employees working on this job. A background investigation and training classes are required to obtain a badge. All costs associated with finger printing and training classes for this program are the responsibility of the Contractor.
- E. Approvals: Any variances from the locations shown for the ACS equipment on the plans that exceed 10 feet in any direction shall be brought to the attention of the engineer before installing the equipment. Any field engineering or modification of standard mounting apparatus shall be brought to the attention of the engineer for approval before such modification is implemented. Sketches or diagrams of the modification may be requested and shall be considered part of this Contract. Samples of cables and coax with installed connectors shall be presented to the engineer for approval upon request. Once approved, any variance from the submitted samples must be approved by the engineer.
- F. Manufacturer's Instructions: Install ACS and components where indicated, in accordance with equipment manufacturer's written instructions, in compliance with National Electrical Code, applicable local codes, and with recognized industry practices, to ensure that the television system complies with requirements and serves intended purposes.
- G. Contractor shall install all power, networking and communication cables as required for the complete and operational ACS. The location and routing of the cables shall be determined and approved by the Airport during construction. In addition, the Contractor shall furnish and install all power supplies, modems and enclosures as required by the ACS component manufacturers.
- H. Identification: Install permanent identification labels on all conduits, junction boxes, conductors, and termination blocks.
- I. Touch Up Work: Touch-up scratched and marred surfaces to match original finishes; remove dirt and construction debris.

### **800-3.2 SYSTEM TESTING AND ACCEPTANCE**

- A. Upon installation of each gate control, perform an installation test. The installation test shall include confirmation of the controls as scheduled and verification that data is being transmitted across the backbone fibers at correct levels per fiber optic module diagnostic indicators. Test all junctions from the input device to system output for intermittent connections and physical strength of junction.
- B. Any problems encountered during the installation, including damage to Airport equipment and ACS elements during this test, will be documented and brought to the airports attention and corrected at Contractor's expense. The Contractor shall promptly correct all problems encountered, providing field service personnel appropriately trained for the types of problems encountered.
- C. The Contractor shall supply a form to be used during these tests for authorization, and initialing, by the Airport, or authorized representative, and the Contractor. This form shall clearly define the items tested, leaving room for the date, ACS element designation, and initials. All ACS functions shall be demonstrated to ensure operation as required by these Specifications and Drawings.

### **800-3.3 OPERATION AND MAINTENANCE MANUALS**

- A. The intent of this Section is to require complete documentation of the ACS for purposes of system operation and maintenance during and after the warranty period. The operation and maintenance manuals shall be exhaustive in the coverage of the system to the extent that they may be used as the sole guide to the troubleshooting, identification and repair of defective parts.
- B. The Contractor shall provide four (4) complete Drawing books and maintenance and operation manuals on the completed system. These manuals shall include specific wiring diagrams, schematics, and functional details such that going to the actual equipment and making reference to this manual may easily identify any component, wire, or piece of equipment in the system. It is required that everything in the system be neatly labeled and easily identifiable. Every terminal, wire, component, or piece of equipment, and other such items shall have a number or letter designation. All of these identification characteristics shall be included in the maintenance and operation manuals. The Contractor shall provide one (1) set of all Drawings as vellums, and where the Drawings are CAD generated, provide the Drawing files in AutoCAD 2012 format. Provide one (1) set of all schedules and tables in Microsoft Excel format.
- i. The maintenance manual requirement of this Section is in addition to shop Drawing requirements. Maintenance manuals and Drawing sets shall be compiled after system fabrication and testing, and shall incorporate any changes made after shop Drawing submittal. The maintenance manuals and Drawing books shall be permanently bound in hard plastic covers.
  - ii. Provide manufacturer's standard literature, covering all equipment included in the system. Maintenance manuals shall contain Specifications, adjustment procedures, circuit schematics, component location diagrams, and recommended replacement parts. References to equipment, not used in this project, shall be crossed out.
  - iii. Drawing Books: All Drawings developed specifically for this project shall be reduced to 11" x 17", folded and bound with hard plastic covers. Provide component identification and cross reference on the Drawings to allow the maintenance department to understand the function of each item (the block Diagram), find the room where the device is mounted (Contract document plans), find its location in a rack (arrangement Drawings), find how it is wired (wiring diagrams), find its detailed Specifications (vendor data sheets), and how to repair it (spare part lists). Provide the following Drawings as a minimum:
    1. Functional Block Diagram, an overall block diagram showing the major inter-connections between subsystems components.
    2. Arrangement Drawings showing the physical arrangement of all major system components.
    3. Elevation Drawings of all equipment racks showing the location of each component in the racks. Components in the racks shall be identified as in the functional block diagrams. Drawing shall show the routes of all cables connecting its components.
    4. Wiring Diagrams showing all interconnecting wiring. Wire identification on the diagrams shall agree with the wire markers installed on the equipment.
  - iv. Submit lists of proposed manufacturer's recommended spare parts to maintain the complete ACS with a minimum of down time. This list shall include part names, part numbers, and source for additional purchase. The parts list shall be cross-referenced to the functional block diagrams and the product data.
  - v. Special Tools List: Submit a list of special tools required to maintain the ACS. Include on the list the name, part number, and source for all special tools.



- vi. Special Test Equipment List: Submit a list of special test equipment required to prove that all components of the system are functioning per Specification.

#### **800-3.4 TRAINING**

- A. Provide ACS system operation and administration/ maintenance training for the Airport Operations Department personnel. The training shall not be generic in nature, but must be customized to relate to Rockford Airport operations.
  - i. Two categories of system training shall be provided. System operational training shall be provided for a maximum of five (5) administration/operations personnel and maintenance training for a maximum of two (2) maintenance personnel. This training shall permit the Airport maintenance personnel to provide basic service to the system related to day-to-day facility maintenance projects without voiding the warranty.
  - ii. Training shall be provided multiple times and at the intervals specified below. One (1) session shall be provided during daytime working hours, and one (1) session during evening working hours, with specific days, work shifts, and hours for training to be selected by the Airport.
  - iii. Training must be in a modular format and shall provide separate areas of training materials specific to the airport's administration, operation, and maintenance.
    1. System Pre-Acceptance training shall be provided when the system is capable of providing beneficial use to the airport.
    2. Follow-up Training, Session, shall be provided between fifteen (15) and thirty (30) days after pre-acceptance training, with times and dates to be selected by the Airport.
  - iv. Provide customized, Rockford Airport specific training materials for each attendee to use at each training session and to keep for reference. Provide five (5) copies of each piece of training material used at each session to the Airport Operations Department at the completion of each training session for their future use.

#### **800-3.5 ACCEPTANCE**

Acceptance will be withheld until the successful completion of the following:

1. Acceptance of all submittals
2. Delivery of final documentation
3. Approval of camera aiming
4. Successful testing
5. Successful training

#### **800-3.6 WIRELESS NETWORK**

- A. Install in accordance with manufacturer's instructions.
- B. Work performed on the elevated towers shall be done in compliance with all safety requirements of OSHA and the Owner.
- C. In general, the preferred arrangement for installation and commissioning is to first install any necessary repeater infrastructure and follow installation to those sites routing back to those locations. It is expected a minimum of 10 ft communication towers on top of roof may be required at each site, however some sites may have lower antenna heights after partial

infrastructure has been installed and tested.

- D. All installation, start-up and commissioning shall be at the convenience of the Owner and as directed by the Owner's representative. No equipment shall be removed from operation, modified, or put in operation without the Owner's knowledge and concurrence. All disruption to facility operations shall be requested in writing a minimum of 72 hours in advance.
- E. All antenna installations shall include consideration for antenna weight, mounting-height, wind and ice loading and potential vandalism.
- F. Install and test all R.F. telemetry equipment at each RTU site. Adjust each directional antenna to maximize signal strength and minimize VSWR. Verify system functionality at each location. Correct any and all deficiencies found at no additional expense to the Owner.
- G. Confirm the Effective Isotropic Radiated Power (EIRP) of each transmitter does not exceed +36dBm (4 Watts). Document results in commissioning report.
- H. All decommissioned leased-line telemetry hardware shall remain the property of the Owner. All such equipment shall be carefully removed from service and turned over to the Owner's representative for use elsewhere, or disposal.
- I. Contractor and supplier shall furnish any other items not specifically noted or detailed in order to provide for a functional system as described in these specifications.
- J. At the completion of equipment commissioning, a report shall be prepared by the Contractor and furnished to the Owner's representative containing all system configuration parameters and data. Six (6) copies shall be required.
- K. Wireless network for gates W51 and W52 will require repeater/bridge location at existing Professional Building. Contractor shall install repeater equipment/modem inside the building in electrical room. Install new circuit breaker inside existing power panel to provide power for the wireless equipment. Match existing conditions.

### **METHOD OF MEASUREMENT**

#### **800-4.1**

The Access Control System Upgrades shall include all material and labor required for the installation of the new card readers, ACS controllers, fiber converters, wireless network, fiber modem and power supplies, hardware, software, training, manuals, system integration, communication and fiber optic cables, patch panels, conduits for communication and fiber optic cables, testing and associated items required for a complete and operational access control system.

Access control system upgrades for gates E33, N6, W51 and W52, including but not limited to fiber optic LAN and wireless network shall be measured and paid for under pay item AR800849 ACCESS CONTROL SYSTEM UPGRADES – LUMP SUM.

Access control system upgrades for gate E18, including but not limited to integration with existing wireless network shall be measured and paid for under pay item AT800849 ACCESS CONTROL SYSTEM UPGRADES – LUMP SUM.

**BASIS OF PAYMENT**

**800-5.1**

Payment will be at the contract unit price per lump sum or each as described below, complete and accepted for each item. This price shall be compensation in full for all preparation, assembly, removal, materials, labor, equipment, tools and incidentals necessary to complete the item as specified herein or as directed by the Engineer.

SUBJECT: ITEM 610, STRUCTURAL PORTLAND CEMENT CONCRETE:  
JOB MIX FORMULA APPROVAL & PRODUCTION TESTING.

- I. This policy memorandum addresses the Job Mix Formula (JMF) approval process and production testing requirements when Item 610 is specified for an airport construction contract.
- II. PROCESS
  - a. The contractor may submit a mix design with recent substantiating test data or he may submit a mix design generated by the Illinois Division of Highways with recent substantiating test data for approval consideration. The mix design should be submitted to the Resident Engineer.
  - b. The Resident Engineer should verify that each component of the proposed mix meets the requirements set forth under Item 610 of the *Standard Specifications for Construction of Airports* and/or the contract special provisions.
  - c. The mix design should also indicate the following information:
    1. The name, address, and producer/supplier number for the concrete.
    2. The source, producer/supplier number, gradation, quality, and SSD weight for the proposed coarse and fine aggregates.
    3. The source, producer/supplier number, type, and weight of the proposed flyash and/or cement.
    4. The source, producer/supplier number, dosage rate or dosage of all admixtures.
  - d. After completion of Items b and c above, the mix with substantiating test data shall be forwarded to the Division of Aeronautics for approval. Once the mix has been approved, the production testing shall be at the rate in Section III as specified herein.

### III. PRODUCTION TESTING

- a. One set of cylinders or beams, depending on the strength specified, shall be cast for acceptance testing for each day the mix is used. In addition, at least one slump and one air test shall be conducted for each day the mix is used. If more than 100 c.y. of the mix is placed in a given day, additional tests at a frequency of 1 per 100 c.y. shall be taken for strength, slump, and air. The concrete shall have a maximum slump of three inches (3") and minimum slump of one inch (1") when tested in accordance with ASTM C-143. The air content of the concrete shall be between 5% and 8% by volume. At no time shall the temperature of the concrete exceed 90 degrees Fahrenheit.
- b. If the total proposed amount of Item 610 Structural Portland Cement Concrete as calculated by the Resident Engineer is less than 50 c.y. for the entire project, the following shall apply:
  - The Resident Engineer shall provide calculations of the quantity of Item 610 to the Division of Aeronautics.
  - One set of cylinders or beams, depending on the strength specified, shall be cast for acceptance testing.
  - One air content and one slump test shall be taken for acceptance testing.
  - The concrete shall have a maximum slump of three inches (3") and minimum of one inch (1") when tested in accordance with ASTM C-143. The air content of the concrete shall be between 5% and 8% by volume. At no time shall the temperature of the concrete exceed 90 degrees Fahrenheit.
- c. The Resident Engineer shall collect actual batch weight tickets for every batch of Item 610 concrete used for the project. The actual batch weight tickets shall be kept with the project records and shall be available upon request of the Department of Transportation.
