





#### GENERAL NOTES

THE PROPOSED WORK IS LOCATED ON FAP 828 DIETERICH BLACKTOP STARTING AT ZION LANE SOUTH OF BIBLE GROVE ROAD TO 50' NORTH OF THE RAILROAD TRACKS IN CLAY CITY IN CLAY COUNTY.

THE WORK INCLUDED IN THIS SECTION CONSISTS OF APPLYING CAPE SEAL TO DIETERICH BLACKTOP, PLUS ANY OTHER NECESSARY WORK TO COMPLETE THE SECTION.

FOR THE MICROSURFACING, THE AGGREGATE GRADATION FOR THE A-1 BITUMINOUS SURFACE TREATMENT SHALL BE CRUSHED STONE, CA 16, AND FRICTION AGGREGATE MIXTURE C.

SHORT TERM PAVEMENT MARKING SHALL BE PAINT AND SHALL BE APPLIED TO THE CENTERLINE ONLY OF THE A-1 TREATMENT. TEMPORARY PAVEMENT MARKING SHALL BE PAINT AND SHALL BE APPLIED IMMEDIATELY AFTER THE MICROSURFACING PASS. THE CENTERLINE STRIPES FOR SHORT TERM PAVEMENT MARKING AND TEMPORARY PAVEMENT MARKING SHALL BE 10 FEET LONG AT 40 FEET CENTERS. SHORT TERM PAVEMENT MARKING AND TEMPORARY PAVEMENT MARKING SHALL INCLUDE NO PASSING ZONES. THE QUANTITY FOR PAINT PAVEMENT MARKING LINE 4" CONSISTS OF 129,271 FEET WHITE AND 23,250 FEET YELLOW.

A QUANTITY OF LONGITUDINAL JOINT REPAIR HAS BEEN INCLUDED FOR FILLING THE HOLES LEFT BEHIND FROM THE REMOVAL OF RAISED REFLECTIVE PAVEMENT MARKERS.
